#### Report of the First Committee

### I, INTRODUCTION

1. The item entitled "Israeli nuclear armament" was included in the provisional agenda of the forty-third session in accordance with General Assembly resolution 42/44 of 30 November 1987,

2. At **its** 3rd plonary meeting, on 23 September 1988, the General Assembly, on the recommendation of the General Committea, decided to include the item in its agenda and to allocate it to the First Committee,

3. At its 2nd meeting, on 12 October, the First Committee decided to hold a general debate on the disarmament items allocated to it, namely, items 51 to 69, 139, 141 and 145. The deliberations on those items took place at the 3rd to 25th meetings, from 17 October to 2 November (see A/C.1/43/PV.3-25). Consideration of and action on draft resolutions on those items took place between 3 and 18 November (see A/C.1/43/PV.26-43).

4. In connection with item 69, the **First** Committee had before it the following document8:

#### II. CONSIDEBATPON OF DRAFT RESOLUTION A/C.1/43/L.6

5. On 28 October, Algeria, Bahrain, Demogratic Yemen, Djibouti, Iraq, Jordan, Kuwait, Lebanon, the <u>a.</u> Mauritania, .-- Tunisia,

Arab Emirates and Xemen submitted a draft rerolution entitled "Israeli nualrar armament" (A/C.1/43/L.6), which was introduced by the representative of Jordan on behalf of the Group of Arab States at the 29th meeting, on 7 November.

6. At its 37th meeting, on 15 November, the Committee voted on draft resolution  $\lambda/C.1/43/L.6$  as follows:

III. RECOMMENDATION OF THE FIRST COMMITTEE

7. The First **Cc.mmittee** recommends to the General Assembly the adoption of the following draft resolution:

Israeli nuclear armament

The General Assembly,

**Bearing** in mind its previous resolutions on Israeli nuclear armament, the latest of which is **42/44** of **30** November 1987,

**Recalling** its resolution **42/28** of 30 November 1987, in which, <u>inter alia</u>, it called **for** placing all nuclear facilities in the region under International

Atomia Energy Agency aafeguarda, pending the • atabliahmont of a nuclear-weapon-free sone in the Middle East,

Recalling further Security Council resolution 487 (1981) of 19 Juno 1981, in which, inter alia, the Council alled upon Israel urgently to place all its nualoar facilities under International Atomia Energy Agency safeguards,

Noting that only Israel has been specifically called upon by the Security Council to place its nuclear facilities under International Atomic Energy Agency safeguards,

Noting with grave concern Israel's persistent refuaal to commit Itaelf not to manufacture or acquire nualear weapons, despite repeated calls by the General Aaaembly, the Seaurity Counail and the International Atomio Energy Agency,

Taking into consideration resolution QC (XXXII)/RES/487 of 23 September 1988 adopted by the General Conference of the International Atomia Energy Agency, in which the Qeneral Conference atrongly condemned thr continued refuaal by Iaraol to renounce the possession of nuclear weapons and to submit all its nuclear facilities to the Agency's aafeguardr in compliance with Security Council resolution 487 (1981),

<u>Deeply alarmed</u> by thr information with regard to the continuing production, development and acquisition of nuclear weapon8 by Iararl,

<u>Aware</u> of the grave conaequences that endanger international pease and security as a result of Israel's development and acquisition of nuclear weapon8 and Israel's collaboration with South Africa to develop nualoar weapon8 and their delivery ayatemo,

<u>Deeply concerned</u> that the declared Israeli policy of attacking and destroying nuclear facilities devoted to peaceful purposes is a part of its nuclear armament policy,

1. <u>Reiterates its condemnation</u> of Israel's refusal to renounce any posaeaaion of nualear weapons;

2. <u>Reiterates also its condemnation</u> of the co-operation between Israel and South Africa!

3. <u>Requests once more</u> the Security Council to take urgent and effective measures to ensure that Israel complies with Council resolution 487 (1981);

4. <u>Demands once more</u> that Israel place all **its** nuclear facilities under International Atomic Energy Agency safeguardsr

5. <u>Calls upon</u> all State6 and organisations that have not yet done so to discontinue co-operating with and giving assistance to Israel in the nuclear field;

6. <u>Reiterates its isquest</u> to the International Atomic Energy Agency to suspend any scientj ic co-operation with Israel that could contribute to its nuclear capabilities;

7. <u>Requests also</u> the International Atomic Energy Agency to inform the Secretary-General of any steps Israel may take to place its nuclear facilities under Agency safeguards;

8. <u>Requests</u> the Secretary-General to follow closely Israeli nuclear activities and to report to the General Assembly at its forty-fourth session;

9. <u>Dec!les</u> to include in the provisional agenda of its forty-fourth session the item entitled "Israeli nuclear armament".
