## QUESTION OF ANTARCTICA

### Report of the First Committee

### I. INTRODUCTION

1. The item entitled "Question of Antarctica" was included in the provisional agenda of the forty-third session in accordance with General Assembly resolution **42/46** A and B of 30 November 1987.

2. At its 3rd plenary meeting, on 23 September 1988; the General Assembly, on the recommendation of the **General Committee**, decided to-include the item in its agenda and to allocate it to the First **Committee**.

3. The First Committee considered the item at its **44th** to 46th meetings, on 21 and 22 November 1988 (A/C.1/43/PV.44-46).

#### **II.** CONSIDERATION OF PROPOSALS

### A. Draft resolution AK.1/43/L.82

5. On 17 November 1988, Antiaua and Barbuda, Bangladesh, Brunei Darussalam, Cameroon, the Congo, Ghana, Indonesia, Kenva, Malavsia, Mali, Nepal, Nigeria, Oman, Pakistan, Rwanda. Sri Lanka, the Sudan. Uaanda. Zaire, Zambia and Zimbabwe, submitted the draft resolution entitled "Question of Antarctica" (A/C.1/43/L.82), which was introduced by the representative of Malaysia at the 46th meeting, on 22 November.

6. At the same meeting, the Committee adopted draft resolution A/C.1/43/L.82 by a roll-call vote of 77 to none, with 7 abstentions (see **para.** 9, draft resolution A). The voting was as follows: 1/

## B. Draft resolution A/C.1/43/L.83

7. On 17 November.1988, Zaire, on behalf of members of the Group of African States, submitted a draft resolution entitled "**Crestion** of Antarctica" (A/C.1/43/L.83). The draft resolution was introduced by the representative of Zaire at the 45th meeting, on 22 November 1988.

Subsequently, the delegations of Cameroon, Canada, Ecuador and the Netherlands indicated that they had intended to announce that they would not participate in the vote on the draft resolution, The-delegation of Swaziland informed the **Secretariat** that it had intended to vote in favour of the draft resolution.

8. At the 46th meeting, the Committee adopted draft resolution A/C.1/43/L.83 by a roll-call vote of 89 to none, with 5 abstentions (see **para.** 9, draft resolution **B**). The voting was as follows:  $\underline{2}/$

9. The First Committee recommends to the General Assembly the adoption of the following resolutions:

#### QUESTION OF ANTARCTICA

### A

The General Assembly,

Having considered the item entitled "Question of Antarctica\*',

**Recalling** its resolutions **38/77** of 15 December 1983, **39/152** of 17 December 1984, **40/156** A and B of 16 December 1985, **41/88** A and B of 4 December 1986 and **42/46** A and B of 30 November 1987,

Recalling the relevant paragraphs of the Political Declaration adopted by the Eighth Conference of Heads of State or Government of Non-Aligned Countries, held at **Harare** from 1 to 6 September 1986, **3**/ and the resolution on Antarctica adopted by the Council of Ministers of the Organization of African Unity at its forty-second ordinary session, held at **Addis Ababa** from 10 to 17 July 1985, **4**/ as well as the decision of the Council of Ministers of the League of Arab States held at Tunis on 17 and 18 September 1986 and resolution **25/5-P(IS)** adopted by the Fifth Islamic Summit Conference of the Organization of the Islamic Conference, held at Kuwait from 26 to 29 January 1987, **5**/

**Taking** into account the debates on this item held since the thirty-eighth session of the General Assembly,

**Welcoming** the increasing awareness and interest in Antarctica shown by the international community,

<u>Convinced</u> of the advantages to the whole of mankind of a better knowledge of Antarctica,

Affirming its conviction that, in the interest of all mankind, Antarctica should continue for ever to be used exclusively for peaceful purposes and that it should not become the scene or object of international discord,

<u>Reaffirming</u> the principle that the international community is entitled to information covering all aspects of Antarctica and t **at** the 'United Nations should be made the repository for all such informatitn in accordance with General Assembly resolutions **41/88** A and **42/46** B,

<u>Conscious</u> of the particular significance of Antarotioa to the international community in terms, <u>inter alia</u>, of international peace and security, environment, its effects on global olimatic conditions, economy and scientif ic research,

Taking into account all aspects pertaining to all areas covered by the Antarctic Treaty system,  $\underline{6}$ /

Noting with appreciation the reports of the Secretary-General on the question of Antarctica, 7/

<u>Reaffirming</u> that the management, exploration, exploitation and use of Antarotioa should be conducted in accordance with the purposes and principles of the Charter of the United Nations and in the interest of maintaining international peace and security and of promoting international co-operation for the benefit of mankind as a whole,

1. Expresses its conviction that any minerals régime on Antarotioa, in order to be of benefit to all mankind, should be negotiated with the full participation of all members of the international community;

2. Further expresses its deep regret that the Antarctic Treaty Consultative Parties have proceeded with negotiations and adopted on 2 June 1988 a Convention on the Regulation of Antarctic Mineral Resource Activities, notwithstanding General Assembly resolutions 41/88 B and 47/46 B, calling for the imposition of a moratorium on negotiation8 to  $\bullet$  atsblish a minerals régime until such time a8 all members of the international community can fully participate in 8uch negotiation81

3. <u>Reiterates its call upon</u> the Antarctic Treaty Conrultativa Parties to invite the Secretary-General or hi8 representative to all meeting8 of the Treaty parties, including their consultativo meetings)

4. <u>Requests</u> the Secretary-General to submit a report on his evaluations thereon to the general Assembly at it8 forty-fourth session;

5. <u>Urges</u> all State8 Member8 of the United Nations to oo-operate with the Secretary-General and to continue consultations on all aspects relating to Antarcticat

6. <u>Decides</u> to include in the provisional agenda of it.8 forty-fourth session the item entitled "Question of Antarctica".

### The General Assembly,

Recalling its resolution 42/46 Aof 30 November 1987,

Having considered the item entitled \*\*Question of Antarctica\*\*,

Notina with **regret** that the racist **apartheid régime** of South Africa, which has been suspended **from** participation in the General Assembly of the United Nations, has continued to participate in the meetings of the Antarctic Treaty Consultative Parties,

Recalling the resolution adopted by the Council of Ministers of the **Organization** of African Unity at its forty-second ordinary session, held at **Addis** Ababa from 10 to 17 July 1985, **§**/

<u>Recallina also</u> the relevant paragraphs of the Political Declaration adopted by the **Eighth Conference** of Heads of State or Government of **Non-Aligned** Countries, held at **Harare** from 1 to 6 September 1986, **9**/

<u>Recalling further</u> that the Antarctic Treaty  $\mathbf{6}$ /is, by its **terms**, intended to further the purposes and principles embodied in the Charter of the United Nations,

Noting further that the policy of **apartheid** practised by the racist minority regime of South Africa, which has been universally condemned, **constitutes** a threat to regional and international peace and security,

1. <u>Views with concern</u> the continuing participation of the <u>apartheid</u> **régime** of South Africa in the meetings of the Antarctic Treaty Consultative Parties:

2. <u>Appeals once again</u> to the Antarctic Treaty Consultative Parties to take urgent measures to exclude the racist <u>apartheid</u> régime of South Africa from participation in the meetings of the Consultative Parties at the earliest possible date;

3. <u>Invites</u> the States parties to the Antarctic Treaty to inform the Secretary-General on the actions taken regarding the provisions of the present resolution;

4. **<u>Requests</u>** the Secretary-General to submit a report in this regard to the General Assembly at its forty-fourth session;

5. <u>Decides</u> to include in the provisional agenda of its forty-fourth session the item entitled "Question of Antarctica".
