Report of the Fifth Committee

1. At its 41st meeting, on 5 Docombor 1988, tho Fifth Committee, pursuant to rule 153 of the rules of procedure of the General Assembly, considered the statements submitted by tho Secretary-General (A/C.5/43/38,A/C.5/43/46 and Add.1, A/C.5/43/49, A/C.5/43/48, A/C.5/43/47 and A/C.5/43/39) on tho programme budget implications of tho draft resolutions recommended by the First Committee under agenda item 54, draft resolution entitled "Establishment of a nuclear-weapon-free sone in the region of the Middly East" (A/43/833, pars. 10); agenda item 63 (Chemical and bacteriological (biological) weapons), draft resolution entitled A/43/938 English Page 2

"Measures to uphold the Authority of the 1925 Geneva Protocol and to support the conclusion of a chemical weapons convention" ($\lambda/43/855$, para.14, draft rerolution λ); agonda item 64 (Qonoral and complete disarmament), draft reaclution • ntitled "International arm8trans.ers" ($\lambda/43/856$, para. 71, draft rerolution I); age:da item 64 (e) (General and complete disarmament: Nuclear disarmament), draft resolution • ntitled "Comprehensive United Nation8 study on nuclear weapons" ($\lambda/43/556$, pare. 71, draft resolution N); agonda item 66 (Review of the implementation of the recommendations and decisions adopted by the Qeneral Assembly at it8 fifteenth special session), draft rerolution entitled "Scientific and technological developments and their impact on international security" ($\lambda/43/858$, pare. 11, draft resolution λ); and agenda item 139 (Verfication in all it8 aspects), draft rerolution entitled "Study on the role of the United Nation8 in the field of verification" ($\lambda/43/094$, para. 14, draft rerolution B). The Fifth Committee had before it the related report of the λ dvisory Committee on λ dministrative and Budgetary Questions ($\lambda/43/7/\lambda$ dd.9).

3. Statements and comments made in the course of the Committee's consideration of these items are reflected in the relevant summary record ($\lambda/C.5/43/SR.41$).

DECISIONS OF THE FIFTH COMMITTEE

A. Establishment of a nuclear-weapon-free zone in the region of the Middle East

3. The Fifth Committee ...ided, without a vote, to inform the Qeneral Assembly that, rhould it adopt the draft rerelution recommended by the Firt Committee in *paragraph* 10 of its report (A/43/833), tha Secretary-General would cover the additional costs from extrabudgetary resources *and* therefore no additional appropriation would be required under section 2B of the programme budget for the biennium 1988-1989.

B. Chemical and bacteriological (biological) weapons

4. The Fifth Committee decided, without a vote, to inform the General Assembly that, should it adopt *draft* resolution A, entitled "Measures to uphoid the authority of the 1925 Geneva Protocol and to support the conclusion of a chemical weapons convention", recommended by the Firrt Committee in paragraph 14 of its report (A/43/855), an additional appropriation of \$60,500 would be required *undor* section 2B of the programme budget for the biennium 1988-1989. Furthermore, the proposed reconvening of the group of gualified experts at Geneva would constitute an rxcoption to paragraph 4 of rection I of General Assembly rerolution 40/243 of 18 December 1985.

C. General and complete disarmament

5. The Fifth Committee decided, without a vote, to inform the General Assembly that, rhould it adopt the draft resolution I, entitled "International arms

transfers", recommended by the First Committee in paragraph 71 of its report $(\lambda/43/856)$, no additional appropriation would be required under section 2B of the programme budget for the biennium 1988-1989.

D. General and complete disarmament: Nuclear disarmament

6. The Fifth Committar decided, by a recorded vote of 98 to 3, with 4 abstentions, to inform the General Assembly that, should it adopt draft resolution N, entitled "Comprehensive United Nation8 study on nuclear weapons", recommended by the First Committee in Qaragrsph 71 of its report (A/43/856), an additional appropriation of \$122,800 would be required under section 2B of the programme budget for the biennium 1988-1989.

^{1/} The representative of France explained after the voting that his dolrgation had *intended* to abstain rather then to vote in favour. Subsequently, the representatives of Kuwait and Somalia indicated that, had their delegations born present, they would have voted in favour.

E. <u>Review of the implementation of the recommendations and decisions adopted by the General Assembly at its fifteenth special session</u>

8. The Fifth Committee decided, without a vote, to inform the General Assembly that, should it adopt draft resolution A, entitled "Scientific and technological developments and their impact on international security", recommended by the First Committee in paragraph 11 of its report (A/43/858), the additional costs involved would be covered from extrabudgetary resources and therefore no additional appropriation would be required under section 2B of the programme budget for the biennium 1988-1989.

F. <u>Verification in all its aspects</u>

9. The Fifth Committee decided, by a recorded vote of 97 to 1, with 1 abstention, to inform the General Assembly that, should it adopt draft resolution B, entitled "Study on the role of the United Nations in the field of verification*', recommended by the First Committee in paragraph 14 of its report (A/43/894), an additional appropriation of \$147,300 would be required under section 2B of the programme budget for the biennium 1988-1989.
