I. INTRODUCTION

1. The General Assembly, at its forty-seventh session, adopted resolution 47/60 B of 9 December 1992, entitled "Maintenance of international security", in which the Assembly, <u>inter alia</u>, invited all Member States to provide their views on further consideration of the question of maintenance of international security, taking into account, <u>inter alia</u>, appropriate provisions of the reports of the Secretary-General entitled "An Agenda for Peace" and "New dimensions of arms regulation and disarmament in the post-cold war era", and requested the Secretary-General to submit a relevant report to the Assembly at its fortyeighth session.

2. Pursuant to the request of the General Assembly, the Secretary-General addressed a note verbale on 6 April 1993 to the Governments of Member States inviting them to submit, by 30 July 1993, their views in accordance with paragraph 2 of the above-mentioned resolution.

3. To this date, the Secretary-General has received replies from Denmark (on behalf of the European Community and its Member States) and the Dominican Republic. Any further replies will be issued as addenda to the present report.
