NOTE

The resolutions and decisions of the General Assembly are identified as follows:

Regular sessions

Until the thirtieth regular session, the resolutions of the General Assembly were identified by an arabic numeral followed by a roman numeral in parentheses indicating the session (for example: resolution 3363 (XXX)). When several resolutions were adopted under the same number, each of them was identified by a capital letter placed between the two numerals (for example: resolution 3367 A (XXX), resolutions 3411 A and B (XXX), resolutions 3419 A to D (XXX)). The decisions were not numbered.

Since the thirty-first session, as part of the new system adopted for symbols of General Assembly documents, resolutions and decisions have been identified by an arabic numeral, indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution 31/1, decision 31/301). When several resolutions or decisions were adopted under the same number, each of them has been identified by a capital letter placed after the two numerals (for example: resolution 31/16 A, resolutions 31/6 A and B, decisions 31/406 A to E).

Special sessions

Until the seventh special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letter “S” and a roman numeral indicating the session (for example: resolution 3362 (S-VII)). The decisions were not numbered.

Since the eighth special session, resolutions and decisions have been identified by the letter “S” and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution S-8/1, decision S-8/11).

Emergency special sessions

Until the fifth emergency special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letters “ES” and a roman numeral indicating the session (for example: resolution 2252 (ES-V)). The decisions were not numbered.

Since the sixth emergency special session, resolutions and decisions have been identified by the letters “ES” and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution ES-6/1, decision ES-6/11).

In each of the series described above, the numbering follows the order of adoption.

A. Elections and appointments

60/401. Appointment of the members of the Credentials Committee

At its 1st plenary meeting, on 13 September 2005, the General Assembly, in accordance with rule 28 of its rules of procedure, appointed a Credentials Committee for its sixtieth session consisting of the following Member States: CAMEROON, CHINA, PANAMA, PORTUGAL, SAINT LUCIA, SAMOA, SIERRA LEONE, RUSSIAN FEDERATION and UNITED STATES OF AMERICA.

60/402. Election of judges of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991

At its 26th plenary meeting, on 4 October 2005, the General Assembly decided to endorse the recommendation of the Secretary-General¹ that was endorsed by the Security Council in its resolution 1629 (2005) of 30 September 2005, namely that Judge Christine Van Den Wyngaert be assigned as of 3 October 2005 as a permanent judge to the *Mrksic et al.* case before the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991.

60/403. Election of five non-permanent members of the Security Council

At its 29th plenary meeting, on 10 October 2005, the General Assembly, in accordance with Article 23 of the Charter of the United Nations and rule 142 of the rules of procedure of the Assembly, elected the CONGO, GHANA, PERU, QATAR and SLOVAKIA as non-permanent members of the Security Council for a two-year term of office beginning on 1 January 2006 to fill the vacancies occurring on the expiration of the terms of office of ALGERIA, BENIN, BRAZIL, the PHILIPPINES and ROMANIA.

Kooijmans (Netherlands), Mr. Francisco Rezek (Brazil) and Mr. Vladlen S. Vereshchetin (Russian Federation).
