# Note by the Secretary-General

#### Addendum

- 1. The Secretary-General has received notification of the resignations of Richard Moon (United Kingdom of Great Britain and Northern Ireland), with effect from 19 January 2011, and Wu Gang (China), with effect from 14 February 2011.
- 2. Accordingly, the General Assembly will be required to appoint, at its current session, two persons to fill the vacancies for the remaining period of the terms of office of Mr. Moon and Mr. Wu, both of which expire on 31 December 2011.
- 3. The Government of the United Kingdom has nominated Patrick Haughey to fill the vacancy arising from the resignation of Mr. Moon.
- 4. In a communication dated 25 January 2011, the Secretariat was informed by the Chair of the Group of Western European and Other States that the candidature of Mr. Haughey had been endorsed by the Group.
- 5. The Government of China has nominated Sun Xudong to fill the vacancy arising from the resignation of Mr. Wu.
- 6. In a communication dated 25 February 2011, the Secretariat was informed by the Chair of the Group of Asian States that the candidature of Mr. Sun had been endorsed by the Group.
