

Note by the Secretary-General

Addendum

- 1. The Secretary-General has received notification of the resignations of Shigeki Sumi (Japan), with effect from 1 February 2012, and Hae-yun Park (Republic of Korea), with effect from 6 February 2012, from the Committee on Contributions.
- 2. Accordingly, the General Assembly will be required to appoint, at its current session, two persons to fill the vacancies for the remaining period of the terms of office of Mr. Sumi and Mr. Park, which expire on 31 December 2012 and 31 December 2014, respectively.
- 3. The Government of Japan has nominated Kazuo Watanabe to fill the vacancy arising from the resignation of Mr. Sumi.
- 4. The Government of the Republic of Korea has nominated Dae-jong Yoo to fill the vacancy arising from the resignation of Mr. Park.
- 5. In a communication dated 27 February 2012, the Secretariat was informed by the Chair of the Group of Asia-Pacific States that the candidatures of Mr. Watanabe and Mr. Yoo had been endorsed by the Group.
