- 20.1 The programme is under the responsibility of the Economic Commission for Europe (ECE).
- 20.2 Acting in its dual role as regional outpost of the United Nations and part of its regional institutional landscape, ECE will continue to pursue the key objectives shared by all the regional commissions, namely, to foster economic integration at the subregional and regional levels, to promote the regional implementation of the internationally agreed development goals, including the Millennium Development Goals, and to support regional sustainable development by contributing to the bridging of economic, social and environmental gaps among their member countries and subregions. To achieve those objectives, all regional commissions, through their convening power, will continue to generate multilateral dialogue, knowledge-sharing and networking at the regional level, and will work together to promote intraregional and interregional cooperation, both among themselves and through collaboration with other regional organizations.
- 20.3 Taking into account the role of the regional commissions as expressed above and the goals and commitments contained in the United Nations Millennium Declaration and in the Plan of Implementation of the World Summit on Sustainable Development, the main objectives of the ECE work programme for 2012-2013 will be (a) to support the integration of the countries of Eastern Europe, the Caucasus and Central Asia, as well as South-Eastern Europe, into the pan-European economy, taking into account the enlarged European Union and the various integration initiatives under way in the eastern part of the region, (b) to improve the quality of life and to contribute to the sustainable development of the region, including in terms of climate change mitigation and adaptation, and (c) to enhance competitiveness, in particular in the emerging market economies and low-income countries of the region, thereby contributing to their economic prosperity. ECE

will engage and promote partnerships among all public and private stakeholders to achieve those objectives. In pursuing the aforesaid goals, adequate consideration will be given to the enduring effects of the economic and financial crisis in the region.

- 20.4 The ECE programme of work, in accordance with the strategic directions provided by member States through the 2005 workplan on ECE reform (E/ECE/1434/Rev.1), which were reaffirmed by the Commission at its sixty-third session in 2009 in its decision A/63 (see E/2009/37), is designed around eight subprogrammes, namely, environment, housing, transport, statistics, economic cooperation and integration, sustainable energy, trade, timber and forestry, and land management and population. The core strategy focuses on (a) the implementation of existing legally binding instruments, norms, standards and guidelines, as well as the negotiation of new ones based on the needs of member States, (b) the provision of technical assistance, policy advice and capacity-building to support the implementation of those norms and standards by countries with economies in transition and (c) the organization of a policy debate and the exchange of experience in the areas of ECE expertise, including supporting policy analysis, studies and statistics.
- 20.5 ECE normative work will promote greater regulatory compatibility among its member States. It will therefore stimulate transboundary cooperation, in particular in the areas of transport, trade facilitation and environmental protection. The transboundary cooperation will also contribute to the region's stability and security, and will have a positive impact on the rest of the world, as many ECE-developed agreements and standards are increasingly being applied in countries of other regions.
- 20.6 Particular attention will also be given to cross-sectoral issues, in particular sustainable development, which requires the engagement of the energy, environment, housing, timber, trade and transport sectors. Furthermore, ECE will promote gender mainstreaming in its relevant areas of activity and, as a whole, will address the gender dimension of development through the economics of gender.
- 20.7 Policy debate and exchange of experience among States members of ECE will facilitate the identification of policies and good practices conducive to achieving the internationally agreed development goals, including the Millennium Development Goals.
- 20.8 ECE technical cooperation activities will be directed at the countries of Eastern Europe, the Caucasus and Central Asia, and South-Eastern Europe. They will contribute to improving national capacities to implement legally binding instruments and other regional norms and standards, and to resolving transboundary challenges. In that respect, ECE will continue to strengthen its cooperation with the United Nations Development Programme (UNDP) at both the regional and country levels. In addition, the United Nations Special Programme for the Economies of Central Asia, jointly executed with the Economic and Social Commission for Asia and the Pacific (ESCAP), will be further strengthened.
- 20.9 Building upon the complementarity of mandates, functions and areas of expertise, ECE will strengthen its cooperation with key partners in the region, in particular with UNDP, the European Commission and the Organization for Security and Cooperation in Europe, as well as with major subregional players. The regional coordination mechanism will be used as a main channel for promoting coherence and collaboration.
- 20.10 Pursuant to General Assembly resolution 62/208 on the Triennial comprehensive policy review of operational activities for development of the United Nations system, and Assembly resolution 62/277 on United Nations system-wide coherence, ECE will ensure system-wide policy coherence at the regional level through the regional coordination mechanism. It will also contribute to system-wide coherence in operational work at the regional level through the United Nations

Development Group and at the country level through the United Nations Development Assistance Framework.

- 20.11 ECE will ensure responsibility for the effective delivery of results and efficient use of resources through (a) results-based management, (b) performance monitoring and (c) the implementation of recommendations of oversight bodies. Furthermore, it will ensure personal and institutional accountability of its managers through the senior management compact and performance appraisal system (ePAS) of all staff, as well the contributions from ECE self-evaluations and the biennial evaluation of the work of the Commission's Sectoral Committees.
- 20.12 Pursuant to General Assembly resolution 63/260 on development-related activities, ECE received a total of four posts (2 P-4, 2 P-3), which has enabled it to strengthen support to countries with economies in transition, in particular low-income and landlocked countries, in their efforts to achieve the internationally agreed development goals, including the Millennium Development Goals, and to ensure greater synergies and coherence between the normative and operational work of ECE subprogrammes. The restructuring of the secretariat and subsequent establishment of the Programme Management Unit and the Development Policies and Cross-Sectoral Coordination Unit in the Office of the Executive Secretary in January 2011 will further enhance those synergies and increase the effectiveness and efficiency of its work.
- 20.13 The expected accomplishments and indicators of achievement for ECE in the biennium 2012-2013 are set out, together with required resources, under the programme of work, as well as under executive direction and management.
- 20.14 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown in table 20.3 below (see also the output information for each subprogramme).

- 20.15 The overall resources required for the biennium 2012-2013 for this section amount to \$63,752,800 before recosting, reflecting a net decrease of \$1,794,300 (or 2.7 per cent) compared with the previous biennium, which relates mainly to the abolition of seven posts as well as reduced non-post requirements.¹ The net decrease shown in table 20.5 below can be summarized as follows:
- (a) The net increase of \$1,004,600 under executive direction and management relates to (a) the inward redeployment of three posts (1 D-1, 1 P-3, 1 General Service (Other level)) from programme support/Technical Cooperation Unit to executive direction and management, (b) inward redeployment of one General Service (Other level) post from the Executive Office under programme support to the Office of the Executive Secretary, (c) abolition of one post at the P-4 level and (d) a net decrease of non-post resources following the redeployment to executive direction and management of resources previously provided under the Technical Cooperation Unit for travel and consultants, offset in part by reduced requirements under contractual services;

- (b) The net decrease of \$902,300 under programme of work relates to:
- (i) A net decrease of \$292,500 under subprogramme 1, Environment, resulting from (a) the inward redeployment of one post at the P-3 level located in Almaty, approved under the Technical Cooperation Unit of programme support to reflect the location of that post more accurately and the abolition of one post at the P-3 level, (b) abolition of one General Service (Other level) post and (c) the reduction under consultants, as efforts will continue to use in-house capacity wherever possible;
 - (ii) A net increase of \$128,300 under subprogramme 2, Transport, resulting from (a) the delayed impact of one new post at the P-3 level established in the context of the proposed programme budget for 2010-2011, (b) the inward redeployment of one post at the P-2 level to subprogramme 2 from the Executive Office under programme support, (c) the abolition of one General Service (Other level) post and (d) a marginal reduction under consultants, as greater in-house capacity will be used;
 - (iii) A net decrease of \$474,900 under subprogramme 3, Statistics, reflecting the abolition of two posts at the P-2 level, combined with a marginal reduction under consultants, as greater in-house capacity will be used;
 - (iv) A combined decrease of \$14,500 under subprogramme 4, Economic cooperation and integration, subprogramme 5, Sustainable energy, subprogramme 7, Timber and forestry, and subprogramme 8, Housing, land management and population, under consultants;
 - (v) A net decrease of \$248,700 under subprogramme 6, Trade resulting from the abolition of one post at the P-2 level, combined with the decrease under consultants and contractual services;
 - (vi) A net decrease of \$1,896,600 under programme support relates to (a) the outward redeployment of three posts (1 D-1, 1 P-3, 1 General Service (Other level)) from the Technical Cooperation Unit to executive direction and management, (b) the outward redeployment of one General Service (Other level) post from the Executive Office to the Office of the Executive Secretary, (c) the outward redeployment of one post at the P-2 level from the Executive Office to subprogramme 2, Transport, (d) the outward redeployment of one post at the P-3 level from the Technical Cooperation Unit to subprogramme 1, Environment. The overall reduction under non-post resources relates to the redeployment of travel and consulting provisions from the Technical Cooperation Unit to the Office of the Executive Secretary under executive direction and management, as well as under supplies and materials, and furniture and equipment.
- 20.16 During the biennium 2012-2013, projected extrabudgetary resources of \$25,012,700 will complement resources from the regular budget to finance various substantive and technical cooperation activities, including training, workshops, seminars and field projects. Projected 2012-2013 expenditures are based on known and the projected level of contributions for new and continuing projects.
- 20.17 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation would amount to \$828,000 including (a) \$822,000, representing a total of 47.1 work-months by Professional staff at the D-1, P-5, P-4/P-3 and P-2 levels, and 12.0 work-months at the General Service (Other level), funded from regular budget resources and reflected under each subprogramme, and (b) \$6,000 for consultants.
- 20.18 The distribution of resources under this section would be as shown in tables 20.4, 20.5 and 20.6.

- 20.19 Unlike the practice for the other regional commissions, resources for administration and conference and general services for ECE are not included under its own programme budget. The resources associated with those requirements are administered by the United Nations Office at Geneva and are consolidated under section 29E, Administration, Geneva, in respect of administration and general services, and under section 2, General Assembly and Economic and Social Council affairs and conference management, in respect of conference-servicing costs.
- 20.20 In order to permit a comparison among regional commissions while at the same time maintaining the advantages of integrated management and avoiding duplication of effort, the estimated resources (at current rates) to be provided by the United Nations Office at Geneva to ECE for administrative, general, conference and library services during the biennium 2012-2013 are summarized in table 20.7.

A. Policymaking organs

- 20.21 The governance structure of ECE has been reformed in accordance with the workplan on ECE reform (E/ECE/1434/Rev.1) adopted by States members of ECE on 2 December 2005 and by the General Assembly in its resolution 60/248. The Commission, which reports to the Economic and Social Council, provides strategic direction to the work of the ECE secretariat and is a forum for high-level policy dialogue on economic development for the region. It meets once every two years for up to three working days. In the intersessional period, the Executive Committee is entrusted with the implementation of the overall policy set by the Commission. It meets regularly and as often as necessary to perform its governance role with regard to programme planning, administrative and budget issues, including extrabudgetary funding, through, inter alia, the review and approval of programmes of work and subsidiary structures of the sectoral committees, ensuring coherence and coordination among subprogrammes. The eight sectoral committees act as governing bodies for the eight subprogrammes: the Committee on Environmental Policy (subprogramme 1); the Inland Transport Committee (subprogramme 2); the Conference of European Statisticians (subprogramme 3); the Committee on Economic Cooperation and Integration (subprogramme 4); the Committee on Sustainable Energy (subprogramme 5); the Committee on Trade (subprogramme 6); the Timber Committee (subprogramme 7); and the Committee on Housing and Land Management (subprogramme 8). Those bodies meet for two to three days annually to provide guidance to ECE on work relating to their respective sectors.

B. Executive direction and management

Resource requirements (before recosting): \$8,056,500

- 20.22 In order to fulfil its responsibilities in terms of executive direction and overall management of ECE, this component has the following functions:
- (a) To contribute to and facilitate the debate among member States on the strategic direction of ECE and to develop a forward-looking strategy for adjusting ECE activities to respond to the emerging and foreseeable priorities of its member States;
 - (b) To foster relationships with member Governments and keep abreast of the needs of States members of ECE;
 - (c) To coordinate the planning and ensure the implementation of the ECE programme of work, to provide guidance and direction for the work of the secretariat, and to promote transparency and interdivisional cooperation;
 - (d) To service meetings of the Commission and its Executive Committee, including the preparation of relevant documentation, to ensure the follow-up to their decisions and to serve as an interface between the Executive Committee and the bureaux of the sectoral committees;

- (e) To ensure efficient and inclusive processes for the monitoring and evaluation of the work of the subprogrammes, including the biennial evaluations of subprogramme performance by sectoral committees, and to promote the application of evaluation findings to the subprogrammes' work;
- (f) To monitor and promote the evaluation of the technical cooperation activities carried out in the ECE divisions and to coordinate multisectoral/intersectoral technical cooperation activities within the ECE mandate, including those developed within subregional frameworks;
- (g) To undertake regional policy reviews pertaining to major cross-sectoral issues related to the United Nations development agenda, in particular sustainable development and the Millennium Development Goals;
- (h) To ensure the implementation of the resolutions and decisions of the General Assembly and the Economic and Social Council that are relevant to the work of ECE, including the regional follow-up to United Nations major outcomes and conferences, in accordance with the Commission's role as a regional outpost of the United Nations, pursuant to Council resolution 1998/46;
- (i) To provide clearance for ECE publications and key documents prepared for the sectoral committees and other subsidiary bodies of ECE;
- (j) To contribute to increasing the visibility of ECE and to raising awareness about and increasing the use of ECE products through the dissemination of information about its activities;
- (k) To contribute, in close cooperation with the other regional commissions, to the discussion on and implementation of United Nations reform, in particular in relation to improving system-wide coherence in United Nations development work;
- (l) To cooperate and coordinate with other United Nations entities active in the ECE region, in particular within the framework of the regional coordination mechanism;
- (m) To promote synergies between the ECE technical cooperation activities and the work of other United Nations system entities, in particular through the United Nations resident coordinator system at the country level and the United Nations Development Group for Europe and Central Asia at the regional level;
- (n) To contribute to relevant reports of the Secretary-General for the General Assembly, the Economic and Social Council and other bodies, and to provide other inputs requested by United Nations Headquarters;
- (o) To foster gender mainstreaming in ECE subprogrammes;
- (p) To ensure effective financial and human resources management as well as compliance with the performance appraisal system.

20.23 The executive direction and management component comprises the following:

- (a) The Office of the Executive Secretary, which includes the Executive Secretary, the Deputy Executive Secretary and the chef de cabinet, has the overall responsibility for management of the programme of work and human and financial resources, and for ensuring the implementation of legislative mandates and compliance with United Nations policies and procedures. It also oversees the functioning of the Programme Management Unit, the Development Policies and Cross-sectoral Coordination Unit and the Information Unit;

- (b) The Programme Management Unit, whose core function is to provide overall coordination of the programme planning, programme performance assessment and evaluation of all ECE activities funded from the regular budget and extrabudgetary resources. The Unit promotes synergies and coherence in the planning and implementation of both the normative and operational activities of ECE. It supports the substantive divisions in their planning, monitoring and evaluation work and facilitates the exchange of experiences among them in this area. In particular, it promotes the use of findings resulting from self-evaluations through regular internal workshops and training. Moreover, the Unit coordinates the ECE technical cooperation activities in all the subprogrammes and, where appropriate, promotes synergies between those activities as well as the operational work undertaken by the other United Nations system entities at the national and regional levels. It also ensures programmatic coordination with other regional commissions and relevant United Nations departments and agencies;
- (c) The Development Policies and Cross-sectoral Coordination Unit, whose core function is to prepare substantive contributions that provide a regional perspective to the major cross-sectoral themes in the United Nations development field, including the Millennium Development Goals, sustainable development and gender. It does so by preparing policy-oriented contributions on those themes and by coordinating inputs from the ECE substantive divisions. Such contributions are made for the preparation of and the follow-up to United Nations global conferences and summits, and for various reports of the Secretary-General to the Economic and Social Council and the General Assembly on economic and environmental issues. The Unit also services the biannual meetings of the regional coordination mechanism, which gathers the heads of the regional offices for Europe and Central Asia of the United Nations funds, programmes and specialized agencies;
- (d) The Information Unit, which carries out activities to increase visibility and public awareness of ECE work on a national, regional and international basis, including managing relations with the media. It also advises the Executive Secretary, the chiefs of divisions and other ECE staff on ways and means to better promote their activities, in particular through the ECE website.

- 20.26 The proposed resources for executive direction and management, which amount to \$8,056,500, reflecting a net increase of \$1,004,600 compared with the previous biennium, comprise \$7,482,000 for the funding of 21 posts (1 USG, 1 D-2, 3 D-1, 4 P-5, 1 P-4, 1 P-3, 1 P-2, 1 General Service (Principal level), 8 General Service (Other level)) and non-post requirements of \$574,500. Post costs reflect a net increase of \$1,009,300 owing to (a) the inward redeployment of three posts (1 D-1, 1 P-3, 1 General Service (Other level)) to the Programme Management Unit from the Technical Cooperation Unit of programme support, (b) inward redeployment of one General Service (Other level) post from the Executive Office under the programme support component to the Office of the Executive Secretary and (c) abolition of one post at the P-4 level. The net decrease in non-post requirements mainly reflects reductions under consultants and contractual services in efforts to use more in-house capacity and reduced television production requirements.
- 20.27 The redeployment of the aforementioned posts from the Technical Cooperation Unit and the Executive Office of the programme support component to executive direction and management, in particular to the new Programme Management Unit, is the result of the restructuring of the Office of the Executive Secretary, in which the Technical Cooperation Unit and the Programme Planning, Monitoring and Evaluation Unit will be merged to provide better coordination and support to the work programme and to allow synergies and coherence in the implementation of all ECE activities. The new unit will provide overall coordination of the technical cooperation activities, including monitoring and evaluating the activities, and will service meetings, report to the Commission and its Executive Committee and ensure an interface between the Executive Committee and the bureaux of the sectoral committees.

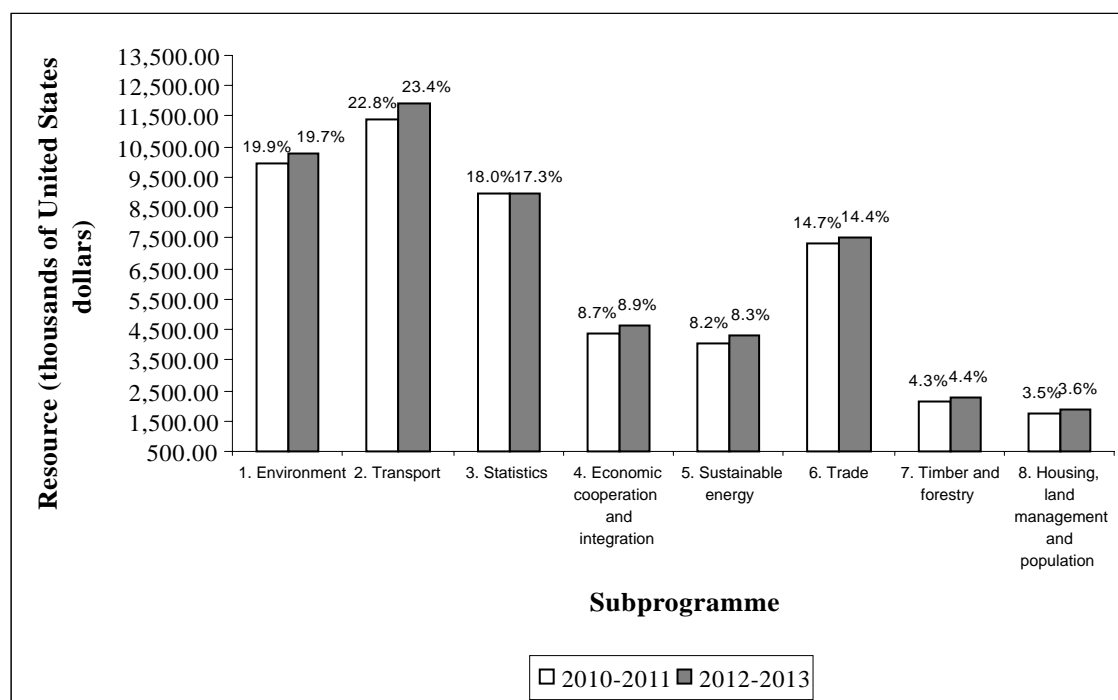

- 20.31 The proposed resources for subprogramme 1, Environment, which amount to \$9,664,800, comprise (a) \$9,510,300 for the funding of 31 posts (1 D-1, 3 P-5, 7 P-4, 9 P-3, 1 P-2, 10 General Service (Other level)), reflecting a net decrease of \$287,400 compared with the previous biennium owing to the inward redeployment of one post at the P-3 level, approved under technical cooperation management under programme support, abolition of one post at the P-3 level and one General Service (Other level) post, and (b) \$154,500 for non-post operational requirements, reflecting a decrease of \$5,100 under consultants.
- 20.32 During the biennium 2012-2013, projected extrabudgetary resources of \$15,600,200 will assist countries with economies in transition in the implementation of ECE legal instruments, norms and standards. - 20.36 The proposed resources for subprogramme 2, Transport, which amount to \$11,506,300, comprise \$11,343,100 for the funding of 38 posts (1 D-1, 4 P-5, 6 P-4, 9 P-3, 4 P-2, 1 General Service (Principal level), 13 General Service (Other level)) and \$163,200 for operational non-post provisions, such as for consultants and travel of staff, reflecting a net increase of \$128,300 compared with the previous biennium. The increase reflects (a) the delayed impact of one post at the P-3 level, effective 1 January 2010, established in the context of General Assembly resolution 64/243, (b) redeployment of one post at the P-2 level from the Executive Office of the programme support component and (c) the abolition of one General Service (Other level) post.
- 20.37 The incumbent of the post at the P-2 level to be inwardly redeployed would be responsible for econometrics and data analysis related to sustainable transport, in particular in the field of rail and intermodal transport. The Transport Division's need for interpretation and analysis of transport statistics and qualitative economic information calls for expertise not available from the manual statistics work performed at the General Service (Other level).
- 20.38 During the biennium 2012-2013, projected extrabudgetary resources of \$3,940,500 will (a) enable the supervision, on behalf of the contracting parties to the Convention, of the application of the TIR customs transit regime, including the operation of the TIR guarantee system and the fulfilment of the functions entrusted to it by the TIR Administrative Committee, (b) allow the undertaking of activities relating to the TEM and TER projects, (c) provide support for the implementation of the Transport, Health and Environment Pan-European Programme and (d) enable the organization of capacity-building workshops. Projected 2012-2013 extrabudgetary resources are based on anticipated and known levels of contribution for new and existing continuing projects.

- 20.42 The proposed resources for subprogramme 3, Statistics, which amount to \$8,496,000 comprise (a) \$8,355,500 for the funding of 28 posts (1 D-1, 3 P-5, 4 P-4, 6 P-3, 3 P-2, 1 General Service (Principal level), 10 General Service (Other level)) and (b) \$140,500 for non-post requirements relating to consultants and travel of staff. The reduction of \$472,600 compared with the previous biennium reflects the abolition of two posts at the P-2 level and decreases under non-post requirements relating to consultancy (\$2,300).
- 20.43 During the biennium 2012-2013, projected extrabudgetary resources of \$453,300 will (a) provide for workshops and seminars designed to develop the capacity of countries of Eastern and South-Eastern Europe, the Caucasus and Central Asia to produce and use gender statistics, (b) provide for a capacity-building programme on new challenges in economic statistics in Central Asia and Eastern European countries through regional workshops and (c) help to develop the capacity of countries of Eastern Europe, the Caucasus and Central Asia to produce and use migration statistics

- 20.62 The proposed resources amounting to \$2,142,700 comprise (a) \$2,089,600 for the funding of seven posts (1 P-5, 1 P-4, 1 P-3, 1 P-2, 1 General Service (Principal level), 2 General Service (Other level)) and non-post requirements relating to consultants and travel of staff (\$53,100).
- 20.63 During the biennium 2012-2013, projected extrabudgetary resources of \$49,700 will finance consultants, travel of experts and contractual services, as well as grants and contributions to support Geneva Timber and Forest Study and Discussion Papers as well as capacity-building workshops. The estimated resources for 2012-2013, representing a decrease compared with the previous biennium, are based on existing information about possible contributions.

- 20.64 Substantive responsibility for subprogramme 8 is vested in the Environment, Housing and Land Management Division. The subprogramme will be implemented in accordance with the strategy

- 20.65 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) adequate national statistical data and information are available on the housing and land management situation, in particular for the preparation of the country profile studies on the housing sector and land administration reviews for countries with economies in transition, (b) political will and adequate institutions exist in member countries to implement the recommendations of the Committee on Housing and Land Management, (c) there is political will to support activities that improve the knowledge base and capacity for designing and implementing population-related policies and programmes and (d) extrabudgetary resources are available for population-related activities.

- 20.67 The proposed resources relate to the continuation of six posts (1 P-5, 1 P-4, 2 P-2, 2 General Service (Other level)) and non-post operational requirements relating to consultants and travel of staff.
- 20.68 During the biennium 2012-2013, projected extrabudgetary resources of \$518,800 will: provide the means for workshops and seminars designed to develop the capacity of countries of Eastern Europe, the Caucasus and Central Asia to formulate policies and to design and carry out programmes that help their societies adapt to population ageing and facilitate the delivery of expert advice on the substantive issues related to the preparation of the 2012 Ministerial Conference on Ageing; assist the participation of delegates from countries in Eastern Europe, the Caucasus and Central Asia at region-wide meetings in follow-up to the 2012 conference; be utilized for the preparation of the country profiles on the housing sector, the land administration reviews and

policy guidelines on housing and land management, support the work on energy efficiency in housing and on a possible legally binding instrument on affordable, healthy and ecological housing, support the organization of capacity-building activities, aimed to promote the implementation of policy guidelines and recommendations by member States; and make it possible to carry out expert missions to member States and provide wide dissemination of policy guidelines and recommendations developed by the subprogramme. The level of extrabudgetary resources broadly reflects the expected contributions to support existing continuing projects.

D. Programme support

Resource requirements (before recosting): \$6,623,000

- 20.69 The programme support component comprises the Executive Office and the Information Systems Unit. Services provided under this heading relate to budget and finance, human resources management, conference services, general services and information technology services. The Technical Cooperation Unit has been moved to the executive direction and management component and merged with the Programme Planning, Monitoring and Evaluation Unit into the Programme Management Unit.

Outputs

- 20.70 During the biennium 2012-2013, the following outputs under overall management will be delivered by the Executive Office and information technology-related support will be provided by the Information Systems Unit:
- (a) Overall management: coordination of administrative support, including human resources, financial and budgetary support, and general services provided to ECE as a whole; provision of guidance and supervision on control, monitoring and reporting on the implementation of the ECE programme budget;
 - (b) Information Technology Services:
 - (i) Implementation of United Nations policies related to information technology strategies and acquisition plans; planning and coordination of all information and communication technology resources; collaborative work with service providers, the Information and Communications Technology Service in the United Nations Office at Geneva, and the United Nations International Computing Centre; closely monitoring and liaising with service providers where services/hosting have been outsourced;
 - (ii) Project management and establishment of information technology resources, and provision of information technology services (Internet/Intranet, development of core ECE systems and groupware applications) to ECE divisions in support of their substantive programmes to improve cooperation with member States and other international organizations in the collection, dissemination and communication of information;
 - (iii) Acquisition of information technology equipment and other equipment and furniture, materials and supplies; desktop configuration and installation, including such security measures as anti-virus and anti-spam software; provision of help desk services to ECE as a whole; installation and maintenance of new infrastructure systems and services, such as archiving/documentation infrastructure, a documents management system, or a web content management system;
 - (iv) Operation and coordination of the Integrated Management Information System and provisions for the future enterprise resource planning system within ECE;

- (c) Conference services:
 - (i) Establishment and management of the ECE programme of meetings, related documentation, facilities and services required in close coordination with conference services in the United Nations Office at Geneva; arrangements for ECE meetings hosted outside Geneva by member Governments; and informal meetings held outside Geneva within the context of the ECE programme of workshops for countries with economies in transition;
 - (ii) Preparation and organization of the biennial session of ECE, the sessions of the ECE Executive Committee and required documentation and meetings services;
 - (iii) Preparation and administration of the programme of publications;
- (d) Programme budget and accounts:
 - (i) Preparation of the ECE biennial programme budgets and financial performance reports in liaison with the Office of Programme Planning, Budget and Accounts;
 - (ii) Financial control and certification of all accounts under the responsibility of ECE, in cooperation with the Office of Programme Planning, Budget and Accounts, and the Financial Resources Management Service of the United Nations Office at Geneva;
 - (iii) Administration of technical cooperation activities and extrabudgetary resources within ECE, including regional advisory services under section 23, Regular programme of technical cooperation;
- (e) Human resources management:
 - (i) Administration of ECE staff and other personnel, including recruitment, placement and career development, in coordination with the Human Resources Management Service of the United Nations Office at Geneva and the Office of Human Resources Management at Headquarters;
 - (ii) Identification of staff training needs, including the provision of training to upgrade professional skills and in-house training in computer applications and arrangements for appropriate courses in cooperation with the Staff Development and Learning Service, United Nations Office at Geneva;
 - (iii) Staff management relations in the context of the ECE Sectoral Assembly and elected staff representatives.

- 20.71 The proposed resources, reflecting a net decrease of \$1,896,600 compared with the previous biennium, relate to the funding of 14 posts (1 P-5, 1 P-4, 2 P-3, 2 P-2, 1 General Service (Principal level), 7 General Service (Other level)). The decrease under posts reflects (a) the redeployment of three posts (1 D-1, 1 P-3, 1 General Service (Other level)) from the Technical Cooperation Unit to the Programme Management Unit under executive direction and management, (b) outward redeployment of one post at the P-3 level from the Technical Cooperation Unit to subprogramme 1, Environment, (c) outward redeployment of one General Service (Other level) post from the Executive Office to the Office of the Executive Secretary and (d) outward redeployment of one post at the P-2 level from the Executive Office to subprogramme 2, Transport. The non-post operational resources, reflecting a decrease of \$162,500, pertain to, inter alia, requirements relating to other staff costs, contractual services, general operating expenses, supplies and materials, grants and contributions.
- 20.72 The redeployment of the above-mentioned posts from the Technical Cooperation Unit and the Executive Office of the programme support component to executive direction and management, in particular to the new Programme Management Unit, is the result of the restructuring of the Office of the Executive Secretary, in which the Technical Cooperation Unit and the Programme Planning, Monitoring and Evaluation Unit will be merged to provide better coordination and support to the work programmes and to allow synergies and coherence in the implementation of all ECE activities. The new unit will provide overall coordination of the technical cooperation activities, as well as monitoring and evaluation. Moreover, it will service meetings, report to the Commission and its Executive Committee, and ensure an interface between the Executive Committee and the bureaux of the sectoral committees. The outward redeployment of one post at the P-3 level from the Technical Cooperation Unit is to reflect the post more appropriately under subprogramme 1, Environment, given the substantive nature of its functions.
- 20.73 During the biennium 2012-2013, projected extrabudgetary resources of \$1,960,000 will complement the regular budget resources available to the Executive Office to provide administrative backstopping and other related services of the extrabudgetary activities of ECE.

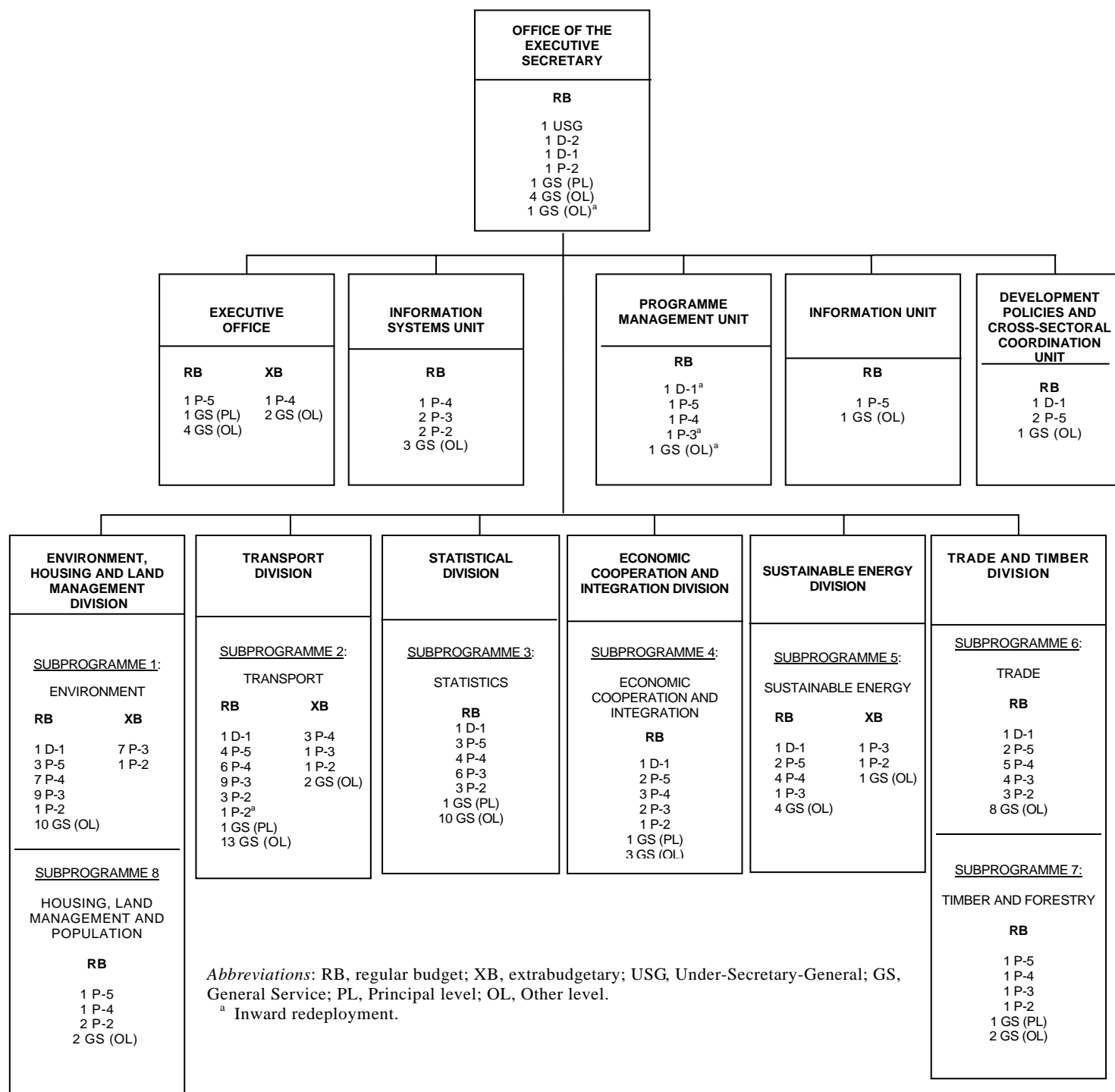

ECE also reviewed the structure of its Executive Office, all human resources-related functions and, in particular, how recruitment and placement is supported by the Office. As a result of these reviews, the ECE Executive Office has restructured the human resources-related side of the Office and has proposed the redeployments contained in the 2012-2013 proposed programme budget.

*Brief description of the recommendation**Action taken to implement the recommendation*

The ECE Executive Office has also had preliminary discussions with the Chief of the Human Resources Management Service, United Nations Office at Geneva, regarding those steps of the recruitment and placement process for which it supports ECE as a client organization. It was agreed between the ECE Executive Office and the Chief of the Human Resources Management Service that those discussions would continue once the restructuring of the ECE Executive Office was completed. Both the ECE Executive Office and the Chief of the Human Resources Management Service also agree that specific standards should be determined for the provision of recruitment and placement services. In addition, the Service has agreed to support the ECE Executive Office in terms of the further training of hiring managers to address problem areas in recruitment and placement.
