- 22.1 The overall orientation of the programme is to foster comprehensive, equitable, integrated and sustainable development and economic and social cooperation in the region, and to maintain and strengthen economic relations between the member countries of the Economic and Social Commission for Western Asia (ESCWA) and with other countries of the world. ESCWA is responsible for the implementation of the programme.
- 22.2 Policy direction for the programme is provided in Economic and Social Council resolutions 1818 (LV) and 1985/69, establishing ESCWA and amending its terms of reference in order to underscore the social functions of the Commission. Further direction is provided in Council resolution 2005/50, in which ESCWA was requested to provide support to member countries in realizing the Millennium Development Goals, including by building capacities to formulate policies, monitor the progress made, measure its impact and prepare regional reports. In addition, in its resolution 269 (XXIV), the Commission requested its Executive Secretary to increase coherence and synergy with other regional United Nations organizations and, through the Commission's lead role in the Regional Coordination Group, foster partnerships and cooperation with those organizations.
- 22.3 Together with the other regional commissions, ESCWA will continue to pursue work aimed at promoting regional and subregional economic integration, as well as implementation of the internationally agreed development goals, including the Millennium Development Goals, and support for sustainable development. As the regional arms of the United Nations, the regional

commissions will use their convening power to continue to advance multilateral dialogue and support regional networks and the sharing of knowledge, and will strive to further intra- and interregional cooperation among themselves, as well as with other regional and subregional entities. The Commission will continue to engage with the Executive Committee on Economic and Social Affairs as a key global body for ensuring coherence on common thematic areas among entities of the United Nations Secretariat working in the social and economic sectors.

- 22.4 In the biennium 2012-2013, ESCWA will pursue its programme objectives by promoting economic and social integration at both the subregional and regional levels, and fostering solidarity in the international political arena and global economy. Regional integration will be scaled up to cover the Arab region through continued strategic partnership with the Economic Commission for Africa Subregional Office for North Africa and with such regional and subregional organizations as the League of Arab States (LAS) and the Gulf Cooperation Council (GCC). The programme comprises seven interdependent subprogrammes that focus on four regional priority areas and three cross-cutting issues, namely:
- (a) Stimulating sustainable management of natural resources, with emphasis on water, energy and the productive sectors, while incorporating climate change responses to sectoral strategies and plans;
 - (b) Promoting integrated social policies;
 - (c) Stimulating sustainable economic development based on higher productivity and competitiveness and through regional integration and cooperation in a globalizing world;
 - (d) Accelerating the development, adaptation, diffusion and use of advanced technology, in particular information and communications technology;
 - (e) Enhancing statistical capacity development;
 - (f) Promoting gender mainstreaming, the advancement of women and their effective participation and involvement;
 - (g) Promoting peacebuilding and mitigating the impact of conflict, its root causes and spillover effects on sustainable development.
- 22.5 The current global financial crisis has had a negative impact on economic performance in the region, resulting in plunging financial markets and real estate asset prices, the collapse of commodity prices and a decline in export earnings. The resulting contraction in economic activity has led to mounting unemployment. Consequently, the need for proactive employment policies to absorb the growing labour force in the region, particularly aimed at young people and women, is more pressing than ever.
- 22.6 The development and implementation of integrated social policies are yet to be given the same level of consideration as economic policies, despite development experience showing that economic growth, on its own, does not lead to equitable and inclusive development, social justice and social stability. In this regard, particular attention should be paid to both the equitable provision of public services and the integration of key social groups — including women and youth — into the process of development. In addition, greater emphasis should be given to enhancing good governance so as to ensure that effective processes and mechanisms are established to facilitate transparent and participatory policy formulation and implementation.
- 22.7 The region is characterized by large gas and oil reserves and production, food dependency and scarce water resources. The water shortage challenge is amplified by such factors as rapid population growth and the overexploitation of available water resources, and will be further exacerbated by climate change, which is expected to increase the proportion of areas affected by

droughts, producing significant negative effects on agricultural productivity and other productive sectors, which may undermine national and regional development agendas. As such, ESCWA will continue to support member countries in building capacities to sustainably manage water and energy resources, in line with the Plan of Implementation of the World Summit on Sustainable Development (Johannesburg Plan of Implementation), by promoting integrated water resources management practices to facilitate progress in the implementation of the targets on water and sanitation of Goal 7 of the Millennium Development Goals. Advocating for improved energy access in poor areas and the efficient use of energy sources (for example, cleaner fuels and renewable energy resources) will remain a key priority. ESCWA will also provide technical advice to incorporate climate change adaptation and mitigation responses into sectoral strategies and plans, by preparing regional assessments of the impact of climate change on water resources, advancing the role of the energy sector in reducing greenhouse gas emissions, and supporting member countries to utilize available international resources for supporting relevant projects. Furthermore, ESCWA will continue to strengthen capacity in member countries to improve sustainable rural livelihoods, and increase the productivity and competitiveness of small- and medium-scale enterprises.

- 22.8 ESCWA will pursue an integrated approach to development with a view to balancing economic growth and social equity in the region while giving special consideration to the least developed and conflict-stricken countries. To this end, efforts will be made to support the design and implementation of national policies to promote an equitable and inclusive process of development, enhancing regional capacity to collectively address crucial existing and emerging challenges, through the promotion of regional integration initiatives, advances in intraregional trade and investment, the development of an integrated transport and communications infrastructure, and the facilitation of trade and transport.
- 22.9 The marginalization of women and their limited access to information and resources hinder the development process in Arab countries. ESCWA will support efforts to enhance gender equality and the advancement of women through: (a) sharing of documentation and exchange of best practices within the region; (b) capacity-building of national machineries for women to better uphold their role and responsibilities; (c) providing technical expertise in gender mainstreaming; and (d) implementing and monitoring international conventions and conferences.
- 22.10 ESCWA will strive to promote the development of knowledge-based economies in the region through analysis and normative activities, to build local capacity in information and communications technology and to narrow the digital divide. This will be coupled with the formulation of coordinated strategies and action plans for the development of the information and communications technology sector within the framework of the World Summit on the Information Society.
- 22.11 Developing statistical capacity continues to be essential in order to enhance the ability of countries in the region to generate timely, reliable, comparable and gender-disaggregated statistics for informed policymaking and programme development, and for tracking progress realized in achieving internationally agreed development goals, including the Millennium Development Goals.
- 22.12 Security and stability are the minimum conditions for sustainable human development and the full realization of human potential. However, continued instability, conflict and occupation and their spillover effects are a driving force of the development deficit in ESCWA member countries. In partnership with its member countries, other United Nations system offices and other multilateral and regional institutions, ESCWA activities will aim to minimize the ramifications of long-running instability by assisting member countries in formulating conflict prevention, reconciliation and revitalization policies within development programmes that are resilient to continuous crisis.

ESCWA will also assist member countries to formulate and implement policies and programmes that address the economic and social spillover effects generated by conflict and/or occupation as well as the impact of emerging global challenges on the most vulnerable ESCWA member countries, in particular the least developed countries. ESCWA will build on its comparative advantage and established in-house expertise in identifying and mainstreaming good governance models catering to the specificities of ESCWA member countries, and modernizing State structures related to peacebuilding efforts with the goal of achieving stability and sustainable development in the region.

- 22.13 ESCWA will continue to carry out analytical and normative work, supplemented by the provision of technical cooperation support in line with the articulated needs of ESCWA member countries. It will act as a facilitator for the exchange of knowledge and information by providing a forum for networking and multilateral dialogue on regional and global development issues, while paying due consideration to the advancement of South-South cooperation. Special attention will be given to the promotion of gender mainstreaming through the programme of work of the organization and within the Commission, in pursuance of the global priorities of the United Nations. Similarly, lessons derived from evaluation exercises will be consolidated to improve the design and performance of programmes, in view of the United Nations commitment to encourage and support evaluation practices to enhance learning and accountability.
- 22.14 The regional support provided by ESCWA should contribute towards:
- (a) Increased national capacity to devise and apply comprehensive, equitable economic and social policies and programmes, and to deal with transboundary issues;
 - (b) Improved coordination of the efforts and resources of United Nations bodies with a view to providing joint responses in tackling multifaceted problems that the countries of the region face;
 - (c) Enhanced work of the Economic and Social Council and its functional commissions in reviewing and appraising the progress made in the implementation of the outcomes of the United Nations conferences and summits;
 - (d) Increased knowledge-sharing and South-South cooperation between the countries of the region and with countries in other regions, thereby furthering the promotion of intra- and interregional collaboration;
 - (e) Enhanced development capacity and utilization of the knowledge capital in the region.
- 22.15 It is anticipated that the consultations which have taken place among the thematic clusters of the Executive Committee on Economic and Social Affairs will contribute to enhanced coordination and increased collaboration in major common work areas of the United Nations Secretariat dealing with economic and social development. Moreover, through its leadership of the regional coordination mechanism, ESCWA strives to facilitate consultation processes among the United Nations entities concerned, leading to the identification of priority areas where collective support for development interventions could be provided, whether at the level of the ESCWA region or in the broader context of the Arab region.
- 22.16 As part of promoting a culture of accountability in accordance with General Assembly resolution 64/259, the Executive Secretary signed a compact in February 2011 with the Secretary-General committing to achieve specific programmatic objectives contained in the programme budget, including greater integration of activities of the ESCWA subprogrammes, enhancing the Commission's strategic roles in the region and contributing to the harmonization of regional interventions among United Nations organizations and other key regional stakeholders regarding emerging global issues in the ESCWA region as well as in the broader context of the Arab region.

The Executive Secretary also committed to responsible stewardship of financial and human resources provided by Member States, implementation of oversight body recommendations, compliance with regulations and rules and ethical standards, and risk management. To this end, the Executive Secretary will continue to ensure that these objectives are properly reflected in the workplans and performance assessments of staff at all levels of the Commission. ESCWA has also developed a performance monitoring tool to enhance the joint management of programme and budget performance information. Increased efforts will also be made to implement all recommendations from oversight bodies in a timely manner.

- 22.17 In its resolution 63/260, the General Assembly provided the Commission with additional post resources under five of its subprogrammes, which has enabled it to improve the effectiveness and efficiency in delivering on its mandates, including:
- (a) Expansion of its knowledge base and expertise in negotiating instruments for shared water resources management to support the region and member countries in carrying out vulnerability and impacts assessment of climate change on water resources in the region;
 - (b) Strengthened capacity to support the Arab Forum on Social Policy and the work of ESCWA in the areas of social impacts of the financial crisis in the region and the urban development divide;
 - (c) Enhanced research and technical assistance capacity in the areas of financing for development, negotiations of bilateral investment agreements and double taxation avoidance agreements, and remittances;
 - (d) Improved support to ESCWA member countries in substantive preparations for establishing science, technology and innovation observatories;
 - (e) Strengthened capacity in the area of gender statistics, including the provision of technical assistance to countries in the region.
- 22.18 The overall resources proposed for the biennium 2012-2013 amount to \$62,772,600, reflecting a decrease of \$525,800, or 0.8 per cent, compared with the revised appropriation for the biennium 2010-2011. The net decrease, reflected in table 22.5 below, can be summarized as follows:
- (a) The increase of \$414,900 under executive direction and management relates to non-post requirements for (i) Regional Coordination Mechanism meetings (\$30,100) and (ii) business continuity (\$384,800);
 - (b) The increase of \$309,100 under the programme of work is the net result of (i) a net increase of \$308,200 under posts related to the establishment of three new posts (1 D-1 in subprogramme 6, and 1 D-1 and 1 P-5 in subprogramme 7), abolition of three posts (2 Local level in subprogramme 3, 1 Local level in subprogramme 4) and the downward reclassification of a post from the P-4 to the P-3 level in subprogramme 2, offset in part by (ii) a marginal increase under non-post requirements (\$900);
 - (c) The decrease of \$1,249,800 under programme support is the net result of (i) a net decrease of \$50,100 under posts related to the abolition of one Local level post in Central Support Services in the Administrative Services Division and the delayed impact of the establishment of one National Officer post in Central Support Services approved in 2010-2011, (ii) a decrease of \$47,000 under non-post resources related to the non-recurrent provisions approved in 2010-2011 under general operating expenses, and furniture and equipment related to the revised estimates on strengthened and unified security management system, and (iii) a decrease of \$1,152,700 under various non-post resources.

- 22.19 During the biennium 2012-2013, expected extrabudgetary resources, amounting to \$5,199,500, would be utilized to complement resources from the regular budget to finance activities aimed at national capacity-building, including advisory service missions, training workshops and field projects. The reduction in the overall level of extrabudgetary resources is the result of the completion of projects financed from the United Nations Development Group Iraq Trust Fund, as well as the lack of firm commitments for new funding for technical cooperation projects for the biennium 2012-2013 at this point of presentation of the budget.
- 22.20 The issue of publications as a part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized below and as described in the output information for each subprogramme.

- 22.21 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation would amount to \$811,400, representing a total of 36.5 work-months of Professional staff and 15.5 work-months of Local level staff estimated at \$537,100, and \$274,300 for non-post requirements. The overall amount consists of \$663,000 from the regular budget and \$148,400 financed from extrabudgetary resources.
- 22.22 The estimated percentage distribution of resources under this section would be as shown in table 22.4 below.

A. Policymaking organs

Resource requirements (before recosting): \$145,000

- 22.23 The Economic and Social Commission for Western Asia is comprised of 14 member States.
- 22.24 The session of the Commission, which reports to the Economic and Social Council, provides overall direction to the work of the secretariat. It meets once biennially for four working days, normally at its headquarters. As mandated by resolution 230 (XXI), which was adopted on 11 May 2001 at the twenty-first session of the Commission, the Preparatory Committee shall be an integral part of the sessions of the Commission. It will meet prior to the plenary of the Commission to consider programmatic agenda items. Consequently, the twenty-seventh session will be convened in 2012, with a session comprising the senior officials segment (2 days in 2012) to consider programmatic agenda items, followed by the ministerial plenary segment (2 days in 2012).
- 22.25 The Technical Committee meets three times per biennium to provide advice to the ESCWA secretariat on the programmatic issues, including the draft strategic framework, the proposed programme of work and follow-up on the implementation of the programme of work; mobilization of extrabudgetary resources; follow-up on the Commission's resolutions, and identifying emerging regional economic and social issues for the consideration of the Commission session. The Technical Committee was established pursuant to the decision of the Commission at its twenty-fourth session, with the aim of enhancing interaction and close consultation between the members of the Commission and its secretariat on substantive development issues.
- 22.26 The Commission has seven specialized subsidiary intergovernmental committees. Six of them meet biennially and one meets annually.¹ The sequence and dates of their sessions and that of the Technical Committee will be as follows:
- (a) The ninth session of the Committee on Energy (subprogramme 1) (2 days in 2012);
 - (b) The tenth session of the Committee on Water Resources (subprogramme 1) (3 days in 2013);
 - (c) The ninth session of the Committee on Social Development (subprogramme 2) (3 days in 2013);
 - (d) The thirteenth and fourteenth sessions of the Committee on Transport (subprogramme 3) (3 days in 2012 and 3 days in 2013);
 - (e) The eighth session of the Technical Committee on Liberalization of Foreign Trade, Economic Globalization and Financing for Development in the Countries of the ESCWA Region (subprogramme 3) (2 days in 2013);
 - (f) The tenth session of the Statistical Committee (subprogramme 5) (3 days in 2012);
 - (g) The sixth session of the Committee on Women (subprogramme 6) (3 days in 2013);
 - (h) The seventh meeting of the Technical Committee (2 days in 2012);
 - (i) The eighth meeting of the Technical Committee (2 days in 2013);
 - (j) The ninth meeting of the Technical Committee (2 days in 2013).
- 22.27 The Advisory Committee of Ambassadors meets twice a year to ensure the continued dialogue between the ESCWA secretariat and member States. It is comprised of heads of diplomatic missions in the host country of the Commission, as well as a high-level representative of the host

country. The Advisory Committee plays a consultative role and functions as a principal means of communication between member States and the ESCWA secretariat, and among member States themselves on important matters requiring attention during the period between the biennial sessions of the Commission (1 day 2 times in 2012 and 1 day 2 times in 2013).

- 22.28 The total number of meetings of the legislative bodies amounts to 36 meeting days.

- 22.29 A provision of \$145,000 is required under (a) temporary assistance for meetings to provide interpretation and translation services, and (b) general temporary assistance during the session of the Commission, the sessions of its seven subsidiary intergovernmental committees and the meeting of the ESCWA Technical Committee.

B. Executive direction and management

Resource requirements (before recosting): \$4,018,100

- 22.30 Executive direction and management comprises the Office of the Executive Secretary and the ESCWA United Nations Information Service.
- 22.31 The Office of the Executive Secretary provides overall direction and integrated management, programme oversight, planning and coordination, as well as policy guidelines to the substantive divisions, the technical cooperation programme and other support services for the proper implementation of the work programme of ESCWA as mandated by the General Assembly, and the realization of United Nations system-wide policies and mandates. It ensures that ESCWA, as the regional arm of the United Nations, plays a major role in the economic and social development of the region, undertakes to translate issues of global importance into regional action as mandated by member States and facilitates the articulation of the collective concerns of member countries by incorporating them into the global agenda. Moreover, the Office maintains effective and regular contact with representatives of member States to exchange views on substantive issues of mutual concern, with the Executive Office of the Secretary-General and with the regional commissions coordination office in New York.
- 22.32 The Office of the Executive Secretary also ensures more coherence and effective collaboration and coordination between ESCWA and the rest of the United Nations Secretariat, especially among the five regional commissions, specialized agencies, funds and programmes. It will continue to strengthen cooperation and coordination with international and regional intergovernmental and non-governmental organizations, especially with the League of Arab States and its subsidiary bodies.
- 22.33 The Office of the Executive Secretary is responsible for the functioning and servicing of the intergovernmental machinery of the Commission, including its biennial session and its subsidiary bodies, the ESCWA Advisory Committee of Ambassadors and the ESCWA Technical Committee.

- 22.34 The Office of the Executive Secretary also gives overall direction to services rendered by the ESCWA United Nations Information Service, whose core functions are to disseminate public information on the work of ESCWA throughout the region and to provide information services to the Office and the Divisions of ESCWA. The activities of the ESCWA United Nations Information Service aim at increasing public awareness and understanding of the work conducted by the United Nations, in general, and ESCWA, in particular, and mobilizing public support for the increased role of ESCWA in the economic and social development of the region.

22.37 The amount of \$3,385,100 under posts would provide for the continued funding of the 16 posts in the Office of the Executive Secretary (1 Under-Secretary-General, 1 D-2, 1 P-5, 1 P-4, 1 P-3, 1 P-2, 8 Local level) and the Information Service (2 Local level), as indicated in the table above.

22.38 The non-post requirements of \$633,000 include provisions for: (a) general temporary assistance and overtime, which would provide for the preparation and servicing of the twenty-sixth session of the Commission and its subsidiary bodies; (b) consultants to undertake studies in areas that do not fall within the expertise of the substantive divisions in connection with the preparation of the ESCWA annual report; (c) two annual think tank meetings, which would serve as a platform for the exchange of views among experts on the salient priority issues of the region, and four regional coordination mechanism meetings to promote strategic coordination and information sharing at the regional and subregional levels among United Nations entities and other regional and subregional partners; (d) travel requirements of the Office of the Executive Secretary and the information services; and (e) provisions for business continuity. The increase of \$414,900 compared with the previous biennium relates to provisions for the regional coordination mechanism meetings and business continuity.

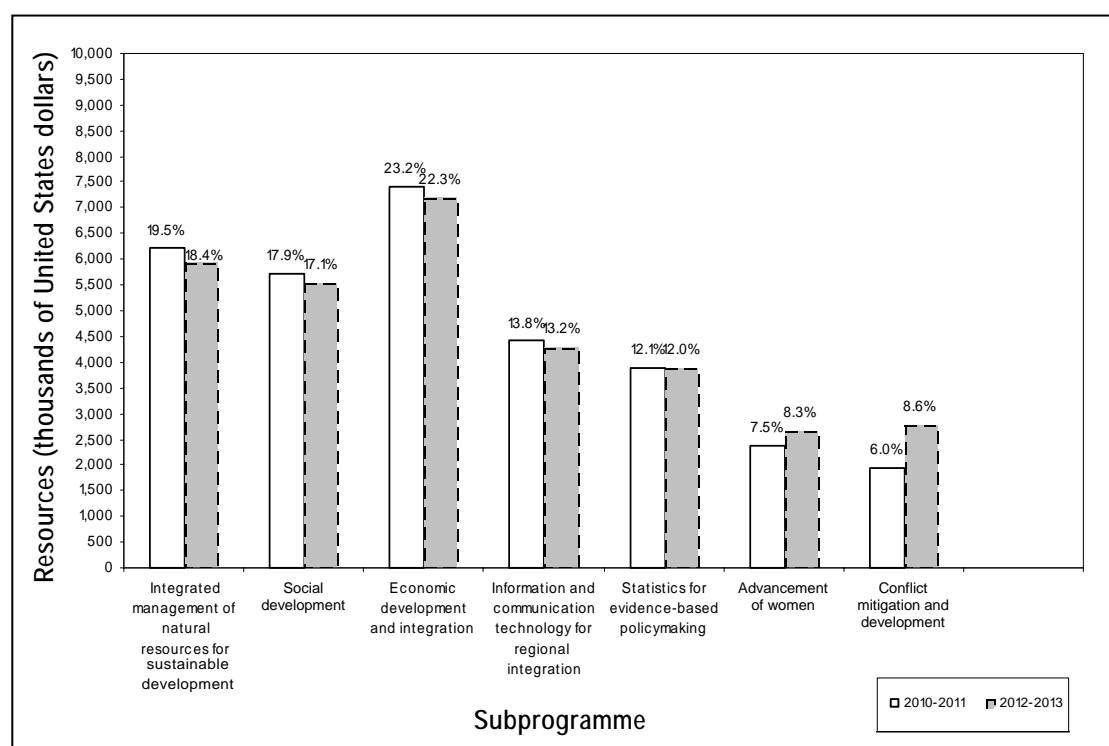

- 22.42 The amount of \$5,564,400 under posts would provide for the continued funding of 24 posts (1 D-1, 4 P-5, 4 P-4, 3 P-3, 2 P-2, 10 Local level) as indicated in the table above. The Sustainable Development and Productivity Division comprises the Office of the Chief (1 D-1, 1 P-5, 2 Local level), the Water Resources Section (1 P-5, 2 P-4, 1 P-2, 3 Local level), the Energy Section (1 P-5, 1 P-4, 2 P-3, 2 Local level) and the Production Sectors Section (1 P-5, 1 P-4, 1 P-3, 1 P-2, 3 Local level). The decrease of \$274,600 compared with the previous biennium relates to the proposed redeployment of a post of Economic Affairs Officer (P-3) in the Water Resources Section to subprogramme 7 as a result of redistribution of responsibilities among the existing staff of the Section.
- 22.43 The non-post requirements of \$374,600 would be required for other personnel costs, consultants, expert group meetings and travel of staff. The decrease of \$10,000 compared with the previous biennium is attributable to lower requirements for consultants as a result of greater use of in-house capacity where possible.
- 22.44 Extrabudgetary resources of \$2,824,800 would provide for: (a) support for networking on integrated water resources management; (b) support to member countries in the field of water supply and sanitation; (c) assessment of the impact of climate change on water resources and socio-economic vulnerability in the Arab region; and (d) rural electrification using wind energy in selected countries of the ESCWA region. - 22.48 The amount of \$5,294,400 under posts would provide for the continued funding of 23 posts (1 D-1, 3 P-5, 4 P-4, 3 P-3, 3 P-2, 9 Local level) as indicated in the table above. The Social Development Division comprises the Office of the Chief (1 D-1, 1 P-3, 2 Local level), the Social Policies Section (1 P-5, 1 P-4, 2 P-2, 3 Local level), the Social Participatory Development Section (1 P-5, 2 P-4, 1 P-3, 2 Local level) and the Population and Social Development Section (1 P-5, 1 P-4, 1 P-3, 1 P-2, 2 Local level). The decrease of \$37,300 compared with the previous biennium relates to the proposed downward classification of a post of Social Affairs Officer from the P-4 level to the P-3 level in the Office of the Chief as a result of rationalizing and streamlining of the post structure.
- 22.49 The requirements for non-post resources in the amount of \$227,800 would provide for other personnel costs, consultants, expert group meetings and travel of staff. The reduced requirement of \$142,800 compared with the previous biennium is due to fewer expert group meetings, reduced reliance on consultants and a critical consideration of participation at various meetings.
- 22.50 Extrabudgetary resources amounting to \$547,700 would: (a) reinforce ESCWA work on mitigating the problem of youth unemployment in the Arab region; (b) contribute to providing qualitative information on and facilitating the exchange of experience of private social foundations in the ESCWA region; and (c) promote pro-poor development approaches with a focus on vulnerable groups in the region. The projected increase in extrabudgetary resources is a result of anticipated new funding for projects on social policy, youth and urban observatories.

- 22.66 The amount of \$3,646,500 under posts provides for the continued funding of 16 posts (1 D-1, 2 P-5, 2 P-4, 3 P-3, 1 P-2, 7 Local level) as indicated in the table above. The Statistics Division comprises the Office of the Chief (1 D-1, 1 Local level), the Economic Statistics Section (1 P-5, 2 P-4, 1 P-3, 3 Local level) and the Social Statistics Section (1 P-5, 2 P-3, 1 P-2, 3 Local level).
- 22.67 The requirements under non-post resources of \$223,300 would provide for other personnel-related costs, consultants, expert group meetings and travel of staff.
- 22.68 Extrabudgetary resources of \$150,000 are intended to strengthen the capacity of statisticians for evidence-based policymaking in the region in the priority areas identified by the Statistical Committee and provide forums and networks for statisticians to exchange information and experience in statistical work and methods which would lead to enhancement of statistical capacity in the region. The projected decrease in extrabudgetary resources compared with the previous biennium is due to the lack of firm commitments for new funding at this stage.

- 22.72 The amount of \$2,460,400 under posts would provide for the funding of 11 posts (1 D-1, 1 P-5, 2 P-4, 2 P-3, 1 P-2, four Local level) as indicated in the table above. The increased requirements amounting to \$244,700, compared with the previous biennium, relate to the proposed establishment of the post of Head of Division (D-1) in response to the draft resolution of the Commission (E/ESCWA/RES/L.295) of 20 May 2010, wherein the Commission requests the secretariat of ESCWA to complete the administrative measures relating to the upgrade of the current Centre for Women to the level of a division. The draft resolution was considered by the Economic and Social Council at its substantive session in 2010 and the secretariat submitted an oral statement of programme budget implications stating that financial implications for the biennium 2012-2013 would be considered in accordance with established budgetary procedures in the context of the proposed programme budget for the biennium 2012-2013. However, the Council decided to defer consideration of the draft resolution to its substantive session in 2011. In the meantime, the proposal to upgrade the current Centre for Women to the level of a division, together with the related resources, is being put forward in anticipation of a favourable decision. Should the decision be contrary to the assumption made herein, the General Assembly would be advised accordingly through appropriate mechanisms.
- 22.73 The incumbent of the proposed new post would be responsible for the overall management of the division and would formulate and implement the substantive work of the division, coordinate with other divisions and entities, and represent the division at international, regional and national meetings.
- 22.74 The requirements under non-post resources of \$212,700 would provide for other personnel related costs, consultants, expert group meetings and travel of staff. The increase of \$46,100 compared with the previous biennium is related mainly to the engagement of consultants for two additional non-recurrent publications and the higher number of participants in connection with the convening of four expert group meetings, as reflected in paragraph 22.71 (a) (iii).
- 22.75 Extrabudgetary resources of \$34,300 would be used for such technical cooperation activities as workshops and field projects to strengthen the capacity of Government officials, non-governmental organizations and civil society organizations in gender mainstreaming and the implementation of the Convention on the Elimination of All Forms of Discrimination against Women. The projected decrease in extrabudgetary resources compared with the previous biennium is due mainly to the expected completion of a project in 2010-2011 and the lack of firm commitments for new funding at this stage.

- 22.79 The amount of \$2,547,900 under posts would provide for the funding of 11 posts (1 D-1, 2 P-5, 2 P-4, 2 P-3, 1 P-2, 3 Local level) as indicated in the table above. The proposed division would comprise the Office of the Chief (1 D-1, 1 Local level), the Emerging Trends and Conflict Mitigation Section (1 P-5, 1 P-4, 1 P-3, 1 Local level) and the Governance, Instability and Development Section (1 P-5, 1 P-4, 1 P-3, 1 P-2, 1 Local level).
- 22.80 The increased requirements amounting to \$722,500 compared with the previous biennium relate to the proposed establishment of two new posts, namely, the Chief of Division (D-1) and the Chief of the Governance, Instability and Development Section (P-5), as well as the redeployment of a post from subprogramme 1 for an Economic Affairs Officer (P-3). The proposal for the additional posts is in response to the draft resolution of the Commission (E/ESCWA/RES/L.294) of 20 May 2010, wherein the Commission requests the secretariat of ESCWA to upgrade the Section for Emerging and Conflict-related Issues to the level of a division. The draft resolution was considered by the Economic and Social Council at its substantive session in 2010 and the secretariat submitted an oral statement of programme budget implications stating that financial implications for the biennium 2012-2013 would be considered in accordance with established budgetary procedures in the context of the proposed programme budget for the biennium 2012-2013. However, the Council decided to defer consideration of the draft resolution to its substantive session in 2011. In the meantime, the proposal to upgrade the Section for Emerging and Conflict-related Issues to the level of a division, together with the related resources, is being put forward in anticipation of a favourable decision. Should the decision be contrary to the assumption made herein, the General Assembly would be advised accordingly through appropriate mechanisms.
- 22.81 Non-post resources of \$239,800 would provide for other personnel-related costs, consultants, expert group meetings and travel of staff. The additional requirements amounting to \$133,500

compared with the previous biennium relate to: (a) the engagement of consultants for additional reports and studies for two non-recurrent publications related to emerging issues and governance: Arab states 2025 and mainstream conflict-management mechanism through public sector modernization; (b) the increased number of expert group meetings related to the consultative meeting on establishing the intergovernmental committee on emerging issues and development; and (c) increased requirements for travel as a result of the expanded scope of the Division.

- 22.82 Extrabudgetary resources of \$1,295,400 would be used for: (a) strengthening the institutional capacity of the Government of Iraq to coordinate and monitor implementation of civic education and life skills programmes; and (b) promoting peaceful coexistence among Palestinian youth. The projected decrease in extrabudgetary resources compared with the previous biennium is the result of the expected completion of projects financed from the United Nations Development Group-Iraq Trust Fund in 2012.

D. Programme support

- 22.83 Programme support comprises the Administrative Services Division and the Programme Planning and Technical Cooperation Division.

Outputs

- 22.84 The outputs of the Administrative Services Division include the following:
- (a) Overall administration and management: advising the Executive Secretary on all administrative, management and organizational matters; provision of policy guidelines and coordination of the central common services; representation of the United Nations in negotiations with the host country on various issues relating to implementation of the headquarters agreement; and providing managerial oversight of the security service at ESCWA;
 - (b) Human resources management: recruitment and placement; provision of staff administration and staff welfare services; training; career development and upgrading of substantive skills; staff-management relations, provision of medical services and legal advice; and succession planning, in cooperation with programme managers, focusing on gender issues;
 - (c) Budgetary and financial services: provision of guidance, coordination and support services to programme managers in the preparation of programme budget proposals and performance reports; overall control of utilization of programme budget and extrabudgetary resources; provision of accounting services and financial disbursements, including payroll, vendors, per diem and other entitlements; coordination of the Integrated Management Information System (IMIS); formulation of administrative responses and monitoring of follow-up to the reports of various oversight bodies, such as the Board of Auditors, the Joint Inspection Unit and the Office of Internal Oversight Services; review and analysis of proposals relating to extrabudgetary financing; preparation of memorandums of understanding; and negotiation, monitoring and implementation of cost-sharing arrangements with the various United Nations agencies;
 - (d) Information technology, communications and systems: provision of information technology services and infrastructure, and standardization of software and hardware; provision of in house programming services to all substantive divisions in order to ensure compatibility with the existing technology, as well as to establish a centralized control management system of

the Local Area Network; provision of videoconferencing; and enhancement of the ESCWA Internet and Intranet sites;

- (e) Central support services: administration of the implementation of the headquarters agreement between the United Nations and the host Government; facilities management and maintenance; provision of commercial and procurement services; provision of transportation, logistic and travel services; liaison with Government officials of the host country; provision of postal services; maintenance of central registry and archives system; and store and inventory management;
- (f) Conference services: provision of conference services to the policymaking organs of ESCWA and other intergovernmental meetings held under its auspices, including the preparation and coordination of official meetings; provision of interpretation, verbatim reporting, translation and editorial services; provision of documentation and publication services; and provision of secretarial and technical support;
- (g) Library services: provision of library services and information to staff, member States, United Nations libraries and depository libraries, and other clients, including the acquisition of publications, databases; indexing of ESCWA documents on the Official Documents System to make them available to Internet users; and development of library Internet and Intranet web pages.

22.85 The outputs of the Programme Planning and Technical Cooperation Division include the following:

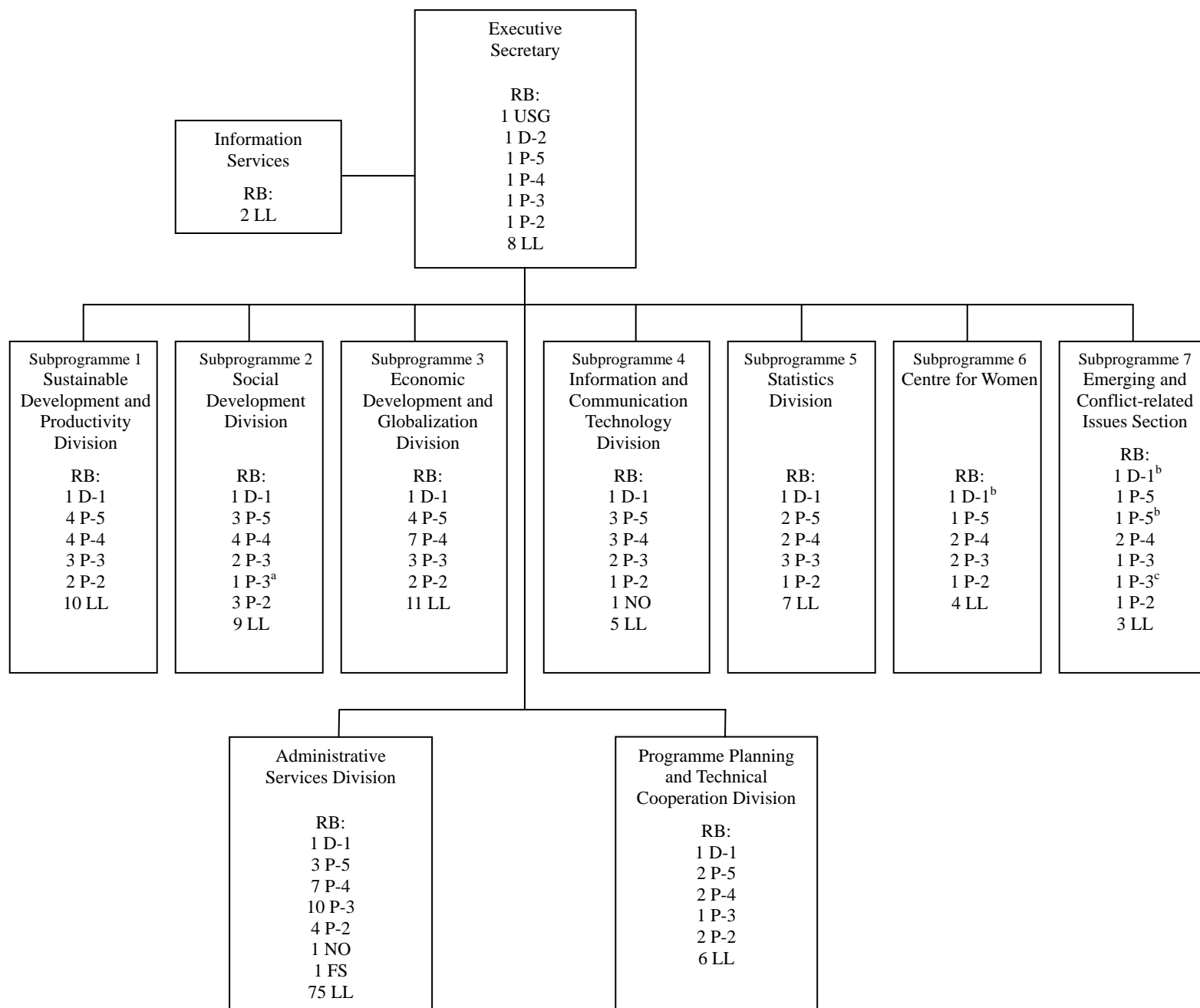

- (c) Management of technical cooperation activities: provision of policy guidance and support to the substantive offices in the formulation, monitoring and evaluation of their respective technical cooperation programmes and projects, including those projects funded from the Development Account; management of the Regular Programme of Technical Cooperation and Development Account, and coordination with the Department of Economic and Social Affairs in this respect; facilitation of networking and knowledge management on ESCWA technical cooperation; provision of proactive support to partnership development and resource mobilization within the context of the ESCWA Technical Cooperation Strategy; and promotion of information and communications support and promotional initiatives on technical cooperation programmes and technical cooperation development.

- 22.86 The amount of \$19,523,800 under posts provides for the continued funding of 115 posts (33 Professional and above, 82 Local level, Field Service and National Officer) as indicated in the table above. The net decrease of \$50,100 compared with the previous biennium relates to the abolition of a Local level post of Team Assistant in Central Support Services in the Administrative Services Division and the delayed impact of the new National Officer post in the same Division, established with effect from 2010, in the context of General Assembly resolution 64/244.
- 22.87 Requirements under non-post resources of \$6,831,800 include: (a) other personnel-related costs; (b) consultants to provide for specialized legal expertise and for strengthening monitoring and evaluation systems; (c) travel of staff; (d) operational expenses; and (e) contribution to the ESCWA Joint Medical Services Unit. The reduced requirements amounting to \$1,199,700 relate to: (a) the non-recurrent provision of \$47,000 under alteration of office space, office furniture and office automation equipment relating to the revised estimates on the strengthened and unified security management system; (b) the redeployment of \$158,800 to executive direction and management relating to business continuity; and (c) lower requirements of \$993,900 under various non-post objects of expenditure based on anticipated levels of expenditure, mainly under consultants, general operating expenses, supplies and materials, and furniture and equipment.
- 22.88 Extrabudgetary resources of \$317,300 would provide for services in support of technical cooperation activities. The projected decrease in the level of resources compared with the previous biennium reflects the overall reduction in the anticipated level of extrabudgetary resources available to ESCWA during the biennium 2012-2013, resulting in lower programme support income.
