

- 9.1 The overall objective of the programme is to promote and support international cooperation in the pursuit of sustained economic growth, the eradication of poverty and hunger, and sustainable development for all. While focused on tackling interlinked challenges in the social and economic fields, the programme also seeks to contribute to a mutually reinforcing relationship among the three pillars of the United Nations work: peace and security, development and human rights.
- 9.2 The programme is under the responsibility of the Department of Economic and Social Affairs. Its key programmatic thrusts are (a) to provide substantive support to the bodies established under the Charter of the United Nations dealing with development issues, namely, the General Assembly, the Economic and Social Council and its related functional commissions, and expert bodies; (b) to monitor and analyse development trends, prospects and policy issues globally; and (c) to provide support for capacity development in policy formulation and implementation, in particular in relation to the achievement of the internationally agreed development goals, including the Millennium Development Goals, through, inter alia, implementation of the regular programme of technical cooperation and Development Account projects.
- 9.3 The programme has put development issues at the centre of global deliberations and helped Member States to forge a shared vision of development based on the internationally agreed development goals and commitments, with the Millennium Development Goals at the core, as identified in the outcomes of the major United Nations conferences and summits, including the 2005 World Summit. Those commitments are collectively referred to as the United Nations development agenda.

- 9.4 In the biennium 2012-2013, the programme will continue to mobilize and provide practical support to help translate the development commitments into action. It will focus on the delivery of four main functions: (a) monitoring, research and analysis of development issues and emerging challenges, including through support to the global statistical system; (b) normative and policy support to United Nations intergovernmental processes; (c) assistance in capacity development and active promotion of capacity-building activities in order to support implementation of global conference outcomes at the country level; and (d) fostering collaboration and partnerships within the United Nations system and with civil society and the private sector.
- P.5 Fulfilling those functions requires strengthened analytical and monitoring capacity, in particular to identify and address emerging issues and cross-cutting policy challenges and to support both national development strategies and accountability and monitoring mechanisms at the intergovernmental level. Strategic integration is also essential, to promote a coherent and coordinated implementation process for the internationally agreed development goals, including the Millennium Development Goals. This includes enhancing horizontal linkages across the subprogrammes of programme 7 to enable more effective and flexible support to Member States in pursuing the development agenda, in cooperation with entities of the Executive Committee on Economic and Social Affairs. The programme provides strategic support to the Executive Committee and ensures its stronger linkages with the United Nations Development Group, other executive committees and various other partners.
- 9.6 The programme will continue to emphasize the mainstreaming of gender perspectives into its subprogrammes. Consultations have taken place among concerned entities of the Executive Committee on Economic and Social Affairs at the thematic cluster level. Those consultations are expected to continue, enhancing coordination and collaborative work among programmes in major common work areas of the Secretariat in the social and economic sectors.
- 9.7 The Department remains supportive of General Assembly resolution 64/259 and is actively engaged in system-wide measures taken in support of the resolution. In the current biennium, the Department of Economic and Social Affairs has worked closely with the Department of Management in the areas of performance reporting with regard to the timely reporting and monitoring of programme outputs and in the preparation and review of senior managers' compacts consistent with the need for greater personal and institutional accountability. The Department is also working closely with the Office of Human Resources Management on the implementation of recently issued administrative guidelines on performance management and career and staff development. The Department has engaged in discussions on the implementation of a results-based management framework and has participated in risk assessments undertaken by the Office of Internal Oversight Services. The Department continues to facilitate the work of the various oversight bodies and implements the relevant recommendations that arise from their reviews of the Department.
- In its resolution 63/260, the General Assembly approved 13 posts in response to requirements identified by the Department as being critical to improving the effective and efficient delivery of the mandates of development-related activities (A/62/708). It should be noted that, of the 13 posts approved, five were for subprogramme 2, Gender issues and the advancement of women. Those posts have now been transferred to the newly established entity for gender equality and the empowerment of women, UN-Women. The remaining eight posts have been assigned to their respective offices and subprogrammes and have contributed to the effective delivery of those programmes of work. In this regard, the Department has had to ensure the strategic use of these posts to optimize their impact on the delivery of its mandate. This is reflected in some of the redeployments and realignments of resources that have been proposed in this programme budget.

- 9.9 The P-5 post approved under executive direction and management has been assigned to the Strategic Planning Unit, whose role in dealing with cross-cutting issues and coordinating activities within the Department, the Executive Committee on Economic and Social Affairs and the entire United Nations system was central to the Department's proposal. The establishment of the Unit remains an integral part of the Department's efforts to identify new and emerging challenges, especially cross-cutting issues, and developing strategies for its work on these issues. In this connection a D-1 post has been redeployed to head the Unit, which is now comprised of the new P-5 post and an existing P-4 post. As constituted the Strategic Planning Unit aims to assist the Under-Secretary-General in specific strategic planning processes, namely (a) pursuing substantive strategic priorities; (b) enhancing interdivisional cooperation and facilitating Department-wide strategic reviews and actions, particularly on cross-cutting issues; and (c) engaging stakeholders, including Member States and key strategic partners in the Secretariat and the United Nations system.
- 9.10 The remaining seven posts approved under the Department's programme of work have made a positive impact in the respective subprogrammes:
  - (a) The P-4 post established in subprogramme 1 has strengthened the substantive support that the Office for Economic and Social Council Support and Coordination provides to the Development Cooperation Forum, established by the General Assembly in resolution 61/16. The post has strengthened the work being undertaken in research and policy analysis; preparing reports for the Development Cooperation Forum and other substantive notes and analytical background documents; coordinating preparations for the Forum; and liaising with the United Nations system on matters related to the Forum;
  - (b) The P-4 post approved in subprogramme 3 for the secretariat of the Permanent Forum on Indigenous Issues has strengthened the secretariat's work in promoting and implementing Forum recommendations and United Nations Development Group guidelines on indigenous peoples' issues; preparing analytical papers and statements in support of these efforts; and overseeing activities funded by the Trust Fund on Indigenous Issues;
  - (c) The P-4 post approved for subprogramme 4, Sustainable development, has strengthened substantive preparations and support for intergovernmental bodies, including the Commission on Sustainable Development, the Economic and Social Council and the General Assembly, and pursued activities to advance the sustainable development agenda of the Commission, including exploring opportunities for cooperation; policy research in the thematic areas of the Commission; monitoring trends; and engaging Member States.
  - (d) The P-3 post established under subprogramme 5, Statistics, has been used to support work being undertaken with regard to the Millennium Development Goals, specifically the programming of data related to goals 1 (eradicate extreme poverty and hunger) and 7 (ensure environmental sustainability) and the dissemination of information on the Statistics Division's work related to the goals, including the launch of the Gender Equality and Women's Empowerment Progress Chart 2010 and the coordination of the World Statistics Day event (October 2010). In this regard, the Division's website (http://unstats.un.org/unsd/mdg/) has become the source of statistical data for review and access by Member States and all other interested parties;
  - (e) The P-4 post approved in subprogramme 6, Population, has assisted the Population Division in speeding up the publication of planned outputs and responding to requests for substantive documentation and briefing papers. The additional resource has strengthened the Division's substantive support to the informal thematic debate on international migration and development, which is being organized by the President of the General Assembly in response

- to resolution 63/225, and preparations for the High-level Dialogue on International Migration and Development to be convened in 2013 in response to the same resolution;
- (f) The P-5 post approved in subprogramme 9, Sustainable forest management, has enhanced the capacity of the secretariat of the United Nations Forum on Forests to be actively involved in developing and producing sound forest policy analysis and practical policy advice to address sustainable forest management in general and the implementation of the non-legally binding instrument on all types of forests in particular, as well as other major global challenges. The secretariat has also furthered the Forum's consideration of a sound solution by 2013 on financing forest activities through the preparation of analytical papers and notes on this subject; prepared the Secretary-General's report on forests for people, livelihoods and poverty eradication for the Forum's ninth session; advanced its capacity-building programme; and provided substantive input to other sustainable development processes including preparations for the Cancun and Rio+20 conferences;
- (g) The P-4 post approved in subprogramme 10, Financing for development, strengthens the analytical capacity of the Financing for Development Office to produce reports on the implementation of the Monterrey Consensus, which includes the emergence and expansion of new substantive areas in financing for development such as innovative sources of finance, including financing required to address climate change. The additional resource strengthens the Office's capacity to remain engaged in new developments in financing for development; make recommendations to Member States and assess progress in a rapidly changing world; and contribute to multi-stakeholder consultations on innovative finance and other emerging issues in financing for development.
- 9.11 In paragraph 49 of its resolution 64/289, the General Assembly decided to establish as a composite entity, to be operational by 1 January 2011, the United Nations Entity for Gender Equality and the Empowerment of Women, to be known as UN-Women, by consolidating and transferring to the entity the existing mandates and functions of the Office of the Special Adviser on Gender Issues and Advancement of Women and the Division for the Advancement of Women of the Secretariat, as well as those of the United Nations Development Fund for Women and the International Research and Training Institute for the Advancement of Women, to function as a secretariat and also to carry out operational activities at the country level. The General Assembly, in part VI of resolution 65/259, approved effective 1 January 2011 the transfer of the responsibility for subprogramme 2, Gender issues and advancement of women, and the related resources to section 37, UN-Women, of the programme budget for the biennium 2010-2011.<sup>1</sup>
- 9.12 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized in table 9.3 and as described in the output information for each subprogramme. The decrease in 2012-2013 results from efforts to be made to use electronic form, whenever possible, instead of printing non-recurrent publications.
- 9.13 With regard to publications, a working group headed by the Department of Public Information and the Department for General Assembly and Conference Management was established in 2010 to examine the entire publishing process in the Secretariat and find ways to make it more efficient,

for example by combining publications, analysing the need for publications and increasing the use of Internet publishing with a view to reducing the volume of printed publications.

- 9.14 The overall regular budget resources required for the biennium 2012-2013 amount to \$148,820,100 before recosting, reflecting a decrease of \$3,715,400 (2.4 per cent). The decrease, shown in table 9.5 below, can be summarized as follows:
  - (a) An increase of \$410,400 under policymaking organs resulting primarily from non-recurrent requirements for activities related to the United Nations Conference on Sustainable Development (Rio+20 Conference), authorized by the General Assembly in its resolution 64/236;
  - (b) An increase of \$458,900 under executive direction and management resulting mainly from (a) the inward redeployment of posts (1 D-1 post from subprogramme 5, 1 P-4 post from subprogramme 8 and 1 General Service (Principal level) post from programme support), offset by the outward redeployment of 1 P-3 post to subprogramme 8 and 1 General Service (Other level) post to programme support, in order to strengthen the Strategic Planning Unit and to support the Department-wide programme management, monitoring and evaluation activities overseen centrally by the Office of the Under-Secretary-General (\$558,900) and (b) a reduction of \$100,000 in non-post resources including general temporary assistance (\$45,700), overtime (\$4,300) and consultants (\$50,000) owing to more stringent use of these resources;
  - (c) A decrease of \$4,475,600 under programme of work relating to:
    - (i) A net decrease of \$362,600 under subprogramme 1, Economic and Social Council support and coordination, owing to the abolition of 1 P-4 post in an effort to rationalize and streamline the post structure of the subprogramme;
    - (ii) A net decrease of \$469,500 under subprogramme 3, Social policy and development, from the abolition of 2 General Service (Other level) posts (\$302,600) in an effort to rationalize and streamline the post structure, and reduced non-post requirements relating mainly to the concerted efforts to reduce the number of experts and the duration and location of meetings (\$166,900);
    - (iii) A net decrease of \$482,700 under subprogramme 4, Sustainable development, owing to the abolition of 1 P-5 post (\$401,200) in an effort to rationalize and streamline the post structure, and reduced non-post requirements resulting mainly from the concerted efforts to reduce the number of experts, as well as the duration and location of meetings (\$81,500);
    - (iv) A net decrease of \$1,752,500 under subprogramme 5, Statistics, owing to (a) reduced requirements for posts (\$804,500) resulting from a reduction of \$661,500 owing to the abolition of three posts (1 P-3, 1 P-2/1 and 1 General Service (Other level)) and the outward redeployment of a D-1 post to executive direction and management (\$455,400),

offset by an increase of \$312,400 owing to the proposed establishment of 2 P-3 posts that would assume the functions previously provided under a contractual arrangement with the International Computing Centre for server support and statistical applications development; and (b) a decrease of \$948,000 for non-post requirements related mainly to the termination of the contract with the International Computing Centre (\$775,200), other staff costs (\$23,100), consultants (\$13,200), experts (\$34,000), travel of staff (\$10,800), external printing (\$60,500), supplies and materials (\$4,700) and furniture and equipment (\$26,500);

- (v) A net decrease of \$397,900 under subprogramme 6, Population, owing to reduced requirements for consultants (\$158,600), experts (\$104,500), travel of staff (\$65,600), contractual services (\$63,000) and furniture and equipment (\$6,200);
- (vi) A net decrease of \$340,700 under subprogramme 7, Development policy and analysis, owing to the abolition of two General Service (Other level) posts (\$302,600) and reduced requirements for experts (\$20,000), contractual services (\$10,000), supplies and materials (\$4,100) and furniture and equipment (\$4,000);
- (vii) A net decrease of \$394,100 under subprogramme 8, Public administration and development management, resulting from the abolition of two General Service (Other level) posts and the outward redeployment of 1 P-4 post to executive direction and management (\$362,800) in exchange for 1 P-3, and reduced requirements for consultants (\$20,000), staff travel (\$5,000) and supplies and materials (\$6,300);
- (viii) A net decrease of \$100,200 under subprogramme 9, Sustainable forest management, due to reduced requirements for consultants (\$48,000), experts (\$26,100), travel of staff (\$12,200) and furniture and equipment (\$13,900);
- (ix) A net decrease of \$175,400 under subprogramme 10, Financing for development, from the abolition of one General Service (Other level) post (\$151,300) and reduced requirements for experts (\$20,000) and external printing (\$4,100);
- (d) A net decrease of \$109,100 under programme support resulting from: (a) increased requirements for posts (\$288,900) owing to the delayed impact of 2 new posts (1 P-5 and 1 P-4) established in 2010-2011 (\$332,200), offset by the net decreased requirements (\$43,300) resulting from the inward redeployment of 1 General Service (Other level) post and the outward redeployment of 1 General Service (Principal level) post to executive direction and management; and (b) net decreased requirements of \$398,000 for non-post requirements under contractual services (\$300,000), general operating expenses (\$17,000), supplies and materials (\$20,000), furniture and equipment (\$50,000) and other staff costs (\$11,000).
- 9.15 Capacity development activities focus on key priority areas in which the Department of Economic and Social Affairs has accumulated extensive normative, analytical and operational experience and has a proven and credible knowledge base, including networks of experts and repertoire of good practices, and which provide a positive contribution to the work of the United Nations development system as a whole. The priority areas include strengthening of statistical capacities, including monitoring of the Millennium Development Goals; macroeconomic policy advice; promoting social inclusion and integration of all vulnerable groups; encouraging policies that promote national sustainable development strategies, with a particular focus on climate change mitigation and adaptation and sustainable management of forests; and strengthening of public administration and information and communications technology for development, including electronic government.

- 9.16 The Department will be conducting self-evaluations and self-assessments and will report on the implementation of evaluation activities. A departmental evaluation policy will be developed. Training programmes on monitoring and evaluation will be organized to further strengthen departmental monitoring and evaluation capacity. Pursuant to General Assembly resolution 58/269, resources identified for monitoring and evaluation amount to \$640,700, of which \$638,400 represents 47.8 work-months of staff at various grades and \$2,300 relates to non-post resources. Of the staffing resources amounting to \$638,400, \$598,100 will be funded from the regular budget and \$42,600 from extrabudgetary resources.
- 9.17 During the biennium 2012-2013, total projected extrabudgetary resources amounting to \$150,878,100 will supplement resources from the regular budget to finance various substantive and technical cooperation activities, including consultancies, expert groups, travel, technical advisory services, training, workshops, seminars and field projects. The decrease in projected extrabudgetary resources results from the conclusion of extrabudgetary-funded projects in the biennium 2010-2011. In addition, there are no commitments to extend these funding arrangements, taking into account the current global financial situation, which may impact the level of voluntary contributions in the biennium 2012-2013.
- 9.18 The estimated percentage distribution of the resources of the programme in the biennium 2012-2013 is shown in table 9.4. The resource and post requirements are summarized in tables 9.5 and 9.6.

9.19 Provision of an amount of \$2,793,400 is made for requirements related to standing intergovernmental organs and expert bodies, special sessions of the General Assembly and intergovernmental processes, the servicing of which is the responsibility of the Department of Economic and Social Affairs and which are deemed to require specific provisions. The provisions for experts serving on committees in their individual capacity are in accordance with General Assembly resolution 2491 (XXIII), as amended by resolution 41/176, 42/25, section VI and 43/217, section IX, while the provisions for members of the functional commissions are in accordance with General Assembly resolutions 1798 (XVII), 2128 (XX) and 2245 (XXI).

9.20 The amount of \$2,793,400 includes a one-time provision of \$434,000 for the Rio+20 Conference.

# Standing intergovernmental organs and expert bodies

#### **Statistical Commission**

### Resource requirements (before recosting): \$103,300

- 9.21 The Statistical Commission was established by the Economic and Social Council in its resolution 8 (I). Its terms of reference, as set out in Council resolutions 8 (I), 8 (II) and 1566 (L), are to assist the Council in promoting the development of national statistics and the improvement of their comparability; coordinating the statistical work of the specialized agencies; developing the central statistical services of the Secretariat; advising the organs of the United Nations on general questions relating to the collection, interpretation and dissemination of statistical information; and promoting the improvement of statistical methods in general. The Commission consists of 24 representatives of Member States elected by Council for a period of four years.
- 9.22 Bearing in mind General Assembly resolution 50/227 of 24 May 1996 the need to provide for more continuity in the Commission's decision-making and oversight of the global statistical process, and with the aim of enabling the Commission to follow up on the statistical implications of the major United Nations conferences and summits, the Council, in its resolution 1999/8, decided that the Commission should meet annually for a period of four working days in New York, beginning in 2000. The forty-third and forty-fourth sessions of the Commission are scheduled to be held in 2012 and 2013, respectively.

### **Commission on Population and Development**

### Resource requirements (before recosting): \$118,400

- 9.23 The Population Commission was established by the Economic and Social Council in its resolution 3 (III). Its terms of reference were initially set out in Council resolution 150 (VII). In its resolution 49/128, the General Assembly decided that the revitalized Population Commission should be renamed the Commission on Population and Development and that it should meet on an annual basis. The Commission is composed of 47 representatives of Member States elected by the Economic and Social Council for a period of four years (Council decision 1995/320). It normally meets annually for a period of five working days.
- Under its terms of reference the Commission is to assist the Council by (a) arranging for studies and advising the Council on population issues and trends, the integration of population and development strategies, population and related development policies and programmes and the provision of population assistance as well as addressing any population and development questions on which either the principal or the subsidiary organs of the United Nations or the specialized agencies may seek advice; (b) monitoring, reviewing and assessing the implementation of the Programme of Action of the International Conference on Population and Development at the national, regional and global levels, identifying reasons for success and failure, and advising the Council thereon; and (c) reviewing the findings of research and analysis pertaining to the interrelationships between population and development at the national, regional and international levels and advising the Council thereon.
- 9.25 Pursuant to General Assembly resolution 57/270 B, the Commission reviewed its methods of work at its thirty-eighth session, in 2005. In its decision 2005/2, the Commission reaffirmed its central role in coordinating the review and assessment of the overall implementation of the Programme of Action of the International Conference on Population and Development and the outcome of the twenty-first special session of the General Assembly at all levels; and reiterated the need to conduct periodically comprehensive reviews and appraisals of the implementation of the

Programme of Action and the key actions for its further implementation. The forty-fifth and forty-sixth sessions of the Commission are scheduled to be held in 2012 and 2013, respectively.

### **Commission for Social Development**

### Resource requirements (before recosting): \$197,400

9.26 The Social Commission was established as a functional commission of the Economic and Social Council by the Council in its resolution 10 (II). As a result of a comprehensive reappraisal of the role of the Commission, the Council, in its resolution 1139 (XLI), renamed it the Commission for Social Development to clarify its role as a preparatory body of the Council for the entire range of social development policy. Following the convening of the World Summit for Social Development in 1995, the Council, by its resolution 1995/60, decided that the Commission should review, on a periodic basis, issues related to the follow-up and implementation of the Copenhagen Declaration on Social Development and the Programme of Action adopted by the Summit. By its resolution 1996/7, the Council decided to expand the membership of the Commission from 32 to 46 representatives of Member States, elected by the Council for a period of four years, and that it should meet in annual sessions of eight working days. By its resolution 2005/11, the Council decided that the Commission would be organized in a series of two-year action-oriented implementation cycles that would include a review segment and a policy segment. The fiftieth and fifty-first sessions of the Commission are scheduled to be held in 2012 and 2013, respectively.

### **Commission on Sustainable Development**

### Resource requirements (before recosting): \$924,300

9.27 The Commission on Sustainable Development was established as a functional commission of the Economic and Social Council by the Council in its decision 1993/207. Its functions are set out in General Assembly resolution 47/191. The Commission is composed of 53 representatives of Member States elected by the Council for a period of three years, and meets annually for a period of two to three weeks. The Commission reports to the Council and provides recommendations to the Assembly through the Council. As a consequence of the World Summit on Sustainable Development and Council resolution 2003/61, the work of the Commission is organized in a series of two-year action-oriented implementation cycles, which include a review session and a policy session. It will continue to meet annually as in the past; every second year will be reserved for intergovernmental negotiations. The review session will focus on the results of the implementation of the programme of work by Governments, international organizations and major groups at the national and regional levels and will establish the topics to be negotiated in the following year's session of the Commission. The twentieth session of the Commission is scheduled to be held in 2013, as the United Nations Conference on Sustainable Development will take place in 2012.

## **Committee for Development Policy**

## Resource requirements (before recosting): \$345,200

9.28 The Economic and Social Council, in annex I to its resolution 1998/46, renamed the Committee for Development Planning, functioning in accordance with Council resolutions 1035 (XXXVII) and 1079 (XXXIX) and decision 1995/215, the Committee for Development Policy and reconfirmed its status as a subsidiary body of the Council. In accordance with Council resolution 1998/46, the Committee is composed of 24 independent experts with expertise drawn from the fields of economic development, social development and environmental protection who reflect adequate geographical and gender balance. Its membership includes experts who are able to make a contribution on emerging issues and the multilateral process. The experts are nominated by the

- Secretary-General following consultation with interested Governments and are approved by the Council. The term of office of each member is three years.
- 9.29 The Committee is called upon to undertake a triennial review of the status of least developed countries and to meet on that issue once every three years. Since the adoption of additional guidelines for the identification of least developed countries in 2007, this also involves undertaking impact assessments of countries found eligible for graduation. Furthermore, the Committee reports to the Council its findings of the monitoring exercises on the development progress of countries graduating and graduated from the list of least developed countries.
- 9.30 The Council decides on the programme of work of the Committee. The Committee meets in annual session for five working days and submits its report to the Council at its substantive session in July. The General Assembly, the Secretary-General and the subsidiary bodies of the Economic and Social Council may propose, through the Council, issues for consideration by the Committee. With respect to the submission of its report to the Council, the Committee has decided that its Chairperson or a designated member should attend the session of the Council to introduce the report and respond to any queries raised. The fourteenth and fifteenth sessions of the Committee for Development Policy are scheduled to be held in 2012 and 2013, respectively.

### **Committee of Experts on Public Administration**

### Resource requirements (before recosting): \$323,200

9.31 The Committee of Experts on Public Administration, established by the Economic and Social Council in its resolution 2001/45, has been holding annual sessions since 2003 in accordance with Council resolution 2003/60. It consists of 24 experts appointed in their personal capacity by the Council upon the nomination of the Secretary-General. The Committee's role is twofold: first, to support the intergovernmental deliberations in providing policy options and making recommendations to Member States for improving governance and public administration structures and processes for development; and second, to guide and monitor the performance of the Division of Public Administration and Development Management in the implementation of the United Nations Programme on Public Administration, Finance and Development. The eleventh and twelfth sessions of the Committee are scheduled to be held in 2012 and 2013, respectively.

### **Committee of Experts on International Cooperation in Tax Matters**

### Resource requirements (before recosting): \$341,700

- 9.32 By its resolution 2004/69, the Economic and Social Council decided to rename the Ad Hoc Group of Experts on International Cooperation in Tax Matters the Committee of Experts on International Cooperation in Tax Matters. The Committee comprises 25 members nominated by Governments who act in their expert capacity. The members are appointed by the Secretary-General, after notification of the Council, for a term of four years and are drawn from the fields of tax policy and tax administration. Their appointment reflects adequate equitable geographical distribution, representing different tax systems. As from 2005, the Committee meets once a year for five days in Geneva.
- 9.33 The Committee of Experts is mandated to (a) keep under review and update as necessary the United Nations Model Double Taxation Convention between Developed and Developing Countries and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries; (b) provide a framework for dialogue with a view to enhancing and promoting international tax cooperation among national tax authorities; (c) consider how new and emerging issues could affect international cooperation in tax matters and develop assessments, commentaries and appropriate recommendations; (d) make recommendations on capacity-building and the

- provision of technical assistance to developing countries and countries with economies in transition; and (e) give special attention to developing countries and countries with economies in transition in dealing with all the above issues. The Committee submits its report on the work of its annual session to the Economic and Social Council at its substantive session.
- 9.34 By its resolution 2006/48, the Council noted the creation of four subcommittees on substantive matters (treaty abuses, mutual assistance in collecting tax debts, definition of permanent establishment and exchange of information); and two working groups (international tax arbitration and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries). At its second session, the Committee established a new subcommittee on dispute resolution (replacing the former working group on tax arbitration) and a new working group on Islamic financial instruments, while the subcommittee on mutual assistance completed its work. The eighth and ninth sessions of the Committee of Experts on International Cooperation in Tax Matters are scheduled to be held in 2012 and 2013, respectively.

### **United Nations Forum on Forests**

### Resource requirements (before recosting): \$98,200

- 9.35 By its resolution 2000/35, the Economic and Social Council established the United Nations Forum on Forests as an intergovernmental subsidiary body of the Council to serve as a permanent policy and political forum with the main objective of promoting the management, conservation and sustainable development of all types of forests and to strengthen long-term political commitment to that end. The Forum is composed of all States Members of the United Nations and members of the specialized agencies with full and equal participation, including voting rights.
- 9.36 In its resolution 2006/49, the Council decided that following its seventh session in 2007, the Forum should meet biennially for a period of up to two weeks on the basis of a focused multi-year programme of work adopted by the Forum at its seventh session.
- 9.37 The Forum is mandated to perform a set of principal functions related to efforts to achieve the shared global objectives on forests; implementation of a non-legally binding instrument on all types of forests; policy development; international coordination among organizations, instruments and institutions; international cooperation; monitoring, assessment and reporting; and strengthening political commitment. The Economic and Social Council, in its resolution 2006/49, decided to strengthen the international arrangement on forests and, inter alia, accorded a long-term mandate to the Forum through 2015. The tenth session of the Forum is scheduled to be held in 2013.

#### **Permanent Forum on Indigenous Issues**

## Resource requirements (before recosting): \$341,700

9.38 In its resolution 2000/22, the Economic and Social Council established a permanent forum on indigenous issues as a subsidiary organ of the Council, consisting of 16 members, 8 members to be nominated by Governments and elected by the Council and 8 members to be appointed by the President of the Council following formal consultation with the Bureau and the regional groups, through their coordinators. Nominations are decided on the basis of broad consultations with indigenous organizations, taking into account the diversity and geographical distribution of the indigenous people of the world as well as the principles of transparency and equal opportunity for all indigenous people, including internal processes, when appropriate, and local indigenous consultation processes. All members serve in their personal capacity as independent experts on indigenous issues for a period of three years, with the possibility of re-election or reappointment for one further period. States, United Nations bodies and organs, intergovernmental organizations

- and non-governmental organizations in consultative status with the Council may participate as observers. Organizations of indigenous people may also participate as observers, in accordance with the procedures that have been applied in the Working Group on Indigenous Populations of the Subcommission on the Promotion and Protection of Human Rights.
- 9.39 The Economic and Social Council decided that the Permanent Forum should hold an annual session of 10 working days at the United Nations Office at Geneva or at United Nations Headquarters or at such other place as the Permanent Forum may decide in accordance with the existing Financial Regulations and Rules of the United Nations. The eleventh and twelfth sessions of the Permanent Forum on Indigenous Issues are scheduled to be held in 2012 and 2013, respectively.

# B. Executive direction and management

## Resource requirements (before recosting): \$7,121,000

- 9.40 The Under-Secretary-General for Economic and Social Affairs is responsible for the overall direction, supervision and management of the Department in the implementation of its mandates and approved programme of work. He serves as convener of the Executive Committee on Economic and Social Affairs as well as the Programme Manager of the Development Account and is responsible for the overall management of technical cooperation activities. The Under-Secretary-General is assisted by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs and the Assistant Secretary-General for Economic Development.
- 9.41 The Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs supports the Under-Secretary-General by providing substantive support to the Economic and Social Council and other relevant intergovernmental bodies. He also serves as Secretary of the United Nations System Chief Executives Board for Coordination. The Assistant Secretary-General for Economic Development serves as the principal economic adviser to the Under-Secretary-General and assists the Under-Secretary-General by leading and coordinating the policy research and analysis work of the Department.
- 9.42 The Office of the Under-Secretary-General provides support and advice to the Under-Secretary-General and, as appropriate, to the Assistant Secretaries-General on the planning, coordination, management and assessment of the work of the Department.
- 9.43 The Strategic Planning Unit supports the Under-Secretary-General in promoting strategic integration and policy coherence, including collaborative work with other Secretariat entities.

The amount of \$7,121,000 provides for (a) \$5,913,300 for 17 posts (1 USG, 2 ASG, 2 D-1, 4 P-5, 2 P-4 and 6 General Service (1 Principal level and 5 Other level)); and (b) \$1,207,700 for non-post requirements, including other staff costs (\$146,700), consultants (\$130,700), travel of staff (\$525,000), supplies (\$7,000), furniture and equipment (\$15,000) and grants and contributions (\$383,300). 

# **Subprogramme 1 Economic and Social Council support and coordination**

## Resource requirements (before recosting): \$13,093,900

- 9.45 The subprogramme is under the responsibility of the Office for Economic and Social Council Support and Coordination. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 1 of programme 7 of the strategic framework for the period 2012-2013 (A/65/6/Rev.1).
- 9.46 The Office for Economic and Social Council Support and Coordination supports the efforts of the General Assembly and the Economic and Social Council to promote a more coherent and integrated implementation of the United Nations development agenda, comprised of the international development goals agreed upon at the major United Nations conferences and summits, including the Millennium Development Goals. The outcome of the 2005 World Summit reaffirmed the principal role of the Council in economic and social development as a quality platform for policy dialogue, for annual ministerial-level substantive reviews and for holding a biennial high-level Development Cooperation Forum as well as for supporting efforts to address humanitarian emergencies and establishing links between the Council and the Peacebuilding Commission. 9.49 The amount of \$13,093,900 provides (a) \$12,322,100 for 45 posts (1 D-2, 4 D-1, 6 P-5, 8 P-4, 5 P-3, 3 P-2/1, 1 General Service (Principal level) and 17 General Service (Other level)), to service meetings of intergovernmental and other bodies, such as the Second Committee of the General Assembly, the Economic and Social Council, the Committee on Non-Governmental Organizations and ad hoc advisory groups on African countries emerging from conflict; preparation of parliamentary documentation, publications and technical material (website, newsletters, brochures) for these meetings; organization of technical cooperation activities (seminars, workshops, field projects); support for the quadrennial comprehensive review process; and provision of substantive servicing and support to the biennial Development Cooperation Forum and the annual ministerial review; and (b) \$771,800 for non-post requirements including other staff costs (\$35,400), consultants (\$190,500), experts (\$104,200), travel of staff (\$174,400), contractual services (\$105,200), supplies and materials (\$17,600), furniture and equipment (\$48,300) and grants and contributions (\$96,200). The decrease of \$362,600 under this subprogramme results mainly from the abolition of 1 P-4 post in an effort to rationalize and streamline the post structure of the subprogramme.

9.50 During the biennium 2012-2013, projected extrabudgetary resources of \$1,911,000 will be used (a) to ensure multi-stakeholder participation in the annual ministerial review preparatory process; (b) to acquire external expertise to improve the analytical work for the triennial comprehensive policy review of United Nations operational activities for development; and (c) to support the

global preparations for the Development Cooperation Forum, including substantive studies, global and regional preparatory meetings and expert group meetings. The decrease of \$995,500 in projected extrabudgetary resources is due primarily to reduced requirements for general temporary assistance and consultants and experts funded for the annual ministerial review and the Development Cooperation Forum, owing to greater reliance on in-house capability.

# **Subprogramme 3 Social policy and development**

### Resource requirements (before recosting): \$16,918,000

- 9.54 The amount of \$16,918,000 provides (a) \$15,849,900 for 58 posts (1 D-2, 3 D-1, 5 P-5, 15 P-4, 8 P-3, 8 P-2/1, 1 General Service (Principal level) and 17 General Service (Other level)) that are required to provide normative, analytical and operational support to Member States and intergovernmental and non-governmental organizations on a broad range of socio-economic issues through monitoring of national and global trends and emerging issues; substantive servicing of intergovernmental meetings; promotion of dialogue with major stakeholders; preparation of reports and publications; organization of expert group meetings, seminars and panel discussions; and advisory services; and (b) \$1,068,100 for non-post requirements including other staff costs (\$67,900), consultants (\$105,700), experts (\$405,500), travel of staff (\$223,200), contractual services (\$109,400), supplies and materials (\$32,500), furniture and equipment (\$76,900) and grants and contributions (\$47,000). The decrease of \$469,500 results from the abolition of two General Service (Other level) posts (\$302,600) in an attempt to rationalize and streamline the post structure of the subprogramme and reduced non-post requirements (\$166,900) from more stringent use of resources.
- 9.55 During the biennium 2012-2013, projected extrabudgetary resources of \$1,881,000 under this subprogramme will be used (a) to support the representation of the Permanent Forum on Indigenous Issues at important meetings of interest for its mandate; language-related needs of the Forum; preparation of special publications and workshops; pilot projects in countries based on earmarked contributions; and small grants in the context of the Second International Decade of the World's Indigenous People; (b) to support catalytic and innovative interventions to build national capacities, including the capacities of non-governmental organizations, for disability action; to support exchanges at subregional, regional and interregional levels on good practices in relation to, and guidelines for the full implementation of, the Convention on the Rights of Persons with Disabilities; and (c) to contribute to effective follow-up to the priorities of the Copenhagen Declaration and Programme of Action on Social Development, the twenty-fourth special session of the General Assembly and the Millennium Declaration by supporting research and preparation of documents on catalytic and innovative interventions in the areas of poverty eradication, employment and decent work and social integration. The decrease of \$204,600 in projected extrabudgetary resources results from the conclusion of extrabudgetary-funded projects in the biennium 2010-2011.

The amount of \$17,343,300 provides (a) \$16,536,300 for 58 posts (1 D-2, 5 D-1, 11 P-5, 11 P-4, 9.59 5 P-3, 4 P-2/1, 2 General Service (Principal level) and 19 General Service (Other level)) to provide substantive support to Member States and the intergovernmental processes on sustainable development through the collection of national information, empirical research, analytical reports, expert consultations, technical assistance and addressing the various priority themes considered by the Commission on Sustainable Development in following up on the implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21, the Johannesburg Plan of Implementation, the Barbados Programme of Action for the Sustainable Development of Small Island Developing States and the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States; and (b) \$807,000 for non-post requirements including overtime (\$7,400), consultants (\$188,100), experts (\$307,100), travel of staff (\$175,000), contractual services (\$33,700), supplies and materials (\$27,800) and furniture and equipment (\$67,900). The decrease of \$482,700 is the result of reduced requirements for posts (\$401,200) resulting from the abolition of 1 P-5 and reduced requirements for expert meetings (\$81,500) in an attempt to rationalize and streamline the structure of the subprogramme.

9.60 During the biennium 2012-2013, projected extrabudgetary resources of \$5,778,900 under this subprogramme will be used to support (a) the participation of representatives of developing countries and countries with economies in transition in a range of meetings related to sustainable development, participation of the same group of countries in the intergovernmental preparatory meeting and the seventeenth session of the Commission; (b) the analytical and technical cooperation work programmes related to energy and water; and (c) activities relating to paragraphs 9, 20, 25 and 26 of the Johannesburg Plan of Implementation. The decrease of \$5,922,100 in projected extrabudgetary resources results from the conclusion of extrabudgetary-funded projects in the biennium 2010-2011, including the abolition of one post.

- 9.64 The amount of \$31,417,200 provides (a) \$30,041,800 for 122 posts (1 D-2, 5 D-1, 9 P-5, 17 P-4, 22 P-3, 14 P-2/1, 12 General Service (Principal level) and 42 General Service (Other level)) to provide substantive servicing to the Statistical Commission and assist national and international statistical systems in the areas of: (i) statistical capacity-building; (ii) standards and methodological development; (iii) coordination of international statistical activities; and (iv) data dissemination; and (b) \$1,375,400 for non-post requirements including other staff costs (\$279,900), consultants (\$163,300), experts (\$285,500), travel of staff (\$133,400), contractual services (\$345,600), supplies and materials (\$57,400) and furniture and equipment (\$110,300). The decrease of \$1,752,500 is the result of (a) a reduction of \$804,500 in requirements for posts, which is the net result of increased requirements from the proposed establishment of 2 P-3 posts, offset by the abolition of 3 posts (1 P-3, 1 P-2/1 and 1 General Service (Other level)) and the outward redeployment to executive direction and management of 1 D-1 post, the functions of which will be assumed by the branch chiefs; and (b) a reduction of \$948,000 in non-post requirements owing mainly to the termination of the contractual arrangements with the International Computing Centre related to technical services for server support and statistical application development and hosting (\$775,200), and other objects of expenditure (\$172,800). The two P-3 posts proposed to be established will be responsible for the services formerly provided by the International Computing Centre.
- 9.65 During the biennium 2012-2013, projected extrabudgetary resources of \$234,000 under this subprogramme will be used to (a) create UNdata, a new portal which enables free access to United Nations system-wide statistics through innovative and user-friendly formats and interfaces, and provide technical assistance to Member States on statistical dissemination; and (b) support the project on comparative analysis of national statistical systems, financing the preparatory work and travel to an international conference on national statistical systems, focusing in particular on the measurement of climate change. The decrease of \$353,000 in projected extrabudgetary resources results from the conclusion of extrabudgetary-funded projects in the biennium 2010-2011.

## **Subprogramme 6 Population**

#### Resource requirements (before recosting): \$12,863,800

- 9.66 Substantive responsibility for this subprogramme is vested in the Population Division. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 6 of programme 7 of the strategic framework for the period 2012-2013 (A/65/6/Rev.1).
- 9.67 The subprogramme will facilitate access by Governments and civil society to information on population trends, their demographic components and their interrelationships with social and economic development, so as to provide a sound basis for the formulation of government policies and programmes. The official United Nations demographic estimates and projections will be prepared for all countries and areas of the world, as well as urban and rural areas and major cities, and will serve as the standard and consistent set of population figures for use throughout the United Nations system. International migration, fertility and reproductive health, the demographic impact of HIV/AIDS and the changing age structures of populations and their impact on development will be the critical issues addressed. These areas have been stressed in the Millennium Declaration, the Millennium Development Goals, the Declaration of Commitment on HIV/AIDS, the Programme of Action of the International Conference on Population and Development and resolutions adopted by the Commission on Population and Development. Work in the area of international migration and its relation to development has intensified as a result of the 2006 High-level Dialogue on International Migration and Development and its follow-up (General Assembly resolutions 61/208 and 62/270) and the attention given to the topic by the Commission on Population and Development (resolution 2006/2). Other priority areas for analysis will be national population policies and the relationships between population dynamics and development issues.
- 9.68 The subprogramme will enhance the substantive support to and servicing of intergovernmental bodies (the Commission on Population and Development and the General Assembly) in relation to agenda items concerning population through the preparation of high-quality documentation, analytical work and facilitation of consensus-building and policy development. Activities carried out under the subprogramme support the implementation of the recommendations contained in the Programme of Action adopted by the International Conference on Population and Development, the key actions for the further implementation of the Programme of Action adopted at the twenty-first special session of the General Assembly and the outcomes of the Millennium Summit and high-level follow-up meetings. In particular, the activities include monitoring progress towards the achievement of the goals set out in the Programme of Action, the Millennium Development Goals and the goals of the outcome document of the World Summit, as well as analysing and investigating new policy issues and emerging global trends in the field of population and development.
- 9.69 The subprogramme will continue to strengthen and expand the distribution of population information in digital form, both through CD-ROMs and online, in order to respond effectively to the growing demand for timely information and data and to support coordination among the United Nations entities in the field of population.
- 9.70 The functions of the Population Division of the Department of Economic and Social Affairs increasingly serve as the basis for the population activities of the Secretariat. The objective of the subprogramme during the biennium is to strengthen the international community's capacity to address current and emerging population issues effectively and to integrate the population dimension into the development agenda at the national and international levels. To this end, the subprogramme will increase understanding of the nature of demographic phenomena, in particular

the interrelationships between population and development, by (a) providing substantive support to United Nations bodies, especially to the Commission on Population and Development, and assessing progress made in the implementation of the Programme of Action of the International Conference on Population and Development; (b) facilitating the discussion of key or emerging population issues by experts or government representatives; (c) preparing comprehensive studies on population issues and population trends relating to fertility, marriage and family, mortality, international and internal migration, HIV/AIDS, urbanization, population growth, population ageing, population prospects, population policy and population in relation to development; (d) disseminating population information and policy-relevant findings in the area of population, in particular through the Population Division's websites; and (e) building capacity to address population issues at the national level through workshops or through the dissemination of technical material, such as manuals and software.

- 9.73 The amount of \$12,863,800 provides (a) \$12,481,400 for the continuation of 45 posts (1 D-2, 2 D-1, 7 P-5, 7 P-4, 10 P-3, 2 P-2/1, 4 General Service (Principal level) and 12 General Service (Other level)) to provide substantive servicing to the Commission on Population and Development and to the General Assembly in matters related to population issues, including international migration and development and the monitoring of the Plan of Action of the International Conference on Population and Development; to prepare the set of official United Nations population estimates and projections that serves as the basis for the population-related statistics prepared by other entities of the United Nations system; to monitor population policies and trends in fertility, mortality, migration and urbanization and interrelationships between population and development for all countries or areas of the world; and (b) \$382,400 for non-post requirements including other staff costs (\$89,600), consultants (\$65,500), experts (\$23,400), travel of staff (\$39,600), contractual services (\$79,600), supplies and materials (\$24,700) and furniture and equipment (\$60,000). The decrease of \$397,900 is attributable to reduced requirements for consultants, experts, travel of staff, contractual services and furniture and equipment, owing to more stringent use of resources.
- 9.74 During the biennium 2012-2013, no provision is made for extrabudgetary resources, owing to the completion of projects related to population and development in the biennium 2010-2011. There are no commitments to extend these funding arrangements, taking into account the current global financial situation, which may impact the level of voluntary contributions in the biennium 2012-2013

- 9.76 To achieve the subprogramme's objectives, the Division carries out three core functions: (a) assisting the General Assembly and the Economic and Social Council in identifying and better understanding new and emerging economic development issues and challenges, in particular in the context of the Millennium Development Goals, and with full consideration of the implications of major cross-cutting issues such as climate change; (b) fostering and disseminating a unified United Nations view on the world economic outlook and its implications for the prospects of developing countries; (c) strengthening the capacity of developing countries to integrate macroeconomic and social policies in national development strategies.

9.79 The amount of \$12,744,200 provides (a) \$12,029,600 for 44 posts (1 D-2, 3 D-1, 5 P-5, 8 P-4, 5 P-3, 5 P-2/1, 7 General Service (Principal level) and 10 General Service (Other level)) to provide substantive and administrative support to the Committee for Development Policy and to the intergovernmental process in identifying and understanding new and emerging economic issues, pursuing improved dialogue on the world economic situation and strengthening the capacity of developing countries to integrate macroeconomic and social policies in national development strategies; and (b) \$714,600 for non-post requirements including other staff costs (\$61,700), consultants (\$132,500), experts (\$242,000), travel of staff (\$131,200), contractual services

(\$59,700), supplies and materials (\$26,100) and furniture and equipment (\$61,400). The decrease of \$340,700 results primarily from the abolition of 2 General Service (Other level) posts (\$302,600) in an attempt to rationalize and streamline the structure of the subprogramme, as well as reduced requirements for consultancy services (\$10,000), experts (\$20,000), supplies and materials (\$4,100) and furniture and equipment (\$4,000), owing to more stringent use of resources.

9.80 During the biennium 2012-2013, projected extrabudgetary resources of \$20,000 under this subprogramme will be used to support development planning and projections at a minimum level, owing to the expected completion of related projects and taking into account the current global financial situation, which may impact the level of voluntary contributions in the biennium 2012-2013.

## **Subprogramme 8 Public administration and development management**

- 9.81 Substantive responsibility for this subprogramme is vested in the Division for Public Administration and Development Management. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 8 of programme 7 of the strategic framework for the period 2012-2013 (A/65/6/Rev.1).
- 9.82 The strategy to achieve the expected accomplishments, particularly in the work focus areas of institutional and human resource capacity development, electronic/mobile government development and development management through citizen engagement and information and communications technology, is based on an integrated approach which includes the following:
  - (a) Providing substantive support to the General Assembly, the Economic and Social Council, the Committee of Experts on Public Administration, the United Nations Public Service Awards and United Nations Public Service Day;
  - (b) Promoting greater awareness, common approaches, understanding and sustainable policy options among Governments in key substantive areas of public administration and development management;
  - (c) Strengthening partnerships and cooperation with other international, regional and professional organizations, both public and private, and within and outside the United Nation system, including the building of an online global public administration knowledge base which is comprehensive, useful and easy to access;
  - (d) Providing analytical research, advocacy, advisory services, training and knowledge-sharing, particularly to countries or related institutions who have requested assistance, and to developing countries, especially the least developed countries, countries emerging from conflict or crisis and countries with economies in transition.

The amount of \$12,857,600 provides (a) \$12,161,900 for 47 posts (1 D-2, 3 D-1, 6 P-5, 9 P-4, 2 P-3, 3 P-2/1, 2 General Service (Principal level) and 21 General Service (Other level)) to support the work of the Committee of Experts on Public Administration and Member States in strengthening governance and public administration capacity by producing the planned outputs in support of normative activities, such as substantive servicing of intergovernmental bodies and production of parliamentary documentation as well as other mandated outputs, including but not limited to ad hoc expert group meetings, recurrent and non-recurrent publications, the organization of special events, the production of technical materials, the backstopping of projects and the provision of advisory support and training; and (b) \$695,700 for non-post requirements including other staff costs (\$38,900), consultants (\$204,100), experts (\$169,100), travel of staff (\$159,200), contractual services (\$54,600), supplies and materials (\$15,200) and furniture and equipment (\$54,600). The decrease of \$394,100 is the net result of reduced requirements for posts (\$362,800) owing to the abolition of 2 General Service (Other level) posts and the outward redeployment of 1 P-4 post, offset by the inward redeployment of 1 P-3 post in an attempt to rationalize and streamline the resources, as well as the reduced requirements for consultants (\$20,000), travel of staff (\$5,000) and supplies and materials (\$6,300) attributable to more stringent use of resources.

9.86 During the biennium 2012-2013, no provision is made for extrabudgetary resources, owing to the completion of projects related to public administration and population and development in the biennium 2010-2011, including the abolition of one post. There are no commitments to extend these funding arrangements, taking into account the current global financial situation, which may impact the level of voluntary contributions in the biennium 2012-2013.

### Subprogramme 9 Sustainable forest management

#### Resource requirements (before recosting): \$3,240,400

- 9.87 Substantive responsibility for this subprogramme is vested in the secretariat of the United Nations Forum on Forests. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 9 of programme 7 of the strategic framework for the period 2012-2013 (A/65/6/Rev.1).
- 9.88 The secretariat of the United Nations Forum on Forests serves as the focal point in the Department of Economic and Social Affairs for all forest-related issues; supports and services the intergovernmental process by overseeing logistical preparations for Forum sessions, preparing and disseminating parliamentary documents and information in a timely manner, assisting the bureau

of the Forum and facilitating the smooth running of Forum sessions and related meetings (e.g., ad hoc expert group meetings).

9.89 The secretariat also supports implementation of the Global Objectives on Forests; fosters effective international dialogue on sustainable forest management; enhances monitoring, assessment and reporting on implementation of sustainable forest management, including by providing analyses and syntheses of reporting; and manages topical work on key areas such as climate change, biodiversity, desertification, finance, transfer of technology, law enforcement and governance. It specifically works to facilitate the implementation of forest-related elements of internationally agreed development goals, including those contained in the United Nations Millennium Declaration and in the outcomes of the major United Nations conferences and international agreements since 1992. It contributes to the forest-related agenda items of the Economic and Social Council and the conferences of the parties to the three Rio conventions, and to important intradepartmental activities including monitoring of the implementation of the Millennium Development Goals and the work of the Department of Economic and Social Affairs on conflict and disaster prevention and recovery.

- 9.92 The amount of \$3,240,400 provides (a) \$2,563,000 for the continuation of 8 posts (1 D-2, 2 P-5, 2 P-4, 1 P-3 and 2 General Service (Other level)) to provide overall coordination on forest-related activities within the United Nations system, specialized agencies and the Collaborative Partnership on Forests; substantive servicing of intergovernmental and expert bodies; preparation of reports of the Secretary-General's on agenda items of Forum sessions; monitoring and reporting progress towards the achievement of the Global Objectives on Forests; production of publications and outreach materials on sustainable forest management; and substantive servicing of the Forum; and (b) \$677,400 for non-post requirements, including overtime (\$2,400), consultants (\$215,100), experts (\$230,000), travel of staff (\$199,900), supplies and materials (\$10,000) and furniture and equipment (\$20,000). The decrease of \$100,200 represents reduced requirements for consultants, experts, travel of staff and furniture and equipment owing to increased reliance on in-house capacity and more stringent use of resources.
- 9.93 During the biennium 2012-2013, projected extrabudgetary resources of \$3,531,000 under this subprogramme will be used to support (a) substantive inputs in fostering international cooperation and continued policy development and dialogue among Governments; (b) follow-up on international forest-related developments, including those related to the Global Objectives on Forests and the International Year of Forests; policy advice to Governments; enhancing cooperation among international organizations; and providing substantive support to intersessional activities and expert groups; and (c) facilitation of the participation of country representatives and major groups in the meetings of the Forum and related sessions, forestry-related international forums and servicing of the multidisciplinary Collaborative Partnership on Forests. The increase of \$917,000 results from the additional activities required in support of the Forum and technical cooperation-related projects.

#### 1. Executive Office

#### Resource requirements (before recosting): \$7,377,000

9.99 The Executive Office assists the Under-Secretary-General in the discharge of the Department's responsibilities in the areas of personnel, finance and general administration. In the biennium 2012-2013, the Office will continue to enhance the effectiveness of programme support, both in the traditional areas of responsibility and in streamlining the management and administration of the Department's extrabudgetary funds.

9.100 The amount of \$7,377,000 provides (a) \$3,673,700 for 15 posts (1 D-1, 2 P-5, 3 P-4 and 9 General Service (2 Principal level and 7 Other level)) to assist the Under-Secretary-General in the discharge of the Department's responsibilities in the areas of personnel, finance and general administration; and (b) \$3,703,300 for non-post requirements, including other staff costs (\$350,700), contractual services (\$2,327,400), general operating expenses (\$904,200), hospitality (\$21,300), supplies and materials (\$5,800) and furniture and equipment (\$93,900). The decrease of \$840,900 is the result of reduced requirements for posts (\$493,900) owing to the outward redeployment of one Professional post and 1 General Service post to the Capacity Development Office, and the decrease in requirements for contractual services (\$280,000), general operating expenses (\$17,000) and

furniture and equipment (\$50,000). The decrease in non-post requirements results from increased efforts in utilizing in-house capacity and the delayed replacement of furniture and equipment.

9.101 During the biennium 2012-2013, projected extrabudgetary resources of \$6,142,200 will be used to support the operational programmes of the Department and the extrabudgetary activities under programme support. The increase of \$507,800 results from the additional activities required for the completion of related projects in the biennium 2012-2013.

### 2. Information Support Unit

#### Resource requirements (before recosting): \$2,324,000

- 9.102 The Information Support Unit, reporting to the Under-Secretary-General, is responsible for providing information technology and communications services to the Department, including the development and coordination of access to electronic information resources in the economic and social fields. The Unit has four main responsibilities: (a) to formulate policies and strategies in the areas of knowledge management, electronic technical cooperation, website communications, publishing and electronic administration; (b) to advance those policies and strategies through concrete information system projects; (c) to acquire, manage and produce electronic information content; and (d) to support operations in the form of network administration, computer help desk, database administration, information technology asset management and videoconferencing.
- 9.103 In addition, the Unit produces an electronic newsletter on the work of the Department entitled DESA News, which is distributed to all staff in the Department and to other interested parties on the Web, every two months; and a weekly electronic bulletin entitled DESAlert, which is distributed to departmental and secretariat staff, permanent missions, resident coordinators and country teams as well as other interested parties. It designs and builds information systems and customizes enterprise applications to support the programmatic objectives of the Department. In order to ensure the Department's involvement in Secretariat-wide initiatives related to its areas of responsibility, the Unit participates in relevant Secretariat policy and normative bodies, including the Information and Communications Management Committee, chaired by the Chief Information Technology Officer, the Publications Board, the Working Group on Electronic Publications and the Task Force on Knowledge Management.

9.104 The amount of \$2,324,000 provides (a) \$2,206,800 for 9 posts (1 P-5, 1 P-4, 1 P-3, 3 P-2/1 and 3 General Service (1 Principal level and 2 Other level)) to provide communications and information management services to the Department, including knowledge sharing; knowledge and information policy formulation; Web publishing; preparing and disseminating electronic newsletters and alerts; website development; multilingual Web content planning, coordination and preparation; publications support; managing electronic Web forums; systems analysis and

development; database design, construction and management; network administration; second-tier computer helpdesk support; information technology asset management; and videoconferencing; and (b) \$117,200 for other staff costs, contractual services, supplies and materials and furniture and equipment. The decrease of \$549,700 results from a reduction of \$498,700 in requirements for posts owing to the outward redeployment of 1 D-1 and 1 General Service (Principal level) post, offset by the inward redeployment of 1 General Service (Other level) post, and a reduction in requirements for other staff costs (\$11,000), contractual services (\$20,000) and supplies and materials (\$20,000) owing to stringent use of resources.

### 3. Capacity Development Office

#### Resource requirements (before recosting): \$1,693,100

9.105 The Capacity Development Office provides management and operational support to the implementation of the Department's capacity development strategy, ensuring effective translation of intergovernmental guidance into the Department's capacity development activities. In the biennium 2012-2013, the Office will continue to coordinate the Department's operational activities for development and support integrated programming, financial and administrative support for the capacity development programmes and projects implemented by the Department, including its extrabudgetary project portfolio, the regular programme of technical cooperation and the Development Account. The Office will continue to support the Under-Secretary-General in his role as programme manager of the Development Account, which includes, in this biennium, the active management of over 100 Development Account projects at various stages of implementation financed under three tranches.

- 9.106 The amount of \$1,693,100 provides for 5 posts (1 D-1, 1 P-5, 2 P-4 and 1 General Service (Other level)) to assist the Under-Secretary-General with the management of the development account and the implementation of the Department's capacity development programmes and projects. This provision, which reflects the delayed impact of 2 new posts established in 2010-2011, includes the inward redeployment of 1 D-1 post from the Information Support Unit, formerly referred to as the Communications and Information Management Service within programme support, as well as the inward redeployment of 1 P-4 post and 1 General Service post from the Executive Office.
- 9.107 During the biennium 2012-2013, projected extrabudgetary resources of \$131,200,000 represent the operational portfolio which delivers the capacity development activities of the Department, funded under donor arrangements. The decrease of \$5,985,500 is due to an anticipated decline in voluntary contributions based on the current portfolio, pipeline projects and donor funding.

### **Advisory Committee on Administrative and Budgetary Questions** (A/64/7)

The Advisory Committee notes that statistical activities carried out by the Department of Economic and Social Affairs appear under subprogramme 5, Statistics, of section 9; component 1, Economic and social affairs, of section 22, Regular programme of technical cooperation; and income section 3, Services to the public. The Committee requests the Secretary-General to clarify to the General Assembly the basis for the distribution of resources devoted to activities related to statistics (para. IV.16).

The activities of the Statistics Division are carried out in accordance with the general mandate of the Division, namely (a) to disseminate high-quality data, (b) to support the Statistical Commission in its normative role regarding statistical standards and methods, (c) to support Member States in strengthening their national statistical capacity and (d) to facilitate coordination of the statistical programmes of the United Nations system. The rationale for the distribution of resources devoted to activities related to statistics is as follows:

- 1. Activities funded under the programme budget (subprogramme 5, Statistics, of section 9) are geared towards the objective of expanding the normative and coordinating role of the Statistics Division.
- 2. Activities funded under the regular programme of technical cooperation are intended to strengthen the national statistical system of developing countries.
- 3. Activities funded under income section 3 are directed at ensuring the quality of data used in revenue-generating products, such as the United Nations commodity trade statistics database, the database for industrial statistics and the classifications registry. This important dimension of the programme sustains the level of quality required to generate revenue from these products.

The Advisory Committee was informed that the Department had undertaken efforts to enhance coherence in delivery, increase strategic collaboration across subprogrammes and proactively address the "silo" mentality and to build a stronger team spirit. Furthermore, it had made efforts to improve communication and promote transparency within the Department. The Committee expects that the results of these efforts will be reflected in the next budget submission (para. IV.12).

Efforts continued to increase strategic collaboration, communication and transparency within the Department. The Strategic Planning Unit, for example, facilitated greater collaboration among the divisions on crosscutting issues like youth, conflict, disaster and development, and led the preparation of the Department's implementation plan for followup to the 2010 Millennium Development Goals Summit. Wide-ranging consultations were undertaken with divisions in drafting the plan and an annual review of the plan will be


Action taken to implement the recommendation

The Advisory Committee was informed that the Department had established, under the joint leadership of division directors, three internal working groups: on the financial crisis, on climate change and on the summit to be held in 2010 on the Millennium Development Goals. The Committee was also informed that the Department served as the convener of the Executive Committee on Economic and Social Affairs, which brings together all Secretariat entities dealing with development. In addition, discussions with the United Nations Conference on Trade and Development are ongoing to establish a joint work programme, and efforts to re-establish the partnership agreement with UNDP are under way. The Committee welcomes those efforts and recommends that the Secretary-General provide information on the work of those entities in the proposed programme budget for the biennium 2012-2013 (para. IV.14).

initiated. A Department-wide network was established for supporting international years.

Three internal departmental working groups, on the financial crisis, climate change and the 2010 Millennium Development Goals Summit, met regularly and prepared cross-divisional papers and reports, thus enhancing coherence and strengthening departmental performance in these areas.

The Department strengthened its monitoring and evaluation capacity through monitoring and evaluation training programmes for divisional focal points, including review of gender dimensions in monitoring and evaluation processes. The Department conducted self-evaluations and self-assessments and reported on the implementation of evaluation activities.
