Appointments to fill vacancies in subsidiary organs and other appointments

Appointment of members of the Advisory Committee on Administrative and Budgetary Questions

Note by the Secretary-General

1. The Secretary-General has received notification of the resignation of Namgya C. Khampa (India) from the Advisory Committee on Administrative and Budgetary Questions, effective 11 February 2013. Accordingly, the General Assembly will be required to appoint, at its current session, a person to fill the vacancy for the remaining period of the term of office of Ms. Khampa, which expires on 31 December 2013.
2. The Government of India has nominated Vinay Kumar to fill the vacancy arising from the resignation of Ms. Khampa.
3. In a communication dated 22 February 2013, the Secretariat was informed by the Chair of the Group of Asia-Pacific States that the candidature of Mr. Kumar had been endorsed by the Group.
