Overall orientation

- 18A.1 Since the adoption in June 2012 of the Economic Commission for Africa (ECA) biennial programme plan for the biennium 2014-2015 by the Committee for Programme and Coordination, a number of important developments at the global and regional levels have necessitated a revision of the plan and its related proposed programme budget for 2014-2015 to enable the Commission to respond effectively to the new developments. Key among these are the outcomes of the United Nations Conference on Sustainable Development and the consultations on a post-2015 development agenda. At the regional level, a new leadership at the African Union Commission, coupled with the prospects of an emergent Africa have created a new reality for ECA, making it necessary for the institution to reposition and recalibrate itself to ensure that it responds to the evolving needs and demands of its member States in a rapidly changing global environment. submission, therefore, reflects the main outcomes of the review and consultations undertaken by the new ECA leadership to establish a new strategic direction and programme structure for the Commission, in response to the new priorities of its member States. The mandate for these changes was provided in resolution 908 (XLVI), adopted at the forty-sixth session of ECA held in Abidjan on 25 and 26 March 2013, as part of the sixth joint annual meetings of the African Union Conference of Ministers of Economy and Finance and the ECA Conference of African Ministers of Finance, Planning and Economic Development. The mandate is derived from the decision of the Assembly of Heads of State and Government of the African Union at its twentieth ordinary summit (Assembly/AU/Dec.450 (XX)) in January 2013, which endorsed the refocusing of ECA to support the transformation agenda of Africa. Furthermore the Assembly called upon the Secretary-General to provide required support to ECA to enhance its work in accordance with Africa's priorities.

- 18A.2 The overall objective of the programme is to assist African countries in formulating and implementing policies and programmes that will lead to sustainable economic growth and inclusive development, with particular emphasis on accelerating structural transformation, in line with the priorities of the New Partnership for Africa's Development (NEPAD), as well as the internationally agreed development goals, including those contained in the United Nations Millennium Declaration (General Assembly resolution 55/2), and in the outcomes of other major United Nations conferences and international agreements since 1992.
- 18A.3 The mandate for the programme derives from Economic and Social Council resolution 671A (XXV), by which the Council established ECA. The mandate has been further elaborated on in a number of General Assembly and Economic and Social Council resolutions, as well as in ECA resolutions 718 (XXVI), 726 (XXVII), 779 (XXIX), 809 (XXXI) and 844 (XXXIX). Further mandates have emanated from the African Union and the outcomes and decisions of major global conferences and summits, which include the 2005 World Summit Outcome; the 2012 United Nations Conference on Sustainable Development and the quadrennial comprehensive policy review of operational activities for development of the United Nations system.
- 18A.4 Africa has made remarkable progress in advancing economic and social development in recent years. For eight years prior to the financial and economic crisis, real gross domestic product grew consistently at an average rate of 5 per cent per annum, making the continent one of the fastest growing regions of the world. The continent's swift and relatively strong recovery from the global financial and economic crises, coupled with the progress on the social and political fronts, are driving a new spirit of optimism about Africa's prospects and potentials. There is hope that strong growth rates will translate into jobs, incomes and irreversible human development gains. Africa's enormous wealth will be used to foster equitable and inclusive growth and generate opportunities for all. Economic transformation and social progress will drive further improvements in democratic governance and accountability as the middle class grows and demands more of their leaders and service providers.
- 18A.5 Real gains have been made and Africa has an unprecedented opportunity for sustained economic growth, shared prosperity and poverty reduction. However, a number of important challenges remain and must be urgently addressed if Africa is to achieve much-needed structural transformation and diversification and translate high growth into meaningful poverty reduction. These include achieving higher, sustained and equitable growth; investment in human development, including: improving access to education, health and infrastructure; employment creation; boosting agriculture and food security; speeding up the pace of regional integration; promoting trade, including intra-African trade; and enhancing State and institutional capacities for improved economic management. Ensuring gender equality and building national statistical capacity should also remain a top priority. Resource mobilization is a critical cross-cutting challenge that must be addressed if Africa is to make progress in these areas.

- 18A.6 Africa continues to make steady progress towards internationally agreed goals, including the Millennium Development Goals. The continent is on track to achieve universal primary education (Goal 2), and gender equality and women empowerment (Goal 3). Enrolment in primary schools is up from 64 per cent in 2000 to 87 per cent in 2010. Women across Africa are becoming more empowered, with more girls attending both primary and secondary school, and more women in positions of political power. Although most African countries are unlikely to achieve the health targets of the Millennium Development Goals, the rate of progress has accelerated in recent years. For instance, mortality rates for children under five years of age declined by almost 40 per cent between 1990 and 2011. HIV/AIDS prevalence rates fell from 5.9 to 4.9 per cent during the period 2001 and 2011. Maternal mortality improved by 42 per cent between 1990 and 2010. Poverty is also on the decline, falling below 50 per cent in 2008 (to 47.5 per cent) for the first time. The absolute number of poor people also declined for the first time in 2008. Increased growth rates, underpinned largely by the oil and primary commodity exports sectors, have played a role in the decline in poverty. With the Millennium Development Goals target date of 2015 fast approaching, much needs to be done to accelerate the pace of progress towards their achievement and to minimize inequalities in access to vital social services without compromising the quality of such services. Invariably, the post-2015 agenda must reorient the development paradigm towards a sustainable and inclusive pathway. For Africa, the overarching priority is for a transformative agenda that promotes sustainable and inclusive growth that is underpinned by human development, technological adaptation and innovation and facilitated by an enabling internal and global environment.
- 18A.7 The overriding policy challenge facing the continent, therefore, is to sustain the current positive trends to drive inclusive, broad-based growth and development to achieve structural transformation. Sustaining these trends will depend critically on a favourable international environment that supports Africa's special needs — particularly in climate change, international trade and enhancing the continent's voice in key global decision-making forums and processes.
- 18A.8 In line with its mandate and in response to growing demand from member States for its services, ECA has taken steps to reposition itself and refocus its programmes to make them more responsive to the transformative agenda of the continent. Following extensive consultations with a wide range of stakeholders, which included senior policymakers of the member States, a comprehensive internal review of the programme of work and priorities was undertaken, which resulted in a revised strategic direction for the Commission's work, involving changes to its programmes, organizational structure, management and administrative processes. In this regard, it is proposed that the overall ECA programme of work be organized around nine interdependent and complementary subprogrammes that reflect the substantive priorities of member States, as reflected in the NEPAD programme: 1, Macroeconomic policy; 2, Regional integration and trade; 3, Innovations, technologies and management of Africa's natural resources; 4, Statistics; 5, Capacity development; 6, Gender and women in development; 7, Subregional activities for development; 8, Development planning and administration; and 9, Social development policy.
- 18A.9 The nine subprogrammes, which are a reconfiguration of the former subprogrammes, are aimed at allowing ECA to specialize and focus on areas of comparative advantages in economic and social development. Through specialization, the work of ECA would not duplicate activities that are better undertaken elsewhere including in the African Union or in United Nations specialized agencies. Another important consideration relates to clustering issues from the perspective of their potential contribution to regional integration. The new strategic direction will also ensure adequate emphasis on supporting African countries to overcome identified gaps in planning, statistics, contract negotiations and helping them to adjust to mega-trends, such as urbanization, shifting demographics and challenges of environmental sustainability. Linked to this is the need to place

more emphasis on social development in accordance with the original mandate of ECA, while avoiding duplication of social programmes of specialized agencies.

- 18A.10 *Macroeconomic policy.* The subprogramme on macroeconomic policy will focus on conducting research and normative work to support African member States in transforming their economies from low to middle-income status. The subprogramme will also conduct applied research with the outcomes used to provide sound macroeconomic policy to member States to achieve high-level and sustainable growth, employment creation and poverty reduction. In refocusing the work of ECA with a view to avoiding duplication and concentrating on comparative advantage to the Commission, the subprogramme would also focus on economic governance. By bringing the work of governance from the former subprogramme 3, ECA will use its comparative advantage to undertake work in areas of economic governance, including contract negotiation of the extractive industries, regulation of markets and policies to prevent rent-seeking activities.
- 18A.11 *Regional integration and trade.* The subprogramme on regional integration and trade will place emphasis to the central role of regional integration in African development by promoting the nexus between trade, industry, agriculture, land, infrastructure and investment and supporting African countries to boost intra-Africa trade and participate effectively in international trade. The focus of the subprogramme will be on conducting analytical research in the areas of: (a) industrialization and infrastructure; (b) investment; (c) food security, agriculture and land; and (d) trade. The research will focus on regional approaches to tackling the challenges in these areas so as to promote regional integration as a strategy for economic development. In this regard, the Action Plan for the Accelerated Industrial Development of Africa, the African Agribusiness and Agro-industries Development Initiative, the Programme for Infrastructure Development in Africa and the Comprehensive Africa Agriculture Development Programme will guide the subprogramme in undertaking research on how the economies of African countries could be transformed from the current low income to middle income levels.
- 18A.12 *Innovations, technologies and management of Africa's natural resources.* The subprogramme on innovations, technologies and management of Africa's natural resources aims at undertaking research and analytical work on the use of innovations and technological systems as an engine of economic growth. The subprogramme will also continue to support gender sensitive strategies for building and sustaining Africa's digital economy and creating an enabling environment for the knowledge economy through evidence-based research that assists African countries to formulate, implement and evaluate information and communications technology and science and technology policies and strategies. Within the framework of NEPAD priorities, the subprogramme will promote the mainstreaming of technology and innovations in national and subregional development policies and strategies. It will work closely with other subprogrammes, particularly subprogramme 1, in implementing the outcomes of the United Nations Conference on Sustainable Development, including: supporting countries in the establishment of sustainable development goals; financing sustainable development in Africa; technology development, transfer and deployment; and capacity-building and institutional strengthening for sustainable development in Africa. New emphasis will be placed on cross-sectoral issues and intersectoral linkages. In line with the role assigned to the regional commissions at the Conference, a systematic effort will be made by this subprogramme, in close collaboration with the other subprogrammes, to further integrate the three dimensions of sustainable development into the ECA work programme. In addition to this core approach, the biennial event on sustainable development, the Africa regional implementation meeting, will be upgraded to a high-level political forum on sustainable development at the regional level, that will address issues calling for joint consideration of economic, social and environmental aspects, and provide an opportunity for region-wide policy dialogue among policymakers and other actors from the three constituencies. Lastly, the subprogramme will focus on research and analytical work on mineral resources development and a

green economy, and on strengthening the capacity of African countries to participate more effectively in international climate negotiations.

- 18A.13 *Statistics.* The subprogramme on statistics has been enhanced to strengthen the ability of African countries to formulate sound evidence-based policies. It will increase the use of modern technology to collect, compile and use quality, comparable and harmonized statistics to: (a) monitor progress towards the implementation of set development objectives, including internationally agreed goals, such as the Millennium Development Goals; and (b) support regional integration, including harmonization of methods for censuses, surveys, national accounts, economic classifications, and development indicators, in compliance with international methodologies. The subprogramme will increase its support to African countries to improve their statistical operations, including conducting censuses and surveys and making the data and information products available to users promptly. Special attention will be given to the efficient use of administrative data, such as civil registration and vital statistics, which are necessary for producing gender-disaggregated and gender-responsive statistics, evidence-based service delivery procedures, and monitoring and reporting of progress towards internationally agreed development goals. The subprogramme will also continue its role in the implementation of the African Statistics Charter designed by the African Union Commission and the Strategy for the Harmonization of Statistics in Africa. With a view to improving the quality of data, the subprogramme will work with national statistical offices to implement modern data-collection practices using hand-held devices and other modern information and communications technology-based tools and methodologies.
- 18A.14 *Capacity development.* The subprogramme on capacity development will play a vital role in ensuring that the key policy findings in ECA research are used to support policy implementation at the national, subregional and continental levels. It will do so by strengthening the capacity of member States, regional economic communities and the African Union to implement their development priorities. Unlike programme 9 of the United Nations, which focuses on advocacy for United Nations support for NEPAD, this subprogramme is geared towards strengthening the capacity of the African Union and its organs, including the African Union Commission, the NEPAD Planning and Coordinating Agency, the secretariat of the African Peer Review Mechanism and the regional economic communities, in deepening and advancing the African Union's agenda of continental integration. The strategy will also focus on strengthening the capacities of African countries and their development organization in formulating and implementing appropriate policies and programmes for achieving the internationally agreed development goals. In collaboration with the subregional offices of ECA, the subprogramme will jointly undertake multi-year programmes and activities with the regional economic communities. The subprogramme will also scale up its assistance to member States in the implementation of the African Peer Review Mechanism, particularly in building and maintaining a credible database on relevant information as well as supporting the governance architecture of the African Union.
- 18A.15 *Gender and women in development.* The research and analytical work of the subprogramme on gender and women in development will focus on gender inequality and persisting gender gaps and their challenges to development in Africa. It will also address the systemic sociocultural barriers and their impact in limiting the capacity of member States to put in place legislative, policy, and institutional changes that promote gender equality and women's empowerment. The subprogramme will enhance its work on ending violence against women and support the efforts of member States to mainstream gender and development in national programmes. Partnership with the subprogramme on statistics will be strengthened to collect and collate gender statistics to determine the impact of programmes on gender equality and women's empowerment. The work of the subprogramme will also address the gender dimensions of trade and climate change.

- 18A.16 *Subregional activities for development.* The subprogramme on subregional activities for development will be delivered through the five subregions of Central, East, North, South and West Africa. It will strengthen the capacity of member States to formulate evidence-based plans and policies in the respective subregions through the production and dissemination of quality and timely statistics to essentially produce on a periodic basis, country profiles and risk analyses to inform policy and decision-making. This subprogramme will also promote the design and implementation of subregional development initiatives. Hence, it will be enhanced to focus on data collection, production of country risk and political profiles and special initiatives.
- 18A.17 *Development planning and administration.* The subprogramme on development planning and administration will be the focus for training activities to improve public sector management with particular regard to economic policy formulation, analysis, implementation, monitoring and evaluation. It will also be used to improve and strengthen national visioning and development planning in member States.
- 18A.18 *Social development policy.* The subprogramme on social development policy has been enhanced to mainstream human development and concerns, such as employment, population, social protection and youth issues, into regional and national policies and strategies. Activities in these vital areas will be complemented by promoting a better understanding of the delivery of social services in the context of urban planning and management. The subprogramme will undertake work on accelerating the process of achieving the goals set out in the United Nations Millennium Declaration and the outcomes of the United Nations Conference on Sustainable Development. In addition, it will undertake work in population movements, including internal and international migration, population displacements and redistribution, and their linkages to economic and social development, as well as the opportunities and challenges of urbanization.
- 18A.19 The modalities for implementation will include a combination of policy research to generate knowledge, advocacy and consensus-building, advisory services and technical cooperation. ECA will deliver these services through economic and social analyses and the preparation of reports to monitor and track the progress of Africa on global and regional commitments; formulation of policy recommendations, guidelines and standards to support policy dialogue; organization of policy dialogue to facilitate consensus-building and adoption of common regional positions on key issues; and providing technical assistance and capacity-building in the form of advisory services and training to disseminate best practices. The Commission will continue to ensure the high quality and impact of its outputs by strengthening its quality assurance processes.
- 18A.20 As part of the implementation strategy, the research and analytical work of ECA will be sharpened and will aim at producing analyses that are more policy-oriented and issue-oriented, to offer a good basis for policy dialogue among member States. The analyses will be supported by reliable statistics on African countries — a revamped area of work which will consist of selecting and gathering primary data for indicators relating to all aspects of the work of ECA to be made available to end users. This will result in the introduction of country profiles and risk analyses on the political, economic, social and environmental conditions of African countries, a new recurrent publication to be prepared by the subregional offices.
- 18A.21 Policy dialogue and exchange of country experiences will be strengthened in all the subprogrammes. A major objective will be to foster policy dialogue among member States through the Conference of Ministers and other conferences and seminars in order to distil policy best practices for wider replication in the region. Furthermore, new activities corresponding to issues emerging from recent global and regional conferences will be undertaken in such areas as natural resources development and management, promoting sustainable energy, green economy policies, industrialization and urbanization.

- 18A.22 With a view to responding to the enhanced role of the regional commissions resulting from the new mandate on the quadrennial comprehensive policy review, capacity development and technical assistance will be streamlined and will focus on the specific needs and priorities of Africa's least developed, landlocked and island developing countries, as well as countries emerging from conflict or natural disasters. A coherent strategy for identifying the needs of these countries and to determine activities responding thereto will be adopted to increase those countries' chances of graduating to middle-income status. Technical assistance will be demand-driven, results-oriented and evaluated. It will be provided for both individual countries and groups of countries. An improved strategy and mechanism will be put in place for prioritizing technical assistance for the biennium 2014-2015.
- 18A.23 In implementing the programme, ECA will leverage its comparative strengths to engage a wide range of partners from within and outside the United Nations system in order to maximize the impact of its work. To this end, the Commission will continue to be involved in the work of the Executive Committee on Economic and Social Affairs, as the main vehicle for ensuring policy and operational coherence in United Nations development activities, as well as enhancing collaboration with United Nations Development Group entities. ECA will also continue to build on its existing partnerships with the African Union, the African Development Bank (AfDB) and other regional organizations, as well as with African civil society and private sector organizations. In addition, ECA will strengthen its collaboration with the NEPAD Planning and Coordinating Agency, as a technical body of the African Union, to strengthen its capacity to implement its programmes within the context of the Ten-Year Capacity-Building Programme for the African Union. Inter-agency coordination and collaboration among United Nations agencies working in Africa will continue to be strengthened through the Regional Coordination Mechanism of United Nations agencies convened by ECA in support of the African Union and its NEPAD programme at the regional and subregional levels. In addition, it will work closely with other regional commissions to develop joint initiatives and inputs, with a view to strengthening the regional dimension in global development. At the national level, ECA will work closely with the United Nations resident coordinator system to exploit the inherent strengths of the funds and programmes at that level.
- 18A.24 To address gender disparities in development, the programme plan for 2014-2015 emphasizes the mainstreaming of gender into national development policies and strategies. To this end, the full implementation of the Beijing Declaration and Platform for Action will remain a major area of focus. ECA will actively promote the mainstreaming of a gender perspective in the design, implementation, monitoring and evaluation of policies and programmes in political, economic and social spheres. A gender perspective has also been integrated into the expected accomplishments of all nine subprogrammes.
- 18A.25 Other key features of the restructuring include the realignment of activities, both within and across subprogrammes, to ensure coherence and complementarities in the programme. The new programme structure is designed to promote convergence by clustering together closely related thematic issues or priorities for better synergies and effective programme delivery. Similarly, the intergovernmental machinery will be revised to ensure that the subsidiary bodies are congruent with the new programme priorities and structure. In this regard, the following intergovernmental machinery of the Commission will be maintained: (a) Conference of African Ministers of Finance, Planning and Economic Development and its Committee of Experts; (b) Intergovernmental Committee of Experts of ECA subregional offices; (c) Committee on Gender and Social Development; (d) Committee on Sustainable Development; (e) Committee on Regional Cooperation and Integration; and (f) Committee on Statistics.
- 18A.26 Furthermore, across all the subprogrammes, there will be fewer and more productive meetings with a sharper focus and a reduction in outputs and activities of marginal utility. Workshops will also be

streamlined and delivered through the African Institute for Economic Development and Planning, thus allowing the substantive divisions at ECA headquarters to concentrate on conducting policy research that will inform the capacity development activities. Similarly, the number of publications will be substantially reduced in the new biennium, as a number of recurrent publications and reports will be dropped and others converted to non-recurrent publications. The reduction is also a result of the decision to increase the dissemination of information to the public through electronic means for all ECA publications, including through social media.

Overview of resources

- 18A.27 The overall resources proposed for the biennium 2014-2015 amount to \$139,266,600 before recosting, reflecting a net decrease of \$5,679,600, compared with the 2012-2013 budget at revised rates. Resource changes result from four factors, namely: (a) technical adjustments relating to the removal of non-recurrent requirements in 2012-2013; (b) new or expanded mandates and intercomponent changes; (c) resource changes in line with General Assembly resolution 67/248; and (d) resource changes reflected in the report of the Secretary-General on the budget outline 2014-2015.
- 18A.28 The proposed resources for the biennium 2014-2015 have been realigned with the new programme structure as detailed in programme 15 of the biennial programme plan which will be before the Committee on Programme Coordination at its fifty-third session. The organization chart in annex I reflects this realignment in its totality.
- 18A.29 The distribution of resources is reflected in tables 18A.3 to 18A.5 below.

Other assessed and extrabudgetary resources

- 18A.34 During the biennium 2014-2015, it is anticipated that extrabudgetary resources will amount to \$72,764,100, reflecting an increase of \$21,091,500 over the estimated \$51,672,600 under the biennium 2012-2013, which represents 52 per cent of the overall requirements for ECA, which will be mobilized mostly from bilateral sources under agreements between ECA and global and regional institutions and organizations concerned with African development. In recent years, ECA has seen a surge in extrabudgetary resources, owing to increased confidence by its partners in the enhanced work of ECA in support of Africa's development and the improved management of these resources. Extrabudgetary resources will complement resources from the regular budget to finance technical cooperation activities and build the capacity of member States in a number of priority areas, such as macroeconomic policy, industrialization, development planning, trade, and natural resources contracts negotiation.
- 18A.35 The projected increase of \$51,672,600 is mainly due to the estimated increase of 85 posts from the 141 posts estimated for the biennium 2012-2013 to 226 posts for 2014-2015, to be financed from extrabudgetary resources. The outputs in support of the proposed programme of work are described under the various subprogrammes.

Other information

- 18A.36 Monitoring and evaluation provide regular feedback on programme performance, help to facilitate the management and decision-making processes, and contribute to managing results. Monitoring of activities and evaluations take place at the programme, subprogramme and project levels to track implementation of outputs and progress towards the achievement of objectives and expected accomplishments. Two categories of evaluations are typically conducted and include: (a) external evaluations, which are managed and conducted by entities outside ECA, such as the Office of Internal Oversight Services; and (b) internal evaluations, undertaken by ECA.
- 18A.37 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation are estimated at \$2,218,900, representing 146 work-months estimated at \$1,399,200 for staff and \$819,700 for non-post requirements. This amount consists of \$1,520,000 from the regular budget and \$698,900 from extrabudgetary resources.
- 18A.38 Resources for business continuity activities will be utilized for implementing various activities, such as: maintaining a dedicated personnel for pandemic preparedness; conducting first aid, trauma, emergency response training at ECA headquarters and subregional offices; conducting independent business continuity plan assessment and business continuity preparedness assessment at ECA subregional offices; upgrading of the disaster recovery site currently located at the United Nations Office at Nairobi; providing support and equipment (including maintenance) to critical staff, and maintaining the relevant level of supplies necessary to respond to crisis or emergency situations.
- 18A.39 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued in both print and electronic, as summarized in table 18A.8 below and as distributed in the output information for each subprogramme.

- 18A.40 Inter-agency coordination and collaboration among United Nations agencies working in Africa will continue to be strengthened through the Regional Coordination Mechanism of United Nations agencies convened by ECA in support of the African Union and its NEPAD programme at the regional and subregional levels. In addition, it will work closely with other regional commissions to develop joint initiatives and inputs, with a view to strengthening the regional dimension in global development. At the national level, ECA will work closely with the United Nations resident coordinator system to exploit the inherent strengths of the funds and programmes at that level.

A. Policymaking organs

Resource requirements (before recosting): \$902,700

- 18A.41 The institutional changes and restructuring at ECA also involved a review of the Commission's intergovernmental machinery to align it with the new programme orientation. The changes resulted in the elimination of overlapping bodies, merging of closely related bodies and creation of new organs. These changes will lead to a more streamlined, cost-effective and coherent intergovernmental structure, closely aligned with the structure of the African Union and characterized by well planned and better prepared meetings. Following the restructuring, the intergovernmental machinery of the Commission should consist of the following bodies:

1. Organs dealing with overall development issues

Conference of African Ministers of Finance, Planning and Economic Development and its Committee of Experts

- 18A.42 The Conference of African Ministers of Finance, Planning and Economic Development provides legislative mandate and policy guidance to the work of the Commission, considers and endorses the work programme of the ECA secretariat, serves as a forum for articulating the position of Africa on development issues on the agenda of the United Nations, and decides on the recommendations of its subsidiary bodies and of the Executive Secretary. The Conference meets on an annual basis. Since 2008, the annual session of the Conference has been organized jointly with the African Union Conference of African Ministers of Economy and Finance to achieve greater coherence in articulating Africa's position on key development issues.
- 18A.43 The Committee of Experts meets prior to the Conference and provides technical support to it. The Bureau of the Commission includes a representative from each of the five subregions of the continent, namely, North Africa, East Africa, Southern Africa, West Africa and Central Africa. It consists of a chairperson, three vice-chairpersons and a rapporteur elected on a subregional basis.

Intergovernmental Committees of Experts of ECA subregional offices

- 18A.44 The five Intergovernmental Committees of Experts of the five subregional ECA offices meet annually prior to and report to the Conference of African Ministers of Finance, Planning and Economic Development through the Committee of Experts. They oversee the overall formulation and implementation of the programme of work and priorities of the respective subregional offices, make recommendations on issues concerning economic and social development in their respective subregions, as well as on the promotion and strengthening of subregional economic cooperation and integration. Whenever the need arises, meetings are held back-to-back with major ministerial conferences of the regional economic communities, in order to provide a platform for subregional ministerial caucuses to discuss specific subregional development challenges. The outcomes of such meetings are brought to the attention of the Conference of African Ministers of Finance, Planning and Economic Development.

2. Functional and sectoral subsidiary organs of the Commission

Committee on Gender and Social Development

- 18A.45 The role of the Committee on Social Development, as an advisory forum of experts and policymakers, is to provide guidance to the Commission in its work of promoting equitable and inclusive human and social development in Africa, with particular focus on gender, employment, population and youth development, social protection and urbanization. The Committee reviews follow-up activities pertaining to global conferences and regional action programmes in the areas

of social development, including the global and regional platforms for action on the advancement of women. It also reviews major trends and issues of regional interest regarding human and social development. The Committee meets biennially.

Committee on Sustainable Development

- 18A.46 The Committee serves as a forum of experts that provides advice to the Commission in integrating the economic, social and environmental dimensions of sustainable development in line with the outcome of the United Nations Conference on Sustainable Development. In this regard, the Committee will provide guidance to the work of ECA in the interlinked areas of food security, agriculture, land, climate change, including green economy policies and natural resources development and management. In response to the mandate from the Conference on promoting a balanced integration of the three dimensions of sustainable development, the members of the Committee will comprise experts and policymakers representing the three constituencies: economic, social and environment. The Committee meets on a biennial basis. The outcomes of its meeting will feed into the Africa regional implementation meeting, which has been upgraded to a high-level political forum on sustainable development at the regional level.

Committee on Regional Cooperation and Integration

- 18A.47 The Committee promotes the implementation of measures designed to strengthen economic cooperation and integration among African countries. It coordinates and harmonizes policies and programmes among African countries as a prerequisite for accelerating regional economic integration, with particular focus on critical sectors such as trade and investment policy, as well as infrastructure and industrialization. It comprises experts in the field of trade and integration drawn from Governments and the private sector. It meets on a biennial basis.

Committee on Statistics

- 18A.48 The Committee, composed of experts and policymakers in the field of statistics, is responsible for providing strategic direction to the work of the Commission on statistics and statistical development in Africa, covering all the relevant fields of statistics. The members of the Committee include experts from such fields as statistics, planning, information and communications technology, including geo-information. The Committee meets on a biennial basis.
- 18A.49 With the exception of the Commission, which meets in a six-day annual session, all intergovernmental organs of the Commission will meet for a duration ranging from three to five days.
- 18A.50 The distribution of resources for policymaking organs is reflected in table 18A.9 below.

- 18A.51 The resource requirements in the amount of \$902,700 provide for temporary assistance for meetings, overtime, communications and supplies and materials required for servicing the session of the Commissions and its subsidiary bodies.

B. Executive direction and management

Resource requirements (before recosting): \$15,623,100

- 18A.52 Executive direction and management comprises the Office of the Executive Secretary, the Strategic Planning and Operational Quality Division, the Public Information and Knowledge Management Division, Business Continuity, and the Office of Partnership.
- 18A.53 The Office of the Executive Secretary provides overall strategic direction and leadership for the efficient management and effective implementation of the ECA programme of work, while ensuring the optimal use of resources. The Executive Secretary and the two Deputy Executive Secretaries work together to provide strategic direction, policy guidance and leadership to the formulation of regional strategies and programmes aimed at translating Africa's return to the path of growth over the past decade into a comprehensive project of transformative development agenda, in line with the priorities of NEPAD, the Millennium Development Goals, and other regional and international development commitments.
- 18A.54 The Office maintains and manages effective partnerships and collaboration with major African continental organizations in particular, the African Union Commission and AfDB, the regional economic communities as well as other key stakeholders in order to promote synergies in policies and activities on major regional development issues and concerns for Africa. It fosters African ownership and consensus-building on emerging and urgent development policy issues facing the continent, and promotes policy advocacy on Africa in the international community. The Office promotes the effective coordination of the role of the United Nations in Africa by maintaining regular consultations with organizations of the United Nations system working in Africa to promote concerted action on United Nations-system activities including the annual session of the Regional Coordination Mechanism in the region. It also strengthens collaboration with the other regional commissions with a view to sharing experiences, and coordinating and harmonizing actions on issues of mutual and collective interest.
- 18A.55 Furthermore, the Office will introduce a new initiative — the senior research fellowship scheme — the primary objective of which is to establish and promote an interface between the work of the Commission and policymakers and academics working in the same areas. The programme will develop a network of fellows whose work will contribute to ECA knowledge management activities as material and inputs for policy analysis and decision-making.
- 18A.56 The Office of the Executive Secretary also provides policy direction to the organization of the annual session of the Commission and ensures effective implementation of action emanating from resolutions and decisions of the Commission, the Economic and Social Council and other intergovernmental organizations. It provides policy guidance to the five ECA subregional offices and the African Institute for Economic Development Planning to ensure that they are responsive to the needs of member States and their major intergovernmental institutions, including the regional economic communities. In addition, it ensures that there are effective synergies between them and ECA substantive divisions at headquarters to deliver as one.
- 18A.57 The Office also oversees and coordinates the Commission's contribution to the effective functioning of the tripartite joint secretariat partnership between ECA, AfDB and the African Union Commission under the aegis of the tripartite Joint Secretariat Support Office. Through the Joint Secretariat, the Office works closely with its leading regional institutional partners on the implementation of a number of special initiatives, such as the African Development Forum, the Coalition for Dialogue on Africa, the Strategic Partners Forum, the mutual accountability process, and the high-level policy forums designed to reinforce the work of the Commission and thus provide further impetus to Africa's development agenda. At the same time, the Office assists in

servicing the meetings of the Joint Secretariat and its related working groups, and enhancing liaison and processes of institutional cooperation, as well as the monitoring of progress being made in implementation of the Joint Secretariat programmes and special initiatives.

- 18A.58 The Office also plays a critical leadership and oversight role in terms of ECA support to the African Peer Review Mechanism and the overall NEPAD process. It leads the resource mobilization efforts of the Commission in the context of the ECA partnership agenda, and ensures that resources mobilized are put to effective use to advance the development of Africa.
- 18A.59 The Strategic Planning and Operational Quality Division includes the Programme Planning and Budgeting Section, the Evaluation Section and the Operational Quality Section. The Division supports and advises the Executive Secretary on the overall strategic direction and priorities in the areas of programme planning, budgeting, monitoring and evaluation and operational quality assurances, including reporting on the implementation of all ECA programmes within a results-oriented framework to ensure organizational effectiveness.
- 18A.60 The Budget Unit was moved from programme support to executive direction and management to work together with programme planning under the new Programme Planning and Budgeting Section. The section was established to provide better synergy and coordination in terms of planning and preparation of an integrated programme of work of ECA, including preparation of the biennial programme plan and programme budget.
- 18A.61 The Public Information and Knowledge Management Division comprises the External Communications and Media Relations Section. The Publications and Documentations Section, Information Technology and Umoja Support Section, and Library and Knowledge Services Section are budgeted under programme support but report directly to the Public Information and Knowledge Management Division. The Division brings together the related strategies for public information, communication, information technology, library services and knowledge management, which will address key areas of the building blocks for policy research and knowledge delivery.
- 18A.62 The Office for Partnerships coordinates the ECA partnerships and technical cooperation programme. It also manages technical cooperation projects and funds, builds and maintains partnerships between ECA and its development partners and mobilizes extrabudgetary resources, and provides guidance and support to the substantive divisions and subregional offices in developing higher quality demand-driven technical cooperation projects that are clearly linked with the Commission's normative and analytical work and that clearly feed into the achievement of the Commission's expected accomplishments and handles project appraisal, monitoring and evaluation of technical cooperation projects.
- 18A.63 The business continuity activity at ECA ensures continuity of the Commission's critical operations at all times, including when faced with such risks as threat of a pandemic, the localized sudden onset of a disaster, technological failures or military or terrorist-related incidents.

- 18A.67 The resource requirements under posts, estimated at \$12,306,200 and reflecting an increase of \$489,400, would provide for 52 posts (1 Under-Secretary-General, 2 D-2, 3 D-1, 7 P-5, 8 P-4, 10 P-3, 1 National Professional Officer and 20 Local level). The increase is due to the proposed establishment of one D-2 post of Deputy Executive Secretary, to address the Commission's flat senior management structure which hinders active participation in the decision-making process both at the internal level of the Secretariat and at the level of the intergovernmental machinery of the United Nations. In particular, there are 16 D-1 posts in ECA that report directly to the Under-Secretary-General, which results in management bottlenecks that impede a more effective and optimal implementation of the work programme and the further strengthening of the high-end dialogue with member States. In addition, the Deputy Executive Secretary will be in charge of the policy research section of the organization, which includes subprogramme 1, Macroeconomic policy, subprogramme 2, Regional integration and trade, subprogramme 3, Innovations, technologies and management of Africa's natural resources, subprogramme 4, Statistics, subprogramme 6, Gender and women in development, and subprogramme 9, Social development policy.
- 18A.68 The amount of \$3,316,900, reflecting a decrease of \$61,300, would provide for non-post requirements, under other staff costs, consultants, travel of staff, contractual services, general operating expenses, supplies and materials, and furniture and equipment. The decrease is due to reduced requirements for business continuity.
- 18A.69 The estimated extrabudgetary resources of \$7,393,500, which provide for 24 posts (1 D-1, 2 P-4, 4 P-3, 2 P-2, 3 National Professional Officer and 12 Local level), will contribute towards the provision of support services to substantive projects and programmes in the areas of conceptualization, formulation, monitoring and evaluation and preparation of periodic progress reports on the implementation of projects. They will contribute towards the achievement of the expected accomplishments and the delivery of planned outputs under executive direction and management.

18A.75 The resource requirements under posts, estimated at \$6,446,500 and reflecting a decrease of \$611,500, will provide for 28 posts (1 D-1, 4 P-5, 6 P-4, 5 P-3, 2 P-2 and 10 Local level). The decrease relates to the abolishment of two P-3 posts and one Local level post, in line with General Assembly resolution 67/248, as reflected in table 18A.6, item 1, of the present report.

18A.76 The amount of \$938,200, reflecting a decrease of \$84,300 for external printing, provides for non-post requirements under other staff costs, consultants, experts, travel of staff and contractual services. The decrease under external printing is in line with General Assembly resolution 67/248, as reflected in table 18A.6, item 2, of the present report.

18A.82 The resource requirements of \$5,877,700, reflecting a decrease of \$445,700, would provide for the continuation of 27 posts (1 D-1, 3 P-5, 4 P-4, 6 P-3, 3 P-2 and 10 Local level). The decrease is due to the abolishment of one P-5 post to partially offset the establishment of one D-2 post of Deputy Executive Secretary, under executive direction and management; and (b) the abolishment of one Local level post, in line with General Assembly resolution 67/248.

18A.83 Non-post requirements estimated at \$676,000, reflecting a decrease of \$10,000, will provide for other staff costs, consultants and experts, travel of staff and contractual services. 18A.140 The resource requirements of \$4,351,000, reflecting a decrease of \$744,200, will provide for 23 posts (1 D-1, 1 P-5, 4 P-4, 4 P-3, 2 P-2, 3 National Professional Officer and 8 Local level). The decrease is due to the abolishment of one P-5 Liaison Officer post and one P-4 Social Affairs Officer post, in line with General Assembly resolution 67/248, as reflected in table 18A.6, item 2, of the present report.

- 18A.141 Non-post requirements of \$1,959,500, reflecting a decrease of \$137,300, will provide for other staff costs, consultants and experts, grants and contributions, travel of staff, contractual services, supplies and materials, furniture and equipment and other general operating requirements. In particular, the resources will be used for the preparation, publication and dissemination of country profiles and risk analyses. The resources will also assist with the strengthening of capacity of the East African Community and the Intergovernmental Authority on Development to accelerate implementation of subregional initiatives.

Subprogramme 8 Development planning and administration

Resource requirements (before recosting): \$2,600,000

- 18A.143 Substantive responsibility for this subprogramme is vested in the African Institute for Economic Development and Planning based in Dakar. The subprogramme will focus on training activities to improve public sector management with particular regard to economic policy formulation, analysis, implementation, monitoring and evaluation. In doing so, the subprogramme will reinforce its collaboration with the five ECA subregional offices and the forging of partnerships with local universities, development training institutions, and development research centres, with a view to enhancing the Institute's ability to deliver its capacity development and training programmes locally in-country and/or subregionally.

During the biennium 2014-2015, the Division of Administration will continue to provide the services mentioned to ensure efficient support to the functions and services of ECA headquarters in Addis Ababa, the five subregional offices and the African Institute for Economic Development and Planning. The Division will also coordinate with the United Nations agencies, funds and programmes based in Ethiopia to support the United Nations common services framework.
- 18A.158 The key areas of focus will be the implementation of United Nations system-wide projects, such as the International Public Sector Accounting Standards (IPSAS); quality support to staff members in career advancement and development; further delegation of authority to the subregional offices in human and financial resource management; renovation of the United Nations Conference Centre and support to the new office facility, which will host an additional 650 staff of the United Nations system; coordination of emergency resilience and response support to almost 30 United Nations

agencies serving in the country; and greater coordination with the member organizations or offices to further strengthen the medical services provided at the United Nations Health Care Centre. In addition, the Division will continue to participate actively in the Secretariat-wide dialogue on priority themes, such as the future service delivery model, including shared service centres and mobility framework.

- 18B.1 The Regional Commissions New York Office serves as the focal point for all aspects of the substantive and operational activities of the five regional commissions with departments, offices and funds and programmes at United Nations Headquarters. As part of its outreach role on behalf of the commissions, it maintains regular contact with the permanent missions of States Members of the United Nations, relevant intergovernmental and non-governmental organizations, liaison offices of organizations of the United Nations system and the public in New York.
- 18B.2 The Office provides substantive and representational activities to the General Assembly and Economic and Social Council under agenda items relevant to the work of the regional commissions. Through its participation in these global intergovernmental meetings, the Office ensures that the mandates and activities of the regional commissions, which address a wide variety of economic and social issues, are taken into account in the deliberations and recommendations of the General Assembly, Economic and Social Council and subsidiary bodies. It participates in inter-agency and intersecretariat meetings, such as those of the United Nations System Chief Executives Board for Coordination, notably its policy and operational pillars, through the High-level Committee on Programmes and the United Nations Development Group, respectively, their subsidiary bodies, as well as the Executive Committee on Economic and Social Affairs, to ensure coherent, efficient and cost-effective representation of all the commissions, as well as improved harmonization and cooperation between the regional commissions and relevant United Nations organizations, including the funds and programmes and the specialized agencies. It provides the commissions with analysis and synthesis of developments as they occur during the intergovernmental and inter-agency meetings held at Headquarters, as well as policy recommendations relating to those developments.
- 18B.3 The Office assists in identifying global trends, challenges and opportunities with a bearing on the work and positioning of the regional commissions and provides strategic advice in this regard.  - (iii) Booklets, fact sheets, wallcharts, information kits: publications, in print and on the United Nations website, of a biennial newsletter which is circulated to delegations, relevant entities within the United Nations, funds, programmes and agencies of the United Nations system, other relevant institutions, and the general public (24);
 - (iv) Participation in meetings of the United Nations System Chief Executives Board for Coordination and other inter-agency meetings and activities, and contribution to joint activities (58); representation of the five regional commissions at inter-agency and interdepartmental meetings held at Headquarters; acting as the coordinating secretariat for interregional cooperation, which includes supporting the role of the current coordinator of the regional commissions, servicing the meetings of the Executive Secretaries, providing global advice at annual meetings of the chiefs of programme planning of the commissions, acting as a clearing house for the project proposals of the commissions funded from the United Nations Development Account and representing the commissions at meetings of the Steering Committee of the Development Account (10).

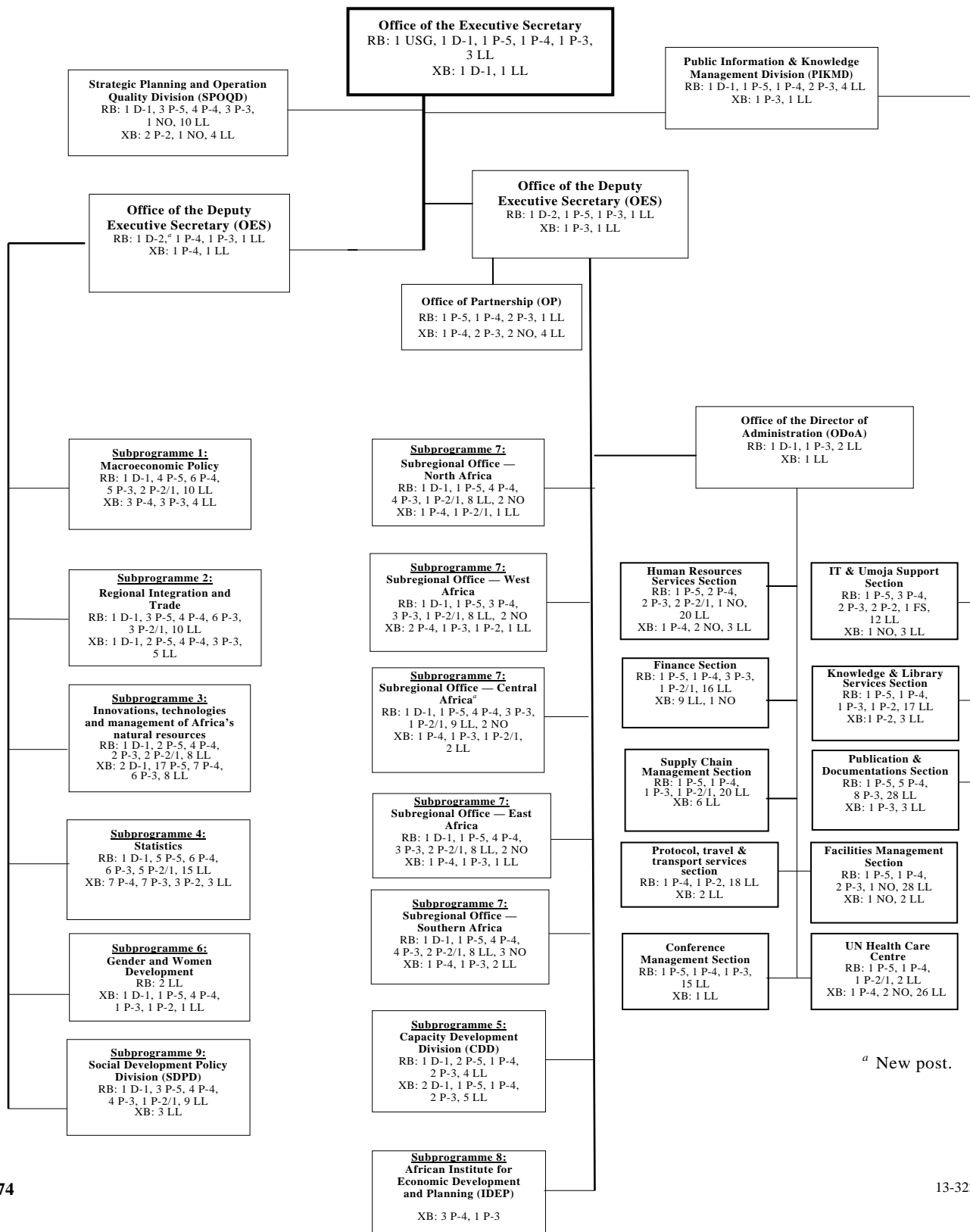

Advisory Committee on Administrative and Budgetary Questions (A/66/7)

The Committee welcomes the progress made in this process and requests that continuous impact assessments be carried out in this regard and reported in future budget submissions (para. V.28).

Activities carried out at the level of subregional offices contributed highly to enhancing awareness and knowledge in social policy, economic policy management, regional integration, market analysis and modelling, trade policy, gender mainstreaming, election and democratic processes. The impact of the ECA programme was widely reported by key respondents to a survey organized during the biennium. In particular, regional economic communities are gradually gaining development momentum with steps towards merger noted among some of them. Officials in many of these institutions have reflected on the importance of the contribution of ECA. However, a number of challenges were identified. Chief among them were: (a) the focus of the Commission, which is working on several fronts at the risk of spreading itself too thin; and (b) the synergy between headquarters divisions and the subregional offices. The restructuring exercise under way in ECA is addressing mainly the above-mentioned challenges in order to get the Commission to achieve more tangible results, as well as strengthen relevance and visibility.

The Advisory Committee considers that the factors highlighted by the Secretary-General are internal to ECA itself and it is within the purview of its management to address them fully. The Committee expects that information on the remedial measures taken will be provided in the context of the proposed programme budget for the biennium 2014-2015 (para. V.30).

ECA has taken steps to reposition itself and refocus its programmes to make them more responsive to the transformative agenda of the continent. Following extensive consultations with a wide range of stakeholders, which included senior policymakers of the member States, a comprehensive internal review of the programme of work and priorities was undertaken, which resulted in a revised strategic direction for the Commission's work, involving changes to its programmes, organizational structure, management and administrative processes. In this regard, it is proposed that the overall ECA programme of

Brief description of the recommendation

Notwithstanding the assurances provided, the Advisory Committee remains concerned at the persistently high vacancy rates at ECA. The current level of vacancies there is significantly higher than at the time of the Committee's consideration of the programme budget for the biennium 2010-2011. The Committee requests that the root causes of the high vacancy rates be seriously addressed by the Commission, with the support of the Office of Human Resources Management, with a view to ensuring that sustainable strategies are put in place. The comments and recommendations of the Advisory Committee on the continuing need for long-vacant posts are contained in chapter I, paragraph 92, which it finds relevant in the case of ECA. The Committee further requests that the General Assembly be provided with updated information on the current status of existing vacancies and remedial action taken at the time of its consideration of the Secretary-General's proposed programme budget for 2012-2013 (para. V.32).

Action taken to implement the recommendation

work be organized around nine interdependent and complementary subprogrammes and reflect the substantive priorities of member States, as reflected in the NEPAD programme and allow ECA to specialize and focus on areas of comparative advantages in economic and social development. These changes are now reflected in the new programme structure as detailed in programme 15 of the biennial programme plan 2014-2015 which will be before the Committee for Programme and Coordination at its fifty-third session. These changes are also reflected under section 18 of the proposed programme budget for the biennium 2014-2015.

ECA is working with the Office of Human Resources Management to ensure that sustainable strategies are put in place to address the high vacancy rate. During 2012-2013, ECA froze recruitment pending the Executive Secretary's unveiling of the new strategic direction of the organization. Upon the restructuring, revised positions aligned with the new ECA structure were developed. As a result, ECA is currently embarking upon a recruitment drive with the Office of Human Resources Management which involves widespread vacancy announcements in *Inspira* and in national magazines/newspapers in various parts of the world to ensure that the vacant positions are filled by September 2013.
