## Overall orientation

- 9.1 The overall objective of the programme is to promote and support international cooperation in the pursuit of sustained economic growth, the eradication of poverty and hunger, and sustainable development for all. While the programme is focused on tackling interlinked challenges in the social, economic and environmental fields, it also seeks to contribute to a mutually reinforcing relationship among the three pillars of United Nations work: peace and security, development and human rights.

*Note:* The following abbreviations are used in tables and charts: ASG, Assistant Secretary-General; GS, General Service; OL, Other level; PL, Principal level; RB, regular budget; USG, Under-Secretary-General; XB, extrabudgetary.

- 9.2 The programme, which is under the responsibility of the Department of Economic and Social Affairs, ensures complementarity and synergy among its nine subprogrammes. Its key programmatic thrusts are: (a) to provide substantive support to the bodies established under the Charter of the United Nations dealing with development issues, namely, the General Assembly, the Economic and Social Council and its related functional commissions, and expert bodies; (b) to monitor and analyse development trends, prospects and policy issues globally; and (c) to provide support for capacity development in policy formulation and implementation, in particular in relation to the achievement of the internationally agreed development goals, including the Millennium Development Goals, through, inter alia, the implementation of the regular programme of technical cooperation and Development Account projects.
- 9.3 The programme has placed development issues at the centre of global deliberations and helped Member States to forge a shared vision of development based on the internationally agreed development goals and commitments, with the Millennium Development Goals at the core, as identified in the outcomes of the major United Nations conferences and summits, including the outcome document of the United Nations Conference on Sustainable Development, held in Rio de Janeiro, Brazil, from 20 to 22 June 2012. Those commitments are collectively referred to as the United Nations development agenda. The programme supports the advancement of the United Nations development agenda beyond 2015, including linkages to the United Nations Conference on Sustainable Development and its follow-up process.
- 9.4 The Strategic Planning Unit and the Communications and Information Management Service will merge to form the Strategic Planning and Communications Service, which is to be headed by the incumbent of the D-1 post currently in charge of the Strategic Planning Unit.
- 9.5 During the biennium 2014-2015, the programme will continue to mobilize and provide practical support to help translate the development commitments into action. It will focus on the delivery of four main functions: (a) monitoring, research and analysis with respect to development issues and emerging challenges, including through support for the global statistical system; (b) normative and policy support for United Nations intergovernmental processes; (c) assistance in capacity development and the active promotion of capacity-building activities in order to support the implementation of global conference outcomes at the country level; and (d) the fostering of collaboration and partnerships within the United Nations system and with civil society and the private sector. Increased attention will be given to the capacity development needs of the least developed countries, small island developing States and countries emerging from conflicts.
- 9.6 The performance of those functions requires strengthened analytical and monitoring capacity, in particular to identify and address emerging issues and cross-cutting policy challenges and to support both national development strategies and accountability and monitoring mechanisms at the intergovernmental level. Strategic integration is also essential, to promote a coherent and coordinated implementation process for the internationally agreed development goals, including the Millennium Development Goals, and to support the design of the framework for the United Nations development agenda beyond 2015. This includes enhancing horizontal linkages across the subprogrammes of programme 7 to permit more effective and flexible support for Member States in pursuing the development agenda, in particular the follow-up to the United Nations Conference on Sustainable Development, in cooperation with entities of the Executive Committee on Economic and Social Affairs, to which the programme provides strategic support. In addition, the programme ensures stronger linkages between the Executive Committee and the United Nations Development Group, other executive committees and various other partners.
- 9.7 The programme will continue to emphasize the mainstreaming of gender perspectives into its subprogrammes. Consultations have taken place among relevant entities of the Executive Committee on Economic and Social Affairs at the thematic cluster level. Those consultations are

expected to continue enhancing areas of coordination and collaborative work carried out in the United Nations Secretariat in the area of sustainable development.

- 9.8 Capacity development activities are focused on key priority areas in which the Department of Economic and Social Affairs has accumulated extensive normative, analytical and operational experience, with a proven and credible development knowledge base, including networks of experts and a repertoire of good practices, and provide a value-added contribution to the work of the United Nations development system as a whole. The Department's priority areas include strengthening statistical capacities, including monitoring the implementation of the Millennium Development Goals; providing macroeconomic policy advice; promoting the social inclusion and integration of all vulnerable groups; encouraging policies that promote national sustainable development strategies, with a particular focus on climate change mitigation and adaptation and the sustainable management of forests; and strengthening public administration and information and communications technology (ICT) for development, including e-government.
- 9.9 During the biennium 2014-2015, the programme will continue to implement the outcome document of the United Nations Conference on Sustainable Development, entitled "The future we want", which was endorsed by the General Assembly in its resolution 66/288.
- 9.10 The resource requirements needed in order to implement "The future we want" were detailed in the report of the Secretary-General on revised estimates resulting from the decisions contained in that document (A/67/591). The General Assembly, in its resolution 67/246, endorsed the recommendation of the Advisory Committee on Administrative and Budgetary Questions that the resource requirements for 2012-2013 identified in the Secretary-General's report be approved and that the requirements for 2014-2015 be considered in the context of the present report. Those resource requirements previously presented in the Secretary-General's report are reflected in the present report under policymaking organs, executive direction and management, subprogrammes 3, 4 and 9, and programme support.

### Overview of resources

- 9.11 The overall resources proposed for the biennium 2014-2015 for section 9 amount to \$160,447,700 before recosting, reflecting a net decrease of \$2,013,300 (1.2 per cent) compared with the 2012-2013 resources at revised rates. Resource changes result from four factors: (a) technical adjustments relating to the removal of non-recurrent requirements and the addition of delayed impact for new posts approved in 2012-2013; (b) new or expanded mandates and inter-component changes; (c) resource changes in line with General Assembly resolution 67/248; and (d) resource changes reflected in the report of the Secretary-General on the proposed budget outline for the biennium 2014-2015 (A/67/529 and Corr.1).
- 9.12 The distribution of resources is reflected in tables 9.3 to 9.5.

### Technical adjustments

- 9.13 Resource changes reflect the removal of non-recurrent requirements totalling \$3,943,500 relating to the implementation of “The future we want”, as detailed in the report of the Secretary-General on revised estimates (A/67/591). The reduction is offset in part by an amount of \$271,200 relating to the delayed impact of two P-3 posts established in the biennium 2012-2013, pursuant to Assembly resolution 66/248.

### New mandates and inter-component changes

- 9.14 For the biennium 2014-2015, the Department’s proposal includes increases in non-post resources resulting from the following mandated activities:
- (a) A non-recurrent provision of \$5,207,600 for the implementation of “The future we want”, as detailed in the report of the Secretary-General on revised estimates (A/67/591) and as reflected under policymaking organs, executive direction and management, subprogrammes 3, 4 and 9, and programme support;
  - (b) A non-recurrent provision of \$314,000 in support of the Department’s substantive preparations for the third international conference on small island developing States, as called for by the General Assembly in resolution 66/288 and endorsed by the Assembly in its resolution 67/207;



- (c) A provision of \$1,150,100 to build the Department's capacity to implement the provisions of General Assembly resolution 67/226, on the quadrennial comprehensive policy review of operational activities for development of the United Nations system.

#### Changes in line with General Assembly resolution 67/248

- 9.15 Resource changes of \$4,416,300 are proposed in line with General Assembly resolution 67/248. The primary resource changes in the amount of \$3,822,700 and the related impact are outlined in table 9.6.

**Extrabudgetary resources**

- 9.17 During the biennium 2014-2015, total projected extrabudgetary resources amounting to \$159,404,800 will supplement resources from the regular budget to provide for various substantive and technical cooperation activities, including consultancy, expert groups, travel, technical advisory services, training, workshops, seminars and field projects.

**Other information**

- 9.18 The Department will conduct self-evaluations and self-assessments and will report on the implementation of evaluation activities. Training programmes on monitoring and evaluation will be organized to further strengthen departmental monitoring and evaluation capacity. The departmental evaluation policy, finalized in July 2012, will serve as a basis for these monitoring and evaluation activities.
- 9.19 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation would amount to \$90,200, representing a total of 8.25 work-months of Professional staff for the biennium 2014-2015, funded from regular budget resources.
- 9.20 The issuance of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized in table 9.8 and as distributed in the output information for each subprogramme.
- 9.21 The Department's publications are also a revenue source for the Secretariat, generating \$1.92 million in sales and subscriptions in 2011 and 2012. An additional \$1.96 million in revenue was generated in data subscriptions during the same period.

- 9.22 Provision is made under this subsection for requirements related to standing intergovernmental organs and expert bodies, special sessions of the General Assembly and intergovernmental processes, the servicing of which is the responsibility of the Department of Economic and Social Affairs and which are deemed to require specific provisions. The provision for experts serving on committees in their individual capacity are in accordance with General Assembly resolution 2491 (XXIII), as amended by resolutions 41/176, 42/25, section VI, and 43/217, section IX, while the provisions for members of the functional commissions are in accordance with General Assembly resolutions 1798 (XVII), 2128 (XX) and 2245 (XXI).

## Standing intergovernmental organs and expert bodies

### Statistical Commission

#### *Resource requirements (before recosting): \$103,200*

- 9.23 The Statistical Commission was established by the Economic and Social Council in its resolution 8 (I). Its terms of reference, as set out in Council resolutions 8 (I), 8 (II) and 1566 (L), are to assist the Council in: promoting the development of national statistics and the improvement of their comparability; coordinating the statistical work of the specialized agencies; developing the central statistical services of the Secretariat; advising the organs of the United Nations on general questions relating to the collection, interpretation and dissemination of statistical information; and promoting the improvement of statistical methods in general. The Commission consists of 24 representatives of Member States elected by the Council for a period of four years.
- 9.24 Bearing in mind General Assembly resolution 50/227 and the need to provide for more continuity in the Commission's decision-making and oversight with respect to the global statistical process, and with the aim of enabling the Commission to follow up on the statistical implications of the major United Nations conferences and summits, the Council, in its resolution 1999/8, decided that the Commission would meet annually for a period of four working days in New York, beginning in 2000.

- 9.25 The forty-fifth and forty-sixth sessions of the Statistical Commission are scheduled to be held in 2014 and 2015, respectively.

#### **Commission on Population and Development**

##### ***Resource requirements (before recosting): \$118,300***

- 9.26 The Population Commission was established by the Economic and Social Council in its resolution 3 (III). Its terms of reference were initially set out in Council resolution 150 (VII). In its resolution 49/128, the General Assembly decided that the revitalized Population Commission would be renamed the Commission on Population and Development and that it would meet on an annual basis. The Commission is composed of 47 representatives of Member States elected by the Council for a period of four years (Council decision 1995/320). It normally meets annually for a period of five working days.
- 9.27 Under its terms of reference, the Commission is to assist the Council by: (a) arranging for studies and advising the Council on population issues and trends, the integration of population and development strategies, population and related development policies and programmes and the provision of population assistance, as well as addressing any population and development questions on which either the principal or the subsidiary organs of the United Nations or the specialized agencies may seek advice; (b) monitoring, reviewing and assessing the implementation of the Programme of Action of the International Conference on Population and Development at the national, regional and global levels, identifying reasons for success and failure, and advising the Council thereon; and (c) reviewing the findings of research and analysis pertaining to the interrelationships between population and development at the national, regional and international levels and advising the Council thereon.
- 9.28 Pursuant to General Assembly resolution 57/270 B, the Commission reviewed its methods of work at its thirty-eighth session, in 2005, and at its thirty-ninth session, in 2006. In its decision 2005/2, entitled "Methods of work of the Commission on Population and Development", the Commission reaffirmed its central role in coordinating the review and assessment of the overall implementation of the Programme of Action of the International Conference on Population and Development and the outcome of the twenty-first special session of the General Assembly at all levels, and reiterated the need to conduct periodically comprehensive reviews and appraisals of the implementation of the Programme of Action and the key actions for its further implementation. By its resolution 2006/1, the Commission decided that it would adopt a multi-year programme of work limited to a two-year planning horizon, based on special themes from the Programme of Action of the International Conference on Population and Development, and that in considering those annual themes, it would continue to review and assess both their substantive and policy aspects as well as the progress made in programme implementation in relation to the themes.
- 9.29 The forty-seventh and forty-eighth sessions of the Commission on Population and Development are scheduled to be held in 2014 and 2015, respectively.

#### **Commission for Social Development**

##### ***Resource requirements (before recosting): \$197,200***

- 9.30 The Social Commission was established as a functional commission of the Economic and Social Council by the Council in its resolution 10 (II). As a result of a comprehensive reappraisal of the role of the Commission, the Council, in its resolution 1139 (XLI), renamed it the Commission for Social Development to clarify its role as a preparatory body of the Council for the entire range of social development policy. Following the convening of the World Summit for Social Development, in 1995, the Council, by its resolution 1995/60, decided that the Commission would review, on a periodic

basis, issues related to the follow-up and implementation of the Copenhagen Declaration on Social Development and the Programme of Action adopted at the Summit. By its resolution 1996/7, the Council decided to expand the membership of the Commission from 32 to 46 representatives of Member States, elected by the Council for a period of four years, and that it would meet in annual sessions of eight working days. The Council also decided, by its resolution 2005/11, that the Commission would be organized in a series of two-year action-oriented implementation cycles that would include a review segment and a policy segment.

- 9.31 The fifty-second and fifty-third sessions of the Commission for Social Development are scheduled to be held in 2014 and 2015, respectively.

#### **Commission on Sustainable Development**

##### ***Resource requirements (before recosting): 0***

- 9.32 The Commission on Sustainable Development was established as a functional commission of the Economic and Social Council by the Council in its decision 1993/207. Its functions are set out in General Assembly resolution 47/191.
- 9.33 In resolution 66/288, the General Assembly endorsed “The future we want”, as well as the decision to replace the Commission on Sustainable Development with a universal, intergovernmental, high-level political forum that builds on the strengths, experiences, resources and inclusive participation modalities of the Commission.
- 9.34 The twentieth and final session of the Commission on Sustainable Development is scheduled to be held in 2013.

#### **High-level political forum on sustainable development**

##### ***Resource requirements (before recosting): \$699,700***

- 9.35 The General Assembly, in resolution 66/288, decided to establish a universal, intergovernmental, high-level political forum building on the strengths, experiences, resources and inclusive participation modalities of the Commission on Sustainable Development and subsequently replacing the Commission. The high-level political forum will follow up on the implementation of sustainable development and should avoid overlap with existing structures, bodies and entities in a cost-effective manner. The mandate of the forum is outlined in paragraph 84 of the annex to resolution 66/288.

#### **Committee for Development Policy**

##### ***Resource requirements (before recosting): \$345,000***

- 9.36 The Economic and Social Council, in annex I to its resolution 1998/46, renamed the Committee for Development Planning, functioning in accordance with Council resolutions 1035 (XXXVII) and 1079 (XXXIX) and decision 1995/215, the Committee for Development Policy and reconfirmed its status as a subsidiary body of the Council. In accordance with Council resolution 1998/46, the Committee is composed of 24 independent experts who possess expertise in the fields of economic development, social development and environmental protection and who reflect adequate geographical and gender balance. Its membership includes experts who are able to make contributions in terms of emerging issues and the multilateral process. The experts are nominated by the Secretary-General following consultation with interested Governments and are approved by the Council. The term of office of each member is three years.



- 9.37 The Committee is called upon to undertake a triennial review of the status of least developed countries and to meet on that issue once every three years. Since the adoption in 1997 of additional guidelines for the identification of least developed countries, this has also involved undertaking impact assessments of countries found to be eligible for graduation. Furthermore, the Committee reports to the Council its findings with respect of the monitoring exercises on the development progress of countries graduating from the list of least developed countries. In its resolution 67/221, the General Assembly requested the Committee to monitor the development progress of graduated countries on an annual basis for the first three years after graduation became effective and triennially thereafter. Economic and Social Council resolution 2011/20 reflects the Council's intention to engage in more frequent interactions with the Committee on the themes of the high-level segment and on other pertinent issues that the Committee wishes to bring to the attention of the Council.
- 9.38 The sixteenth and seventeenth sessions of the Committee for Development Policy are scheduled to be held in 2014 and 2015, respectively.

#### **Committee of Experts on Public Administration**

***Resource requirements (before recosting): \$323,100***

- 9.39 The Committee of Experts on Public Administration, which has been holding annual sessions since 2003 in accordance with Economic and Social Council resolution 2003/60, was established by the Council in its resolution 2001/45 and consists of 24 experts appointed in their personal capacity by the Council upon their nomination by the Secretary-General. The Committee's role is twofold: first, to support intergovernmental deliberations in providing policy options and making recommendations to Member States to improve governance and public administration structures and processes for development; and secondly, to guide and monitor the performance of the Division for Public Administration and Development Management in the implementation of the United Nations Programme in Public Administration and Development.
- 9.40 The thirteenth and fourteenth sessions of the Committee of Experts on Public Administration are scheduled to be held in 2014 and 2015, respectively.

#### **Committee of Experts on International Cooperation in Tax Matters**

***Resource requirements (before recosting): \$341,400***

- 9.41 By its resolution 2004/69, the Economic and Social Council decided to rename the Ad Hoc Group of Experts on International Cooperation in Tax Matters the Committee of Experts on International Cooperation in Tax Matters. The Committee comprises 25 members who act in their expert capacity, nominated by Governments. The members are appointed by the Secretary-General, after the notification of the Council, for a term of four years and are drawn from the fields of tax policy and tax administration. Their appointment reflects adequate equitable geographical distribution, representing different tax systems. As from 2005, the Committee meets on a yearly basis for a period of five days in Geneva.
- 9.42 The Committee of Experts on International Cooperation in Tax Matters is mandated to: (a) keep under review and update as necessary the United Nations Model Double Taxation Convention between Developed and Developing Countries and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries; (b) provide a framework for dialogue with a view to enhancing and promoting international tax cooperation among national tax authorities; (c) consider how new and emerging issues could affect international cooperation in tax matters and develop assessments, commentaries and appropriate recommendations; (d) make recommendations on capacity-building and the provision of technical assistance to developing countries and

countries with economies in transition; and (e) give special attention to developing countries and countries with economies in transition in dealing with all the aforementioned issues. The Committee submits its report on the work of its annual session to the Economic and Social Council at its substantive session.

- 9.43 In its resolution 2006/48, the Economic and Social Council noted the creation of four subcommittees on substantive matters, namely, treaty abuses, mutual assistance in collecting tax debts, the definition of permanent establishment, and the exchange of information, and two working groups, on international tax arbitration and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries.
- 9.44 In its resolution 2008/16, the Economic and Social Council recognized that the Committee had agreed to create, as necessary, ad hoc subcommittees composed of experts and observers who would work according to the Committee's rules of procedure to prepare and determine the supporting documentation for the agenda items, including requests for papers by independent experts, for consideration at its regular session.
- 9.45 At each annual session, the Committee reviews the list of subcommittee and working groups and decides to terminate those that have fulfilled their mandates and to establish new ones to be tasked with new mandates emerging from its programme of work.
- 9.46 The tenth and eleventh sessions of the Committee of Experts on International Cooperation in Tax Matters are scheduled to be held in 2014 and 2015, respectively.

#### **United Nations Forum on Forests**

##### ***Resource requirements (before recosting): \$98,000***

- 9.47 By its resolution 2000/35, the Economic and Social Council established the United Nations Forum on Forests as an intergovernmental subsidiary body of the Council, to serve as a permanent policy and political forum, with the main objective of promoting the management, conservation and sustainable development of all types of forests, and to strengthen long-term political commitment to that end. The Forum is composed of all States Members of the United Nations and members of specialized agencies with full and equal participation, including voting rights.
- 9.48 By its resolution 2006/49, the Economic and Social Council decided that following its seventh session, in 2007, the Forum would meet biennially for a period of up to two weeks on the basis of a focused multi-year programme of work adopted by the Forum at its seventh session.
- 9.49 The Forum is mandated to carry out principal functions related to: supporting efforts to achieve the shared global objectives on forests; facilitating the implementation of a non-legally binding instrument on all types of forests; policy development; international coordination among organizations, instruments and institutions; international cooperation; monitoring, assessment and reporting; and strengthening political commitment. By its resolution 2006/49, the Economic and Social Council decided to strengthen the international arrangement on forests and accorded a mandate to the Forum through 2015.
- 9.50 The eleventh session of the United Nations Forum on Forests will be held in 2015, when the effectiveness of the international arrangement on forests will be reviewed and future options considered. Preparations for the review of the international arrangement on forests will take fully into account the implications of and interconnections with deliberations on the post-2015 United Nations development agenda and sustainable development goals, in order to position forests in the outcomes of those processes.

### Permanent Forum on Indigenous Issues

#### *Resource requirements (before recosting): \$341,400*

- 9.51 The Economic and Social Council, by its resolution 2000/22, established the Permanent Forum on Indigenous Issues as a subsidiary organ of the Council, consisting of 16 members, 8 members to be nominated by Governments and elected by the Council and 8 members to be appointed by the President of the Council following formal consultation with the bureau and the regional groups, through their coordinators. Nominations are decided on the basis of broad consultations with indigenous organizations, taking into account the diversity and geographical distribution of the indigenous people of the world as well as the principles of transparency, representatively and equal opportunity for all indigenous people, including internal processes, when appropriate, and local indigenous consultation processes. All members serve in their personal capacity as independent experts on indigenous issues for a period of three years, with the possibility of re-election or reappointment for one additional period. States, United Nations bodies and organs, intergovernmental organizations and non-governmental organizations in consultative status with the Council may participate as observers. Organizations of indigenous people may also participate as observers.
- 9.52 The Economic and Social Council decided that the Permanent Forum would hold an annual session of 10 working days at the United Nations Office at Geneva, United Nations Headquarters or such other place as the Permanent Forum might decide in accordance with existing Financial Rules and Regulations of the United Nations.
- 9.53 The thirteenth and fourteenth sessions of the Permanent Forum on Indigenous Issues are scheduled to be held in 2014 and 2015, respectively.
- 9.54 The distribution of resources for policymaking organs is reflected in table 9.10.

- 9.55 The amount of \$2,567,300, reflecting a decrease of \$1,642,000, would be required to cover the costs of travel of the members of the Commission, the Committees and the Forums for the sessions of those bodies. The decrease in non-post resources results from the decision of Heads of State and Government and high-level representatives, in the outcome document of the United Nations Conference on Sustainable Development, entitled “The future we want” (General Assembly resolution 66/288, annex), to replace the Commission on Sustainable Development with a high-level political forum. In this regard, there is no longer a mandate to provide for the travel of representatives to sessions of the Commission in 2014-2015. The reduced requirements are offset in part by a one-time provision of \$699,700 for the implementation of activities related to the United Nations Conference on Sustainable Development, as detailed in the Secretary-General’s report on revised estimates (A/67/591), to facilitate the participation of representatives in regional meetings on the priorities of the high-level political forum.

- 9.56 However, in line with paragraph 86 of “The future we want”, the General Assembly is to launch an intergovernmental and open, transparent and inclusive process to define the format and organizational aspects of the high-level forum, with the aim of convening the first high-level forum at the beginning of the sixty-eighth session of the Assembly. The Secretary-General will revert to the Assembly on the financial requirements, if any, once the format and organizational structure of the high-level forum have been defined by the Assembly.

## **B. Executive direction and management**

### ***Resource requirements (before recosting): \$10,384,600***

- 9.57 The Under-Secretary-General for Economic and Social Affairs is responsible for the overall direction, supervision and management of the Department in the implementation of its mandates and its approved programme of work. He serves as convener of the Executive Committee on Economic and Social Affairs as well as the Programme Manager of the Development Account and is responsible for the overall management of technical cooperation activities. The Under-Secretary-General is assisted by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs and the Assistant Secretary-General for Economic Development.
- 9.58 The Assistant Secretary-General for Economic Development serves as the principal economic adviser to the Under-Secretary-General and assists the Under-Secretary-General by leading and coordinating the policy research and analysis work of the Department. The Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs supports the Under-Secretary-General by providing substantive support to the Economic and Social Council and other relevant intergovernmental bodies. In order to further strengthen system-wide coordination, guidance to the secretariat of the Chief Executives Board for Coordination will be provided directly by the Executive Office of the Secretary-General.
- 9.59 The Office of the Under-Secretary-General provides support and advice to the Under-Secretary-General and, as appropriate, to the Assistant Secretaries-General on the planning, coordination, management and assessment of the work of the Department.
- 9.60 The Strategic Planning Unit supports the Under-Secretary-General in promoting strategic integration and policy coherence, including collaborative work with other Secretariat entities.
- 9.61 The Department’s proposal includes the redeployment of its Communications and Information Management Service resources from programme support to executive direction and management. The redeployment will accurately reflect the direct working relationship that the Service has with regard to its support for the Office of the Under-Secretary-General, particularly in the formulation of policies and strategies in the areas of knowledge management, website communications, publishing and electronic administration. The proposed move will strengthen the central role of the service in the development of information systems and enterprise applications to support programme delivery. In addition, the Service represents the Department in relevant Secretariat policy and normative bodies, including the Information and Communications Management Committee, the Working Group on Electronic Publications and the Task Force on Knowledge Management. The change in structure formalizes current reporting and working arrangements of the Service, which at present is currently managed by the Office of the Under-Secretary-General.

9.63 The amount of \$10,384,600, reflecting a net increase of \$2,870,600, would provide for: (a) \$8,435,600 for 26 posts (1 Under-Secretary-General, 2 Assistant Secretary-General, 2 D-1, 5 P-5, 3 P-4, 1 P-3, 3 P-2 and 9 General Service (2 Principal level and 7 Other level)); and (b) \$1,949,000 for non-post requirements, including other staff costs (\$554,900), consultants (\$127,100), experts (\$154,200), travel of staff (\$552,500), contractual services (\$72,900), supplies and materials (\$70,900), furniture and equipment (\$33,200) and grants and contributions (\$383,300). In addition to a one-time provision of \$144,400 for the implementation of activities related to the United Nations Conference on Sustainable Development, as detailed in the Secretary-General's report on revised estimates (A/67/591), in support of the implementation of "The future we want", the net increase in resources is due mainly to the inward redeployment of nine posts (1 P-5, 1 P-4, 1 P-3, 3 P-2, 1 General Service (Principal level) and 2 General Service (Other level)) within the Communications and Information Management Service from programme support to executive direction and

management, as well as non-post resources offset by reductions under consultants in line with resolution 67/248, as reflected in table 9.6, item 2, of the present report.

- 9.64 During the biennium 2014-2015, projected extrabudgetary resources of \$3,573,700 would provide for five General Service posts (3 Principal level and 2 Other level) and non-post resources, including general temporary assistance, consultants and experts, travel of staff, contractual services and other expenditures in support of technical cooperation activities. The decrease of \$34,400 is due primarily to reduced requirements for consultants and experts owing to greater reliance on in-house capability.

### Subprogramme 1

#### Economic and Social Council support and coordination

***Resource requirements (before recosting): \$14,774,000***

- 9.66 The subprogramme is under the responsibility of the Office for Economic and Social Council Support and Coordination. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 1 of programme 7 of the biennial programme plan for the period 2014-2015.
- 9.67 The Office for Economic and Social Council Support and Coordination supports the efforts of the General Assembly and the Economic and Social Council to promote more coherent and integrated implementation of the United Nations development agenda, comprising the international development goals agreed upon at the major United Nations conferences and summits, including the Millennium Development Goals. The outcome of the 2005 World Summit reaffirmed the principal role of the Council in economic and social development, as a quality platform for policy dialogue, annual ministerial-level substantive reviews and the holding of a biennial high-level Development Cooperation Forum. The Council's role in supporting efforts to address humanitarian emergencies and in strengthening links between the Council and the Peacebuilding Commission, as well as its many functional commissions and subsidiary bodies, has also been stressed. "The future we want" strengthened the role of the Council in promoting integrated and coordinated follow-up to major global conferences and summits in the economic, social, environmental and related fields and recognized the key role of the Council in achieving balanced integration of the three dimensions of sustainable development. The Office for Economic and Social Council Support and Coordination, as the substantive secretariat of the Council, provides technical support to the Council in integrating these dimensions. Additional activities carried out by the Office include supporting the General Assembly quadrennial comprehensive review of United Nations operational activities for development, supporting the Committee on Non-Governmental Organizations, and acting as the focal point for interreligious, intercultural and intercivilizational matters within the United Nations system, as mandated under Assembly resolution 62/90, and for the Assembly plenary meeting on development, as mandated under Assembly resolution 60/265.

- 9.71 The amount of \$ 14,774,000, reflecting an increase of \$748,700, would provide for: (a) \$12,891,100 for 44 posts (1 D-2, 4 D-1, 6 P-5, 9 P-4, 5 P-3, 3 P-2 and 16 General Service (1 Principal level and 15 Other level)) to undertake substantive analyses and technical monitoring of development progress at the national, regional and global levels; provide substantive servicing and support for meetings of intergovernmental and other bodies, such as the General Assembly and its Second Committee, the Economic and Social Council, including its annual ministerial review and its Development Cooperation Forum, the Committee on Non-Governmental Organizations and the Ad Hoc Advisory Group on Haiti; prepare parliamentary documentation, publications and technical material (website, newsletter, brochures) for these meetings; organize technical cooperation activities (seminars, training workshops, field projects); and support the monitoring, reporting and implementation of the quadrennial comprehensive policy review of United Nations operational activities for development; and (b) \$1,882,900 for non-post requirements, including other staff costs (\$894,900), consultants (\$401,700), experts (\$120,800), travel of staff (\$184,900), contractual services (\$111,500), supplies and materials (\$18,700), furniture and equipment (\$54,200) and grants and contributions (\$96,200). The net increase of \$748,700 is due mainly to: an increase in non-post resources related to a one-time provision of \$1,150,100 to build the Department's capacity to implement the provisions of General Assembly resolution 67/226, offset in part by the

proposed abolishment of two General Service (Other level) posts amounting to \$311,600 in line with Assembly resolution 67/248, as reflected in table 9.6, item 1, of the present report.

- 9.72 During the biennium 2014-2015, projected extrabudgetary resources of \$1,193,000 will be used: (a) to ensure multi-stakeholder participation in the annual ministerial review preparatory process; (b) to permit the utilization of external expertise to improve the analytical work for the quadrennial comprehensive policy review of United Nations operational activities for development; and (c) to support the global preparations for the Development Cooperation Forum, including the financing of substantive studies, global/regional preparatory meetings and expert group meetings. The decrease of \$2,165,500 in projected extrabudgetary resources is due primarily to reduced requirements for general temporary assistance and consultants and experts funded by the annual ministerial review and the Development Cooperation Forum, owing to greater reliance on in-house capability.

9.77 The amount of \$17,562,600, reflecting a decrease of \$498,500, would provide for: (a) \$16,488,800 for 59 posts (1 D-2, 3 D-1, 5 P-5, 14 P-4, 8 P-3, 8 P-2 and 20 General Service (1 Principal level and 19 Other level)) to support normative, analytical and operational support for Member States and intergovernmental and non-governmental organizations on a broad range of socioeconomic issues through monitoring of national and global trends and emerging issues; substantive servicing of intergovernmental meetings; promotion of dialogue with major stakeholders; preparation of

reports and publications; organization of expert group meetings, seminars and panel discussions; and provision of advisory services; and (b) \$1,073,800 for non-post requirements, including other staff costs (\$76,800), consultants (\$64,000), experts (\$400,100), travel of staff (\$240,800), contractual services (\$126,600), supplies and materials (\$33,600), furniture and equipment (\$81,700) and grants and contributions (\$50,200). The decrease in resources is due mainly to the abolishment of one post of Social Affairs Officer (P-4) and a reduction in non-post resources in line with resolution 67/248, as reflected in table 9.6, item 3, of the present report.

- 9.78 During the biennium 2014-2015, projected extrabudgetary resources of \$2,094,000 under this subprogramme will be used: (a) to support the representation of the Permanent Forum on Indigenous Issues at important meetings of interest for its mandate; language-related needs of the Forum; the preparation of special publications and workshops; pilot projects in countries based on earmarked contributions; and small grants in the context of the Second International Decade of the World's Indigenous People; (b) to support catalytic and innovative interventions to build national capacities, including the capacities of non-governmental organizations for disability action, to support exchanges at the subregional, regional and interregional levels on good practices in relation to and guidelines for the full implementation of the Convention on the Rights of Persons with Disabilities; and (c) to contribute to effective follow-up to the priorities of the Copenhagen Declaration and Programme of Action on Social Development and the Millennium Declaration by supporting research and preparation of documents on catalytic and innovative interventions in the areas of poverty eradication, employment and decent work and social integration. The decrease of \$902,300 in projected extrabudgetary resources results from the conclusion of extrabudgetary-funded projects in the biennium 2012-2013.

- 9.83 The amount of \$20,637,800, reflecting an increase of \$757,300, would provide for: (a) \$17,308,000 for 58 posts (1 D-2, 5 D-1, 12 P-5, 10 P-4, 5 P-3, 4 P-2 and 21 General Service (2 Principal level and 19 Other level)); and (b) \$3,329,800 for non-post requirements, including other staff costs (\$1,560,300), consultants (\$383,000), experts (\$854,700), travel of staff (\$365,400), contractual services (\$55,100), supplies and materials (\$29,400) and furniture and equipment (\$81,900). ## Subprogramme 4

### Statistics

#### *Resource requirements (before recosting): \$33,473,800*

- 9.85 The subprogramme is implemented by the Statistics Division. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 4 of programme 7 of the biennial programme plan for the period 2014-2015.
- 9.86 The Statistics Division carries out its activities in close cooperation with national statistical offices and national geospatial information agencies. It works in collaboration with other offices of the Secretariat, the regional commissions, United Nations specialized agencies, funds and programmes and non-United Nations intergovernmental organizations. In particular, the Division acts as the secretariat for the Statistical Commission, the Committee of Experts on Global Geospatial Information Management and other intergovernmental bodies in the area of geographical

information management, all of which report to the Economic and Social Council. The Division also serves the Committee for the Coordination of Statistical Activities.

- 9.87 The structure of the Division's programme has five parts: (a) statistical capacity-building; (b) standards and methodological development; (c) the coordination of international statistical activities; (d) data dissemination; and (e) support for the development of geospatial information systems. In statistical capacity-building programmes, the Division helps Member States to build sound national statistical systems, which include solid institutional infrastructures, systematic data collection activities, the compilation of aggregate macroeconomic and social statistics according to global standards and norms, and a multichannel data dissemination system. In the area of methodological work, the Division develops manuals essential for the compilation of reliable and comparable statistics. Other methodological guidelines are also established for the collection, processing, analysis and dissemination of data. In the coordination of international statistical activities, the Division serves as the secretariat for the Statistical Commission and its bureau, as well as other coordinating bodies. In data dissemination, the Division supports national and international decision makers with a range of global statistical products. In line with a recent Economic and Social Council mandate, the Division is now also facilitating the development of an intergovernmental and inter-agency architecture for the area of geospatial information.
- 9.88 During the biennium 2014-2015, the Division will continue to focus on the development of core information programmes for a national statistical and geospatial information system. This will include activities related to the population census, economic surveys, the system of national accounts and its extensions, relevant environmental statistics and geospatial information systems.

- 9.92 The amount of \$33,473,800, reflecting a decrease of \$396,200, would provide for: (a) \$31,288,700 for 121 posts (1 D-2, 5 D-1, 9 P-5, 17 P-4, 21 P-3, 15 P-2 and 53 General Service (12 Principal level and 41 Other level)) to provide substantive servicing to various intergovernmental bodies, including the Fifth Committee, the Statistical Commission and the Committee of Experts on Global Geospatial Information Management, and to assist national and international information systems in the areas of: (i) statistical capacity-building; (ii) standards and methodological development; (iii) the coordination of international statistical activities; (iv) data dissemination; and (v) support for the development of geospatial information systems; and (b) \$2,185,100 for non-post requirements, including other staff costs (\$721,100), consultants (\$249,900), experts (\$474,400), travel of staff (\$146,900), contractual services (\$397,700), supplies and materials (\$63,100) and furniture and equipment (\$132,000). The net decrease of \$396,200 in resources is due mainly to the abolishment of two posts of Statistician (P-3) and two posts of Statistics Assistant (General Service (Other level)) in line with resolution 67/248, as reflected in table 9.6, item 2, of the present report, offset in part by a one-time provision of \$264,300 for the implementation of activities related to the United Nations Conference on Sustainable Development, as detailed in the Secretary-General's report on revised estimates (A/67/591).
- 9.93 During the biennium 2014-2015, projected extrabudgetary resources of \$518,000 under the subprogramme will be used to: (a) create UNdata, a new portal that will permit free access to United Nations system-wide statistics through innovative and user-friendly formats and interfaces and provide technical assistance to Member States on statistical dissemination; and (b) support the project on comparative analysis of national statistical systems, financing the preparatory work for and travel to an international conference on national statistical systems, focusing in particular on the measurement of climate change. The increase of \$29,800 in projected extrabudgetary resources results from additional activities required in support of the Commission.

## Subprogramme 5

### Population

#### *Resource requirements (before recosting): \$13,378,800*

- 9.94 Substantive responsibility for the subprogramme is vested in the Population Division. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 5 of programme 7 of the biennial programme plan for the period 2014-2015.
- 9.95 The Population Division of the Department of Economic and Social Affairs is responsible for monitoring the implementation of the Programme of Action of the International Conference on



Population and Development in accordance with General Assembly resolutions 49/128 and S-21/2. It produces the population estimates and projections used throughout the United Nations system; prepares estimates of three of the four indicators associated with the Millennium Development Goals target of attaining universal access to reproductive health; contributes, in partnership with other United Nations agencies, to the production of estimates of child mortality (also a key Millennium Development Goal indicator); provides substantive secretariat support to the Commission on Population and Development of the Economic and Social Council; and participates in or leads technical groups on methodological developments related to the measurement of child mortality, adult mortality, HIV/AIDS and international migration. The Division is responsible for addressing all population issues, including international migration and development, the demographic impact of HIV/AIDS, population ageing, urbanization, fertility and reproductive health, national population policies and the interrelations between population dynamics and development, including the integration of population dimensions into the international development agenda and into the formulation of sustainable development goals.

- 9.96 The subprogramme will facilitate access for Governments and civil society to information on population trends, their demographic components and the interactions between population dynamics and sustainable development, including the gender dimensions of demographic phenomena, especially with regard to fertility, mortality, migration, HIV/AIDS, urbanization, population growth, population ageing and the environment, so as to provide a sound basis for the formulation of government policies and programmes. Official United Nations demographic estimates and projections will be prepared for all countries and areas of the world, as well as urban and rural areas and major cities, and will serve as a standard, consistent set of population figures for use throughout the United Nations system, including for the production of indicators for monitoring progress towards the achievement of all internationally agreed goals, including the Millennium Development Goals and sustainable development goals. International migration, fertility and reproductive health, the demographic impact of HIV/AIDS and the changing age structures of population and their impact on sustainable development will be the critical issues addressed. Those areas have been identified as high priorities in “The future we want”, the Millennium Declaration, the Millennium Development Goals, the Declaration of Commitment on HIV/AIDS, the Programme of Action of the International Conference on Population and Development and various resolutions adopted by the Commission on Population and Development. Work in the area of international migration and its interrelationship with development has intensified as a result of the 2006 High-level Dialogue on International Migration and Development and the follow-up thereto (General Assembly resolutions 61/208 and 62/270), the preparations for the second High-level Dialogue (scheduled for September 2013) and the attention given to the topic by the Commission on Population and Development (see Commission resolution 2006/2).
- 9.97 The subprogramme will enhance substantive support for and servicing of intergovernmental bodies (the Commission on Population and Development and the General Assembly) in relation to agenda items relevant to the field of population, through the preparation of high-quality documentation, analytical work and the facilitation of consensus-building and policy development. Activities carried out under the subprogramme support the implementation of the recommendations contained in the Programme of Action of the International Conference on Population and Development; the key actions for the further implementation of the Programme of Action, adopted at the twenty-first special session of the Assembly; the outcomes of the Millennium Summit and high-level follow-up meetings; and “The future we want”. In particular, activities include monitoring progress towards the achievement of the goals set out in the Programme of Action, the Millennium Development Goals and the sustainable development goals, as well as analysing and investigating new policy issues and emerging global trends in the fields of population and sustainable development.

- 9.98 The subprogramme will continue to strengthen and expand the distribution of population information in digital form, including through CD-ROMs and expanded and improved websites and online databases, in order to respond effectively to the growing demand for timely information and data and to support coordination among United Nations entities in the area of population.
- 9.99 The functions of the Population Division are increasingly serving as the basis for the population activities of the United Nations Secretariat. The objectives of the subprogramme are to strengthen the international community's capacity to effectively address current and emerging population issues; to integrate population dimensions into the international development agenda, including the sustainable development goals; and to assist Member States in the formulation of the post-2015 development agenda. To this end, the subprogramme will increase understanding of the nature of demographic phenomena, in particular the interrelationship between population and sustainable development, by: (a) providing substantive support to United Nations bodies, especially to the Commission on Population and Development, and assessing progress made in the implementation of the Programme of Action of the International Conference on Population and Development and towards the achievement of the internationally agreed development goals, including the Millennium Development Goals; (b) facilitating the discussion by experts or government representatives of key or emerging population issues and their interlinkages with sustainable development; (c) preparing comprehensive and sex-disaggregated studies on population issues and population trends relating to fertility, including indicators of reproductive health, mortality, international and internal migration, HIV/AIDS, urbanization and spatial distribution of population, population growth, population ageing, population policy and population in relation to development; (d) disseminating population information and policy-relevant findings in the area of population, in particular through improved Population Division databases and websites, and by using new information technology dissemination tools; and (e) building capacity to address population issues at the national level through workshops or the dissemination of technical material such as manuals and software.

- 9.103 The amount of \$13,378,800, reflecting a decrease of \$382,200, would provide for: (a) \$12,703,400 for 44 posts (1 D-2, 2 D-1, 7 P-5, 7 P-4, 9 P-3, 2 P-2 and 16 General Service (4 Principal level and 12 Other level)) to provide substantive servicing to various intergovernmental bodies, including the Fifth Committee, the Statistical Commission and the Committee of Experts on Global Geospatial Information Management, and to assist national and international information systems in the areas of: (i) statistical capacity-building; (ii) standards and methodological development; (iii) the coordination of international statistical activities; (iv) data dissemination; and (v) support for the development of geospatial information systems; and (b) \$675,400 for non-post requirements, including other staff costs (\$83,200), consultants (\$195,200), experts (\$101,800), travel of staff (\$102,100), contractual services (\$102,600), supplies and materials (\$26,100) and furniture and equipment (\$64,400). The decrease in resources is due mainly to the abolishment of one post of Population Affairs Officer (P-3) and reductions under consultants and experts in line with resolution 67/248, as reflected in table 9.6, item 2, of the present report.
- 9.104 For the biennium 2014-2015, no provision is made for extrabudgetary resources, owing to the completion of projects related to population and development during the biennium 2012-2013. There are no commitments to extend these funding arrangements, given the current global financial situation, which may affect the level of voluntary contributions in the biennium 2014-2015.

## Subprogramme 6

### Development policy and analysis

**Resource requirements (before recosting): \$13,180,400**

- 9.105 The subprogramme falls under the responsibility of the Development Policy and Analysis Division. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 6 of programme 7 of the biennial programme plan for the period 2014-2015.

- 9.106 To achieve the subprogramme's objectives, the Division carries out three core functions: (a) assisting the General Assembly and the Economic and Social Council in identifying and better understanding crucial economic development issues and challenges, in particular in the context of accelerating the implementation of the Millennium Development Goals, and formulating a sustainable development agenda beyond 2015; (b) fostering and disseminating a concerted United Nations view on the world economic outlook and its implications for the prospects of developing countries; and (c) providing assistance for the strengthening of the capacity for policy analysis in developing countries through the integration of macroeconomic and social policies into national development strategies.

9.110 The amount of \$13,180,400, reflecting a decrease of \$743,300, would provide for: (a) \$12,422,300 for 44 posts (1 D-2, 3 D-1, 5 P-5, 8 P-4, 5 P-3, 4 P-2 and 18 General Service (7 Principal level and 11 Other level)) to provide substantive and administrative support to the Committee for Development Policy and for the intergovernmental process in identifying and understanding new and emerging economic issues, pursuing improved dialogue on the world economic situation, and strengthening the capacity of developing countries to integrate macroeconomic and social policies into national development strategies; and (b) \$758,100 for non-post requirements, including other staff costs (\$65,400), consultants (\$132,500), experts (\$262,800), travel of staff (\$132,100), contractual services (\$68,500), supplies and materials (\$29,700) and furniture and equipment (\$67,100). The decrease in resources is due mainly to: (a) the abolishment of one post of Associate Economic Affairs Officer (P-2) and one post of Staff Assistant (General Service (Other level)) in line with resolution 67/248, as reflected in table 9.6, item 2, of the present report; and (b) the removal of non-recurrent provisions for 2013 related to the implementation of United Nations Conference on Sustainable Development activities during the biennium 2012-2013.

9.111 For the biennium 2014-2015, no provision is made for extrabudgetary resources, owing to the completion of related projects and given the current global financial situation, which may affect the level of voluntary contributions during the biennium 2014-2015.

## **Subprogramme 7**

### **Public administration and development management**

#### ***Resource requirements (before recosting): \$13,327,700***

9.112 Substantive responsibility for the subprogramme is vested in the Division for Public Administration and Development Management. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 7 of programme 7 of the biennial programme plan for the period 2014-2015.

9.113 The strategy for achieving the expected accomplishments of the subprogramme, in particular in the work focus areas of institutional and human resource capacity development, electronic/mobile government development, citizen engagement in managing development and open government data management, is based on an integrated approach that includes preventing corruption by:

- (a) Providing secretariat and substantive support to the General Assembly and the Economic and Social Council;

- (b) Promoting greater awareness, common approaches, understanding and sustainable policy options among Governments in key substantive areas of public governance, administration and development management, particularly through the Committee of Experts on Public Administration, the United Nations Public Service Awards and United Nations Public Service Day;
- (c) Strengthening partnerships and cooperation with other international, regional and professional organizations, both public and private, and within and outside the United Nations system, particularly through the United Nations Public Administration Network;
- (d) Providing advisory services, training activities and knowledge-sharing, and offering information, policy options and policy recommendations, developed as a result of research and analysis undertaken by the subprogramme, including through the United Nations Public Administration Country Studies, to developing countries, especially least developed countries, countries emerging from conflict or crisis and countries with economies in transition.

9.128 The amount of \$8,649,100, reflecting an increase of \$736,200, would provide for: (a) \$6,991,700 for 22 posts (1 D-2, 2 D-1, 4 P-5, 4 P-4, 5 P-3 and 6 General Service (Other level)) to provide support for the intergovernmental processes entrusted with the follow-up to the outcomes of the 2002 International Conference on Financing for Development and the 2008 Follow-up International Conference on Financing for Development to Review the Implementation of the Monterrey

- 9.133 The amount of \$7,393,600, reflecting a decrease of \$519,600, would provide for: (a) \$3,810,400 for the continuation of 15 posts (1 D-1, 2 P-5, 3 P-4 and 9 General Service (2 Principal level and 7 Other level)) to assist the Under-Secretary-General in the discharge of the Department's responsibilities in the areas of personnel, finance and general administration; and (b) \$3,583,200 for non-post requirements, including other staff costs (\$452,400), contractual services (\$1,956,500), general operating expenses (\$1,003,000), hospitality (\$22,600), supplies and materials (\$6,500) and furniture and equipment (\$142,200). 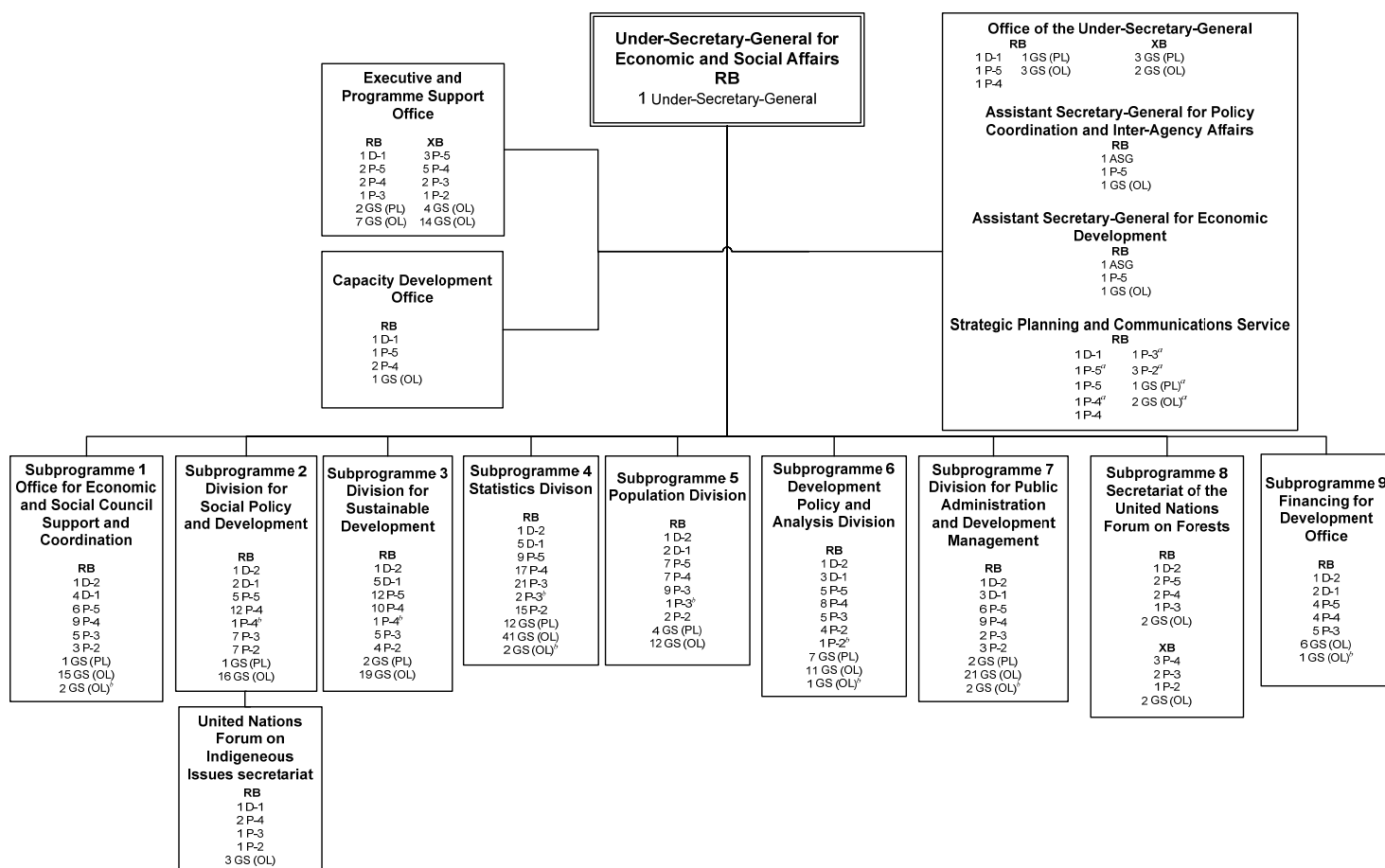

- 9.139 For the biennium 2014-2015, the projected extrabudgetary resources of \$136,780 represent the operational portfolio that will deliver the Department's capacity development activities, funded under donor arrangements. The decrease of \$726,800 is due to an anticipated decline in voluntary contributions based on current portfolio, pipeline projects and donor funding constraints.
