

# Appointment of members and alternate members of the **United Nations Staff Pension Committee**

# **Note by the Secretary-General**

- The Secretary-General has received notification of the resignation of Gerhard Kuntzle (Germany) from the United Nations Staff Pension Committee, with effect from 16 June 2014. Accordingly, the General Assembly will be required to appoint, at its current session, a person to fill the vacancy for the remaining period of the term of office of Mr. Kuntzle, which expires on 31 December 2016.
- The Government of Germany has nominated Jörg Stosberg to fill the vacancy arising from the resignation of Mr. Kuntzle.
- In a communication dated 1 July 2014, the Secretariat was informed by the Chair of Western European and Other States that the candidature of Mr. Stosberg had been endorsed by the group.
