

## Appointments to fill vacancies in subsidiary organs and other appointments: appointment of members of the Committee on Contributions


## **Report of the Fifth Committee**

Rapporteur: Mr. Matthias **Dettling** (Switzerland)

- 1. At its 2nd plenary meeting, on 19 September 2014, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-ninth session the item entitled "Appointments to fill vacancies in subsidiary organs and other appointments: appointment of members of the Committee on Contributions" and to allocate it to the Fifth Committee.
- 2. At its 11th meeting, on 7 November 2014, the Fifth Committee had before it the following documents:
- (a) Note by the Secretary-General concerning the vacancies in the membership of the Committee on Contributions that would occur as a result of the expiration of the term of office of six of its members on 31 December 2014 and the existing vacancy as a result of the resignation of a member whose term of office would have expired on 31 December 2016 (A/69/102/Rev.1);
- (b) Note by the Secretary-General containing the names of six persons nominated by their respective Governments for appointment or reappointment to the Committee on Contributions for a three-year term of office beginning on 1 January 2015 and the person nominated by the Government of Libya to fill the existing vacancy for a term of office beginning on the date of adoption of the decision by the General Assembly and ending on 31 December 2016 (A/C.5/69/6).
- 3. At the same meeting, the Committee decided, by acclamation, to recommend to the General Assembly that it appoint Fu Daopeng (China), Kunal Khatri (United Kingdom of Great Britain and Northern Ireland), Nikolay Lozinskiy (Russian Federation), Henrique da Silveira Sardinha Pinto (Brazil), Thomas Schlesinger (Austria) and Dae-jong Yoo (Republic of Korea) as members of the Committee on Contributions for a three-year term of office beginning on 1 January 2015 (see para. 5).







4. Also at the same meeting, the Committee decided, by acclamation, to recommend to the General Assembly that it appoint Mohamed A. Elshakshuki (Libya) as a member of the Committee on Contributions for a term of office beginning on the date of adoption of the decision by the Assembly and ending on 31 December 2016 (see para. 5).

## **Recommendation of the Fifth Committee**

- 5. The Fifth Committee recommends that the General Assembly:
- (a) Appoint the following persons as members of the Committee on Contributions for a three-year term of office beginning on 1 January 2015:

Fu Daopeng (China)

Kunal Khatri (United Kingdom of Great Britain and Northern Ireland)

Nikolay Lozinskiy (Russian Federation)

Henrique da Silveira Sardinha Pinto (Brazil)

Thomas Schlesinger (Austria)

Dae-jong Yoo (Republic of Korea);

(b) Appoint Mohamed A. Elshakshuki (Libya) as a member of the Committee on Contributions for a term of office beginning on the date of adoption of the decision by the General Assembly and ending on 31 December 2016.
