

# Financing of the African Union-United Nations Hybrid Operation in Darfur

# Report of the Fifth Committee

Rapporteur: Mr. Matthias Dettling (Switzerland)

#### I. Introduction

- 1. At its 2nd plenary meeting, on 19 September 2014, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-ninth session the item entitled "Financing of the African Union-United Nations Hybrid Operation in Darfur" and to allocate it to the Fifth Committee.
- 2. The Fifth Committee considered the item at its 25th and resumed 27th meetings, on 18 and 29 December 2014. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records (A/C.5/69/SR.25 and 27/Add.1).
- 3. For its consideration of the item, the Committee had before it the following documents:
- (a) Report of the Secretary-General on the revised budget for the African Union-United Nations Hybrid Operation in Darfur for the period from 1 July 2014 to 30 June 2015 (A/69/549);
- (b) Related report of the Advisory Committee on Administrative and Budgetary Questions (A/69/671).

# II. Consideration of draft resolution A/C.5/69/L.16

- 4. At its resumed 27th meeting, on 29 December 2014, the Committee had before it a draft resolution entitled "Financing of the African Union-United Nations Hybrid Operation in Darfur" (A/C.5/69/L.16), submitted by the Chair of the Committee on the basis of informal consultations coordinated by the representative of Poland.
- 5. At the same meeting, the Committee adopted draft resolution A/C.5/69/L.16 without a vote (see para. 6).







# III. Recommendation of the Fifth Committee

6. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

# Financing of the African Union-United Nations Hybrid Operation in Darfur

The General Assembly,

Having considered the report of the Secretary-General on the financing of the African Union-United Nations Hybrid Operation in Darfur<sup>1</sup> and the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>2</sup>

Recalling Security Council resolution 1769 (2007) of 31 July 2007, by which the Council established the African Union-United Nations Hybrid Operation in Darfur for an initial period of 12 months from 31 July 2007, and the subsequent resolutions by which the Council extended the mandate of the Operation, the latest of which was resolution 2173 (2014) of 27 August 2014, by which the Council extended the mandate of the Operation until 30 June 2015,

Recalling also its resolution 62/232 A of 22 December 2007 on the financing of the Operation and its subsequent resolutions thereon, the latest of which was resolution 68/297 of 30 June 2014,

- 1. *Endorses* the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions, <sup>2</sup> subject to the provisions of the present resolution, and requests the Secretary-General to ensure their full implementation;
  - 2. Takes note of paragraph of 32 of the report of the Advisory Committee;
- 3. Decides to defer consideration of the recommendations contained in paragraphs 54 and 55 of the report of the Advisory Committee until the second part of its resumed sixty-ninth session;
- 4. *Requests* the Secretary-General to continue his efforts to mitigate the environmental impact of the Operation in full compliance with the existing rules and relevant provisions of General Assembly resolutions;
- 5. Also requests the Secretary-General to ensure that the Operation continues to implement mine detection and clearing services in a timely manner;
- 6. *Requests* the Secretary-General to make every effort to ensure that all planned quick-impact projects are completed in a timely manner;

#### Budget estimates for the period from 1 July 2014 to 30 June 2015

7. Decides to appropriate to the Special Account for the African Union-United Nations Hybrid Operation in Darfur the amount of 1,153,611,300 United States dollars for the maintenance of the Operation for the period from 1 July 2014 to 30 June 2015, inclusive of the amount of 639,654,200 dollars previously

authorized for the Operation for the period from 1 July to 31 December 2014 under the terms of its resolution 68/297;

#### Financing of the appropriation

- 8. Also decides, taking into account the amount of 639,654,200 dollars already apportioned under the terms of its resolution 68/297 for the period from 1 July to 31 December 2014, to apportion among Member States the additional amount of 513,957,100 dollars for the maintenance of the Operation for the period from 1 July 2014 to 30 June 2015, in accordance with the levels updated in its resolution 67/239 of 24 December 2012, taking into account the scale of assessments for 2014 and 2015, as set out in its resolution 67/238 of 24 December 2012;
- 9. Further decides that, in accordance with the provisions of its resolution 973 (X) of 15 December 1955, there shall be set off against the apportionment among Member States, as provided for in paragraph 8 above, their respective share in the Tax Equalization Fund of 11,167,950 dollars, representing the balance of the estimated staff assessment income of 22,864,300 dollars approved for the Operation;
- 10. Decides to keep under review during its sixty-ninth session the item entitled "Financing of the African Union-United Nations Hybrid Operation in Darfur".
