

# I. Introduction

- 1. The previous recommendations made by the Fifth Committee to the General Assembly under agenda item 131 are set out in the reports of the Committee contained in documents A/69/702 and Add.1.
- 2. The Fifth Committee resumed its consideration of the item at its 44th meeting, on 24 June 2015. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary record (A/C.5/69/SR.44).
