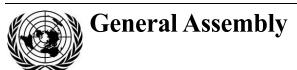

Overall orientation

- 9.1 The overall objective of the programme is to promote and support international cooperation in the pursuit of sustainable development for all. While focused on tackling interlinked challenges in the social, economic and environmental fields, the programme also seeks to contribute to a mutually reinforcing relationship among the three pillars of United Nations work: peace and security, development and human rights.
- 9.2 The programme, which is under the responsibility of the Department of Economic and Social Affairs, ensures complementarity and synergy among its nine subprogrammes. Its key programmatic thrusts are: (a) to provide substantive support to the bodies established under the Charter of the United Nations dealing with development issues, namely, the General Assembly, the Economic and Social Council and its related functional commissions, and expert bodies; (b) to monitor and analyse development trends, prospects and policy issues globally; and (c) to provide support for capacity development in policy formulation and implementation, in particular in relation to the advancement of the United Nations development agenda beyond 2015 (subject to approval by the General Assembly), through, inter alia, the implementation of the regular programme of technical cooperation and Development Account projects.

- 9.3 The programme has placed development issues at the centre of global deliberations and helped Member States to forge a shared vision of development, as identified in the outcomes of major United Nations conferences and summits, including the outcome of the United Nations Conference on Sustainable Development, entitled "The future we want" (General Assembly resolution 66/288, annex). The programme supports the advancement of the United Nations development agenda beyond 2015 (subject to approval by the General Assembly), including linkages to the Conference and its follow-up process.
- In the biennium 2016-2017, the programme will continue to mobilize and provide practical support to help translate the development commitments into action. It will focus on the delivery of four main functions: (a) monitoring, research and analysis of development issues and emerging challenges, including through support for the global statistical system; (b) normative and policy support for United Nations intergovernmental processes; (c) assistance in capacity development to support the implementation of global conference outcomes at the country level; and (d) fostering collaboration and partnerships within the United Nations system and with civil society and the private sector, while ensuring proper accountability and oversight by Member States. Increased attention will be given to capacity development needs of the least developed countries, small island developing States and countries emerging from conflict.
- 9.5 Fulfilling those functions requires strengthened analytical and monitoring capacity to identify and address emerging issues and cross-cutting policy challenges and to support both national development strategies and accountability and monitoring mechanisms at the intergovernmental level. Strategic integration is also essential to promoting a coherent and coordinated implementation process for the internationally agreed development goals in the context of advancing the United Nations development agenda beyond 2015 (subject to approval by the General Assembly). This includes enhancing horizontal linkages across the subprogrammes to facilitate more effective and flexible support for Member States in pursuing the development agenda and the follow-up to the United Nations Conference on Sustainable Development, in cooperation with entities of the Executive Committee on Economic and Social Affairs, to which the programme provides strategic support and ensures its stronger linkages with the United Nations Development Group, other executive committees and various other partners.
- 9.6 The programme will continue to emphasize the mainstreaming of gender perspectives into its subprogrammes.

Overview of resources

- 9.7 The overall resources proposed for the biennium 2016-2017 for this section amount to \$170,578,500 before recosting, reflecting a net increase of \$6,789,500 (or 4.1 per cent) compared with the appropriation for 2014-2015. Resource changes result from four factors, namely: (a) technical adjustments relating to the removal of non-recurrent requirements; (b) new mandates and inter-component changes; (c) resource changes in line with General Assembly resolution 69/264 (further reductions); and (d) resource changes in line with General Assembly resolution 69/264 on efficiencies. The proposed reductions will not impact full and effective mandate implementation.
- 9.8 Resource changes in line with General Assembly resolution 69/264 reflect the proposed abolishment of two posts (P-5 and General Service (Other level)) in subprogrammes 3 and 4, respectively, and freezing recruitment against established posts, as well as reductions in non-post resources that are anticipated in 2016-2017.
- 9.9 The proposed reductions will be influenced by the future impact of the deployment of Umoja (Foundation and Extension 1) by the end of 2015. As it is too early to determine the specific future

impact of Umoja, the proposed reductions, while firm in financial terms, are flexible in operational terms. The flexibility means that the specific composition of the post freezes, and the reorganization of functions and roles as a result of the freezes and abolishment of posts, will be determined only during 2016-2017, when the impact of Umoja becomes clearer.

Technical adjustments

9.11 Resource changes reflect the removal of non-recurrent requirements totalling \$5,502,900 related to the implementation of the outcome of the United Nations Conference on Sustainable Development and the support to the Third International Conference on Small Island Developing States, pursuant to General Assembly resolutions 66/288 and 67/207, respectively.

New mandates and inter-component changes

9.12 Resources in the amount of \$13,357,600 have been provided in support of new mandates related to: (a) the Secretariat's contribution to the United Nations Resident Coordinator System (\$13 million), in accordance with part VI of General Assembly resolution 69/262; and (b) the establishment of a new P-4 post (\$357,600), pursuant to General Assembly resolution 69/15 on the implementation of the outcome of the Third International Conference on Small Island Developing States (SAMOA Pathway).

Resource changes in line with General Assembly resolution 69/264 (Further reductions)

9.13 Resource changes of \$832,900 are proposed in line with General Assembly resolution 69/264, under posts (\$583,300) and non-post requirements (\$249,600). The decrease of \$583,300 under posts reflects the proposed abolishment of two posts (P-5 and GS (OL)) in subprogrammes 3 (\$418,600) and 4 (\$164,700). A reduction of \$249,600 in non-post resources relates mainly to travel of staff that takes into account the anticipated impact of the approved standards of accommodation for air travel, and further efficiencies that the Department plans to bring about in 2016-2017.

Resource changes in line with General Assembly resolution 69/264 (Efficiencies)

9.14 Resource changes of \$232,300 are proposed in line with General Assembly resolution 69/264, under posts (\$159,900) and non-post resources (\$72,400). The decrease in post resources reflects proposals of freezing recruitment against established posts. The reduced requirements under non-post resources relate to communications, contractual services, furniture and equipment, and office automation equipment.

Extrabudgetary resources

9.15 During the biennium 2016-2017, total projected extrabudgetary resources amounting to \$150,165,100 will supplement resources from the regular budget to provide for various substantive and technical cooperation activities, including consultancy, expert groups, travel, technical advisory services, training, workshops, seminars and field projects.

Other information

- 9.16 The Department will conduct self-evaluations and self-assessments and will report on the implementation of evaluation activities. Training programmes on monitoring and evaluation will be organized to further strengthen departmental monitoring and evaluation capacity. The departmental evaluation policy serves as a basis for the monitoring and evaluation activities.
- 9.17 Pursuant to General Assembly resolution 58/269, resources identified for the conduct of monitoring and evaluation would amount to \$282,800, representing a total of 22 work-months of Professional/ General Service staff for the biennium 2016-2017, funded from regular budget resources.
- 9.18 The issuance of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as summarized in table 9.6 below and as distributed in the output information for each subprogramme.

9.19 The Department's publications are also a revenue source for the Secretariat, generating \$3.4 million in sales and subscriptions in 2013 and 2014.

9.20 Provision is made under this subsection for requirements related to standing intergovernmental organs and expert bodies, special sessions of the General Assembly and intergovernmental processes, the servicing of which is the responsibility of the Department of Economic and Social Affairs and which are deemed to require specific provisions. The provision for experts serving on committees in their individual capacity are in accordance with General Assembly resolution 2491 (XXIII), as amended by resolutions 41/176, 42/25, section VI, and 43/217, section IX, while the provisions for members of the functional commissions are in accordance with General Assembly resolutions 1798 (XVII), 2128 (XX) and 2245 (XXI).

Standing intergovernmental organs and expert bodies

Statistical Commission

Resource requirements (before recosting): \$106,900

- 9.21 The Statistical Commission was established by the Economic and Social Council in its resolution 8 (I). Its terms of reference, as set out in Council resolutions 8 (I), 8 (II) and 1566 (L), are to assist the Council in: promoting the development of national statistics and the improvement of their comparability; coordinating the statistical work of the specialized agencies; developing the central statistical services of the Secretariat; advising the organs of the United Nations on general questions relating to the collection, interpretation and dissemination of statistical information; and promoting the improvement of statistical methods in general. The Commission consists of 24 representatives of Member States elected by the Council for a period of four years.
- 9.22 Bearing in mind General Assembly resolution 50/227 and the need to provide for more continuity in the Commission's decision-making and oversight with respect to the global statistical process, and with the aim of enabling the Commission to follow up on the statistical implications of the major United Nations conferences and summits, the Council, in its resolution 1999/8, decided that the Commission would meet annually for a period of four working days in New York, beginning in 2000.
- 9.23 The forty-seventh and forty-eighth sessions of the Statistical Commission are scheduled to be held in 2016 and 2017, respectively.

Commission on Population and Development

Resource requirements (before recosting): \$122,500

- 9.24 The Population Commission was established by the Economic and Social Council in its resolution 3 (III). Its terms of reference were initially set out in Council resolution 150 (VII). In its resolution 49/128, the General Assembly decided that the revitalized Population Commission would be renamed the Commission on Population and Development and that it would meet on an annual basis. The Commission is composed of 47 representatives of Member States elected by the Council for a period of four years (Council decision 1995/320). It normally meets annually for a period of five working days.
- 9.25 Under its terms of reference, the Commission is to assist the Council by: (a) arranging for studies and advising the Council on population issues and trends, the integration of population and development strategies, population and related development policies and programmes and the provision of population assistance, as well as addressing population and development questions on which either the principal or the subsidiary organs of the United Nations or the specialized agencies may seek advice; (b) monitoring, reviewing and assessing the implementation of the Programme of Action of the International Conference on Population and Development at the national, regional and global levels, identifying reasons for success and failure, and advising the Council thereon; and (c) reviewing the findings of research and analysis pertaining to the interrelationships between population and development at the national, regional and international levels and advising the Council thereon.
- 9.26 Pursuant to General Assembly resolution 57/270 B, the Commission reviewed its methods of work at its thirty-eighth session, in 2005, and at its thirty-ninth session, in 2006. In its decision 2005/2, entitled "Methods of work of the Commission on Population and Development", the Commission reaffirmed its central role in coordinating the review and assessment of the overall implementation of the Programme of Action of the International Conference on Population and Development and

the outcome of the twenty-first special session of the General Assembly, and reiterated the need to conduct periodically comprehensive reviews and appraisals of the implementation of the Programme of Action and the key actions for its further implementation. By its resolution 2006/1, the Commission decided that it would adopt a multi-year programme of work limited to a two-year planning horizon, based on special themes from the Programme of Action of the International Conference on Population and Development, and that in considering those annual themes, it would continue to review and assess both their substantive and policy aspects as well as the progress made in programme implementation in relation to the themes. Furthermore, the General Assembly decided in 2011, by its resolution 65/234, to extend the Programme of Action and the key actions for its further implementation beyond 2014, and ensure its follow-up in order to fully meet its goals and objectives.

9.27 The forty-ninth and fiftieth sessions of the Commission on Population and Development are scheduled to be held in 2016 and 2017, respectively.

Commission for Social Development

Resource requirements (before recosting): \$204,300

- 9.28 The Social Commission was established as a functional commission of the Economic and Social Council by the Council in its resolution 10 (II). As a result of a comprehensive reappraisal of the role of the Commission, the Council, in its resolution 1139 (XLI), renamed it the Commission for Social Development to clarify its role as a preparatory body of the Council for the entire range of social development policy. Following the convening of the World Summit for Social Development in 1995, the Council, by its resolution 1995/60, decided that the Commission should review, on a periodic basis, issues related to the follow-up and implementation of the Copenhagen Declaration on Social Development and the Programme of Action adopted by the Summit. By its resolution 1996/7, the Council decided to expand the membership of the Commission from 32 to 46 representatives of Member States, elected by the Council for a period of four years, and that it should meet in annual sessions of eight working days. The Council also decided by its resolution 2005/11, that the Commission would be organized in a series of two-year action-oriented implementation cycles that would include a review segment and a policy segment.
- 9.29 The fifty-fourth and fifty-fifth sessions of the Commission for Social Development are scheduled to be held in 2016 and 2017, respectively.

High-level political forum follow-up on the implementation of sustainable development Resource requirements (before recosting): \$746,100

9.30 The General Assembly, in resolution 66/288, decided to establish a universal, intergovernmental, high-level political forum on sustainable development. The forum replaced the Commission on Sustainable Development and builds on the strengths, experiences, resources and inclusive participation modalities of the Commission. The format and organizational aspects of the high-level political forum are outlined in General Assembly resolution 67/290. The High-Level Political Forum provides political leadership, guidance and recommendations for sustainable development, follows up and reviews progress in the implementation of sustainable development commitments, enhances the integration of the three dimensions of sustainable development and has a focused, dynamic and action-oriented agenda, ensuring the appropriate consideration of new and emerging sustainable development challenges. The annual meetings of the forum are convened under the auspices of the Economic and Social Council. The forum convenes every four years under the auspices of the General Assembly at the level of heads of State, the next session of which will take place in 2017.

9.31 The General Assembly, in part XIV of its resolution 68/247, approved funding support for the participation of representatives from least developed countries to attend the sessions of the forum, which is also implemented in accordance with the provisions of resolution 65/286.

Committee for Development Policy

Resource requirements (before recosting): \$357,400

- 9.32 The Economic and Social Council, in annex I to its resolution 1998/46, renamed the Committee for Development Planning, functioning in accordance with Council resolutions 1035 (XXXVII) and 1079 (XXXIX) and decision 1995/215, the Committee for Development Policy and reconfirmed its status as a subsidiary body of the Council. In accordance with Council resolution 1998/46, the Committee is composed of 24 independent experts who possess expertise in the fields of economic development, social development and environmental protection and who reflect adequate geographical and gender balance. Its membership includes experts who are able to make contributions in terms of emerging issues and the multilateral process. The experts are nominated by the Secretary-General following consultation with interested Governments and are approved by the Council. The term of office of each member is three years.
- 9.33 The Committee is called upon to undertake a triennial review of the status of least developed countries and to meet on that issue once every three years. Since the adoption in 1997 of additional guidelines for the identification of least developed countries, this has also involved undertaking impact assessments of countries found to be eligible for graduation. Furthermore, the Committee reports to the Council its findings with respect of the monitoring exercises on the development progress of countries graduating from the list of least developed countries. In its resolution 67/221, the General Assembly requested the Committee to monitor the development progress of graduated countries on an annual basis for the first three years after graduation became effective and triennially thereafter. Economic and Social Council resolution 2011/20 reflects the Council's intention to engage in more frequent interactions with the Committee on the themes of the high-level segment and on other pertinent issues that the Committee wishes to bring to the attention of the Council.
- 9.34 The eighteenth and nineteenth sessions of the Committee for Development Policy are scheduled to be held in 2016 and 2017, respectively.

Committee of Experts on Public Administration

Resource requirements (before recosting): \$334,700

- 9.35 The Committee of Experts on Public Administration, which has been holding annual sessions since 2003 in accordance with Economic and Social Council resolution 2003/60, was established by the Council in its resolution 2001/45 and consists of 24 experts appointed in their personal capacity by the Council upon their nomination by the Secretary-General. The Committee's role is twofold: first, to support intergovernmental deliberations in providing policy options and making recommendations to Member States to improve governance and public administration structures and processes for development; and secondly, to guide and monitor the performance of the Division for Public Administration and Development Management in the implementation of the United Nations Programme in Public Administration and Development.
- 9.36 The fifteenth and sixteenth sessions of the Committee of Experts on Public Administration are scheduled to be held in 2016 and 2017, respectively.

Committee of Experts on International Cooperation in Tax Matters

Resource requirements (before recosting): \$353,600

- 9.37 By its resolution 2004/69, the Economic and Social Council decided to rename the Ad Hoc Group of Experts on International Cooperation in Tax Matters the Committee of Experts on International Cooperation in Tax Matters. The Committee comprises 25 members who act in their expert capacity, nominated by Governments. The members are appointed by the Secretary-General, after the notification of the Council, for a term of four years and are drawn from the fields of tax policy and tax administration. Their appointment reflects adequate equitable geographical distribution, representing different tax systems. As from 2005, the Committee meets on a yearly basis for a period of five days in Geneva.
- 9.38 The Committee of Experts on International Cooperation in Tax Matters is mandated to: (a) keep under review and update as necessary the United Nations Model Double Taxation Convention between Developed and Developing Countries and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries; (b) provide a framework for dialogue with a view to enhancing and promoting international tax cooperation among national tax authorities; (c) consider how new and emerging issues could affect international cooperation in tax matters and develop assessments, commentaries and appropriate recommendations; (d) make recommendations on capacity-building and the provision of technical assistance to developing countries and countries with economies in transition; and (e) give special attention to developing countries and countries with economies in transition in dealing with all the aforementioned issues. The Committee submits its report on the work of its annual session to the Economic and Social Council at its substantive session.
- 9.39 In its resolution 2006/48, the Economic and Social Council noted the creation of four subcommittees on substantive matters, namely, treaty abuses, mutual assistance in collecting tax debts, the definition of permanent establishment, and the exchange of information, and two working groups, on international tax arbitration and the Manual for the Negotiation of Bilateral Tax Treaties between Developed and Developing Countries.
- 9.40 In its resolution 2008/16, the Economic and Social Council recognized that the Committee had agreed to create, as necessary, ad hoc subcommittees composed of experts and observers who would work according to the Committee's rules of procedure to prepare and determine the supporting documentation for the agenda items, including requests for papers by independent experts, for consideration at its regular session.
- 9.41 At each annual session, the Committee reviews the list of subcommittees and working groups and decides to terminate those that have fulfilled their mandates and to establish new ones to be tasked with new mandates emerging from its programme of work.
- 9.42 The twelfth and thirteenth sessions of the Committee of Experts on International Cooperation in Tax Matters are scheduled to be held in 2016 and 2017, respectively.

United Nations Forum on Forests

Resource requirements (before recosting): \$101,500

9.43 By its resolution 2000/35, the Economic and Social Council established the United Nations Forum on Forests as an intergovernmental subsidiary body of the Council, to serve as a permanent policy and political forum, with the main objective of promoting the management, conservation and sustainable development of all types of forests, and to strengthen long-term political commitment to that end. The Forum is composed of all States Members of the United Nations and members of the specialized agencies with full and equal participation, including voting rights.

- 9.44 By its resolution 2006/49, the Economic and Social Council decided that following its seventh session, in 2007, the Forum would meet biennially for a period of up to two weeks on the basis of a focused multi-year programme of work adopted by the Forum as its seventh session.
- 9.45 The Forum is mandated to carry out principal functions related to supporting efforts to achieve the shared global objectives on forests; facilitating the implementation of a non-legally binding instrument on all types of forests; policy development; international coordination among organizations, instruments and institutions; international cooperation; monitoring, assessment and reporting; and strengthening political commitment. By its resolution 2006/49, the Economic and Social Council decided to strengthen the international arrangement on forests and accorded a mandate to the Forum through 2015.
- 9.46 The eleventh session of the United Nations Forum on Forests will be held in 2015, when the effectiveness of the international arrangement on forests will be reviewed and future options considered.

Permanent Forum on Indigenous Issues

Resource requirements (before recosting): \$353,600

- 9.47 The Economic and Social Council, in its resolution 2000/22, established the Permanent Forum on Indigenous Issues, as a subsidiary organ of the Council, consisting of 16 members, 8 members to be nominated by Governments and elected by the Council, and 8 members to be appointed by the President of the Council, following formal consultation with the Bureau and the regional groups, through their coordinators. Nominations are decided on the basis of broad consultations with indigenous organizations, taking into account the diversity and geographical distribution of the indigenous people of the world as well as the principles of transparency, representatively and equal opportunity for all indigenous people, including internal processes, when appropriate, and local indigenous consultation processes. All members serve in their personal capacity as independent experts on indigenous issues for a period of three years, with the possibility of re-election or reappointment for one further period. States, United Nations bodies and organs, intergovernmental organizations and non-governmental organizations in consultative status with the Council may participate as observers. Organizations of indigenous people may also participate as observers, in accordance with the procedures that have been applied in the Working Group on Indigenous Populations of the Subcommission on the Promotion and Protection of Human Rights.
- 9.48 The Economic and Social Council decided that the Permanent Forum shall hold an annual session of 10 working days at the United Nations Office at Geneva, United Nations Headquarters or such other place as the Permanent Forum may decide in accordance with existing Financial Rules and Regulations of the United Nations.
- 9.49 The fifteenth and sixteenth sessions of the Permanent Forum on Indigenous Issues are scheduled to be held in 2016 and 2017, respectively.
- 9.50 The distribution of resources for policymaking organs is reflected in table 9.8 below.

9.51 The amount of \$2,680,600, reflecting a decrease of \$724,700 would be required to cover the costs of travel of the Commission/Committee and Forum members for the annual and biennial sessions, respectively. The decrease in non-post resources results from the removal of non-recurrent requirements related to the implementation of the outcome of the United Nations Conference on Sustainable Development, pursuant to General Assembly resolution 66/288.

B. Executive direction and management

Resource requirements (before recosting): \$9,966,800

- 9.52 The Under-Secretary-General for Economic and Social Affairs is responsible for the overall direction, supervision and management of the Department in the implementation of its mandates and its approved programme of work. He serves as convener of the Executive Committee on Economic and Social Affairs as well as the Programme Manager of the Development Account and is responsible for the overall management of capacity development activities. The Under-Secretary-General is assisted by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs and the Assistant Secretary-General for Economic Development.
- 9.53 The Assistant Secretary-General for Economic Development serves as the principal economic adviser to the Under-Secretary-General, whom he assists by leading and coordinating the policy research and analysis work of the Department. The Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs supports the Under-Secretary-General by providing substantive support to the Economic and Social Council and other relevant intergovernmental bodies. The Office of the Under-Secretary-General provides support and advice to the Under-Secretary-General and, as appropriate, to the Assistant Secretaries-General on the planning, coordination, management and assessment of the work of the Department.
- 9.54 The Strategic Planning and Communications Service supports the Under-Secretary-General in promoting strategic integration and policy coherence, including collaborative work with other Secretariat entities and the formulation of policies and strategies in the areas of knowledge management, website communications, publishing and electronic administration. In addition, the Service represents the Department in relevant Secretariat policy and normative bodies, including the Publications Board, the Information and Communications Management Committee, the Data Governance Council and the Task Force on Knowledge Management.

9.56 The amount of \$9,966,800, reflecting a decrease of \$480,100 would provide for: (a) \$8,470,900 for 26 posts (1 Under-Secretary-General, 2 Assistant Secretary-General, 2 D-1, 5 P-5, 3 P-4, 1 P-3, 3 P-2 and 9 General Service (2 Principal level and 7 Other level)); and (b) \$1,495,900 for non-post requirements, including other staff costs, consultants, experts, travel of staff, contractual services, supplies and materials, furniture and equipment, and grants and contributions. The decrease in

9.74 The amount of \$18,291,300, reflecting a decrease of \$2,589,100 would provide for: (a) \$17,390,000 for 58 posts (1 D-2, 5 D-1, 11 P-5, 11 P-4, 5 P-3, 4 P-2 and 21 General Service (2 Principal level and 19 Other level)); and (b) \$901,300 for non-post requirements, including other staff costs, consultants, experts, travel of staff, contractual services, supplies and materials and furniture and equipment. The decrease in post resources results from the proposed abolishment of 1 P-5 post in line with General Assembly resolution 69/264, offset in part by the establishment of 1 P-4 post in the Small Island Developing States Unit for the implementation of resolution 69/15 on the outcome of the Third International Conference on Small Island Developing States (SAMOA Pathway). The decrease in non-post resources reflects: the removal of non-recurrent requirements related to the implementation of the outcome of the Fourth United Nations Conference on Sustainable Development and the

- support to the Third International Conference on Small Island Developing States, pursuant to General Assembly resolutions 66/288 and 67/207, respectively; and further reductions under travel of staff that take into account the anticipated impact of the approved standards of accommodation for air travel in line with General Assembly resolution 69/264.
- 9.75 During the biennium 2016-2017, projected extrabudgetary resources of \$1,565,000 under this subprogramme would be used: (a) to support the participation of representatives of developing countries and countries with economies in transition in a range of meetings related to sustainable development and in the intergovernmental meetings; (b) to support analytical and technical cooperation work programmes related to energy and water; and (c) to support activities relating to paragraphs 9, 20, 25 and 26 of the Johannesburg Plan of Implementation, including among others, paragraphs 125 to 129 and 119 to 124 of "The future we want".

Subprogramme 4 Statistics

Resource requirements (before recosting): \$33,836,400

- 9.76 Substantive responsibility for this subprogramme is vested within the Statistics Division. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 4 of programme 7 of the biennial programme plan for the period 2016-2017.
- 9.77 The Statistics Division carries out its activities in close cooperation with national statistical offices and national geospatial information agencies. It works in collaboration with other offices of the Secretariat, the regional commissions, United Nations specialized agencies, funds and programmes and non-United Nations intergovernmental organizations. In particular, the Division acts as the secretariat for the Statistical Commission, the Committee of Experts on Global Geospatial Information Management and other intergovernmental bodies in the area of geographical information management, all of which report to the Economic and Social Council. The Division also serves the Committee for the Coordination of Statistical Activities.
- 9.78 The structure of the Division's programme has five parts: (a) statistical capacity-building; (b) standards and methodological development; (c) the coordination of international statistical activities; (d) data dissemination; and (e) support for the development of geospatial information systems. In statistical capacity-building programmes, the Division helps Member States to build sound national statistical systems, which include solid institutional infrastructures, systematic data collection activities, the compilation of aggregate macroeconomic and social statistics according to global standards and norms, and a multichannel data dissemination system. In the area of methodological work, the Division develops manuals essential for the compilation of reliable and comparable statistics. Other methodological guidelines are also established for the collection, processing, analysis and dissemination of data. In the coordination of international statistical activities, the Division serves as the secretariat for the Statistical Commission and its bureau, as well as other coordinating bodies. In data dissemination, the Division supports national and international decision makers with a range of global statistical products. In line with a recent Economic and Social Council mandate, the Division is now also facilitating the development of an intergovernmental and inter-agency architecture for the area of geospatial information.
- 9.79 During the biennium 2016-2017, the Division will continue to focus on the development of core information programmes for a national statistical and geospatial information system. This will include activities related to the population census, economic surveys, the system of national accounts and its extensions, relevant environmental and trade statistics and geospatial information systems.

- 9.83 The amount of \$33,836,400, reflecting a decrease of \$452,700 would provide for: (a) \$31,868,800 for 121 posts (1 D-2, 5 D-1, 9 P-5, 17 P-4, 22 P-3, 15 P-2 and 52 General Service (12 Principal level and 40 Other level)) to provide substantive servicing to various intergovernmental bodies, including the Fifth Committee, the Statistical Commission and the Committee of Experts on Global Geospatial Information Management, and to assist national and international information systems in the areas of: (i) statistical capacity-building; (ii) standards and methodological development; (iii) the coordination of international statistical activities; (iv) data dissemination; and (v) support for the development of geospatial information systems; and (b) \$1,967,600 for non-post requirements, including other staff costs, consultants, experts, travel of staff, contractual services, supplies and materials and furniture and equipment. - 9.84 During the biennium 2016-2017, projected extrabudgetary resources of \$480,000 under the subprogramme will be used to: (a) build capacity of Member States on the organization and development of national statistical systems as well as the implementation of the Fundamental Principles for Official Statistics, endorsed by the General Assembly in its resolution 68/261, adopted by the Statistical Commission in 1994, reaffirmed in 2013, and endorsed by the Economic and Social Council in its resolution 2013/21; (b) provide training on the concepts and methodologies in the fields of economic, demographic, social, trade and environmental statistics, including the measurement and monitoring of the development indicators framework; and (c) support the implementation of the United Nations Programme on Global Geospatial Information Management in Member States.

Subprogramme 5 Population

Resource requirements (before recosting): \$13,500,500

9.85 Substantive responsibility for the subprogramme is vested in the Population Division. The subprogramme will be implemented in accordance with the strategy detailed under subprogramme 5 of programme 7 of the biennial programme plan for the period 2016-2017.

- 9.86 The Population Division of the Department of Economic and Social Affairs is responsible for monitoring the implementation of the Programme of Action of the International Conference on Population and Development in accordance with General Assembly resolutions 49/128 and S-21/2. It produces the population estimates and projections used throughout the United Nations system; prepares estimates of three of the four indicators associated with the Millennium Development Goals target of attaining universal access to reproductive health; contributes, in partnership with other United Nations agencies, to the production of estimates of child mortality (also a key Millennium Development Goal indicator); provides substantive secretariat support to the Commission on Population and Development of the Economic and Social Council; and participates in or leads technical groups on methodological developments related to the measurement of child mortality, adult mortality, HIV/AIDS and international migration. The Division is responsible for addressing all population issues, including international migration and development, the demographic impact of HIV/AIDS, population ageing, urbanization, fertility and reproductive health, national population policies and the interrelations between population dynamics and development, including the integration of population dimensions into the international development agenda and the monitoring of sustainable development goals.
- 9.87 The subprogramme will facilitate access for Governments and civil society to information on population trends, their demographic components and the interactions between population dynamics and sustainable development, including the gender dimensions of demographic phenomena, especially with regard to fertility, mortality, migration, HIV/AIDS, urbanization, population growth, population ageing and the environment, so as to provide a sound basis for the formulation of government policies and programmes. Official United Nations demographic estimates and projections will be prepared for all countries and areas of the world, as well as urban and rural areas and major cities, and will serve as a standard, consistent set of population figures for use throughout the United Nations system, including for the production of indicators for monitoring progress towards the achievement of all internationally agreed goals, including the Millennium Development Goals and sustainable development goals. Internal and international migration, urbanization, fertility and reproductive health, the demographic impact of HIV/AIDS and the changing age structures of population and their impact on sustainable development are some of the areas identified as high priority in the outcome document of the United Nations Conference on Sustainable Development, "The future we want" (General Assembly resolution 66/288), the Millennium Declaration, the Millennium Development Goals, the Declaration of Commitment on HIV/AIDS, the Programme of Action of the International Conference on Population and Development and various resolutions adopted by the Commission on Population and Development. Work in the area of migration and its interrelationship with development has intensified as a result of the 2006 and the 2013 High-level Dialogue on International Migration and Development and the follow-up thereto (General Assembly resolutions 61/208, 62/270 and 68/4) and the attention given to the topic by the Commission on Population and Development (see Commission resolutions 2006/2 and 2013/1).
- 9.88 The subprogramme will enhance substantive support for and servicing of intergovernmental bodies (including the Commission on Population and Development and the General Assembly) in relation to agenda items relevant to the field of population, through the preparation of high-quality documentation, analytical work and the facilitation of consensus-building and policy development. Activities carried out under the subprogramme support the implementation of the recommendations contained in the Programme of Action of the International Conference on Population and Development; the key actions for the further implementation of the Programme of Action, adopted at the twenty-first special session of the Assembly; the outcomes of the Millennium Summit and highlevel follow-up meetings; and "The future we want". In particular, activities include monitoring progress towards the achievement of the goals set out in the Programme of Action, the Millennium

Development Goals and the sustainable development goals, as well as analysing and investigating new policy issues and emerging global trends in the field of population and sustainable development.

9.89 The subprogramme will continue to strengthen and expand the distribution of population information in digital form, including through expanded and improved websites and online databases, in order to respond effectively to the growing demand for timely information and data and to support coordination among United Nations entities in the area of population.

The reduced requirements also reflect the removal of non-recurrent provisions related to the implementation of the outcome of the United Nations Conference on Sustainable Development, pursuant to General Assembly resolution 66/288.
- 9.124 During the biennium 2016-2017, projected extrabudgetary resources of \$8,992,900 would be used to support the operational programmes of the Department and extrabudgetary activities under programme support. The decrease results from the expected completion of related projects in the biennium 2016-2017.

2. Capacity Development Office

Resource requirements (before recosting): \$2,013,200

- 9.125 The Capacity Development Office provides broad substantive guidance and management to the implementation of the Department's capacity development work, promoting effective translation of intergovernmental outcomes into the Department's operational programmes and capacity development work.
- 9.126 In the biennium 2016-2017, the Office will promote the Department's delivery of integrated policy advisory services drawing on the expertise of the subprogrammes of the Department of Economic and Social Affairs, as a contribution to the formulation of national sustainable development strategies, including the identification of policy options to balance the achievement of social, economic, and environmental goals.
- 9.127 The Office will also promote closer programme cooperation within the United Nations Secretariat and with other United Nations entities, in line with the call for a more coherent and coordinated system-wide approach in implementing the development agenda.
- 9.128 To maximize the effective delivery of the capacity development programme of the Department of Economic and Social Affairs, an integrated programming approach will be taken which ensures full complementarity and synergies between the various strands of the portfolio of the Department of Economic and Social Affairs, including the regular programme of technical cooperation, the Development Account and its extrabudgetary resources.
- 9.129 The Capacity Development Office also provides management oversight, including through monitoring, evaluation and reporting on the capacity development deliverables of the Department of Economic and Social Affairs. It provides efficient and effective administration and management of financial and human resources, including the delivery of extensive capacity development training workshops and Seminars. The Office supports the Under-Secretary-General in his role as Programme Manager of the Development Account, which involves the active management of approximately 150 Development Account projects at various stages of implementation. The Office also supports the management of the United Nations Secretariat's Associate Expert Programme, administering on average 200 experts per annum.
- 9.130 The distribution of resources for the Capacity Development Office is reflected in table 9.32 below.

- Development Account and the implementation of the Department's capacity development programmes, projects and strategy.
- 9.132 During the biennium 2016-2017, the projected extrabudgetary resources of \$130,450,000 represent the operational portfolio which delivers the Department's capacity development activities, funded under donor arrangements. The projected increase of \$1,700,000 is due to the implementation of additional operational projects during 2016-2017.

E. Support of United Nations Secretariat to the Resident Coordinator system

Resource requirements (before recosting): \$13,000,000

- 9.133 In its resolution 2011/7 of 18 July 2011, the Economic and Social Council invited the United Nations Development Group (UNDG) to conduct a review of existing funding modalities in support of the Resident Coordinator system, including appropriate burden-sharing arrangements. The General Assembly, in its resolution 67/226, requested the United Nations development system to submit, for the consideration of the Council and the Assembly in 2013, concrete proposals on the modalities for the funding of the system. In response, UNDG initiated an in-depth review on possible burden-sharing arrangements among the member agencies of UNDG, and after extensive consultations within the Group, and with the High-level Committee on Management/Finance and Budget Network, agreed upon a cost-sharing formula which is based on the size of each agency (expenditure level and head count), its programmatic focus and its draw on the resident coordinator system.
- 9.134 The cost-sharing formula was presented to the Economic and Social Council in the report of the Secretary-General (E/2013/94), and in its resolution 2013/5 the Council requested the respective governing bodies to consider the cost-sharing arrangement for implementation in 2014, subject to approval. In paragraph 111 of the Secretary-General's subsequent report (A/69/63-E/2014/10) on implementation of General Assembly resolution 67/226 on the quadrennial comprehensive policy review of operational activities for development of the United Nations, it was noted that the contribution of the Secretariat will be subject to the approval of the General Assembly during its consideration of the programme budget for 2016/2017.
- 9.135 In paragraph 31 of Economic and Social Council resolution 2014/14, the Council requested entities of the United Nations development system that have not already done so to take appropriate action to implement the agreement, subject to approval of their governing bodies and without impacting programme delivery, including by paying their contributions in full. In paragraph 14 of his report (A/69/535), the Secretary-General noted that the Secretariat's support to the resident coordinator system would entail additional requirements estimated at \$13.0 million, to be considered under section 9, Economic and social affairs. In section VI of its resolution 69/262, the General Assembly looked forward to receiving all relevant information on the resource requirements for the United Nations share in the arrangement in the proposed programme budget for the biennium 2016-2017.
- 9.136 The cost-sharing formula is based on the principle that all UNDG member organizations participate in the funding of the resident coordinator system, which for 2016-2017 has been estimated at \$124.0 million annually, with a 3.5 per cent increase in 2017 for pro forma staff costs. UNDP will provide the backbone funds for the system at a total cost of \$88.0 million, while the remaining costs are shared among 18 UNDG member organizations, including UNDP. Given the diverse nature of the Secretariat and the wide range of its normative, analytical and operational activities in the development arena, the agreed cost-sharing formula covers all departments, offices and programmes of the Secretariat that receive funding from the regular budget and that are members

and/or observers of UNDG. The final assessment for the Secretariat has been established at \$13,391,018, which covers the following 19 members of the United Nations Secretariat: United Nations Environment Programme, the United Nations Human Settlements Programme, the United Nations Office on Drugs and Crime, the United Nations Conference on Trade and Development, the Office of the United Nations High Commissioner for Human Rights, the regional commissions, the Department of Economic and Social Affairs, the Department of Public Information, the Office of the High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States, the Office of the Special Adviser on Africa, the Office of the Special Representative of the Secretary-General for Children and Armed Conflict, the United Nations Fund for International Partnerships, the Office for the Coordination of Humanitarian Affairs, the Office of the Deputy Secretary-General, and the Office of the Spokesperson for the Secretary-General.

9.137 The contribution will be provided to UNDG on an annual basis in January, under grant arrangements.

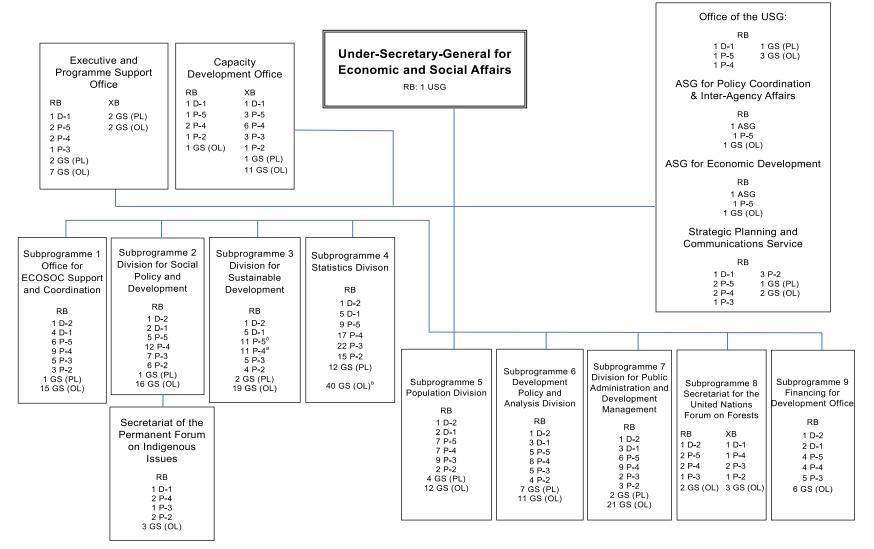
