## **Appointments to fill vacancies in subsidiary organs and other appointments: confirmation of the appointment of members of the Investments Committee**

### **Report of the Fifth Committee**

1. At its 2nd plenary meeting, on 16 September 2016, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its seventy-first session the item entitled “Appointments to fill vacancies in subsidiary organs and other appointments: confirmation of the appointment of members of the Investments Committee” and to allocate it to the Fifth Committee.

2. At its 12th meeting, on 4 November 2016, the Fifth Committee had before it the following documents:

(a) Note by the Secretary-General concerning the vacancies in the membership of the Investments Committee that would occur as a result of the expiration of the term of office of eight of its members on 31 December 2016 ([A/71/103](#));

(b) Note by the Secretary-General in which, in accordance with the provisions of article 20 of the Regulations of the United Nations Joint Staff Pension Fund, the Secretary-General, after consultation with the United Nations Joint Staff Pension Board and the Advisory Committee on Administrative and Budgetary Questions, submitted for confirmation by the General Assembly the reappointment of eight members and the appointment of one member of the Investments Committee as regular members for a three-year term of office ([A/C.5/71/6](#)).

3. At the same meeting, the Committee decided, by acclamation, to recommend to the General Assembly that it confirm the reappointment of Masakazu Arikawa (Japan), Madhav Dhar (India), Simon Jiang (China), Achim Kassow (Germany), Nemir Kirdar (Iraq), Michael S. Klein (United States of America), Linah K. Mohohlo (Botswana) and Gumersindo Oliveros (Spain), and the appointment of



Luciane Ribeiro (Brazil), as regular members of the Investments Committee for a three-year term of office beginning on 1 January 2017 (see para. 4).
