Seventy-fifth session Special Political and Decolonization Committee (Fourth Committee)

Organization of work

Note by the Chair

1. The agenda items allocated by the General Assembly to the Special Political and Decolonization Committee (Fourth Committee) for consideration are listed in document A/C.4/75/1. Background information on those items, including references to related documentation, is set out in the annotations to the agenda (A/75/100 and A/75/100/Add.1).¹

2. The General Assembly, in rule 99, paragraph (b), of its rules of procedure, calls upon each Main Committee to adopt a programme of work indicating, if possible, a target date for the conclusion of its work, the approximate dates of consideration of items and the number of meetings to be allocated for the consideration of each item.

3. The General Assembly decided that the seventy-fifth session should recess on Monday, 14 December 2020, and that, inter alia, the Special Political and Decolonization Committee (Fourth Committee) should complete its work by Tuesday, 10 November 2020 (see A/75/250, paras. 22 and 23).

4. To that end, the Special Political and Decolonization Committee (Fourth Committee) may wish to consider adopting as a provisional guideline the approximate dates set out below for the consideration of the items on its agenda with the understanding that they may be revised periodically, as appropriate. In the light of the extraordinary circumstances relating to the coronavirus disease (COVID-19) pandemic, the Committee will consider the substantive items on its agenda jointly in order to ensure the full and efficient utilization of the Committee at future sessions of the General Assembly. As indicated below, the conference services have allocated 13 in-person meetings to the Committee and have urged the Committee to make every effort to complete its work within the time allotted. Should the Committee wish to change the dates on which it considers items, it would still have to work within the dates and times indicated below.

5. In the preparation of the timetable above, the Chair was guided by the following considerations:

(a) The provisions contained in the present document constitute extraordinary measures arising from the global COVID-19 pandemic and their impact on the work of the General Assembly and its Main Committees at the seventy-fifth session, and would accordingly be approved by the Fourth Committee on an exceptional basis, on the understanding that it would not constitute a precedent for the work of the Committee at future sessions;

(b) Item 126, Revitalization of the work of the General Assembly, is allocated to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programme of work;

(c) Item 142, Programme planning, is allocated to all the Main Committees and the plenary of the General Assembly to enhance the discussion of evaluation, planning, budgeting and monitoring reports. If the Assembly allocates any report submitted under this item to the Fourth Committee, the Committee shall revert to this item.

6. Subject to the provisional organization of work above being acceptable to the Committee and in order to facilitate its work, the Chair wishes to suggest that the list of speakers for the joint general debate on agenda items 50 to 61 be closed on Tuesday, 15 October, at 6 p.m.

7. The Chair also wishes to draw the attention of members of the Committee to the decisions of the General Assembly on the organization of its work contained in document A/75/250, sections II.B to III.

8. Members are also requested to bear in mind the decision of the General Assembly that morning and afternoon meetings should start promptly at 10 a.m. and 3 p.m., respectively, both for plenary meetings and for meetings of the Main Committees during the seventy-fifth session. The attention of the members is also drawn to the decision of the Assembly to waive, at its seventy-fifth session, the quorum required, under rule 108 of the rules of procedure of the General Assembly, for the Chair to declare a meeting open and permit the debate to proceed (see A/75/250, paras. 27 and 32).

9. In view of the limited number of meetings available to the Committee, it is suggested that the time limit for statements be set at 10 minutes, with the exception of statements made by the spokespersons of groups of delegations, which would be extended to 15 minutes. The retention of these existing time limits takes into account the exceptional approach being proposed to consider the substantive items on the Committee's agenda jointly, and is with a view to allowing delegations reasonable time to deliver their consolidated overview statements. Time limits for statements in the exercise of the right of reply will be set at 5 and 3 minutes on an exceptional basis for the seventy-fifth session.

10. The list of documents submitted under the various agenda items allocated to the Special Political and Decolonization Committee (Fourth Committee) is contained in document A/C.4/75/INF/1, which will be updated as necessary.
