

Imtiaz Hussain (Pakistan)

Imtiaz Hussain joined the diplomatic service on 1 November 1986 and has served in various capacities, both in the Ministry for Foreign Affairs and in Pakistan's missions abroad. At the Foreign Ministry, as Desk Officer for Audit and Inspection, he was responsible for the implementation of the Inspector General's reports, in coordination with all relevant departments. As Director (Organization of the Islamic Conference — OIC) in the Ministry for Foreign Affairs, apart from being responsible for political, economic, social and cultural issues, he was in charge of the administrative and budgetary aspects of the OIC. He was Pakistan's delegate to the working group on the OIC administrative reforms during his tenure, from 1997 to 2000. As Director, Security Council and human rights, he is familiar with the Security Council's role in peacekeeping and special political missions.

Mr. Hussain has been posted to Pakistan's embassies in Belgrade, Copenhagen, Zagreb, Sarajevo and Seoul. He has served in Pakistan's Permanent Mission to the United Nations in Geneva and is currently posted as Minister in the Permanent Mission of Pakistan to the United Nations in New York. In Geneva, he was in charge of affairs relating to the Commission on Human Rights, the Office of the United Nations High Commissioner for Refugees, the World Health Organization, the International Labour Organization and the International Organization for Migration, including administrative and budgetary matters. In the Permanent Mission in New York, he is Pakistan's delegate to the Fifth Committee and is familiar with the gamut of administrative and budgetary matters on its agenda.

Through his assignments in the United Nations Division of the Ministry for Foreign Affairs and Pakistan's Permanent Mission to Geneva and New York, he has had hands-on experience in dealing with all aspects of the United Nations, including its administrative and budgetary aspects and management and secretariat reform. He has been the coordinator of the Group of 77 on several important negotiations and has helped the Committee in forging consensus on those issues.

Mr. Hussain has attended numerous summits and ministerial meetings of the Organization of the Islamic Conference, the Non-Aligned Movement and the United Nations during his career.

Mr. Hussain holds a master degree in chemistry from Punjab University, Lahore Pakistan, and has attended several training programmes, including advance courses in public administration in Pakistan and abroad.

Wasim Mir (United Kingdom of Great Britain and Northern Ireland)

Wasim Mir is the Counsellor responsible for management reform and finance at the United Kingdom Mission to the United Nations. As such, he is part of the Mission's senior management team and heads the section responsible for Fifth Committee issues.

Wasim joined the Foreign and Commonwealth Office in 1998 and has spent most of his career focusing on multilateral issues and institutional reform. He worked at the United Kingdom representation to the European Union from 1999 to 2001, focusing on issues around institutional reform and governance. After that, he returned to London, where he joined the United Nations Department, heading a unit responsible for sanctions policy. After two years as head of the Sanctions Unit, Wasim moved on to become Secretary to the Foreign and Commonwealth Office Board and head of internal communications. In this role, he helped the Board guide the Foreign and Commonwealth Office through a far-reaching change programme.

In 2005, Wasim was asked to return to the United Kingdom representation to the European Union and head work on counter-terrorism and counter-proliferation during the presidency of the United Kingdom.

Prior to joining the Foreign and Commonwealth Office, Wasim worked for three years for the Department for Education and Employment, where he was responsible for, among other things, reform of the United Kingdom's approach to employment services and preschool education. He also spent a year on secondment to the European Commission, taking a lead in pushing through reforms in the way in which employment services work together across the European Union.

Wasim studied economics at the London School of Economics, graduating in 2003. He subsequently obtained a masters degree in law from the University of Manchester, graduating in 2004. While working in Brussels, Wasim obtained an executive masters degree in business administration from the University of Leuven, specializing in public sector reform.

Nagesh Singh (India)

Nagesh Singh, a career Foreign Service Officer with the Ministry of External Affairs of India, is currently posted as First Secretary in the Permanent Mission of India to the United Nations in New York. He is India's delegate to the Fifth Committee of the General Assembly, dealing with administrative and budgetary issues. He also looks after peacekeeping finance and accounts in the Mission, especially in the context of India's position as one of the largest troop-contributing countries for United Nations peacekeeping operations, with substantial contributions in terms of contingent-owned equipment and troops. This also entails keeping an account of payments and receivables between the Department of Peacekeeping Operations and the Office of the Controller of Defence Accounts of the Government of India. He also serves as India's representative on the Committee for Programme and Coordination. He is fluent in English and French.

Nagesh Singh has a master of arts degree in economics with specialization in econometrics and monetary theory from the Delhi School of Economics. His bachelor of arts degree is also in economics from the University of Delhi, with specialization in trade and development and statistics and econometrics.
