Ms. Spratt joined the Department of State, Bureau of International Organization Affairs, Office of Management Policy and Resources, in 2004 and has served on the Committee on Contributions since 2007. She serves as the lead analyst on budgetary, administrative, and management issues for a number of key organizations, including the United Nations, the World Health Organization (WHO) and the United Nations Educational, Scientific and Cultural Organization (UNESCO).

In this capacity, she is responsible for United States policies regarding budgetary, management and other institutional issues. Ms. Spratt is also the lead analyst on all aspects of the United Nations capital master plan, on which she has worked closely with the United Nations Secretariat. She also works on the development of budget requests to Congress to finance United States assessed contributions to international organizations and on the allocation processes for this account. Ms. Spratt has served as the United States representative to the Finance and Administrative Experts Group of the UNESCO Executive Board, the Finance and Administrative Committee of the WHO World Health Assembly and the International Atomic Energy Agency Programme and Budget Committee.

Previously, Ms. Spratt worked at the United States Army Corps of Engineers. She served as a Program Manager in the International Engineering Center, where she was responsible for agency activities in Balkan and Baltic countries and in the Republic of Georgia.
