# Appointment of members of the International Civil Service Commission

# Note by the Secretary-General

1. As indicated in document A/64/105 of 16 March 2009, the General Assembly will be required, at its current session, to appoint five persons to fill the vacancies that will occur in the membership of the International Civil Service Commission, beginning on 1 January 2010.

2. The members of the Commission whose terms of office expire on 31 December 2009 are:

Minoru Endo (Japan);

Gilberto Paranhos Velloso (Brazil);

Lucretia Myers (United States of America);

Wolfgang Stöckl (Germany);

Gian Luigi Valenza (Italy).

Thus, the members to be appointed should come from the following regions:

One member from the Asian States;

One member from the Latin American and Caribbean States;

Three members from the Western European and Other States.

- 3. Candidatures have been received from the following Member States:
  - (a) From the Group of Asian States (one vacancy): Minoru Endo (Japan)





- (b) From the Group of Latin American and Caribbean States (one vacancy): Gilberto Paranhos Velloso (Brazil)

Lucretia Myers (United States of America);

Wolfgang Stöckl (Germany);

Gian Luigi Valenza (Italy).

4. The appointment of the members of the Commission is governed by the provisions of articles 3, 4 and 5 of its statute. Pursuant to those provisions, and in accordance with paragraphs 3 and 4 of section II of General Assembly resolution 43/226 of 21 December 1988, the Secretary-General has undertaken consultations with Member States, through the chairmen of the various regional groups, with the executive heads of the other organizations, with staff representatives through the Federation of International Civil Servants' Associations and the Coordinating Committee for International Staff Unions and Associations of the United Nations System and with the Advisory Committee on Administrative and Budgetary Questions.

5. Regarding consultations among Member States, Mr. Gilberto Paranhos Velloso has been endorsed by the Latin American and Caribbean Group.

6. The Secretary-General thus submits to the Fifth Committee for its consideration the list of candidates nominated for membership in the International Civil Service Commission for a four-year term of office beginning 1 January 2010:

As Deputy Permanent Representative to the United Nations (1979-1985), participated in numerous meetings of the different bodies of the Organization, in particular of its economic and social sectors, including all sessions of the General Assembly, in this case from 1974 to 1989, and all sessions of the Economic and Social Council between 1979 and 1985, and their subsidiary bodies

Returned to Brazil in March 1985 to assume the position of Secretary for International Economic and Technical Cooperation of the Secretariat of Planning (Ministry) of the Presidency of the Republic (March-June 1985)

Called back to the Ministry of External Relations and was appointed Head (Director) of the Department of the Americas (1985-1988), and thereafter, for the second time, Chef de Cabinet of the Minister of External Relations of Brazil (1988-1990)

Returning to the Ministry of External Relations Headquarters in June 1999, after tenures as Ambassador of Brazil to the Holy See and to Chile, was appointed Under-Secretary-General of the Foreign Service (1999-2002), a position which translates as the overall Head of all administrative services (personnel, administration, communications, budget, administrative planning and modernization) of the Brazilian Foreign Ministry. During this last period in Brasilia (1999-2002), was appointed on several occasions Acting Foreign Minister of Brazil

### Lucretia F. Myers

#### **Current professional experience**

Lucretia F. Myers is currently a Commissioner on the 15-member International Civil Service Commission that regulates the conditions of service for employees of the United Nations and other international organizations. She was first appointed to the Commission in 1992 and was re-elected for new four-year terms that began in January 1994, January 1998, January 2002 and January 2005.

Ms. Myers retired from the United States Federal Civil Service in February 1998. At the time of her retirement, she was the Senior Policy Adviser for retirement, health and life insurance at the United States Office of Personnel Management.

Prior to serving as the Senior Policy Adviser, Ms. Myers was the Assistant Director for Insurance Programs at the United States Office of Personnel Management. As the Assistant Director, she oversaw the health and life insurance programmes for Federal employees, retirees and their families. The Federal Employees health benefits programme is the largest employer-sponsored health insurance programme in the United States of America. At that time, the programme covered approximately 10 million lives, with 375 health insurance companies receiving annual premiums of nearly \$16 billion. The Office also collected more than \$1.6 billion in premiums and paid \$1.5 billion in benefits annually for the Federal employees' life insurance programme.

From January 1987 to August 1993, Ms. Myers served as the Executive Director of the United States Merit Systems Protection Board, where she managed the programmes and operations of the Board and its 11 regional offices. The Merit Board is a quasi-judicial agency that protects employees against abuses by agency management and conducts studies of the United States Federal Civil Service to ensure that employment practices are based on merit.

Prior to her appointment to the Board, Ms. Myers served in a variety of positions at the United States Office of Personnel Management. Positions held include: Deputy Associate Director for Administration where she was responsible for the agency's fiscal, administrative, information management and human resources management functions; Deputy Associate Director for Compliance and Investigations, where she managed one of the civilian sector's largest background investigations programmes and the federal Government's personnel management evaluation and workforce information programmes; Assistant Director for Retirement Programs and, later, Assistant Director for Pay and Benefits Policy, where she was in charge of administering the Government's largest pay and benefits programmes.

Ms. Myers joined the United States personnel agency in 1979 and soon thereafter was appointed as the Director for Personnel and Equal Employment Opportunity. She came to the Office of Personnel Management from the Department of the Air Force, where she held a variety of positions in human resources management at several geographical locations. Her background includes being a practitioner, manager or executive in virtually all functional areas of human resources management, including position classification and pay administration, labour management and employee relations, recruitment and staffing and training and development. Ms. Myers served on the Department of Defense's Military Health Care Advisory Board and was the United States Office of Personnel Management's liaison to the Board of Directors for the Foundation for Accountability. She was appointed to the Senior Executive Service in 1980 and is a 1983 graduate of the Senior Executive Fellows Program at Harvard's John F. Kennedy School of Government. During her service with the United States Federal Civil Service, she received numerous awards in recognition of her outstanding performance and executive excellence, including the Presidential Rank Award of Distinguished Executive.

### Gian Luigi Valenza

Since 2006, Ambassador Gian Luigi Valenza has been a member of the International Civil Service Commission of the United Nations.

He has served two terms on the Advisory Committee on Administrative and Budgetary Questions (1996-1999 and 1999-2001).

For four successive bienniums (from 1988 to 1995), he held the post of Deputy Chairman of the Finance Committee of the Food and Agriculture Organization of the United Nations (FAO). This nine-member Committee advises the Board of FAO and the World Food Programme (WFP) on matters pertaining to budget, external auditing, pensions and other administrative or financial questions.

He also held the post of Deputy Chairman of the seven-member Juridical and Legal Committee of FAO, which is often called on to examine financial and administrative questions.

In 1994, in the framework of Italy's chairmanship of the Conference on Security and Cooperation in Europe (CSCE), Ambassador Valenza was entrusted with the economic basket and the chairmanship of the Second Economic Forum of Prague (April 1994). He participated in the first part of the recent CSCE Review Conference held in Budapest.

From 1991 to 1994, he held the post of Chairman of the External Audit Committee of the International Fund for Agricultural Development (IFAD) and, during the same period, he was the Head of the Italian delegation for the third replenishment of IFAD.

He was a member of the Italian delegation to the forty-eighth and forty-ninth sessions of the General Assembly. During that time, he was also Chief of the Italian delegation for the entire five-session cycle of the International Committee for Negotiation on Desertification (Nairobi, Geneva, New York, Geneva, Paris).

From 1988 to 1993, he was Permanent Representative of Italy, with the title and rank of Ambassador, to FAO, IFAD and WFP in Rome. From 1983 to 1988, he was Permanent Representative of Italy, also with the title and rank of Ambassador, to the United Nations Environment Programme (UNEP) and to the United Nations Human Settlements Programme in Nairobi.

From 1978 to 1983, he was an international officer in the Organization for Economic Cooperation and Development (OECD) as Assistant Secretary-General, where his duties included relations with international organizations (United Nations, Common Market, European Free Trade Agreement, etc.). In 1973 and 1974, he was a member of the Italian delegation to the General Assembly.

From 1973 to 1975, he was the Head of the International Organizations Desk at the General Department of Political Affairs at the Ministry of Foreign Affairs, which is also concerned with financial matters at the United Nations (Fifth Committee and the Advisory Committee on Administrative and Budgetary Questions).

During his diplomatic career, Ambassador Valenza has also held posts in France (twice), Pakistan, former Czechoslovakia, Poland and Kenya.
