

I also managed all the activities of the secretariats of the Fifth Committee and the Committee for Programme and Coordination, studied and assessed all the activities and practices of the Secretariat and ensured that administrative and technical services covering all areas of the mandates of those two subsidiary bodies of the General Assembly were provided in an efficient and effective manner.

Within the framework of the reform process, and wishing to contribute to improving the efficiency and effectiveness of the two above-mentioned Committees, I prepared a series of recommendations designed to streamline their respective programmes of work.
