**Appointments to fill vacancies in subsidiary organs
and other appointments**

Confirmation of the appointment of members of the Investments Committee

Note by the Secretary-General

1. As indicated in document A/65/103, it will be necessary for the General Assembly, during its current session, to confirm the appointment by the Secretary-General of four persons to fill vacancies in the Investments Committee resulting from the expiration, on 31 December 2010, of the terms of office of Fernando G. Chico Pardo (Mexico), Achim Kassow (Germany), William J. McDonough (United States of America) and Hélène Ploix (France) as regular members and Simon Jiang (China) and Ivan Pictet (Switzerland), as ad hoc members, commencing 1 January 2011.

2. In accordance with the provisions of article 20 of the Regulations of the United Nations Joint Staff Pension Fund, the Secretary-General, after consultation with the United Nations Joint Staff Pension Board and the Advisory Committee on Administrative and Budgetary Questions, submits for confirmation by the General Assembly the reappointment of Mr. Kassow and Mr. McDonough as regular members for three-year terms and of Ms. Ploix as a regular member for a one-year term, as well as the appointment of Mr. Jiang as a regular member for a three-year term. Mr. Kassow is a member of the Board of Managing Directors of Commerzbank AG, Frankfurt, Germany, and has served as a member of the Committee since 1998. Mr. McDonough is the former Vice-Chairman and Special Adviser to the Chairman of Merrill Lynch and Co., Inc., New York, and has served as the Chair of the Committee since 2005. Ms. Ploix, Chairman and Chief Executive Officer (CEO) of Pechel Industries Partenaires, has served on the Investments Committee since 1997 and would be reaching the term limit of 15 years as of 31 December 2011, in accordance with the terms of reference governing the Investments Committee that took effect on 1 January 2005. Mr. Jiang is the founder and Chairman of CyberCity International Limited and has served on the Committee as an ad hoc member since 2005.



3. The Secretary-General has further authorized his representative to consult with the United Nations Joint Staff Pension Board and the Advisory Committee on Administrative and Budgetary Questions to upgrade the ad hoc appointment of Mr. Jiang from an ad hoc to a regular appointment effective 1 January 2011.
4. In accordance with past practice, the Secretary-General proposes to reappoint Mr. Pictet, who has served since 2005, and to appoint Ms. Hilda Ochoa-Brillembourg (Bolivarian Republic of Venezuela), who would replace Mr. Jiang, as ad hoc members of the Investments Committee for one-year terms beginning 1 January 2011.

Hilda Ochoa-Brillembourg, Chartered Financial Analyst, is founding president, Chief Executive Officer and Chief Information Officer of Strategic Investment Group and founding Director of Emerging Markets Management, LLC. She is a Fulbright fellow and recipient of the Fulbright lifetime achievement award. She completed her doctoral studies (except dissertation) in business administration in finance at Harvard Business School; she holds a Master's in public administration from the Harvard Kennedy School of Government and a Bachelor of science in economics from Universidad Andres Bello, Caracas.

From 1976 to 1987, Ms. Ochoa-Brillembourg served as chief investment officer for the Pension Investment Division of the World Bank, and continued as a manager of the World Bank Pension assets until 1996. She also served as asset and liability adviser to the World Bank, the Venezuelan Government, Grupo Electricidad de Caracas and others. A native of Venezuela (Bolivarian Republic of), Ms. Ochoa has served as an independent consultant in the field of economics and finance, a lecturer at the Universidad Católica Andrés Bello and the Instituto de Estudios Superiores de Administración in Venezuela, and as treasurer of the C.A. Luz Eléctrica de Venezuela in Caracas.
