Currently, Dr. Sun is responsible for the budgetary management of public administration, law enforcement and foreign-related expenditures, including the expenditures of the Ministry of Foreign Affairs and the Ministry of Commerce. Related business includes the financing of foreign-related activities, aid from China to foreign countries, budget allocations to the embassies of China, and assessed and pledged contributions to international organizations.
