Appointments to fill vacancies in subsidiary organs and other appointments

Confirmation of the appointment of members of the Investments Committee

Note by the Secretary-General

1. As indicated in document A/66/103, it will be necessary for the General Assembly, during its current session, to confirm the appointment by the Secretary-General of four persons to fill vacancies in the Investments Committee resulting from the expiration, on 31 December 2011, of the terms of office of Masakazu Arikawa (Japan), Madhav Dhar (India), Nemir Kirdar (Iraq) and H       Ploix (France) as regular members. Furthermore, it will be necessary for the Assembly, at its current session, to confirm the appointment of Hilda Ochoa-Brillembourg (Bolivarian Republic of Venezuela) and Ivan Pictet (Switzerland) as ad hoc members for a one-year term commencing on 1 January 2012.

2. In accordance with the provisions of article 20 of the Regulations of the United Nations Joint Staff Pension Fund, the Secretary-General, after consultation with the United Nations Joint Staff Pension Board and the Advisory Committee on Administrative and Budgetary Questions, submits for confirmation by the General Assembly the reappointment of Mr. Arikawa, Mr. Dhar and Mr. Kirdar as regular members for three-year terms, as well as the appointment of Dominique Senequier (France) as a regular member for a three-year term beginning on 1 January 2012, to fill the vacancy arising from Ms. Ploix's retirement. Mr. Arikawa is President and Representative Director of Mcube Investment Solutions, Tokyo, and has served as a member of the Committee since 2005. Mr. Dhar is a founding partner of GTI Capital Partners, New Delhi, and has served as a member of the Committee since 2006. Mr. Kirdar is President and Chief Executive Officer of Investcorp International Limited, London, and has served as a member of the Committee since 2006.

3. In accordance with past practice, the Secretary-General proposes to reappoint Ms. Ochoa-Brillembourg, who has served since 2011, and Mr. Pictet, who has served since 2005, as ad hoc members of the Investments Committee for a one-year term beginning on 1 January 2012.
