

Financing of the support account for peacekeeping operations, the United Nations Logistics Base at Brindisi, Italy, and the Regional Service Centre in Entebbe, Uganda

Note by the Secretary-General

- 1. The present note is issued in accordance with the prorating procedures approved by the General Assembly in its resolution 50/221 B and its resolution on the financing of the Regional Service Centre in Entebbe, Uganda. The annex to the note reflects the resources to be approved by the Assembly in respect of each peacekeeping mission, including the prorated shares of the support account, the United Nations Logistics Base at Brindisi and the Regional Service Centre in Entebbe.
- 2. Once the General Assembly has taken action on the recommendations of the Fifth Committee, a note will be issued on the approved level of resources for all peacekeeping operations.
- 3. The Fifth Committee is requested to take note of the present note.

 - ^b Approved cost estimates for the United Nations Logistics Base at Brindisi of \$81,000,000, net of an unencumbered balance of \$58,200 and other revenue of \$480,500 in respect of the financial period 2015/16.
