



#### I. Introduction

1. As explained in the introductory document A/CN.9/1174, as of 2024 the secretariat will report on its non-legislative activities to the Commission following a calendar year cycle. This document, A/CN.9/1174/Add.6, provides information related to the UNCITRAL Law Library (the "Library"), publications, press releases and other outreach activities from 1 April 2023 until 31 December 2023, taking into account the new calendar-year reporting period and considering that the report from the last Commission session, A/CN.9/1139, covered the period from 1 April 2022 until 31 March 2023.

## II. UNCITRAL Law Library

- 2. In the reporting period, the Library staff responded to approximately 276 reference requests originating from 43 countries. The number of visitors to the Library has continued to increase. The Library received 115 visitors other than meeting participants, staff and interns, including researchers from 18 countries during the current reporting cycle. This is in comparison to 83 visitors in the last reporting period.
- 3. The Library continues to maintain its online public access catalogue (OPAC) jointly with the other United Nations libraries in Vienna. <sup>1</sup>
- 4. The "Bibliography of recent writings related to the work of UNCITRAL" is available to the Commission (A/CN.9/1171), and monthly updates from the date of the latest annual bibliography and a consolidated bibliography remain available on the UNCITRAL website. As at the date of submission of this note, the consolidated bibliography contains 12,405 entries, reproduced in English and in the original language versions.
- 5. In 2023, donations of books were received from the following publishers: Brill, Bruylant/Larcier, Cambridge University Press, China International Economic and Trade Arbitration Commission, Dalloz, Deutsche Institution für Schiedsgerichtsbarkeit, Edward Elgar, Juris Legal Information, LexisNexis, Maldives Law Institute, Oxford University Press, Qatar University Press, Thomson Reuters and Wolters Kluwer.

#### III. Outreach activities

#### A. Press releases

6. The secretariat issued 10 press releases during the reporting period: to mark treaty actions relating to UNCITRAL; to advise about the adoption of an UNCITRAL model law or other relevant text; and to communicate other information of particular importance and direct relevance to UNCITRAL.<sup>2</sup> The Commission may wish to repeat its regular request to States to advise the secretariat when enacting legislation implementing an UNCITRAL model law or other relevant texts.
