

I. Introduction

- 1. This note gives a brief overview of the UNCITRAL secretariat's plans for non-legislative activities during the next reporting period. The activities actually held during that period will be reported to the Commission at its fifty-eighth session, in 2025. The activities reported in the note by the secretariat on coordination activities (A/CN.9/1176) are not included in this note.
- 2. The year 2024 marks the fiftieth anniversary of the adoption of the Convention on the Limitation Period in the International Sale of Goods¹ and the tenth anniversary of the UNCITRAL Transparency Standards (comprising the United Nations Convention on Transparency in Treaty-based Investor-State Arbitration² and the UNCITRAL Rules on Transparency in Treaty-based Investor-State Arbitration,³ including the transparency repository under article 8 of the Rules (see A/CN.9/1174/Add.4)). The secretariat is planning activities to celebrate these anniversaries throughout 2024.⁴
- 3. In addition, as it has become the practice, UNCITRAL Days will be held throughout the year in Africa, Arab States, Asia and the Pacific, and Latin America and the Caribbean.⁵ While themes of UNCITRAL Days' events may differ depending on a demand and interest of a particular region or a co-host, efforts are being made by the UNCITRAL secretariat to prominently feature during those events at least one UNCITRAL text whose anniversary is celebrated in 2024 (see the preceding paragraph).
- 4. Most of the activities will be held online or in a hybrid format, allowing participation of the secretariat in more events, and expanding the reach of the events. Many will be undertaken through the UNCITRAL Regional Centre for Asia and the Pacific (RCAP).
- 5. Annual meetings related to the operation of the Case Law on UNCITRAL Texts (CLOUT) system (see A/CN.9/1174/Add.3) will encompass, as has become the practice, meetings of the CLOUT Steering Committee and of CLOUT national correspondents and voluntary contributors. Information about them will be communicated to the relevant stakeholders in due course.
