

2017 United Nations Pledging Conference for Development Activities

New York, 6 November 2017

Report of the 2017 United Nations Pledging Conference for Development Activities

A. Opening and duration of the session

- 1. In its resolution 45/215, the General Assembly decided, inter alia, that the adoption and signing of the Final Act of the United Nations Pledging Conference for Development Activities should be replaced by the adoption of a procedural report of the Conference.
- 2. The Conference was held at United Nations Headquarters on 6 November 2017.
- 3. The Conference was opened by the Director of the Office for Economic and Social Council Support and Coordination of the Department of Economic and Social Affairs.

B. Attendance

- 4. The Conference was attended by representatives of the Governments of the following States: Albania, Algeria, Andorra, Antigua and Barbuda, Armenia, Bahamas, Bahrain, Bangladesh, Bhutan, Brazil, Burkina Faso, Burundi, Cambodia, Cameroon, Chile, China, Colombia, Czechia, Democratic People's Republic of Korea, Denmark, Dominican Republic, Egypt, Equatorial Guinea, Estonia, Ethiopia, Georgia, Germany, Greece, Guatemala, India, Indonesia, Iran (Islamic Republic of), Iraq, Israel, Italy, Jordan, Kenya, Kiribati, Kuwait, Lao People's Democratic Republic, Lesotho, Liberia, Libya, Liechtenstein, Lithuania, Luxembourg, Malawi, Malaysia, Mauritania, Mauritius, Mongolia, Mozambique, Myanmar, Namibia, Nepal, New Zealand, Norway, Oman, Papua New Guinea, Poland, Qatar, Republic of Korea, Romania, Russian Federation, Saint Kitts and Nevis, Saudi Arabia, Senegal, Serbia, Singapore, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, Sudan, Sweden, Thailand, Togo, Turkey, United Arab Emirates, United States of America, Yemen, Zambia and Zimbabwe.
- 5. The observers for the Holy See and the African Union and the representatives of the following organs, organizations and bodies of the United Nations and the
