The Human Rights Council Advisory Committee,

Recalling Human Rights Council resolution 35/32 of 23 June 2017, in which the Council requested the Advisory Committee to prepare a study that could help States to implement the 2030 Agenda for Sustainable Development by integrating human rights into national policies on the basis of the compilation prepared by the United Nations High Commissioner for Human Rights, and to present it within its regular reporting cycle to the Council at its forty-fifth session, on the occasion of the fifth anniversary of the adoption of the 2030 Agenda,

Recalling also that, at its nineteenth session, the Advisory Committee established a drafting group, currently composed of Mario Luis Coriolano, Ion Diaconu (Rapporteur), Karla Hananía de Varela, Ludovic Hennebel, Ajai Malhotra, Kaoru Obata, Mona Omar, Katharina Pabel, Elizabeth Salmón, Dheerujlall Baramlall Seetulsingh and Changrok Soh (Chair),

1. *Welcomes and takes note* of the updated preliminary outline of the study elaborated by the drafting group;
2. *Welcomes also* the participation of a member of the drafting group in the Forum of the Countries of Latin America and the Caribbean on Sustainable Development and of the Rapporteur in the High-level Political Forum on Sustainable Development respectively;

3. *Notes* that the drafting group and the Advisory Committee held meetings to discuss the topic including the oral reports on the fora on sustainable development by the rapporteur and a member of the drafting group;

4. *Decides* to continue the exchange of views on this subject with external experts and members of the Office of the High Commissioner, in order to prepare the study in accordance with resolution 35/32 of the Human Rights Council;

5. *Invites* the drafting group to continue intersessional discussions and to continue its participation and contribution in regional consultations on the implementation of the Agenda for Sustainable Development and to inform the Advisory Committee at its twenty-second session on its activities related to the preparation of the report to be submitted to the Human Rights Council for adoption at its forty-fifth session;

6. *Requests* the Office of the High Commissioner to inform of all documents prepared by United Nations bodies and other international organizations on different issues concerning the implementation of the 2030 Agenda for Sustainable Development whenever they become available;

7. *Requests also* the drafting group to submit an updated outline to the Advisory Committee at its twenty-second session.
