1. Action jeunesse pour le développement

Introduction

We are pleased to transmit our initial mandatory quadrennial report for the period 2016–2019, delayed owing to the coronavirus disease (COVID-19) pandemic. The quadrennial report is a general policy document of the Economic and Social Council. Our report contains an account of our activities as an organization in status with the Council.

Aims and purposes of the organization

Action jeunesse pour le développement (AJED-Congo) is primarily involved in the following sustainable development priority areas: combating climate change; protecting the environment; managing forest ecosystems; increasing the effectiveness of the arrangements around protected land, marine and coastal areas; preserving biodiversity; combating corruption; mobilizing further to combat desertification and support mitigation and adaptation measures in order to take advantage of the process of rapid and appropriate replenishment of resources in combating climate change, in the interests of present and future generations; combating poverty by launching microprojects in the agropastoral sector; and integrating and reintegrating unemployed young mothers into trade learning programmes.

Specific aims and purposes:

AJED-Congo aims to enable civil society actors to strengthen their role as key partners with public authorities and their capacity to execute projects in the areas of agriculture, the environment, the reduction of emissions from deforestation and forest degradation, climate change, forest and marine biodiversity and ecosystems and tourism development, in the effort to build the economy and fight against poverty.

Expected results: Intended impacts include the improved standard of living and improved protection of the environment and well-being of local and native communities.

2. Alliance globale contre les mutilations génitales féminines

Introduction

The Alliance globale contre les mutilations génitales féminines (AG-MGF) addresses human rights and health concerns, wherever they arise in the world. Currently, AG-MGF focuses on human rights in Africa, Europe, Asia and South America. The Alliance is affiliated with the Inter-African Committee on Traditional Practices (IAC) and collaborates with London-based Human Rights Watch.

Aims and purposes of the organization

Initial aims and purposes: Join networks against female genital mutilation (FGM), to contribute to the eradication of FGM, to map non-governmental organizations (NGOs), to develop a communication strategy and to create a university

chair on FGM. Currently, the Alliance is focusing its efforts on human rights – civil and political, economic, social and cultural right, including the right to health. AG-MGF mainly participates in the work of the Human Rights Council, its subsidiary bodies and the human rights treaty-based bodies, and it monitors the activities of the Office of the United Nations High Commissioner for Human Rights.

Significant changes in the organization

In 2019, AG-MGF focused its work on human rights. It amended its statutes and changed its name to "l'Alliance globale pour les droits humains et la santé", as reported to the secretariat of the Committee on NGOs.

Contribution of the organization to the work of the United Nations

Projects are under way to establish an academic chair on FGM and to create a world map of organizations and their activities to eliminate FGM. The organization has collected information on the situation of FGM in African countries and on the work of local, regional and international organizations. Today, the Alliance focuses on human rights violations (including arbitrary detention, torture, freedom of expression and the press, human rights defenders and refugee rights), in Europe and Latin America, has initiated contacts with the principal human rights NGOs and has launched initiatives with the Inter-Parliamentary Union and the International Labour Organization. The Alliance works closely with permanent missions of States Members of the United Nations, including members of the Human Rights Council.

Introduction

Avocats sans frontières – ASF is an international non-governmental organization (NGO) established in 1992 as a non-profit association under Belgian law. It operates in several countries in North Africa (including Morocco and Tunisia) and Central Africa (Central African Republic, Democratic Republic of the Congo, Uganda, Burundi and Chad), working in the fields of justice and human rights. It conducts its activities in close partnership with national and international civil society.

Aims and purposes of the organization

The aims and purposes of ASF are to use the law to combat social inequality, prevent conflict and achieve human rights. ASF advocates enhanced rule of law based on human rights by promoting legal empowerment, the strengthening of civil society and civic forums, and greater respect for human rights.

Significant changes in the organization

The Board of Directors appointed a new executive director in 2017. There were no changes to the organization's charter during the reporting period.
