

### **Annotations**

### 1. Election of officers


Pursuant to section I of Economic and Social Council resolution 1999/30 and rule 15 of the rules of procedure of the functional commissions of the Council, the Commission elected the Bureau for the sixty-first session on 8 December 2017. The office of Second Vice-Chair became vacant during the intersessional period after the regular part of the sixty-first session in March 2018. The Commission is expected to elect this officer of the Bureau, as well as any other officers as may be necessary for the remainder of the sixty-first session, on 5 December 2018.

### 2. Adoption of the agenda and other organizational matters


The Economic and Social Council, in its decision 2011/259, entitled "Joint meetings of the reconvened sessions of the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice", decided that, starting in 2011, the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice would hold joint meetings during their reconvened sessions for the purpose of considering agenda items included in the operational segment of the agendas of both Commissions, with a view to providing integrated policy directives to the United Nations Office on Drugs and Crime (UNODC) on administrative, budgetary and strategic management issues. The Council also decided that the practice of holding back-to-back reconvened sessions of the Commissions would be continued to enable each Commission to consider, in separate meetings, agenda items included in the normative segment of its agenda.

In accordance with that decision, two meetings of the Commission on Narcotic Drugs will be held jointly with the Commission on Crime Prevention and Criminal Justice during their reconvened sessions in order to consider agenda item 4, on strategic management, budgetary and administrative questions. The remaining items on the agenda will be considered in separate meetings.

The Commission decided at its intersessional meeting on 25 June 2018 to add Wednesday, 5 December 2018, to the reconvened session, and to devote that day to preparations for the ministerial segment in March 2019. This is reflected in the proposed organization of work contained in the annex to the present document. The special segment on preparations for the ministerial segment to be held during the









sixty-second session of the Commission, in 2019, will be convened in an open-ended manner.

In its decision 2017/236, entitled "Improving the governance and financial situation of the United Nations Office on Drugs and Crime: extension of the mandate of the standing open-ended intergovernmental working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime", the Economic and Social Council decided to renew the mandate of the working group until the part of the sessions of the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice to be held in the first half of 2021, at which time the commissions should carry out a thorough review of the functioning of the working group and consider the extension of its mandate. The terms of reference of the working group are contained in Commission on Narcotic Drugs resolution 52/13.

In its resolution 60/3, the Commission requested the working group to continue discussing the biennial consolidated budget of UNODC, the governance and financial situation of UNODC, evaluation and oversight, strengthening human resources governance to improve the gender balance and geographical representation, as well as other matters. The Commission will have before it for its consideration a note by the Secretariat on the work of the working group (E/CN.7/2018/3/Add.1-E/CN.15/2018/3/Add.1).

At its reconvened sixtieth session, the Commission adopted resolution 60/10, entitled "Budget for the biennium 2018–2019 for the Fund of the United Nations International Drug Control Programme", in which it provisionally approved the projected use of general-purpose funds in the biennium 2018–2019 and endorsed the programme support cost funds and special-purpose estimates in the consolidated budget for the biennium, subject to some adjustments to be made.

At its sixty-first session, the Commission had before it for approval a note by the Executive Director on the adjustments to the consolidated budget for the biennium 2018–2019 for UNODC (E/CN.7/2018/12-E/CN.15/2018/14). The Commission adopted its resolution 61/1, entitled "Budget for the biennium 2018–2019 for the Fund of the United Nations International Drug Control Programme", noting and approving the adjustments proposed.

At its reconvened sixty-first session, the Commission will have before it for its consideration the report of the Executive Director on the implementation of the consolidated budget for the biennium 2018–2019 for UNODC (E/CN.7/2018/14-E/CN.15/2018/16) and, for its approval, any revised estimates for the general-purpose funds budget for the biennium 2018–2019 contained therein.

The Commission will also consider the draft annual programme implementation plan for 2020 for UNODC (E/CN.7/2018/CRP.11-E/CN.15/2018/CRP.8).

In its resolution 60/10, the Commission requested UNODC, while upholding Article 101 of the Charter of the United Nations, to intensify its efforts to ensure the recruitment of staff on as wide a geographical basis as possible, in particular in the Professional and higher categories, by, inter alia, intensifying outreach efforts, and to report on the progress thereon to the Commission at its next reconvened session. Further, the Commission requested the Executive Director of UNODC to intensify the efforts of the Office to achieve the goal of a 50/50 gender balance within the Professional and higher categories, including for field representatives, while upholding Article 101 of the Charter of the United Nations, by, inter alia, intensifying outreach efforts, and to report on the progress thereon to the Commission at its next reconvened session. The Commission further requested UNODC to continue to include in such reporting, as well as in the dialogue within the standing open-ended intergovernmental working group on improving the governance and financial situation of the United Nations Office on Drugs and Crime, disaggregated data on the composition of staff by geographical area and gender, as well as measures taken to improve the geographical distribution and gender parity of its staff, including a description of its internal and external recruitment processes. The Commission will have before it for its consideration the report of the Executive Director on gender balance and geographical representation within UNODC (E/CN.7/2018/15-E/CN.15/2018/17).

Item 4 will be considered at the joint meetings with the Commission on Crime Prevention and Criminal Justice pursuant to Council decision 2011/259.

At the special session of the General Assembly on the world drug problem held in 2016, Member States were called on to share relevant information with, as appropriate, and strengthen the capacity of the World Health Organization (WHO), UNODC, the International Narcotics Control Board (INCB) and other relevant international and regional organizations to prioritize the review of the most prevalent, persistent and harmful new psychoactive substances and to facilitate informed

scheduling decisions by the Commission on Narcotic Drugs. Reference is made to the importance and relevance of the UNODC early warning advisory on new psychoactive substances, which enables emerging trends in new psychoactive substances to be monitored and allows data collection and information-sharing with Member States. To further assist in generating and analysing data on the situation with respect to amphetamine-type stimulants and new psychoactive substances, UNODC continues to implement the global Synthetics Monitoring: Analysis, Reporting and Trends (SMART) programme. Information and expertise is provided to WHO to support the prioritization and assessment of substances to be placed under international control.

In its resolution 58/11, the Commission invited WHO to provide regular and timely recommendations for the scheduling of new psychoactive substances by continuing to explore the potential of assessing structurally related substances and substances with similar harm and dependence potential, enhance data-collection tools and contribute to the development of rapid assessment strategies based on all available sources of information.

In that resolution, WHO was further invited to present its scheduling recommendations to the Commission at its annual reconvened session in order to help Member States prepare for forthcoming scheduling decisions at the following regular session of the Commission.

In its resolution 59/8, the Commission invited WHO, with the support of UNODC, relevant regional organizations and Member States, to continue conducting regular, efficient, transparent and timely reviews of the most harmful, prevalent and persistent new psychoactive substances and to use the potential impact of toxicity at both the population and individual levels as the primary factor in prioritizing substances for review. In its resolution 60/4, the Commission requested UNODC, with the support of Member States, WHO and other relevant international and regional organizations, to incorporate toxicological data, in order to provide information on the adverse health consequences of the use of new psychoactive substances, into the early warning advisory system of the Office, building on existing models of data collection in that area with a view to avoiding duplication of efforts. In addition, the Commission invited WHO to continue and accelerate its conducting of regular reviews on the most harmful, prevalent and persistent new psychoactive substances and to provide Member States with the opportunity to contribute to the process for prioritizing substances for review. The online system for collecting toxicological data was launched in September 2018 (unodc.org/tox).

In its resolution 61/8, the Commission encouraged Member States to support UNODC, INCB and WHO in accelerating the process of issuing recommendations for the inclusion of synthetic opioids in the international control regime, in particular through more frequent meetings of the WHO Expert Committee on Drug Dependence and increased data-sharing using the existing online portals supported by UNODC and INCB.

In the same resolution, the Commission encouraged Member States to actively participate in early warning networks and promote, as appropriate, the use of drug surveillance lists and controls and the sharing of relevant information through UNODC, INCB and WHO, within their respective mandates, and enhance bilateral, subregional, regional and international cooperation in the identification and reporting of the threats posed by the non-medical use of synthetic opioids and incidents involving them and, to that end, strengthen the use of national, regional and international established reporting and information exchange systems, such as, where appropriate, the early warning advisory on new psychoactive substances and the SMART programme of UNODC and Project Ion of INCB.

Also in the same resolution, the Commission affirmed the commitment of Member States to share, as appropriate, relevant information with and strengthen the capacity of UNODC, INCB and WHO, and other relevant international and regional organizations to prioritize the review of the most prevalent, persistent and harmful

synthetic opioids for non-medical use and to facilitate informed scheduling decisions by the Commission on Narcotic Drugs.

In the same resolution, the Commission requested UNODC, together with INCB and WHO, to convene an intergovernmental expert group meeting before the sixty-second regular session of the Commission on Narcotic Drugs, taking into consideration cost implications for Member States, on the international challenge posed by the non-medical use of synthetic opioids to learn more about the challenges and to propose core elements for an international response. An intergovernmental expert group meeting on the international challenge posed by the non-medical use of synthetic opioids is to be held in Vienna on 3 and 4 December 2018.

The fortieth meeting of the WHO Expert Committee on Drug Dependence was held in Geneva from 4 to 7 June 2018 and was dedicated to the critical review of cannabidiol and the pre-review of cannabis plant and resin, extracts and tinctures of cannabis, delta-9-tetrahydrocannabinol (THC) and isomers of THC. The forty-first meeting of the WHO Expert Committee on Drug Dependence is scheduled to be held in Geneva in November 2018. At that time, the Committee is to undertake critical reviews of the above-mentioned cannabis components (cannabis plant and resin, extracts and tinctures of cannabis, THC and isomers of THC) as well as of a number of new psychoactive substances, including fentanyl analogues and other psychoactive substances.

It is expected that WHO will report orally to the Commission during its reconvened sixty-first session about the outcomes of the June and November meetings of the Expert Committee on Drug Dependence.

# 10. Contributions by the Commission to the work of the Economic and Social Council, in line with General Assembly resolution 68/1, including follow-up to and review and implementation of the 2030 Agenda for Sustainable Development

At its sixty-first session, in March 2018, when the Commission considered its contributions to the work of the Economic and Social Council, it was noted that efforts to achieve the Sustainable Development Goals and to effectively address the world drug problem were complementary and mutually reinforcing. Speakers emphasized the important role of the functional commissions of the Economic and Social Council in the review process, and encouraged the Commission, as the main policymaking body in the United Nations system dealing with drug-related matters, to continue working closely with all relevant partners, including United Nations entities and the functional commissions of the Economic and Social Council.

On 23 July 2018, the General Assembly adopted resolution 72/305, entitled "Review of the implementation of General Assembly resolution 68/1 on the strengthening of the Economic and Social Council", and decided that the arrangements contained in the resolution and the annex to it is to be reviewed at the seventy-fourth session and at subsequent review cycles in conjunction with the review process of the high-level political forum on sustainable development.

Pursuant to the annex to resolution 72/305, the Economic and Social Council should continue to strengthen its role as the central mechanism for the supervision of its subsidiary bodies and should ensure an adequate division of labour among its subsidiary bodies and harmonization and coordination of their agendas and work programmes. In addition, the Council should improve its outcomes and the outcomes of its subsidiary bodies, making them more relevant, coherent and solution-oriented.

Also pursuant to the annex to resolution 72/305, the General Assembly is to adopt one main theme for the high-level political forum on sustainable development and the Economic and Social Council, and the subsidiary bodies of the Economic and Social Council are to similarly adopt their own respective themes, aligned with the main theme, while continuing to address issues or a theme necessary to discharge their other functions.

With regard to the integration segment of the Economic and Social Council, the General Assembly decided in the same resolution that it would be held for one day immediately before the high-level political forum, and that it would discuss and consolidate all the inputs of Member States, the subsidiary bodies of the Economic and Social Council, the United Nations system and other relevant stakeholders. The segment would also coordinate the work of the subsidiary bodies of the Council, promoting a clearer division of labour among them, and the policies and activities of the specialized agencies relating to the Sustainable Development Goals and other internationally agreed development goals. Heads of United Nations system entities, Chairs of the subsidiary bodies of the Council and the Executive Secretaries of the regional commissions would be invited to participate.

The General Assembly further decided in the same resolution that, while retaining its intergovernmental nature, the Economic and Social Council should seek to promote the active participation of major groups, non-governmental organizations, the private sector, youth and other relevant stakeholders and regional organizations in the activities of the Council and its functional and regional commissions, in accordance with the provisions of their respective rules of procedure and the provisions of General Assembly resolution 67/290 of 9 July 2013 insofar as it pertains to the meetings of the high-level political forum under the auspices of the Council.

With regard to the management segment of the Economic and Social Council, the General Assembly decided in the same resolution that its meetings would focus on the adoption of procedural decisions, consideration of recommendations of subsidiary bodies, as well as the introduction of reports and consideration of draft proposals submitted under relevant agenda items. Dedicated management meetings would also be held to conduct elections to fill regular and outstanding vacancies in subsidiary bodies of the Economic and Social Council and related bodies, normally in the first half and last quarter of the year. In preparing for elections by the Council, Member States should present candidates at least three working days in advance of elections.

The General Assembly also decided in the same resolution that the Economic and Social Council should strengthen its oversight and coordination role of its subsidiary bodies. It should review their work with a view to ensuring their continued relevance. It would also ensure that those bodies produced technical and expert analysis, assessments and policy recommendations to inform the integrated view of the Council and inform efforts to implement the 2030 Agenda. It should effectively integrate the outcomes of its subsidiary bodies into its own work.

The General Assembly decided further in the same resolution that the Economic and Social Council should request its subsidiary bodies to ensure that they best support the implementation of the 2030 Agenda and the work of the Council. Their work should reflect the need for an integrated and action-oriented approach to the Sustainable Development Goals. Their recommendations should build on a solid evidence-based review of progress on the 2030 Agenda and of the outcomes of conferences and summits in their respective area. They should work in an efficient, effective, transparent and inclusive manner. Each subsidiary body is to consider whether there was a continued need for annual negotiated outcomes and ensure that, when they produced such outcomes, they were effective and action-oriented and resulted in increased levels of cooperation.

The Commission may wish to use its reconvened sixty-first session to further consider how it can, within its mandates, best contribute to the follow-up to the 2030 Agenda and support the review of its implementation. It may also wish to discuss how it could further enhance the synergies between its work and that of the other functional commissions of the Council, with a view to making its outcomes more relevant, coherent and solution-oriented in respect of the efforts to implement the 2030 Agenda, thereby contributing to the implementation of General Assembly resolution 72/305.

## 11. Preparations for the ministerial segment to be held during the sixty-second session of the Commission, in 2019

Special segment

In the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem, Member States decided to establish 2019 as a target date for States to eliminate or reduce significantly and measurably: (a) the illicit cultivation of opium poppy, coca bush and cannabis plant; (b) the illicit demand for narcotic drugs and psychotropic substances; and drug-related health and social risks; (c) the illicit production, manufacture, marketing and distribution of, and trafficking in, psychotropic substances, including synthetic drugs; (d) the diversion of and illicit trafficking in precursors; and (e) money-laundering related to illicit drugs.

In the Joint Ministerial Statement adopted at the high-level review by the Commission on Narcotic Drugs of the implementation by Member States of the Political Declaration and Plan of Action held in 2014, Member States reaffirmed their commitment to achieving the targets and goals, and implementing the provisions, set out in the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem.

In the outcome document of the special session of the General Assembly on the world drug problem held in 2016, Member States reaffirmed their commitment to implementing effectively the provisions set out in the Political Declaration and Plan of Action, mindful of the targets and goals set therein, as well as to addressing the general challenges and priorities for action identified in the Joint Ministerial Statement adopted at the high-level review by the Commission on Narcotic Drugs of the implementation by Member States of the Political Declaration and Plan of Action, held in March 2014.

At its sixtieth session, the Commission adopted resolution 60/1, entitled "Preparations for the sixty-second session of the Commission on Narcotic Drugs, in 2019". In that resolution, the Commission decided to convene a ministerial segment to be held during its sixty-second session, in Vienna in 2019, which would last two days in addition to the five days scheduled for the regular session of the Commission, in order to take stock of the implementation of the commitments made to jointly address and counter the world drug problem, in particular in the light of the 2019 target date of the Political Declaration and Plan of Action.

At its sixty-first regular session, held in March 2018, the Commission adopted resolution 61/10, entitled "Preparations for the ministerial segment to be held during the sixty-second session of the Commission on Narcotic Drugs, in 2019", in which it decided that the ministerial segment is to include a general debate and two interactive, multi-stakeholder round tables, to be conducted in parallel with the general debate in the plenary. The Commission encouraged all Member States, observer States and observers to consider being represented at the highest possible level at the ministerial segment, and encouraged all Member States and relevant entities of the United Nations system to actively participate in the discussions of the Commission in preparation for the 2019 ministerial segment.

In that same resolution, the Commission resolved that an outline for the way beyond 2019 would be presented by the Chair to the Commission at its reconvened sixty-first session for further consideration, including at its intersessional meetings prior to the sixty-second session, in the light of the preparations for the ministerial segment.

As mentioned above, at its intersessional meeting on 25 June 2018, the Commission decided to add Wednesday, 5 December 2018, to the reconvened session, and to devote that day to preparations for the ministerial segment in March 2019.

In June 2018, the Commission finalized a workplan for its third, fourth and fifth intersessional meetings. These meetings would have thematic segments focused

on the implementation of the joint commitments contained in the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem, the Joint Ministerial Statement adopted at the high-level review by the Commission on Narcotic Drugs of the implementation by Member States of the Political Declaration and Plan of Action and the outcome document of the thirtieth special session of the General Assembly, entitled "Our joint commitment to effectively addressing and countering the world drug problem". They would also have organizational segments addressing outstanding issues and organizational arrangements of the ministerial segment, and a normative segment focused on the implementation of the international drug control treaties.

Pursuant to that workplan, the Commission is to hold its third intersessional meeting from 25 to 28 September 2018, comprising a thematic and an organizational segment; its fourth intersessional meeting from 22 to 25 October 2018, comprising a thematic and an organizational segment; and its fifth intersessional meeting from 7 to 9 November 2018, with a normative, a thematic and an organizational segment.

The proposed programme of work for the special segment on the preparations for the ministerial segment to be held during the sixty-second session of the Commission, in 2019, is as follows:

- 1. Opening of the special segment.
- 2. Adoption of the agenda and other organizational matters.
- 3. General debate on the preparations for the ministerial segment to be held during the sixty-second session of the Commission, in 2019.
- Other business.
- 5. Closure of the special segment.

### 12. Provisional agenda for the sixty-second session of the Commission

Under agenda item 12, the Commission may wish to consider and discuss the preparations for its sixty-second session, including the provisional agenda and the dates for the regular and reconvened parts of that session.

The Commission is expected to adopt a proposed provisional agenda for the high-level segment, including the themes for the interactive, multi-stakeholder round tables to be held during the ministerial segment.

### 14. Adoption of the report of the Commission on its sixty-first session

Under item 14, the Commission is expected to adopt the report on its reconvened sixty-first session.

Opening of the sixty-second session of the Commission on Narcotic Drugs and election of officers

Pursuant to rule 16 of the rules of procedure of the functional commissions of the Economic and Social Council, the officers of the Commission on Narcotic Drugs hold office until their successors are elected, and they are eligible for re-election.

In section I of its resolution 1999/30, the Economic and Social Council decided that, with effect from 2000, the Commission should, at the end of each session, elect its bureau for the subsequent session and encourage it to play an active role in the preparations for both the regular and the intersessional meetings of the Commission, so as to enable the Commission to provide continuous and effective policy guidance.

Pursuant to section I of Economic and Social Council resolution 1999/30 and rule 15 of the rules of procedure of the functional commissions, the Commission is invited to open, at the end of its reconvened sixty-first session, on 7 December 2018, its sixty-second session for the sole purpose of electing the Chair, three Vice-Chairs and the Rapporteur for that session.

In view of the established practice of rotating the offices on the basis of regional distribution, the officers to be elected by the Commission for its sixty-second session will be from the regional groups as follows:

Chair: African States

First Vice-Chair: Asia-Pacific States

Second Vice-Chair: Eastern European States

Third Vice-Chair: Western European and other States

Rapporteur: Latin American and Caribbean States

In accordance with established practice and Economic and Social Council resolution 1991/39, a group composed of the Chairs of the five regional groups, the Chair of the Group of 77 and China and the representative of or observer for the State holding the Presidency of the European Union will assist the Chair in dealing with organizational matters. That group, together with the elected officers, will constitute the extended Bureau.
