# Report of the Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission

Note by the secretariat\*\*

### I. Introduction

1. The present document covers the activities of the Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission during the period May 2013 to March 2014. The Advisory Committee appointed H.E. Mr. Lutfi Rauf, Ambassador Extraordinary and Plenipotentiary and Permanent Representative of Indonesia to ESCAP, Rapporteur, with the responsibility of presenting the report to the Commission at its seventieth session.

## II. Activities of the Advisory Committee

- 2. During the period under review, the Advisory Committee held six regular sessions and four informal sessions to hear briefings by the secretariat on topics including the Asia-Pacific regional Millennium Development Goals report 2012-2013, the ninth World Trade Organization Ministerial Conference, and the Asia-Pacific Forum on Sustainable Development. At its regular sessions, the Advisory Committee discussed, among other things, the following subjects:
- (a) Outcome of the sixty-ninth session of the Commission: In its review of the outcomes of the sixty-ninth session of the Commission, the Advisory Committee considered the major achievements of the session, including the adoption of 17 resolutions as well as 12 decisions, including a

decision on the dates, venue and theme topic for the seventieth session of the Commission.<sup>2</sup> The Advisory Committee commented that the session had been very successful primarily because of the strong partnership between member States and the secretariat, and that discussions had been very fruitful on a variety of issues, including on the theme study, the *Economic and Social Survey of Asia and the Pacific 2013*,<sup>3</sup> the Ministerial Panel on Sustainable Development and the development agenda beyond 2015, other high-level events, and the resolutions. The Advisory Committee commended the Executive Secretary and the secretariat for convening a successful session of the Commission, and expressed appreciation to the Government of Thailand for hosting the event;

- (b) Preparations for the seventieth session of the Commission: The secretariat informed the Advisory Committee that the Economic and Social Council had endorsed Bangkok as the venue for the seventieth session of the Commission. The Advisory Committee reviewed the preparations made by the secretariat and provided advice and guidance on the dates and the provisional agenda for the session;
- (c) Resolutions adopted by the Commission at its sixty-ninth session: The Advisory Committee provided advice and guidance on the implementation of the resolutions adopted by the Commission, in particular resolution 69/1;
- (d) Proposed calendar of ESCAP meetings and training in the period from January to December 2014: The Advisory Committee reviewed the proposed calendar and was provided with clarifications on the proposed items;
- (e) Review of the draft strategic framework for the biennium 2016-2017: The Advisory Committee reviewed and provided guidance on the draft strategic framework for the biennium 2016-2017 prior to its submission to the Commission at its seventieth session;
- (f) Work of the secretariat in the subregions: The Advisory Committee heard regular briefings, via videoconferencing, on ongoing ESCAP initiatives in the subregions and the work of its subregional offices and regional institutions;
- (g) Review of the preparations for and the outcomes of the following meetings:
  - (i) Third session of the Committee on Environment and Development;
  - (ii) Third session of the Committee on Disaster Risk Reduction;
  - (iii) Third session of the Committee on Trade and Investment, and the Third Asia-Pacific Trade and Investment Week;
  - (iv) Ninth session of the Governing Council of the Asian and Pacific Centre for Transfer of Technology;
  - (v) Ninth session of the Governing Council of the Centre for Sustainable Agricultural Mechanization;
  - (vi) Ninth session of the Governing Council of the Statistical Institute for Asia and the Pacific;
  - (vii) Second session of the Forum of Asian Ministers of Transport;

- (viii) Asian and Pacific Energy Forum;
- (ix) Sixth Asian and Pacific Population Conference;
- (x) Ministerial Conference on Regional Economic Cooperation and Integration in Asia and the Pacific.
- 3. The Advisory Committee was briefed by the secretariat on the *Asia-Pacific Regional Millennium Development Goals Report 2012-2013*. The Advisory Committee welcomed the report and commented that the report was of great importance given the current global deliberations on the development agenda beyond 2015.
- 4. The Advisory Committee was also briefed by the Office of Internal Oversight Services (OIOS) and the ESCAP secretariat on the programme evaluation of ESCAP. The primary focus of the evaluation was on the research and analytical work of the Commission.
- 5. The Advisory Committee further heard a briefing by the secretariat on the regional cooperative mechanism on drought monitoring and early warning. The Advisory Committee noted that disasters were a key issue in the region and had a major impact on people's livelihoods, and underscored the importance of regional cooperation and knowledge sharing to mitigate the threats posed by such disasters.
- 6. The Advisory Committee was briefed by the secretariat on the implementation of resolution 69/1. The Advisory Committee expressed its appreciation for the plan of implementation proposed by the secretariat and constituted an informal working group to provide the secretariat with a sounding board on its work and analyses of the issues related to implementation.
- 7. The Executive Secretary also regularly informed the Advisory Committee of activities relating to the priority issues of the United Nations, as well as the outcome of her missions to ESCAP members and associate members, her attendance at major meetings, collaborative initiatives between member States and the secretariat, and on administrative and programme matters concerning ESCAP. The Advisory Committee expressed its continued appreciation for the briefings of the Executive Secretary, noting that it found them useful and informative.

### III. Conclusion

- 8. In conclusion, the members of the Advisory Committee actively contributed to strengthening its deliberative and advisory role during the reporting period. The partnership between member States and the secretariat was further reinforced. The Advisory Committee provided important advice and guidance on important issues concerning the Commission and the secretariat, including on the implementation of resolution 69/1, organization of various intergovernmental meetings and initiatives of the secretariat.
- 9. At the same time, the Advisory Committee remained conscious of the need for stronger measures to ensure fuller implementation of Commission resolutions, improved coordination among all relevant stakeholders and progress on the economic and social agenda of ESCAP, in accordance with the development priorities of member States. Continued constructive collaboration and mutual support between the Advisory Committee and the Executive Secretary helped advance the Commission's overall goals and objectives and enhance its international profile.
