### **Report of the Secretary-General concerning the credentials of the representatives, deputy representatives and alternate representatives of the members of the Security Council elected for the period 2018–2019**

1. At its 86th plenary meeting, on 2 June 2017, the General Assembly elected Côte d'Ivoire, Equatorial Guinea, Kuwait, Peru and Poland as non-permanent members of the Security Council for a term of two years beginning on 1 January 2018. The General Assembly also elected the Netherlands to replace Italy as a non-permanent member of the Security Council for a term of one year beginning on 1 January 2018.
