Information bulletin from the Russian Federation Ministry of Defence on the status of implementation of the Memorandum on the creation of de-escalation areas (15 November 2017)

Observance of the ceasefire regime

Monitoring groups have continued to monitor observance of the ceasefire regime as part of implementing the Memorandum on the creation of de-escalation areas in the Syrian Arab Republic signed by the Russian Federation, the Republic of Turkey and the Islamic Republic of Iran on 4 May 2017.

The situation in the de-escalation areas has been assessed as stable.

The Russian representative office of the Russian and Turkish Joint Commission reviewing issues related to violations of the ceasefire regime has reported five incidents of gunfire in the following Governorates: two in Aleppo, one in Homs, one in Damascus and one in Ladhiqiyah.

The Turkish representative office has reported five violations in Damascus Governorate.

Most incidents of small arms being fired indiscriminately have been reported in areas controlled by fighters of the terrorist groups Nusrah Front and the Islamic State in Iraq and the Levant (ISIL).

Provision of humanitarian aid to the population of the Syrian Arab Republic

Over the past 24 hours, the Centre for Reconciliation of Opposing Sides in the Syrian Arab Republic carried out one humanitarian operation in Assan, in Aleppo Governorate (300 food parcels, 578 packages of bread). The total weight of the humanitarian aid was 1.7 tons.

In total, 1,677 humanitarian operations have been carried out, with a total weight of 2,292.371 tons.

One humanitarian convoy was sent through the United Nations to al-Rastan, in Homs Governorate, consisting of 46 trucks of the United Nations, the International Committee of the Red Cross and the Syrian Arab Red Crescent (products, medicines) with a total weight of 228 tons.

Over the past 24 hours, medical assistance has been provided to 172 residents.

In total, medical assistance has been provided to 64,276 residents.

Reconciliation of opposing sides

No ceasefire regime agreements were signed over the past 24 hours.

The number of populated areas that have joined the reconciliation process remains unchanged at 2,269.

Negotiations on joining the ceasefire regime continued with armed opposition groups in Aleppo, Damascus, Hama, Homs and Qunaytirah Governorates.

Over the past 24 hours, the Centre for Reconciliation of Opposing Sides in the Syrian Arab Republic has carried out one humanitarian operation in Rasm al-Zabib, in Rif Damascus Governorate, consisting of 500 humanitarian packages (tinned meat, sugar, rice). The total weight of the humanitarian aid was 2.15 tons.

In total, 1,678 humanitarian operations have been carried out, with a total weight of 2,294.521 tons.

Two humanitarian convoys were sent through the United Nations:

To Tall al-Dhahab, in Dar'a Governorate, consisting of two United Nations refrigerated trucks (products, medicines) with a total weight of 12 tons;

To Tayyibah, in Dar'a Governorate, consisting of 24 United Nations refrigerated trucks (products, medicines) with a total weight of 134 tons.

Over the past 24 hours, medical assistance has been provided to 83 residents.

In total, medical assistance has been provided to 64,359 residents.

Reconciliation of opposing sides

Over the past 24 hours, one ceasefire agreement was signed with Mab'ujah in Hama Governorate.

The number of populated areas that have joined the reconciliation process has increased to 2,270.

Negotiations on joining the ceasefire regime continued with armed opposition groups in Aleppo, Damascus, Hama, Homs and Qunaytirah Governorates.

In total, 1,679 humanitarian operations have been carried out, with a total weight of 2,296.7 tons.

Over the past 24 hours, medical assistance has been provided to 210 residents.

In total, medical assistance has been provided to 64,569 residents.

Reconciliation of opposing sides

Over the past 24 hours, one ceasefire regime agreement was signed with Umm al-Qasab in Homs Governorate.

The number of populated areas that have joined the reconciliation process has increased to 2,271.

Negotiations on joining the ceasefire regime continued with armed opposition groups in Aleppo, Hama, Homs, Damascus and Qunaytirah Governorates.

In total, 1,681 humanitarian operations have been carried out; the total weight of humanitarian aid delivered is 2,300.7 tons.

Over the past 24 hours, medical assistance was provided to 383 residents.

In total, medical assistance has been provided to 64,954 residents.

A humanitarian convoy is being sent through the United Nations to Dayr al-Zawr in Dayr al-Zawr Governorate; food and medicines with a total weight of 66 tons are being delivered to the local population.

Reconciliation of opposing sides

No ceasefire regime agreements were signed over the past 24 hours.

The number of populated areas that have joined the reconciliation process is unchanged — it is still 2,273.

Negotiations on joining the ceasefire regime continued with armed opposition groups in Aleppo, Hama, Homs, Damascus and Qunaytirah Governorates.

Over the past 24 hours, medical assistance has been provided to 74 residents.

In total, medical assistance has been provided to 65,028 residents.

A humanitarian convoy was sent through the United Nations to Dayr al-Zawr in Dayr al-Zawr Governorate; food and medicines with a total weight of 66 tons were delivered to the local population.

Reconciliation of opposing sides

Over the past 24 hours, three ceasefire regime agreements were signed with Shuluh, in Homs Governorate, and Kafr Ibbish and Zahir al-Ward, in Aleppo Governorate.

The number of populated areas that have joined the reconciliation process has increased to 2,276.

Negotiations on joining the ceasefire regime continued with armed opposition groups in Aleppo, Hama, Homs, Damascus and Qunaytirah Governorates.
