The thirty-first report contains a summary of the support provided by French forces to MINUSMA from 1 December 2020 to 1 March 2021.

The Barkhane force provided MINUSMA with the following operational support during the period covered by the present report:

#### **Operations**

None.

#### Intelligence

In the area of intelligence, during the period under review the Barkhane force provided the following through FRANIC Bamako:

- Twelve weekly status updates
- Twenty-five special intelligence reports transmitted to MINUSMA
- Nine reports from the Counter-Improvised Explosive Device Exploitation Laboratory

#### Military engineering

Aeronautical engineering

- In accordance with the agreement indicated in point b of the "References" section above, and pursuant to letter of assist France-MINUSMA-2013-12 amendment No. 9 of 22 September 2020, the French aeronautical engineering detachment (25th Air Engineer Regiment) maintained the Gao (Mali) airfield in operational condition.
- Pursuant to the letter of assist mentioned above, the 25th Air Engineer Regiment also mentored the Cambodian detachment of MINUSMA in Tessalit (Mali) in relation to the maintenance of unpaved airfields.
- The aeronautical engineering officer at the engineering branch of the joint forces headquarters oversaw a project to construct an unpaved (laterite) runway in Kidal (Mali) until the end of January 2021.

• The airfield engineering detachment that worked on the construction of the unpaved runway in Kidal had fully disengaged by the end of January 2021. The entire project has been taken over by MINUSMA.

#### Countering improvised explosive devices

- MINUSMA headquarters, the United Nations Mine Action Service and the officer of the Barkhane force responsible for efforts to counter-improvised explosive devices continue to exchange information on a near-daily basis.
- The officer of the Barkhane force responsible for efforts to counter-improvised explosive devices participated in the first working group to counter improvised explosive devices, which was held in Bamako on the occasion of the last operational coordination meeting. In addition, a monthly video teleconference is held between that officer and the counter-improvised explosive device section of the U2 cell of MINUSMA headquarters and the United Nations Mine Action Service.
- Owing to the reinforced measures to counter the coronavirus disease (COVID-19), no more meetings are being held in Gao and no more resources are being accepted for tests by the Counter-Improvised Explosive Device Exploitation Laboratory. These exchanges should nevertheless resume in the next few weeks. On 3 December 2020, 12 Explosive Threat Mitigation Officers taking a post-blast investigation level-1 training course with the United Nations Mine Action Service in Mali attended a presentation by the Counter-Improvised Explosive Device Exploitation Laboratory on its activities, capacities and analytical reports.

#### Logistics

Since 1 December 2020, the Barkhane force has transported a total of 185 persons and 8.22 tons of cargo, at part load, on board its aircraft. None of the aircraft were refuelled, however.

#### Health

The Barkhane force role 1 and 2 medical services are able to support MINUSMA in the event of an influx of injuries or under exceptional circumstances. Bilateral agreements allow MINUSMA personnel of certain nationalities to have access to routine and emergency consultations, paramedical care, dental care and surgical procedures. Such services were rendered exclusively by role 2 in Gao.
