

Letter dated 14 July 2021 from the Secretary-General addressed to the President of the Security Council

I have the honour to refer to Security Council resolution 1966 (2010), adopted on 22 December 2010, establishing the International Residual Mechanism for Criminal Tribunals, and, in particular, to article 10, paragraph 2, of the statute of the Mechanism (annex 1 to the resolution), on the appointment of a person to fill a vacancy in the roster of judges of the Mechanism.

Article 8, paragraph 1, of the statute provides that the Mechanism shall have a roster of 25 independent judges.

One of the judges of the Mechanism, Judge Gberdao Gustave Kam (Burkina Faso) regrettably died on 17 February 2021, leaving a vacancy in the aforementioned roster.

In that regard, article 10, paragraph 2, of the statute provides that, in the event of a vacancy in the roster, after consultation with the Presidents of the Security Council and of the General Assembly, the Secretary-General shall appoint a person meeting the qualifications of article 9, paragraph 1, of the statute, for the remainder of the term of office concerned.

Furthermore, article 9, paragraph 1, of the statute specifies that the judges shall be persons of high moral character, impartiality and integrity who possess the qualifications required in their respective countries for appointment to the highest judicial offices. Particular account shall be taken of experience as judges of the International Tribunal for the Former Yugoslavia or the International Criminal Tribunal for Rwanda.

However, the procedure for identifying a candidate for consideration for appointment under article 10, paragraph 2, which is applicable when a vacancy arises owing to the death of a judge during his or her term of service, is not prescribed in the statute.

In accordance with the established practice regarding the appointment of a judge to fill a vacancy at the International Tribunal for the Former Yugoslavia and the International Criminal Tribunal for Rwanda, which was adopted for the purposes of filling vacancies in the roster of judges of the Mechanism in 2016, 2018, 2019 and 2020, the State of the nationality of the judge to be replaced nominates another candidate.

I am pleased to inform you that the Government of Burkina Faso has nominated Ms. Fatimata Sanou Touré to replace Judge Kam for the remainder of the term of office, which ends on 30 June 2022.





Please find attached the curriculum vitae of Ms. Sanou Touré (see annex). It is my view that Ms. Sanou Touré meets the qualifications that are prescribed in article 9, paragraph 1, of the statute of the Mechanism.

On that basis and in accordance with article 10, paragraph 2, of the statute, I look forward to receiving your views on the appointment of Ms. Sanou Touré as a judge of the Mechanism.

3. Summary of qualifications

I am a magistrate de grade exceptionnel (senior member of the national judiciary) and hold a master's degree in private judicial law and a diplôme de magistrat (judicial service diploma). I completed specialist training in development law at the International Development Law Organization in Italy. I am also involved in defending and promoting human rights in Africa. In that connection, I was elected President of the Association des femmes juristes du Burkina Faso (2013-2017) and Vice- President of the Fondation pour l'étude et la promotion des droits de l'homme en Afrique, whose President is Halidou Ouédraogo. I am also a founding member of the African Women Leaders Network for the Promotion of Sexual and Reproductive Health and Family Planning. I represent human rights organizations on the Economic and Social Council of Burkina Faso. I participated in the preparation of the preliminary draft constitution of the Fifth Republic of Burkina Faso (2017) as a member of the national constitutional commission representing women's associations and as deputy rapporteur of that commission. I have represented the African group on the Women's Advisory Council of the Organization of Islamic Cooperation since November 2019.

4. Professional experience

- Since October 2015, I have served as Chamber President at the Court of Appeal of Ouagadougou. In this position, I preside over the Criminal Chamber, which is responsible for verifying the application of the law by first-instance judges. I also lead the President's Court, which reviews the decisions of the presidents of the courts of first instance, of the Commercial Court and of the Labour Court. I also prepare the decisions rendered.
- October 2012-October 2015: President of the Court of First Instance of Ouagadougou, the largest court of first instance in Burkina Faso. In this position, I:
 - -managed the permanent seat of the court, which was composed of 30 judges, 7 investigating judges and 36 registrars;
 - -ensured the proper functioning of six Criminal Chambers and two Civil Chambers and the issuance of court documents;
 - handled contentious and non-contentious applications;
 - presided over the President's Court;
 - presided over the First Civil Chamber;
 - prepared the decisions rendered.
