Note verbale dated 13 July 2018 from the Permanent Mission of Iraq to the United Nations addressed to the Chair of the Committee

The Permanent Mission of the Republic of Iraq to the United Nations presents its compliments to the Chair of the Security Council Committee established pursuant to resolution [1718 \(2006\)](#) and, with reference to Council resolutions [1718 \(2006\)](#), [1874 \(2009\)](#), [2087 \(2013\)](#), [2094 \(2013\)](#), [2270 \(2016\)](#), [2321 \(2016\)](#), [2356 \(2017\)](#), [2371 \(2017\)](#), [2375 \(2017\)](#) and [2397 \(2017\)](#) regarding the Democratic People's Republic of Korea and pursuant to its note verbale dated 30 April 2018, has the honour to inform the Chair that Iraqi competent authorities have issued decisions Nos. 8 (2018), 17 (2018) and 30 (2018), which freeze funds and financial assets or economic resources of individuals and entities related to the above-mentioned Security Council resolutions. Enclosed is a copy of their names (see annex).

The Iraqi competent authorities have notified, through the Iraqi Gazette, all ministries, local governorates and financial and non-financial institutions, to fully implement all aspects of those decisions, including freezing of funds and other financial assets or economic resources of individuals and entities referred to in those decisions.

The Permanent Mission of the Republic of Iraq to the United Nations would highly appreciate it if the Committee established pursuant to resolution [1718 \(2006\)](#) would treat the above as a national implementation report for the Republic of Iraq.
