STATUS OF CONTRIBUTIONS AS AT 31 DECEMBER 1976 ^{1/}

On the recommendation of the Fifth Committee, as outlined in paragraph 224 (h) of its report (A/10500), the General Assembly, at its thirtieth session, decided that "having in mind the Secretary-General's appeal to Member States to help ease the cash-flow position of the United Nations Organization by forwarding their assessed contributions more promptly, ^{2/} and in view of the complex tasks envisaged for the Organization under General Assembly resolution 3362 (S-VII) of 16 September 1975, the Secretary-General be requested to resume, from 31 December 1975 and on a biannual basis thereafter, publication of a document showing, for each Member State, amounts assessed, paid and owing to the regular budget and on continuing operation for which there is a special assessment; the document should be made available to all Member States and should contain essentially the same information as that published in document A/5822, last issued on 30 November 1964".

The payments shown in the statements have been recorded in accordance with relevant General Assembly resolutions and the Financial Regulations of the United Nations.

The contributions for 1974 and 1975 of Bangladesh, Grenada and Guinea-Bissau, admitted to membership in the Organization at the twenty-ninth session of the General Assembly in 1974, are treated as miscellaneous income and are therefore being shown separately.

The contributions for 1975 and 1976 of Cape Verde, Comoros, Mozambique, Papua New Guinea, Sao Tome and Principe and Surinam, admitted to membership in the Organization during the thirtieth session of the General Assembly in 1975, will not be due and payable until 1977 and have therefore been excluded from this statement.

Similarly, rates of assessment for Angola, Samoa and Seychelles, admitted to membership in the United Nations during the thirty-first session of the General Assembly in 1976, have not yet been established. Therefore, these Member States have been excluded from this statement.
