## Currency

The local currency is the Guatemala Quetzal (GTQ). The average exchange rate is currently approx. GTQ 7.90 to the United States dollar.

#### Transport from the airport to hotels

Participants are advised to book their flights well in advance of the meeting with the travel agency and airline of their choice. The Government of Guatemala will be responsible for the reception of participants upon arrival at the Aurora Airport and their transportation from the airport to their places of accommodation and back.

#### Transfer

Participants will be provided with daily transfers from their hotels to the Salón Azaria, Cayalá and back.

## Visas

Participants are advised to consult the consulates of Guatemala in regards to visa requirements to enter the country, so that they may carry out the necessary procedures beforehand.

## Medical service

#### Climate

The temperature in Guatemala City is around 26°.

## **Electricity and Internet**

In Guatemala, the electrical current has a voltage of 110 throughout the country.

Delegates will have access to a wireless Internet connection (Wi-Fi) at the Salón Azaria, Cayalá.

## Country code

The country code for Guatemala is: (502) (plus a number of 8 digits).

#### **Taxes**

Any purchase of goods in Guatemala are subject to a 12 per cent Value Added Tax. The hotels also charge a fee for the provision of accommodation of 10 per cent. There is a departure tax at La Aurora International Airport of \$30.00+Q20.00 of security tax, which are already included in the airplane ticket.

#### Gratuities

Tips are not included anywhere. In Guatemala, it is customary to tip 10 per cent of the cost of the total consumption. Today, many restaurants automatically include the tip in the receipt or invoice.

#### Use of firearms

For bringing and carrying firearms in the country, participants must process the relevant permits.

The carrying of firearms inside the premises of the Salón Azaria Cayalá is prohibited at all times.

## General information about Guatemala

Guatemala is a sovereign State located in the north-western part of Central America. It has a rich indigenous culture that is rooted in its Mayan heritage and the Spanish influence of the colonial era.

Despite its relatively small size, Guatemala has a very varied climate owing to its mountainous terrain, which rises from sea level to 4,220 metres above sea level. As a result, the country has a diverse range of ecosystems, from the mangrove swamps of the Pacific wetlands to the cloud forests of the high mountains.

The capital of Guatemala is Guatemala City, officially called "Nueva Guatemala de la Asunción".

The official language is Spanish, although there are also 23 Mayan languages, as well as Xinca languages and Garifuna. Garifuna is spoken by the people of African descent living in the department of Izabal, located on the Caribbean coast.

Guatemala City has a mix of modern and colonial architecture and diverse art forms that mark the passage of time and social developments. You can visit monuments, museums, churches, art galleries, theatres and iconic buildings. The historic quarter

is home to the Miguel Ángel Asturias Cultural Centre, the Civic Centre to the south and the main boulevards Avenida Reforma and Avenida Las Américas.

A short distance from the capital lies the picturesque and enchanting city of Antigua Guatemala, an iconic symbol of Spanish colonial heritage. It is located in Panchoy Valley and is surrounded by three volcanoes and mountains home to coffee plantations. It was declared a World Heritage Site by UNESCO in 1979 owing to its history and beauty. With its unique cobblestone streets and historic buildings, the city offers a backdrop against which splendorous cultural and religious traditions come to life.
