Organization of the Meeting

A. Opening and duration of the Meeting

1. The fifty-second session of the Subcommission on Illicit Drug Traffic and Related Matters in the Near and Middle East was held in Beirut from 13 to 17 November 2017. Khawla Mattar, Deputy Executive Secretary of ESCWA, made an opening statement. The Chairperson of the fifty-second session of the Subcommission, General Ghassan Chamseddine also addressed the meeting.

B. Attendance

2. The following States members of the Subcommission were represented: Azerbaijan, Iran (Islamic Republic of), Jordan, Lebanon, Oman, Pakistan, Qatar, Saudi Arabia, Tajikistan and Turkey.

3. Italy was represented by an observer.

4. The Council of Arab Ministers of the Interior, the Central Asian Regional Information and Coordination Centre for Combating Illicit Trafficking of Narcotic Drugs, Psychotropic Substances (CARICC) and the Food and Agricultural Organization (FAO) were also represented.

5. The United Nations Office on Drugs and Crime served as the secretariat of the Meeting.
