## Programme budget for the biennium 2014-2015

### Report of the Fifth Committee

#### I. Introduction

1. At its 2nd plenary meeting, on 19 September 2014, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-ninth session the item entitled “Programme budget for the biennium 2014-2015” and to allocate it to the Fifth Committee.
2. The Fifth Committee considered the item at its 1st and 2nd meetings, on 3 and 7 October 2014. Statements and observations made in the course of the Committee’s consideration of the item are reflected in the relevant summary records ([A/C.5/69/SR.1](#) and 2).
3. For its consideration of the item, the Committee had before it the following documents:
  - (a) United Nations Mission for Ebola Emergency Response and the Office of the Special Envoy on Ebola ([A/69/404](#));
  - (b) Related report of the Advisory Committee on Administrative and Budgetary Questions ([A/69/408](#)).

#### II. Consideration of draft resolution [A/C.5/69/L.2](#)

4. At its 2nd meeting, on 7 October, the Committee had before it a draft resolution entitled “United Nations Mission for Ebola Emergency Response” ([A/C.5/69/L.2](#)), submitted by the Chair of the Committee on the basis of informal consultations coordinated by the representative of India.
5. At the same meeting, the Committee adopted draft resolution [A/C.5/69/L.2](#) without a vote (see para. 6).



### III. Recommendation of the Fifth Committee

6. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolution:

#### **United Nations Mission for Ebola Emergency Response**

*The General Assembly,*

*Having considered* the report of the Secretary-General on the United Nations Mission for Ebola Emergency Response and the Office of the Special Envoy on Ebola<sup>1</sup> and the related report of the Advisory Committee on Administrative and Budgetary Questions,<sup>2</sup>

1. *Takes note* of the report of the Secretary-General;<sup>1</sup>
2. *Endorses* the conclusions and recommendations contained in the report of the Advisory Committee on Administrative and Budgetary Questions;<sup>2</sup>
3. *Recalls* paragraph 24 of the report of the Advisory Committee,<sup>2</sup> and emphasizes that the adoption of the present resolution is without prejudice to any subsequent review of the Mission by the General Assembly and any decision it may take with regard to the budgetary arrangements, organizational structure, staffing and operational requirements of the Mission, when it considers the detailed budget submission by the Secretary-General.
