## **I. Introduction**

1. The previous recommendation made by the Fifth Committee to the General Assembly under agenda item 131 is set out in the report of the Committee contained in document [A/70/624](#).

2. The Fifth Committee considered the item at its 24th and 27th meetings, on 29 February and 10 March 2016. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records.<sup>1</sup>
