**Письмо Постоянного представителя Кипра при Организации
Объединенных Наций от 6 октября 2020 года на имя
Генерального секретаря**

По поручению правительства моей страны препровождаю настоящим два отдельных документа, в которых содержатся сведения о совершенных Турцией вторжениях в национальное воздушное пространство Кипра и нарушениях международных правил воздушного движения в районе полетной информации Кипра (см. приложение I)*, а также незаконном использовании Турцией закрытых портов и аэропортов на Кипре (см. приложение II)* в августе 2020 года. Такая линия поведения вызывает серьезную обеспокоенность у Республики Кипр, является постоянным нарушением ее суверенитета и усугубляет катастрофические последствия вторжения Турции и продолжающейся турецкой оккупации части ее территории.

Кроме того, эта продолжающаяся политика, проводимая в нарушение Устава Организации Объединенных Наций и норм международного права и международных правил и положений, создает постоянную угрозу для международного мира и безопасности, негативно влияет на стабильность в регионе, ставит под угрозу безопасность международной гражданской авиации, создает трудности для воздушного движения над Кипром и препятствует созданию благоприятных условий для осуществления кипрского мирного процесса.

Турция посредством радиообмена продолжает систематически создавать помехи для гражданской и военной авиации в районе полетной информации Никосии, и в этот же период режим, установленный оккупирующей державой в оккупируемом ею районе Кипра, незаконно направил одно извещение для авиационного персонала в связи с учениями, проводившимися турецкими военно-воздушными силами. Кроме того, самолеты турецких коммерческих авиакомпаний систематически используют аэропорт Тимбу, который продолжает незаконно эксплуатироваться с момента закрытия правительством Кипра всех пунктов въезда в районах, не находящихся под его фактическим контролем.

Вышеозначенные действия Турции, которая с 1974 года оккупирует северную часть Республики Кипр, явно рассчитаны на подрыв суверенитета Республики Кипр, закрепление сохраняющегося фактического раздела и повышение статуса сепаратистского образования путем предъявления претензий на воздушное пространство над оккупированной территорией Республики. В этой связи я хотел бы подчеркнуть, что существует только одно кипрское государство — Республика Кипр, как это предусмотрено в различных резолюциях Совета Безопасности (в частности, в резолюциях [541 \(1983\)](#) и [550 \(1984\)](#)), в которых так называемое отделение части Кипра объявляется не имеющим законной силы.

От имени правительства моей страны я заявляю решительный протест в связи с продолжающимися вторжениями Турции в национальное воздушное пространство и территориальные воды Кипра, а также нарушениями ею международных правил воздушного движения и призываю к их немедленному прекращению.

Республика Кипр вновь обращается с призывом соблюдать резолюции Совета Безопасности и закрепленные в Уставе принципы суверенитета и невмешательства.

Наконец, я хотел бы настоятельно призвать Турцию и киприотов-турок содействовать конструктивному возобновлению мирного процесса, вместо того чтобы направлять все усилия на подрыв суверенитета Республики Кипр и закрепление раздела Кипра посредством изменения положения на местах и закрепления статус-кво, включая повышение политического статуса этого сепаратистского образования.

В частности, на данном этапе я должен отметить угрозы Турции, которая несет полную ответственность за сохранение статус-кво в Вароше и за подчиненную ей незаконную местную администрацию оккупированной территории Кипра, вновь открыть огороженную территорию Вароши, а также шаги, предпринимаемые Турцией в этом направлении в нарушение соответствующих резолюций Совета Безопасности и при полном игнорировании как недавних призывов Совета Безопасности избегать осуществления в отношении Вароши действий, которые не согласуются с его резолюциями, так и того факта, что такие действия нанесут катастрофический удар по усилиям, направленным на достижение мира.

Буду признателен за распространение настоящего письма и приложений к нему в качестве официального документа Генеральной Ассамблеи по пункту 44 повестки дня и в качестве документа Совета Безопасности.
