Responding to the North Korean Threat

- * U.S. military activities, whether individual or with other nations, are transparent and defensive in nature.
 - * Designed to demonstrate resolve and ability to respond.
- * Continued provocations by North Korea necessitate defensive measures be exercised and demonstrated.
 - * Responses to the North Korean threat.



Defense Exercises on the Korean Peninsula

- * Military exercises on the Peninsula have been long-standing and focused on the defensive nature of the U.S.-ROK Alliance.
 - * Increase Readiness
 - * Protect The Region
 - * Maintain Stability on the Peninsula
- * Multinational Anchor
 - * United Nations Command **regularly informs** the Korean People's Army
 - * Neutral Nations Supervisory Commission observation

U.S.-ROK Alliance Decision to Deploy THAAD

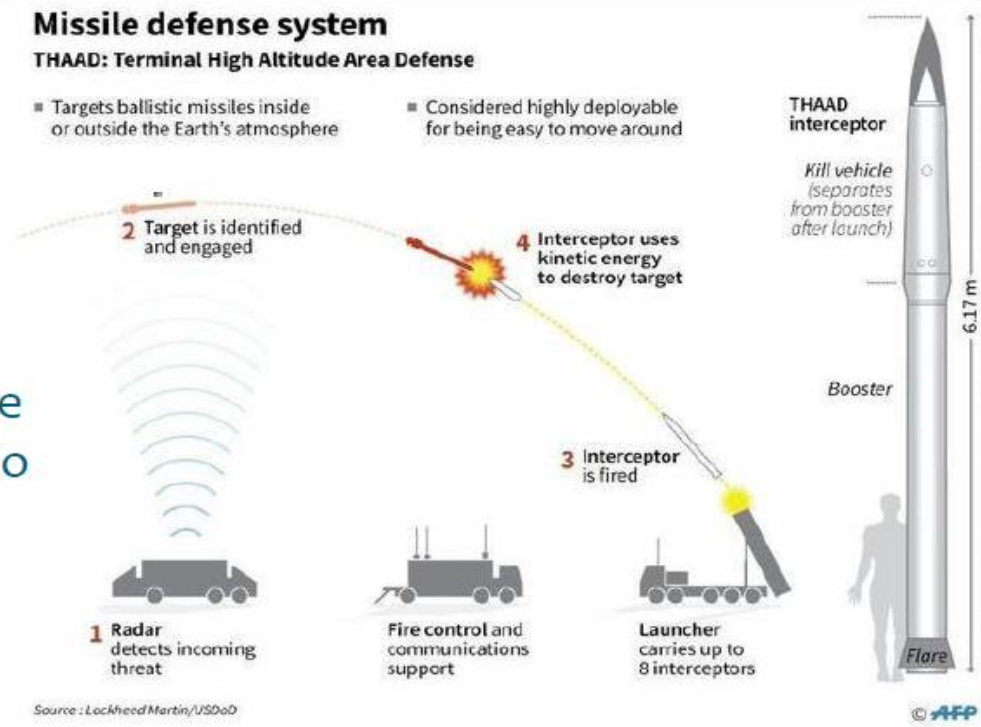
- * THAAD is purely defensive in nature.
- * North Korea's continued pursuit of WMD strike capabilities require defensive measures to be put in place.
- * U.S. ballistic missile defense systems are not designed to negate China or Russia's strategic deterrent.

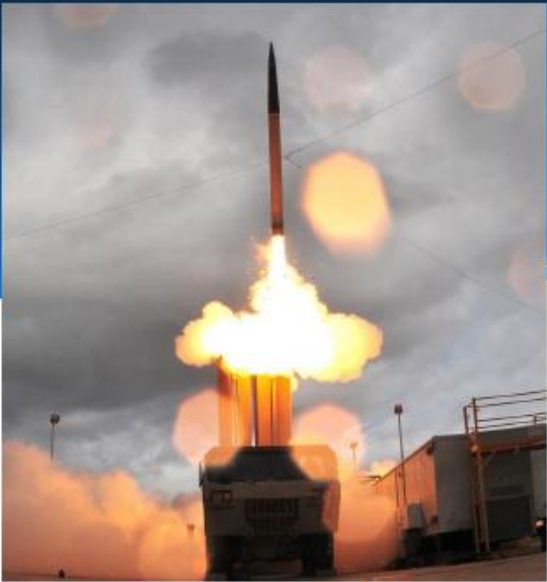


Missile defense system

THAAD: Terminal High Altitude Area Defense

- Targets ballistic missiles inside or outside the Earth's atmosphere
- Considered highly deployable for being easy to move around





A Terminal High Altitude Area Defense (THAAD) interceptor is launched from the Pacific Spaceport Complex Alaska in Kodiak, Alaska, during Flight Experiment THAAD-01, July 30, 2017. During the test, the THAAD weapon system successfully intercepted an air-launched, medium-range ballistic missile target.

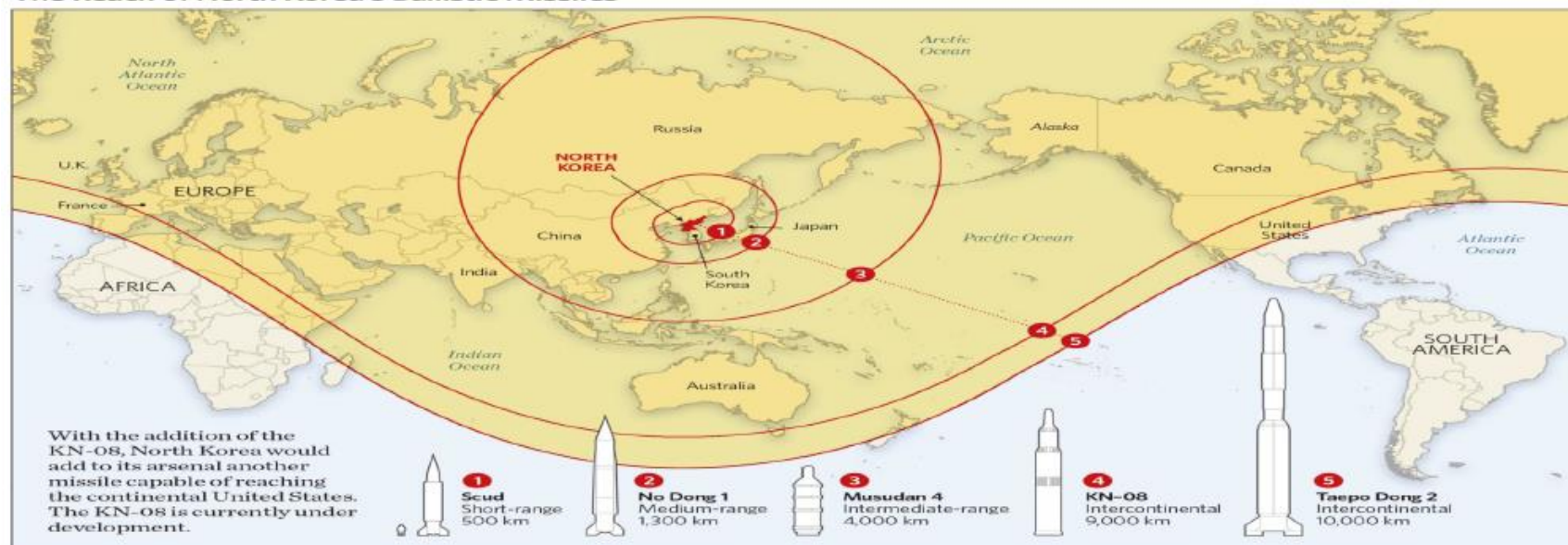
