


مجلس حقوق الإنسان الدورة الثانية والأربعون ۹–۲۷ أيلول/سبتمبر ۲۰۱۹ البند ١ من جدول الأعمال المسائل التنظيمية والإجرائية انتخاب أعضاء اللجنة الاستشارية لمجلس حقوق الإنسان\* مذكرة مقدَّمة من الأمين العام عملاً بقرار مجلس حقوق الإنسان ١/٥، ينتخب المجلس، بالاقتراع السري من قائمة المرشحين الذين قُلِّمت أسماؤهم وفقاً للمتطلّبات المتفق عليها، أعضاءَ اللجنة الاستشارية، المؤلفة من ١٨ خبيراً يعملون بصفتهم الشخصية ويكونون قد رشحتهم الدول الأعضاء في الأمم المتحدة بعد التشاور مع المؤسسات الوطنية لحقوق الإنسان ومنظمات المجتمع المدني. ۲- والتوزيع الجغرافي للأعضاء هو كما يلي: خمسة أعضاء من مجموعة الدول الأفريقية؛ (أ) (ب) خمسة أعضاء من مجموعة دول آسيا والمحيط الهادى؛ عضوان من مجموعة دول أوروبا الشرقية؛ (7) ثلاثة أعضاء من مجموعة دول أمريكا اللاتينية والكاريبي؛ (د) ثلاثة أعضاء من مجموعة دول أوروبا الغربية ودول أخرى. (هـ) واعتمد مجلس حقوق الإنسان، في دورته السادسة، المقرر ١٠٢/٦ المتعلق بمتابعة تنفيذ ۳-قرار المجلس ١/٥ الذي حدد فيه المتطلّبات التقنية والموضوعية لتقديم أسماء المرشحين. والتي

(أ) الكفاءة والخبرة المشهود بهما في مجال حقوق الإنسان؛

· يُعمَّم مرفق هذه الوثيقة كما ورد وباللغة التي قُدِّم بما فقط.

٤ ويتعيّن على الدول، عند اختيار مرشحيها، أن تطبق المبادئ التوجيهية التالية المتعلقة بالمتطلّبات التقنية والموضوعية لتقديم مرشحيها:

- (أ) الكفاءة والخبرة:
- '۱' دراسات أكاديمية في ميدان حقوق الإنسان أو المجالات المتصلة به و/أو الخبرة مع أداء أدوار قيادية في مجال حقوق الإنسان على الصعيد الوطني أو الإقليمي أو الدولي؛
- '۲' خبرة كبيرة (لا تقل عن خمس سنوات) وإسهامات شخصية في ميدان حقوق الإنسان؛
- "" المعرفة بمنظومة الأمم المتحدة وبالولايات والسياسات المؤسسية المتصلة بالعمل في مجال حقوق الإنسان، وكذلك المعرفة بالصكوك والمعايير والتخصصات الدولية في مجال حقوق الإنسان؛ ويحبَّذ الإلمام بالنظم القانونية والحضارات المختلفة؛
  - '٤' إجادة لغة واحدة على الأقل من اللغات الرسمية للأمم المتحدة؛
- 'ه' توافر الوقت الكافي لدى المرشح لأداء عمل اللجنة الاستشارية على نحو فعّال، وذلك لحضور دورات اللجنة والاضطلاع بالأنشطة التي تصدر بما تكليفات بين الدورات على السواء؛
  - (ب) أن يتصف المرشح بمكانة أخلاقية رفيعة؛

(ج) الاستقلالية والنزاهة: يُستبعد الأفراد الذين يشغلون مناصب صنع قرار في الحكومة أو في أي منظمات أو كيانات أخرى قد يترتب على تقلدها تعارض في المصالح مع المسؤوليات الأساسية للولاية؛ ويعمل الأعضاء المنتخبون للجنة الاستشارية بصفتهم الشخصية؛

(د) اعتبارات أخرى: احترام مبدأ عدم الجمع في آنٍ واحد بين عدة مهام في مجال حقوق الإنسان.

 ٥ ويولي مجلس حقوق الإنسان، عند انتخاب أعضاء اللجنة الاستشارية، الاعتبار الواجب للتوازن بين الجنسين ولتمثيل النظم القانونية والحضارات المختلفة تمثيلاً مناسباً.

٦- وفي الدورة السابعة، أجرى مجلس حقوق الإنسان الانتخابات الأولى لاختيار ١٨ عضواً للجنة الاستشارية. وقد انتُخب أربعة أعضاء لمدة سنة واحدة، وسبعة لمدة سنتين، وسبعة لمدة ثلاث سنوات. ٧- وينتخب مجلس حقوق الإنسان، في دورته الثانية والأربعين، وفقاً لبرنامج عمله السنوي، أعضاء اللجنة الاستشارية لشغل المناصب السبعة الشاغرة. ومن هذه المناصب السبعة الشاغرة، يعود منصبان للدول الأفريقية، ومنصبان لدول آسيا والمحيط الهادي، ومنصب واحد لدول أوروبا الشرقية، ومنصب واحد لدول أمريكا اللاتينية والكاريبي، ومنصب واحد لدول أوروبا الغربية ودول أخرى.

٨- وعملاً بأحكام الفقرة ٧١ من قرار مجلس حقوق الإنسان ٥/١، تُقفَل قائمة المرشحين قبل تاريخ الانتخاب بشهرين، وتُتيح الأمانة قائمة المرشحين والمعلومات المتوافرة عنهم للدول الأعضاء وللجمهور قبل تاريخ الانتخاب بشهر على الأقل.

٩- وفي ١٥ أيار/مايو ٢٠١٩، وجمّهت أمانة مجلس حقوق الإنسان مذكرة شفوية إلى منسِقي المجموعات الإقليمية المعنية، تحث فيها على اقتراح أسماء مرشحين وتبلغهم بأن الموعد النهائي لتقديم الترشيحات هو ٢٦ تموز/يوليه ٢٠١٩.

١٠ وتبعاً لذلك، تلقت الأمانة ترشيحات لسبعة مرشحين للانتخاب لعضوية اللجنة الاستشارية من حكومات الاتحاد الروسي، وإسبانيا، وإيران (جمهورية - الإسلامية)، والجزائر، والصين، ومصر، واليابان.

١١- وتُعرض أدناه الترشيحات التي وردت؛ وترد بيانات السيرة الذاتية المتعلقة بالمرشحين في المرفق.
