The representative of the United States requested a recorded vote on Section K of the draft decision.

Before the vote on Section K, the representatives of Pakistan (on behalf of the Group of 77 and China) and the United States made statements.

The Committee then proceeded to vote on Section K of draft decision A/C.5/62/L.17, which was adopted by a recorded vote of 94 votes to 40, with 6 abstentions.

Statements after the vote were made by the representatives of Canada, the United States and Spain.

The Committee then adopted the draft decision as a whole without a vote.

The Committee had before it draft resolution A/C.5/62/L.18, which had been coordinated by the representative of Argentina and Vice-Chairman of the Committee.

The representative of the United States requested a recorded vote on draft resolution A/C.5/62/L.18.

Before the vote on the draft resolution, the representative of Pakistan (on behalf of the Group of 77 and China) made a statement.

The Committee then proceeded to vote on draft resolution A/C.5/62/L.18, which was adopted by a recorded vote of 141 votes to 1, with 0 abstention.

The representative of the United States made a statement after the vote.

Contingency fund: consolidated statement of programme budget implications and revised estimates

The Director of the Programme Planning and Budget Division introduced the note by the Secretary-General (A/C.5/62/22).

The Chairman of the Advisory Committee on Administrative and Budgetary Questions or ally introduced the related report of that Committee.

The Chairman proposed, and the Committee agreed to recommend to the General Assembly to note that a balance of \$12,191,000 remained in the contingency fund.

The Chairman of the Committee then drew the attention of the Committee to the draft report of the Fifth Committee contained in document A/C.5/62/L.23 submitted by the Secretariat, on behalf of the Rapporteur.

The representative of the Syrian Arab Republic requested a recorded vote on Part V of draft resolution A/C.5/62/L.20.

The Committee then proceeded to vote on Part V of draft resolution A/C.5/62/L.20, which was adopted by a recorded vote of 92 votes to 0, with 14 abstentions.

After the adoption of Part V, statements were made by the representatives of Chile, the Libyan Arab Jamahiriya, Lebanon, Algeria, Afghanistan, India, Yemen and the Sudan.

The Secretary of the Committee also made a statement.

The Committee then adopted, without a vote, draft resolutions I to V, contained in document A/C.5/62/L.23.

The Committee had before it draft resolution A/C.5/62/L.25, which had been coordinated by the representative of Poland, on behalf of the Chairman.

The representative of the United States requested a recorded vote on operative paragraph 10 of the draft resolution and on the draft resolution as a whole.

Before the vote, the representative of Pakistan (on behalf of the Group of 77 and China) made a statement.

The Committee then proceeded to vote on operative paragraph 10, of draft resolution A/C.5/621/L.25, which was adopted by a recorded vote of 93 votes to 1, with 47 abstentions.

After the vote, statements were made by the representatives of the Russian Federation and the Dominican Republic (on behalf of the Rio Group).

The Committee then proceeded to vote on the draft resolution as a whole, which was adopted by a recorded vote of 140 votes to 1, with 1 abstention.
