RELATIONSHIP BETWEEN DISARMAMENT AND DEVELOPMENT

Report of the First Committee

Rapporteurt Mr. Doulaye Corentin Kl (Burkina Faso)

I. INTRODUCTION

- 1. The item entitled "Relationship between disarmament and development: report of the Preparatory Committee for the International Conference on the Relationship between Disarmament and Development" was included in the provisional agenda of the forty-first session in accordance with General Assembly resolution 40/155 of 16 December 1985 and decision 40/473 of 20 June 1986.
- 2. At its 3rd plenary meeting on 20 September 1986, the General Assembly, on the recommendation of the General Committee, decided Co include the item in its agenda and to allocate it to the First Committee.
- 3. At ite 2nd meeting on 8 October, the First Committee decided to hold a general debate on the disarmament items allocated to it, followed by statements on specific disarmament agenda items and continuation of general debate, as necessary. The deliberations on those items, namely, items 46 to 65 and item 144, took place between the 3rd and the 32nd meetings, from 13 October t 4 November (see A/C.1/41/PV.3-32).

II. CONSIDERATION OF DRAFT DECISION A/C.1/41/L.78

- 5. On 11 November, the Chairman of the First Committee submitted a draft decision entitled "International Conference on the Relationship between Disarmament and Development" (A/C.1/41/L.78), which he introduced at the 45th meeting, on 14 November
- 6. In this **connection**, the Secretary-General submitted a statement on the programme budget implications of the draft decision (A/C.1/41/L.80).
- 7. At its 45th meeting, on 14 November, the Committee adopted draft decision A/C.1/41/In 78 without a vote (see para. 8).

III. RECOMMENDATION OF THE FIRST COMMITTEE

8. The First Committee **recommends** to the General Assembly the adoption of **the** following draft **decision:**

International Conference on the Relationship between Disarmament and Development

The General Assembly, on the recommendations of the Preparatory Committee for the International Conference on the Relationship between Disarmament and Development 2/ and in conformity with General Assembly decision 40/473 of 20 June 1986, decided:

- (a) To hold the International Conference on the Relationship between Disarmament and Development at United Nations Headquarters in New York from 24 August to 11 September 1987;
- (b) To convene the Preparatory Committee for one more session from 21 April to 1 May 19871
- (c) To request the Member States and the Secretary-General of the Conference, based on the information in the report of the Preparatory Committee 1/ concerning the results so far achieved in the substantial and organizational preparation for the Conference, to continue and intensify their participation in the final stage of the preparatory process, especially in making available their views and proposals on substantive issues, in order to ensure the best possible success of the Conference,
